**Subject: Request for Confidentiality**

To whom it may concern:

Pursuant to the provisions of 0.457 and 0.459 of the Commission's rules (47 C.F.R. §§ 0.457, 0.459), Waymo [Inc.] hereby requests confidential treatment for documents filed with the Commission in connection with the application for equipment authorization referenced above.

## **Permanent Confidentiality**

Waymo requests that the Commission withholds the following documents from public viewing indefinitely:

- Block diagrams
- Electrical schematic diagrams
- Operational descriptions
- Internal photographs
- Antenna specifications
- User manual

These documents reveal technical and design information that is protected by Waymo as confidential and proprietary trade secrets. This information has only been disclosed to employees and contractors of Waymo who are required to maintain its confidentiality, and the information is not disclosed to the public even after commercial release of a device. Furthermore, the device being authorized is not sold to third parties, is only used by Waymo, and is not accessible to the general public or to the device's end users. The device cannot be serviced except by Waymo and its authorized employees and contractors, who are subject to confidentiality requirements as a condition of employment. Waymo does not make the device available to any third parties and therefore does not have a sample NDA to provide in connection with this confidentiality request. The technical and design information found in these documents represent commercially valuable innovations that were obtained by Waymo through substantial efforts and financial cost. As a result, disclosure of this information by the Commission would harm Waymo by giving competitors an unfair advantage.

## **Short Term Confidentiality**

In addition to the above mentioned documents, and to ensure that business sensitive information remains confidential until the actual marketing of newly authorized devices, Waymo requests that the Commission withhold the following documents from public viewing for 180 days after the date the grant of authorization is issued:

- External photographs
- Test setup photographs

These documents reveal technical and design information that has not been publicly disclosed in marketing

materials and is protected by Waymo as confidential and proprietary trade secrets. This information has only been disclosed to those required to maintain its confidentiality and is not disclosed prior to the commercial release of the device. As a result, disclosure of this information by the Commission prior to commercial release would harm Waymo by giving competitors an unfair market advantage because they describe external-facing components that are purpose built for Waymo. Waymo believes the period of confidentiality requested is necessary to protect the information until the commercial release of the device.

It is our understanding that measurement test reports and FCC ID label format cannot be granted as confidential documents and this information will be available for public review once the grant of equipment authorization is issued.
