## 2. RF Exposure evaluation for FCC

According to 447498 D01 General RF Exposure Guidance v06

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances ≤ 50 mm are determined by:

[(max. power of channel, including tune-up tolerance, mW)/(min. test separation distance,

mm)]  $\cdot [\sqrt{f(GHz)}] \le 3.0$  for 1-g SAR and  $\le 7.5$  for 10-g extremity SAR, where:

f(GHz) is the RF channel transmit frequency in GHz

Power and distance are rounded to the nearest mW and mm before calculation

Worse case is as below: [2480 MHz, 6 dBm, (3.98 mW) output power]

 $(3.98/5) \cdot [\sqrt{2.48}(GHz)] = 1.25 < 3.0 \text{ for } 1-g \text{ SAR}$
