2 Labeling Information

Due to the small size of the device and restraints in the manufacturing process, the e-labeling method will be used for this device. The device is only able to be used in conjunction with a mobile device (i.e. smartphone or tablet) that can display the FCC information digitally.

Access to the required information on the e-label:

- 1. Users are able to access the information in no more than three steps in a device's menu. The actual steps are:
 - Tap the three bar menu in the top left
 - Tap "Support"
 - Tap "Legal and Regulatory"
- 2. The information is stored on the device, no special accessories or supplemental plug-ins are required to access the information. The information is secure and un-editable.

Yes, the data is stored on the device and is not able to be edited by the user.

3. Readability of Regulatory Information

The FCC regulatory information is formatted to be the same size font as all other information in the user application.

4. Packaging Labeling

The packaging for the device contains the printed FCCID of the device as well as instructions pointing to the e-labeling of the device for further information.

The cTag will be shipped in bulk packaging of 10 units each. Each shipping tray will contain reference to the FCCID.




Figure 1: Bulk Packaging configuration
