





### **Below 30MHz Test Setup**




### **Below 1000MHz Test Setup**

### 6.3 Test Procedure

#### ---Radiated measurement

- The measuring distance of 3m shall be used for measurements at frequency up to 1GHz and above 1 GHz. The EUT was placed on a rotating 0.8m high above ground, the table was rotated 360 degrees to determine the position of the highest radiation.

- The initial step in collecting conducted emission data is a spectrum analyzer peak detector mode pre-scanning the measurement frequency range. Significant peaks are then marked and then Quasi Peak detector mode re-measured.
- If the Peak Mode measured value compliance with and lower than Quasi Peak Mode Limit Below 1 GHz, the EUT shall be deemed to meet QP Limits and then no additional QP Mode measurement performed. But the Peak Value and average value both need to comply with applicable limit above 1 GHz.
- Testing frequency range 30MHz-1GHz the measuring instrument use VBW=120 kHz with Quasi-peak detection. Testing frequency range 9KHz-150Hz the measuring instrument use VBW=200Hz with Quasi-peak detection. 





- h) The occupied bandwidth shall be reported by providing plot(s) of the measuring instrument display; the plot axes and the scale units per division shall be clearly labeled. Tabular data may be reported in addition to the plot(s).
