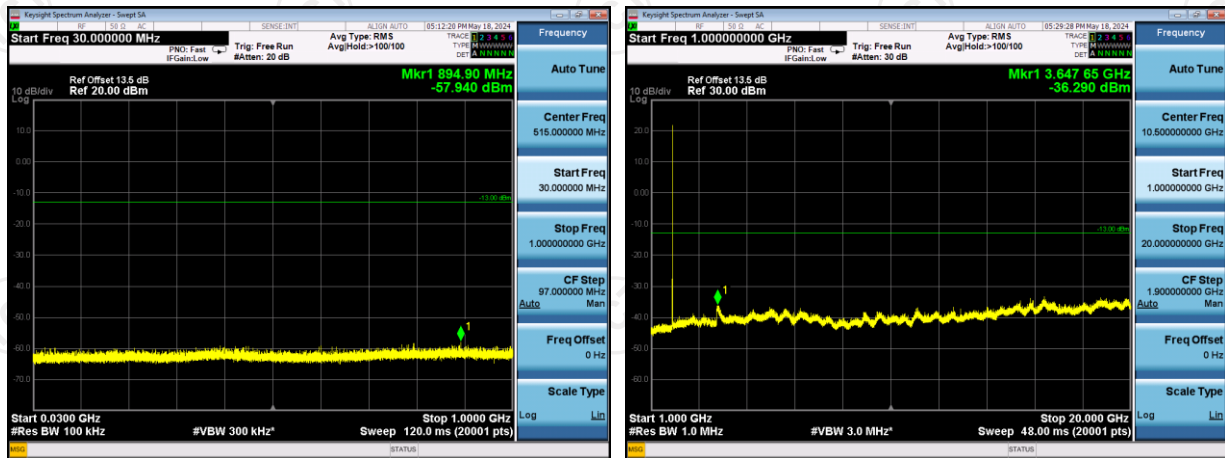
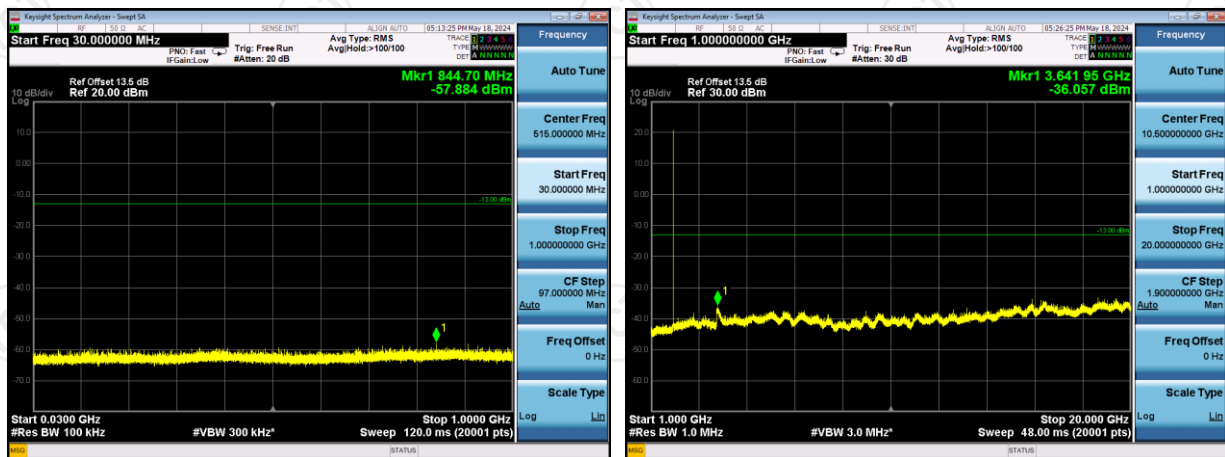

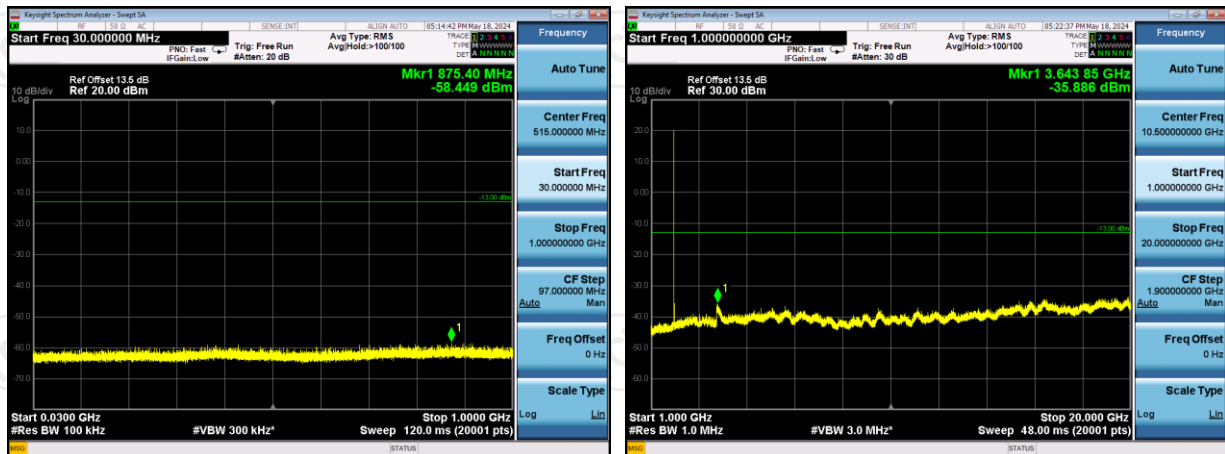
Conducted Spurious Emission on Channel 9262

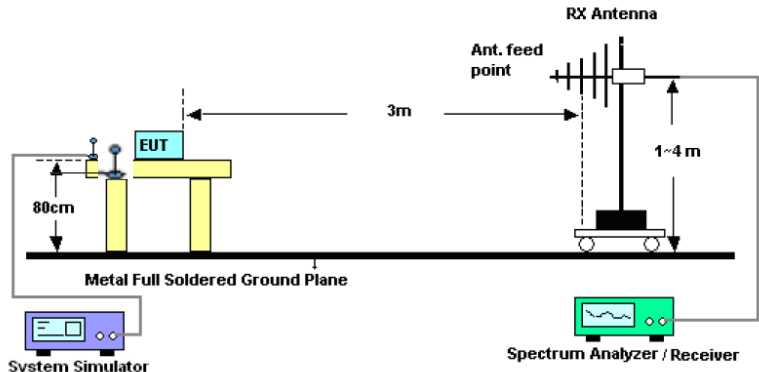
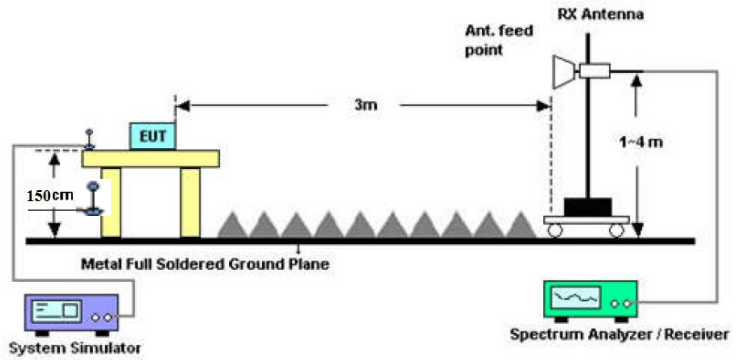

	2.2.17. - The EUT was placed on a non-conductive rotating platform 0.8 meters high in a semi-anechoic chamber. The radiated emission at the fundamental frequency was measured at 3 m with a test antenna and a spectrum analyzer with RMS detector per section 5. of KDB 971168 D01v03. - Key the transmitter, then rotate the EUT 360° azimuthally and record spectrum analyzer power level (LVL) measurements at angular increments that are sufficiently small to permit resolution of all peaks. 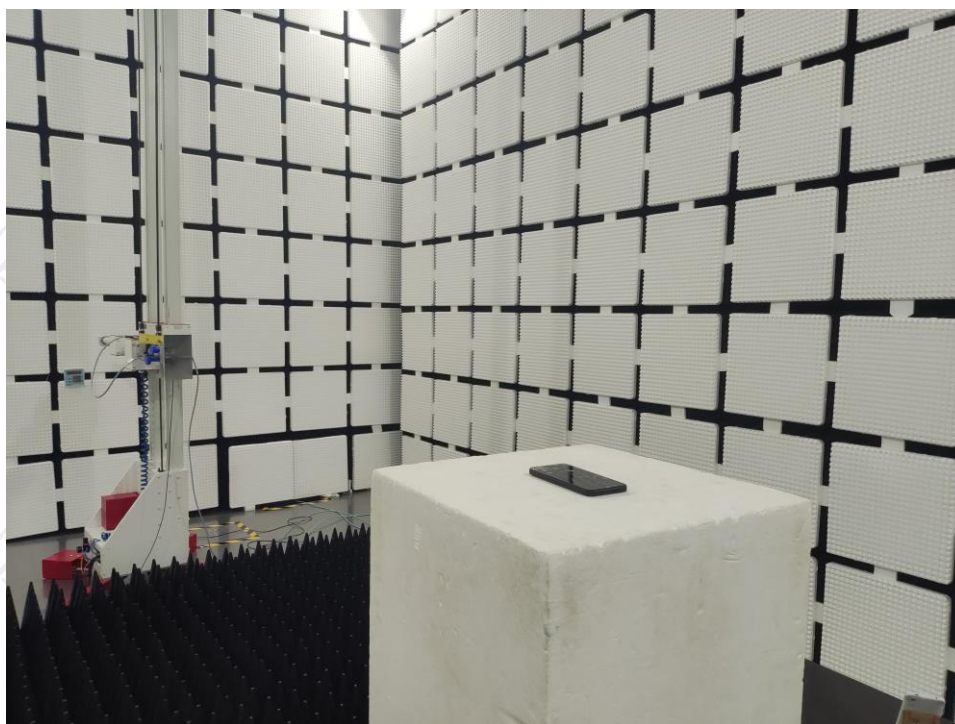
