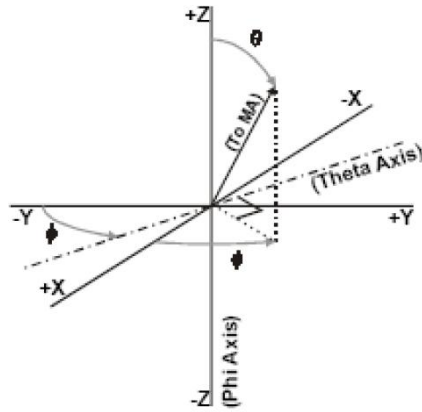
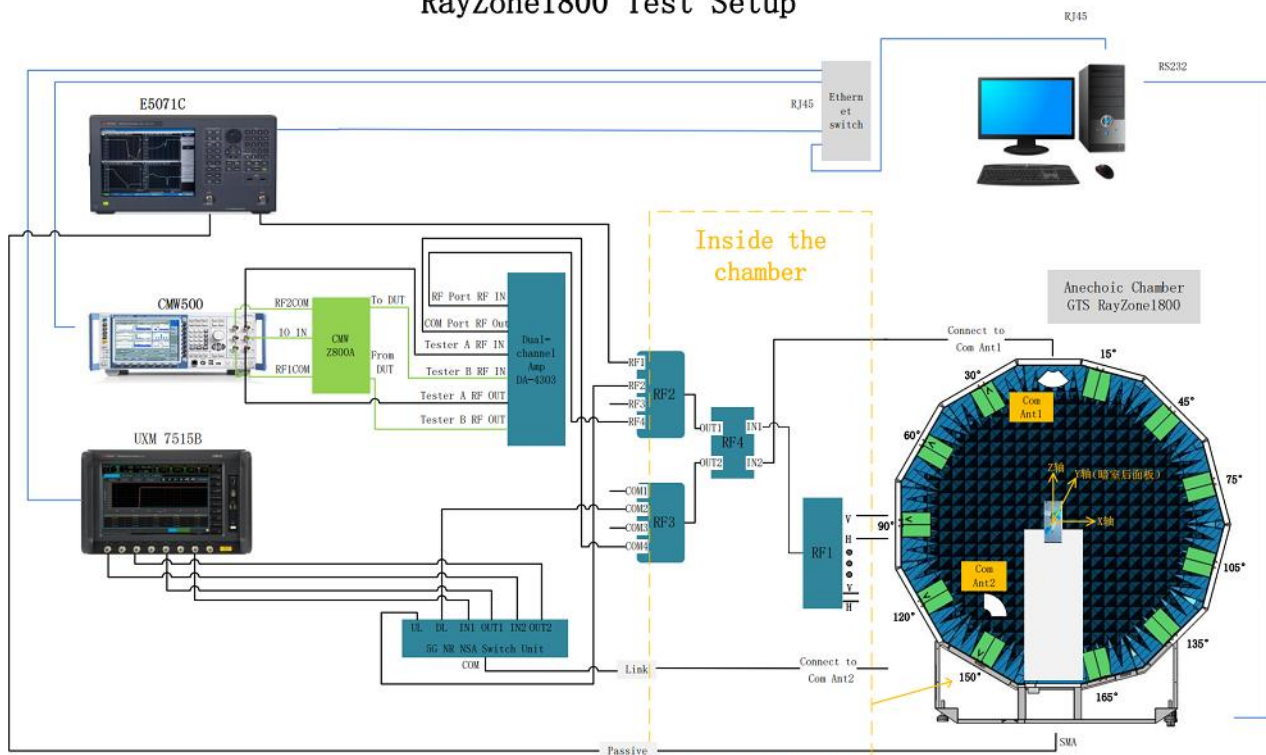


Figure 1 Test coordinate system

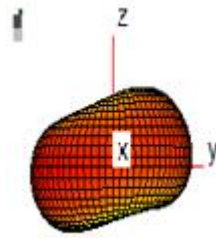

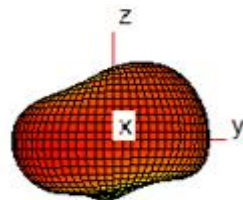

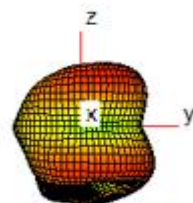

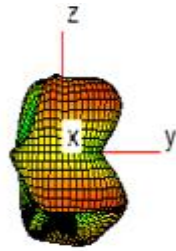

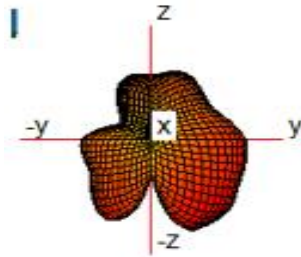

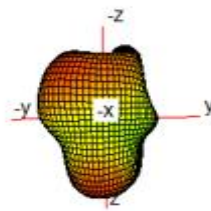
1800MHz



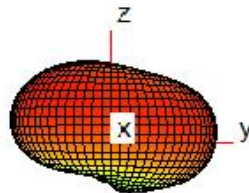

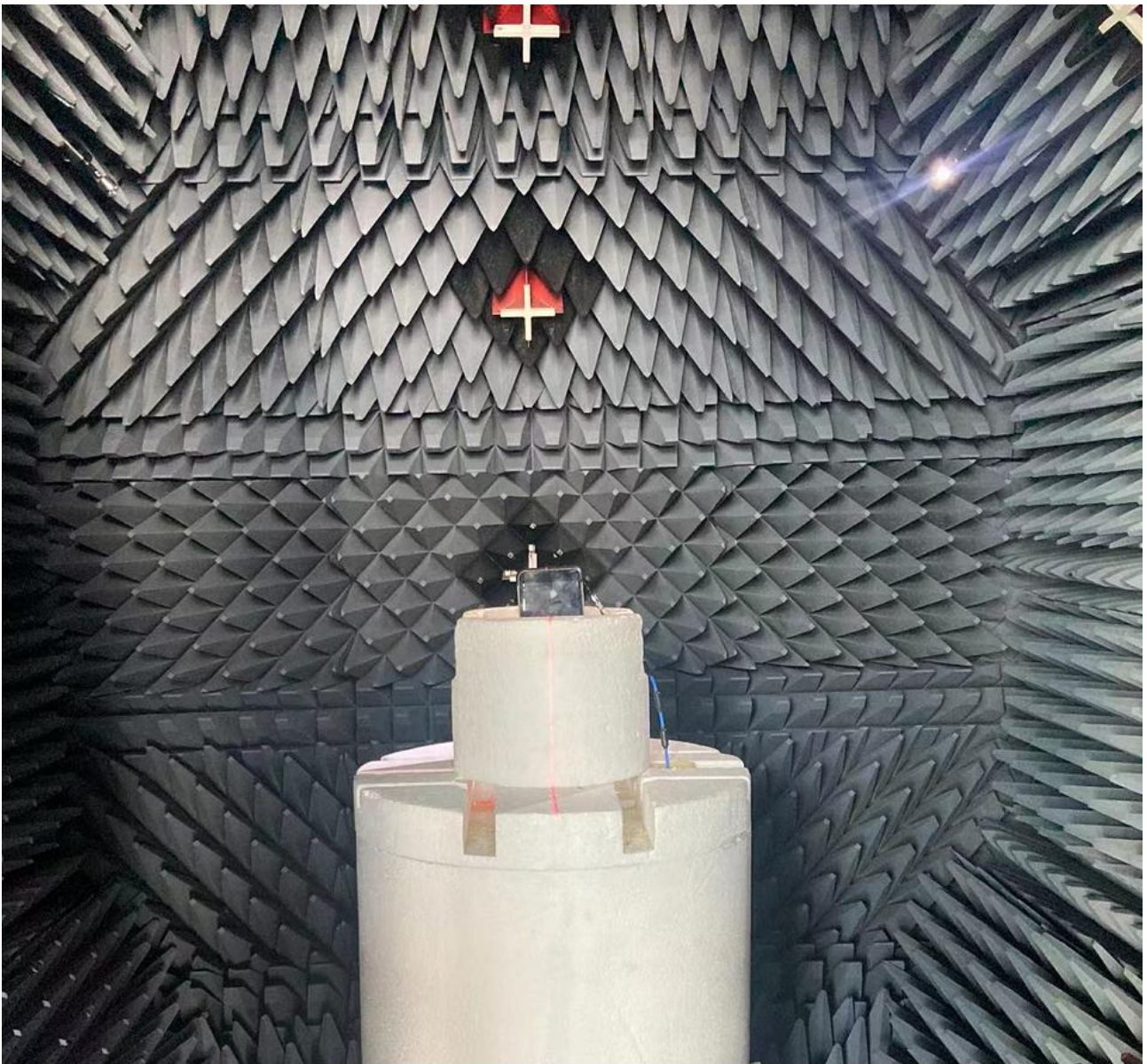
