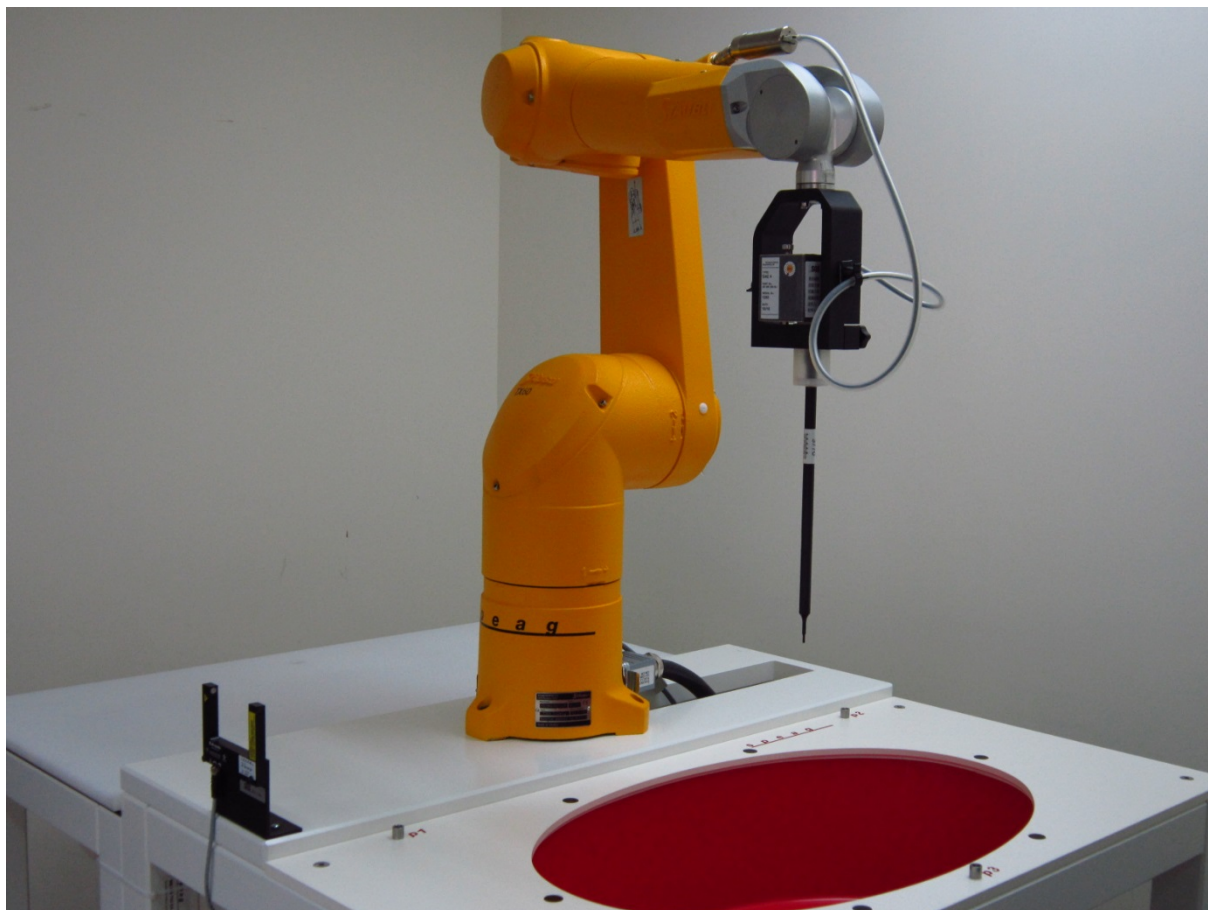

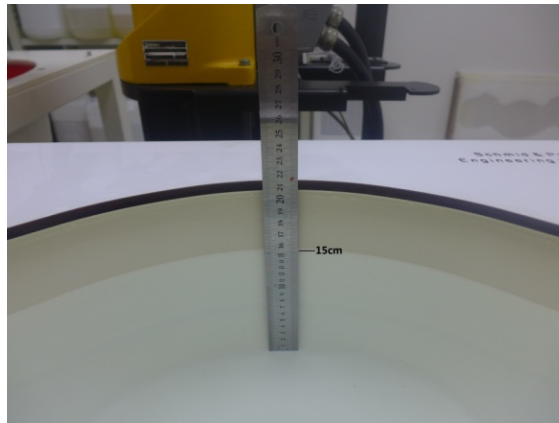

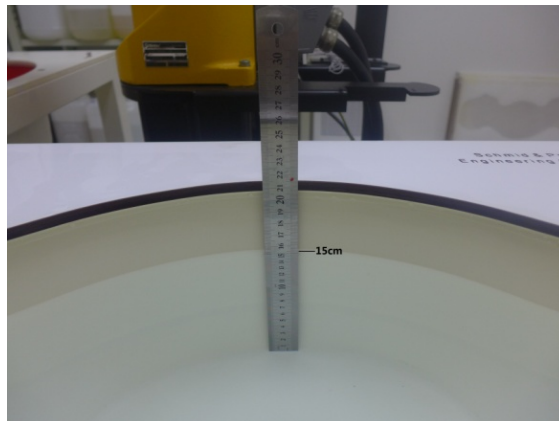

Tissue Simulant Liquid for Head 5GHz

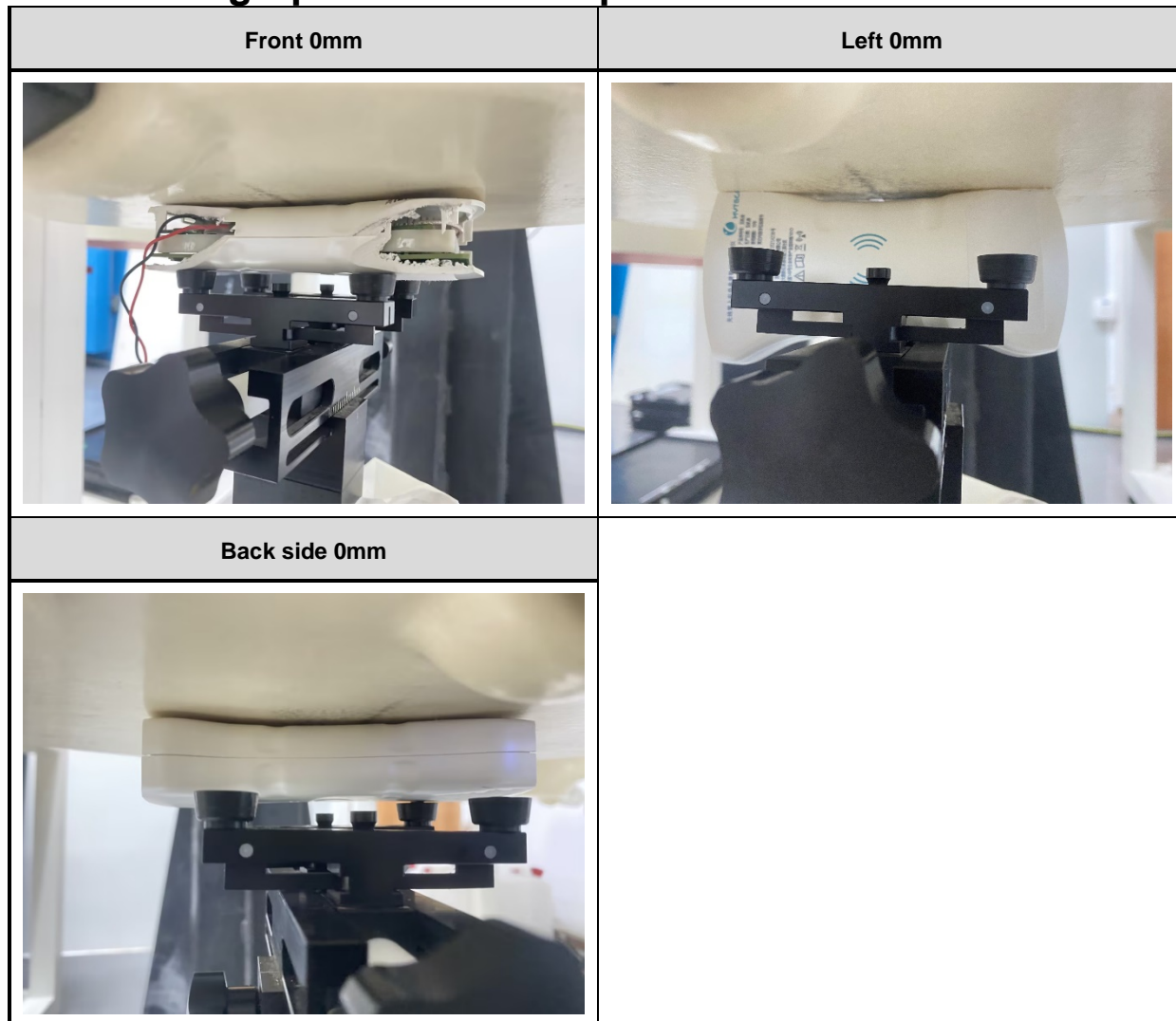

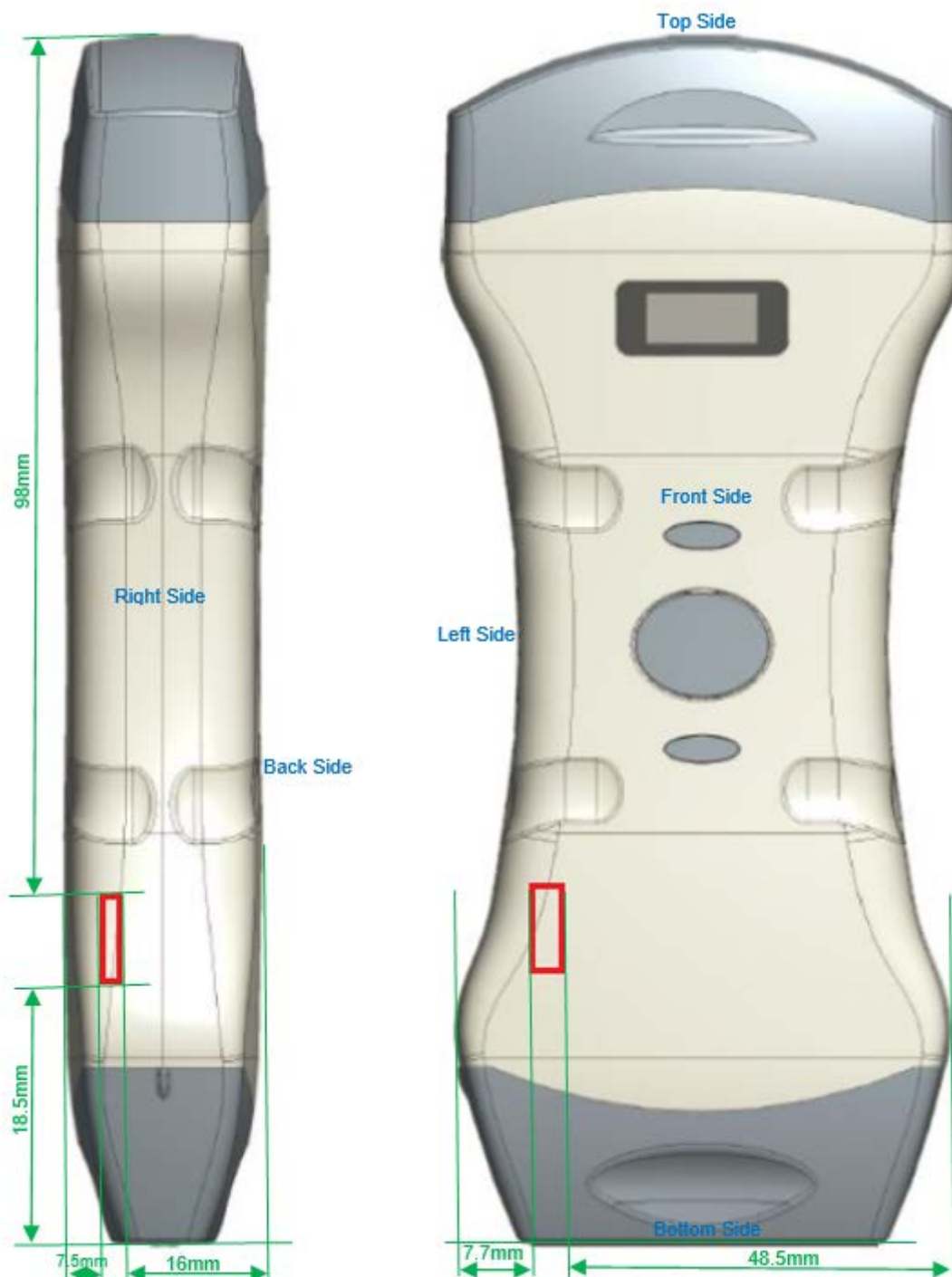
