



Tips

- 1. Except for the operation methods specifically marked in the manual, please do not try to disassemble or replace any parts in the earbuds.
- 2.Don't put the earbuds in the water or any others liquid. The earbuds are not waterproof.
- 3.If any liquid enters the product by accidentally, please disconnect and remove the connection immediately.
- 4. Please make sure that there is no water on your hands when Installing

- or uninstalling the product to avoid electricshock.
- 5.Do not put the product near by the heat source or expose it to the fire source directly.
- 6. Do not put the product in the environment with strong electromagnetic force, otherwise it will cause product malfunction.

Charging bin charging specifications

Reminder: When the battery level of the earphones is below 3.3V, a low battery reminder will be played. (Sound prompt "battery low"), the earphones sound a prompt sound once a minute and turn on a red light every five seconds. Please charge the earphones in a timely manner.





Product operation instructions

① Boot:

Method 1. Turn on the headphones and they will automatically turn on.

Method 2. Press and hold the left/right touch area for 3 seconds, and the blue light will turn on the headset for 1 second. (Voice prompt tone: "power on") (2) Shutdown:

Method 1. Put it back in the charging case, and the headset automatically shuts down and charges.

Product operation instructions

Method 2. The device is disconnected and automatically shuts down after 3 minutes. (Voice prompt tone: "power off")

③ BT pairing:

- 1.Take out the earphones from the charging case, and the left and right earphones automatically connect and enter the pairing state with the phone. (Audio notification tone: "pairing")
- 2. Turn on BT on the mobile phone, search the device name "TF-T15", and click to enter the connection. (Voice prompt tone: "connected")



Enter the device pairing state: The red and blue lights in the primary ear flash alternately, and the secondary ear turns off



LED indicator status

Power on	The blue light on the earphones stays on for 1 second
Power Off	The red light on the earphones lights up three times
TWS pairing status	The red and blue lights on left/right earphones flash alternately
The device pairing status is displayed	The red and blue lights in the primary ear flash alternately, and the secondary ear turns off

Low battery	It beeps once a minute and blinks red every five seconds
Earphone charging	The headset's red light keeps on

factory data reset	The red light on the earphones flashes three times and goes out

Touch operation



Voice Assistant: Press and hold the touch area of the left headset for 2 seconds to start

Volume Increase: Click on the right earphone touch area

Volume minus: Click on the left earphone touch area





Play/Pause: Double click on any earphone touch area

Previous: Three hits left earphone touch area
 Next: Three hits right earphone touch area

Call mode



 Answer/hang up a call: Double click on any earphone touch area

Reject incoming calls: Press and hold any earphone touch area for 2 seconds

Game/ Music mode switch



Music Mode: Press and hold the right earphone touch area for 2 seconds (Voice prompt tone "music mode")

Game mode: Press and hold the right earphone touch area for 2 seconds (Voice prompt tone "game mode")

Restore factory settings

When the earphone is connected to the BT device, tap the left/right earphone five times. After hearing the tone, click within 35 press and hold the headset 10S to clear the pairing information between the headset and the BT device, and then "power off")
