



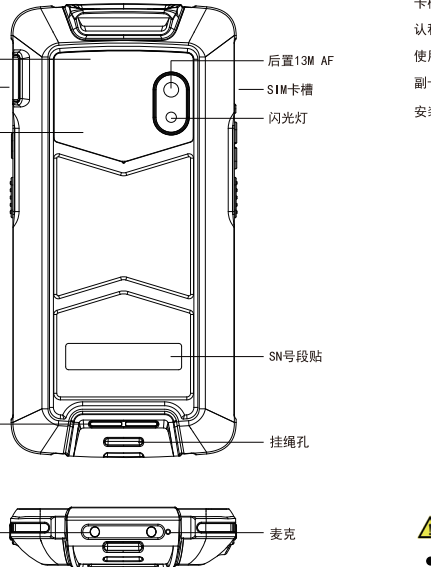
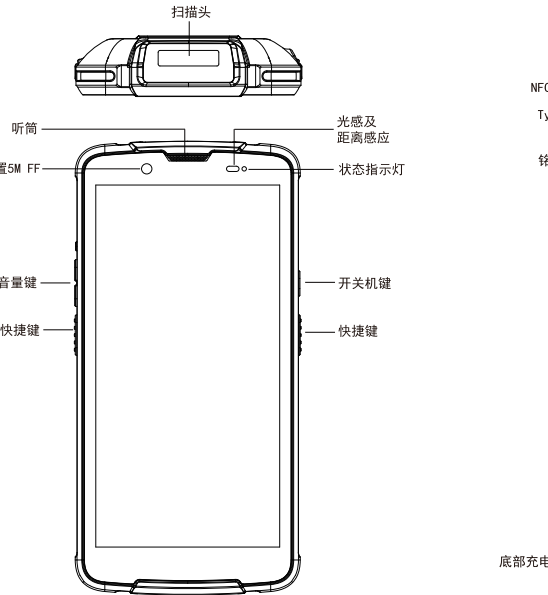

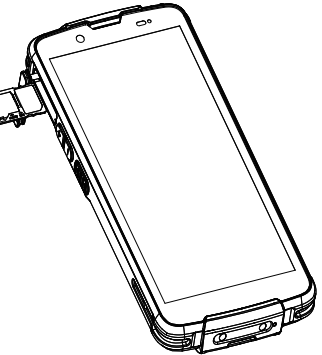

产品外观



安装SIM卡和SD卡

插卡时请注意卡片缺口方向，插入非标准卡片可能会导致设备SIM卡座的损坏。
卡槽1、2可以任意切换为默认移动数据卡；如果两张都是电信卡，副卡（非默认移动数据卡）必须开通电信VoLTE业务，才能同时使用电信双卡；4G网络使用，需要根据运营商网络和相关业务部署情况确定是否支持；电信双卡时，副卡（非默认移动数据卡）不支持电信2G。
安装SIM卡和SD卡时需要打开塞子，使用卡针取出卡托。



安全警告

- 使用卡针时，请注意安全，防止戳伤手指或损伤设备；
- 请保管好取卡针，将其放置在儿童接触不到的地方，防止儿童无意吞食或戳伤。

重新启动设备

按住开机键2秒，点击重新启动。

强制重新启动设备

按住开机键8秒，可强制重新启动设备。

为电池充电

首次使用本产品之前，建议为电池充电。

△注意：充电器应保持紧贴电源插座并易于拔插。

使用扫描功能

进入“设置>扫描”设置菜单，启动扫描，进行扫描功能设置。

小心激光

扫描引擎带有二类激光，在使用过程中请避免直接照射人眼，避免持续凝视激光，以免对人眼造成不可逆伤害。

注意事项

设备应当在-20℃~55℃的环境中使用，储藏温度应介于-30℃~70℃之间。温度过高或过低将会影响设备的性能，甚至造成设备和电池的损坏。
请在5℃~35℃的环境中为设备充电，以免造成电池性能下降、待机时间减少。自行刷新非官方的ROM系统或者破解修改设备的系统文件，将会导致系统出现安全风险，思必拓将不会对此类风险承担责任。

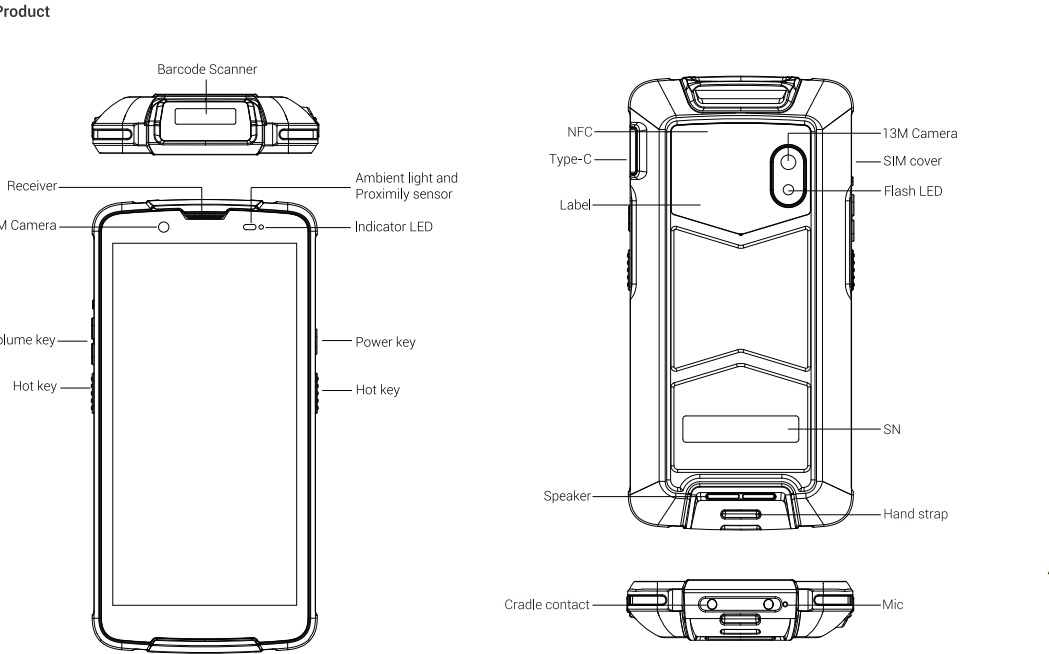

Installation of SIM card and SD Card

Please pay attention to the direction of slot when inserting the card.

Inserting a non-standard card may cause damage to the SIM card holder of the device.

Open the SIM/ SD plug first and take out the card tray with the PIN, then you can insert the SIM and SD card.

Restart Device

Holding power button 2 seconds, choose restart.

Force Device Restart

Holding power button over 8 seconds.

Barcode scanner

Go into "Settings>Scan", enable barcode scanner and configure other settings of barcode scanner.
