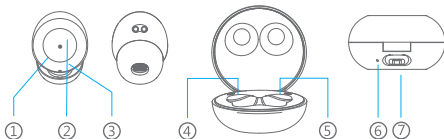

Using Your Earbuds

Turn On & Pairing






Please fully charge the product before initial use

Pairing



* Earbuds will turn on and enter pairing mode automatically when open the charging case for the first time use.

| Earbud Status Indicator | | Status |
|---|--------------------------|-----------------------|
|  | Flashing on both earbuds | Power on |
|  | Flashing on one earbud | Bluetooth Pair |
|  | Lights off | Connected to a device |

- 💡 Make sure the distance of the earbuds and your device is less than 1 meter / 3.3 feet at the first time of connection.
- 💡 When turned on, the earbuds will automatically connect to the last connected device if available. If not, the earbuds will enter pairing mode.
- 💡 Under any abnormal condition, return the earbuds to the charging case with the lid closed for 10s and then take out again.

Turn Off

- 💡 The earbuds will automatically turn off after 10 minutes if no device is connected.
- 💡 When the earbuds are in the charging case and the lid is closed, it will automatically turn off after being fully charged.

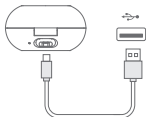


Charging The Earbuds

Earbuds will be charged automatically once they are returned to the charging case with the lid closed.

- 💡 When the battery is low, the earbuds have a voice prompt.
