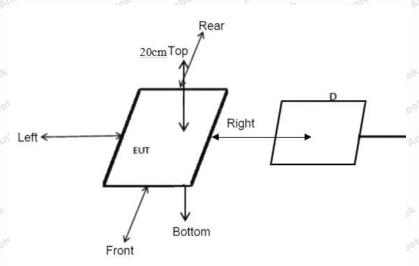

#### 2.3. Test Procedure

- 1) The RF exposure test was performed in anechoic chamber
- 2) The measurement probe was placed at required test distance which is between the edge of the charger and the geometric center of probe.
- The highest emission level was recorded and compared with limit as soon as measurement of each points

(A, B, C, D, E) were completed.(A is the right, B is the back, C is the left, D is the front, and E is the top.)

4) The EUT was measured according to the dictates of KDB 680106 D01 v04
