





Test plot of Maximum Peak Conducted Output Power:


Bluetooth Communication mode (BT DTS-GFSK, 2402MHz)


Bluetooth Communication mode (BT DTS-GFSK, 2440MHz)

For emission measurements at or below 1 GHz, the sample was placed 0.8m above the ground plane of semi-anechoic Chamber*. For emission measurements above 1 GHz, the sample was placed 1.5m above the ground plane of semi-anechoic Chamber*. Measurements in both horizontal and vertical polarities were performed. During the test, each emission was maximized by: having the EUT continuously working, investigated all operating modes, rotated about all 3 axis (X, Y & Z) and considered typical configuration to obtain worst position, manipulating interconnecting cables, rotating turntable, varying antenna height from 1m to 4m in both horizontal and vertical polarizations. CH 0 (2402.0 MHz)






Inner circuit top view
