3.MPE Calculation Method

Predication of MPE limit at a given distance

Equation from page 18 of OET Bulletin 65, Edition 97-01

$$S=PG/4\pi R^2$$

Where: S=power density

P=power input to antenna

G=power gain of the antenna in the direction of interest relative to an isotropic radiator

R=distance to the center of radiation of the antenna

5. Standalone MPE Result

As declared by the Applicant, the EUT is a wireless device used in a fix application, at least 20 cm from any body part of the user or nearby persons; from the maximum EUT RF output power, the minimum separation distance, $r = 20\text{cm}$, as well as the gain of the used antenna above article 4(antenna information), the RF power density can be obtained.

Conclusion: $\text{Sum} = 0.0150 + 0.0985 = 0.1135 < 1$, therefore the result is PASS.

2.4Gwifi Ratio = $\text{MPE} / \text{MPE Limit} = 0.0150 / 1 = 0.0150$;

LTE Ratio = $\text{MPE} / \text{MPE Limit} = 0.0459 / 0.4660 = 0.0985$ (the worstest case);

2. MPE evaluate distance is 20cm from user manual provide by manufacturer.

6. Conclusion

The measurement results comply with the FCC Limit per 47 CFR 2.1091 for the uncontrolled RF Exposure of mobile device.
