#### 4.2. Test mode

Remark: During the test, the dutycycle >98%, the test voltage was tuned from 85% to 115% of the nominal rated supply voltage, and found that the worst case was under the nominal rated supply condition. So the report just shows that condition's data.

We have verified the construction and function in typical operation. All the test modes were carried out with the EUT in transmitting operation, which was shown in this test report and defined as follows:

## 6.7. Antenna Requirement

#### Standard Applicable

#### For intentional device, according to FCC 47 CFR Section 15.203:

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator, the manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited

# FCC CFR Title 47 Part 15 Subpart C Section 15.247(c) (1) (I):

(i) Systems operating in the 2400-2483.5 MHz band that is used exclusively for fixed. Point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi provided the maximum conducted output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6dBi.

#### **Antenna Connected Construction**

The maximum gain of antenna was 3.57 dBi.
