

#### 2.3. Test Procedure

- 1) The RF exposure test was performed in anechoic chamber.
- 2) The measurement probe was placed at required test distance which is between the edge of the charger and the geometric center of probe.
- 3) The highest emission level was recorded and compared with limit as soon as measurement of each points
- (A, B, C, D, E) were completed.(A is the right, B is the back, C is the left, D is the front, and E is the top.)
- 4) The EUT was measured according to the dictates of KDB 680106 D01 v04

Remark; The EUT's test position A, B, C, D and E is valid for the E and H field measurements

#### 2.4. Test Result

- 2.4.1. Equipment Approval Considerations item 5.b of KDB 680106 D01 v04.
- (1) The power transfer frequency is below 1 MHz.
- The device operate in the frequency range 111-205KHz.
- (2) The output power from each transmitting element (e.g., coil) is less than or equal to 15 watts.
  - The maximum output power of the primary coil is 10W.
- (3) A client device providing the maximum permitted load is placed in physical contact with the transmitter (i.e., the surfaces of the transmitter and client device enclosures need to be in physical contact)
- The surfaces of the transmitter and client device enclosures is in physical contact.
- (4) Only § 2.1091-Mobile exposure conditions apply (i.e., this provision does not cover § 2.1093-Portable exposure conditions).
  - The EUT is a Mobile exposure conditions
- (5) The E-field and H-field strengths, at and beyond 20 cm surrounding the device surface, are demonstrated to be less than 50% of the applicable MPE limit, per KDB 447498, Table 1. These measurements shall be taken along the principal axes of the device, with one axis oriented along the direction of the estimated maximum field strength, and for three points per axis or until a 1/d (inverse distance from the emitter structure) field strength decay is observed.
