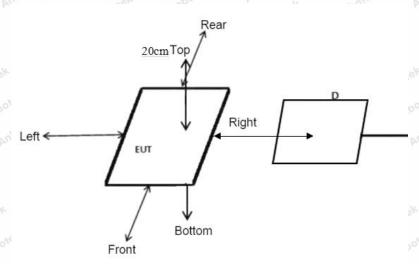

#### 2.3. Test Procedure

- The RF exposure test was performed in anechoic chamber.
- 2) The measurement probe was placed at required test distance which is between the edge of the charger and the geometric center of probe.
- 3) The highest emission level was recorded and compared with limit as soon as measurement of each points

(A, B, C, D, E) were completed.(A is the right, B is the back, C is the left, D is the front, and E is the top.)

4) The EUT was measured according to the dictates of KDB 680106 D01 v04

Remark; The EUT's test position A, B, C, D and E is valid for the E and H field measurements

These measurements shall be taken along the principal axes of the device, with one axis oriented along the direction of the estimated maximum field strength, and for three points per axis or until a 1/d (inverse distance from the emitter structure) field strength decay is observed. Symmetry considerations may be used for test reduction purposes.
