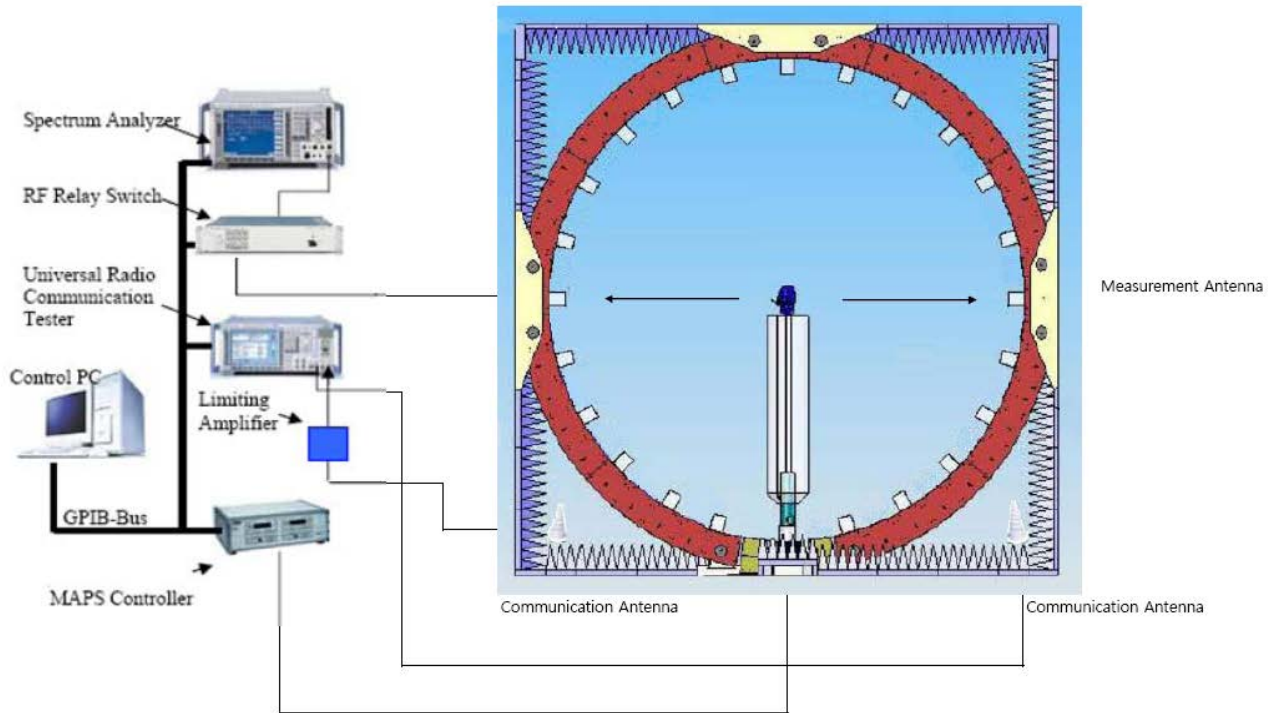

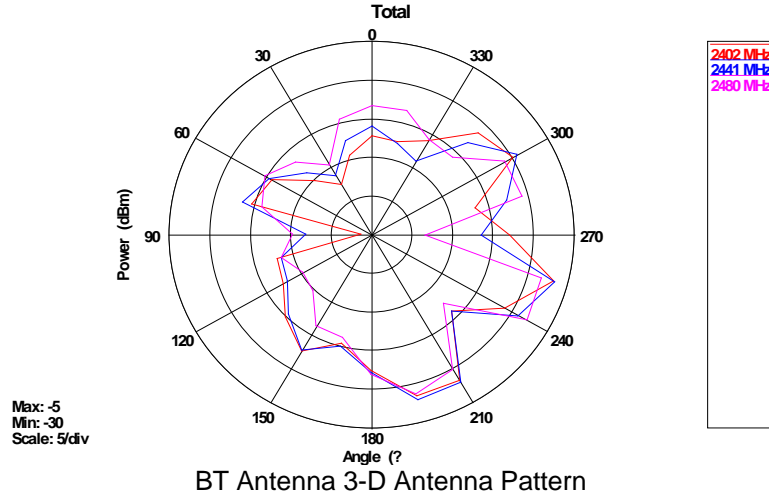

10 3-D Antenna Pattern



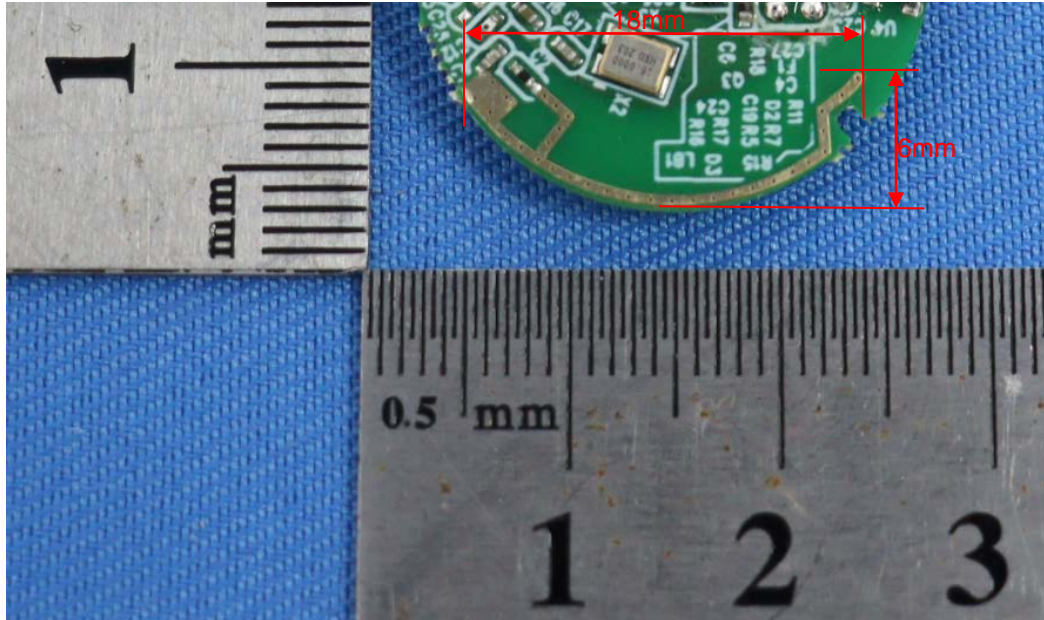
