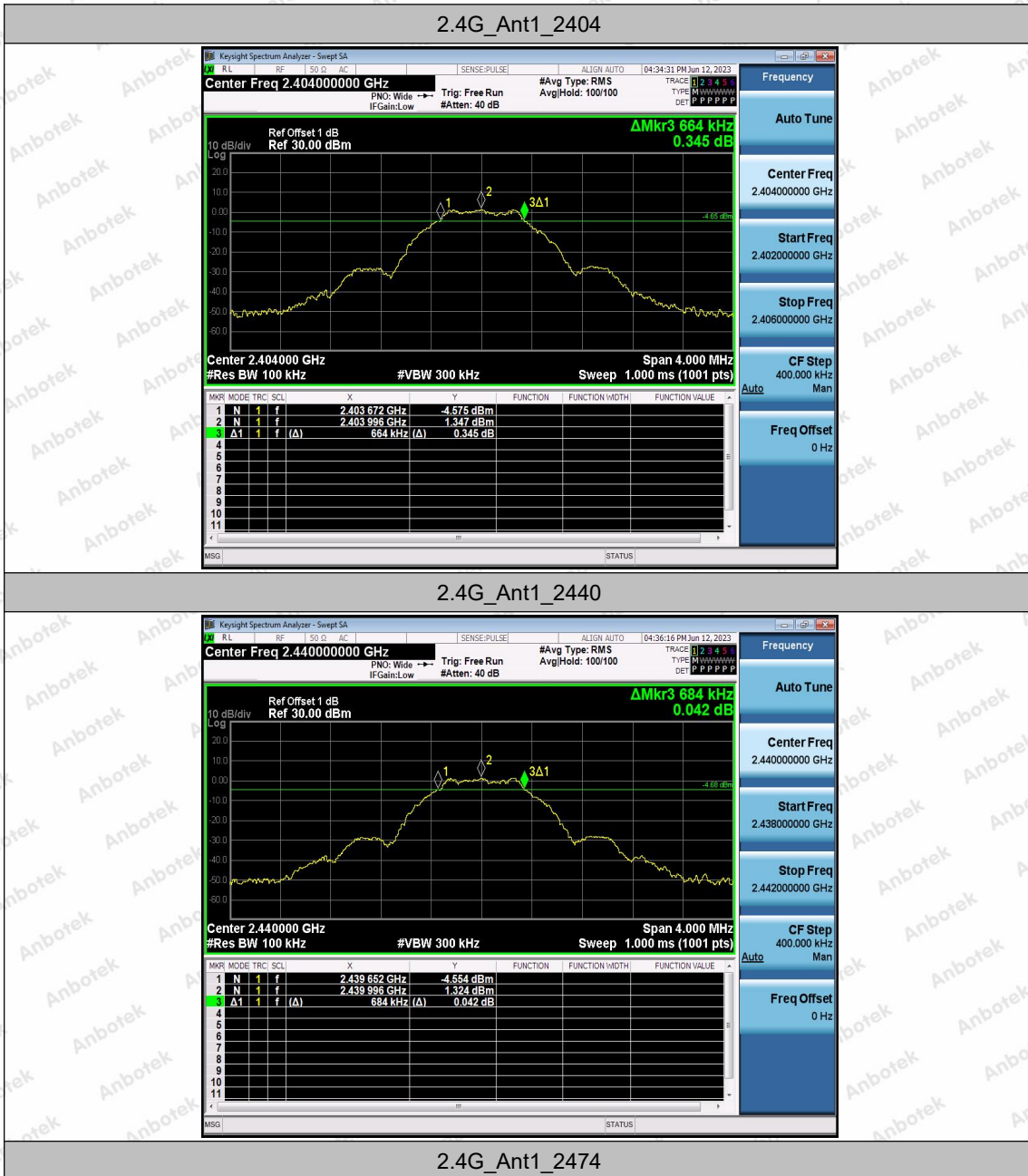

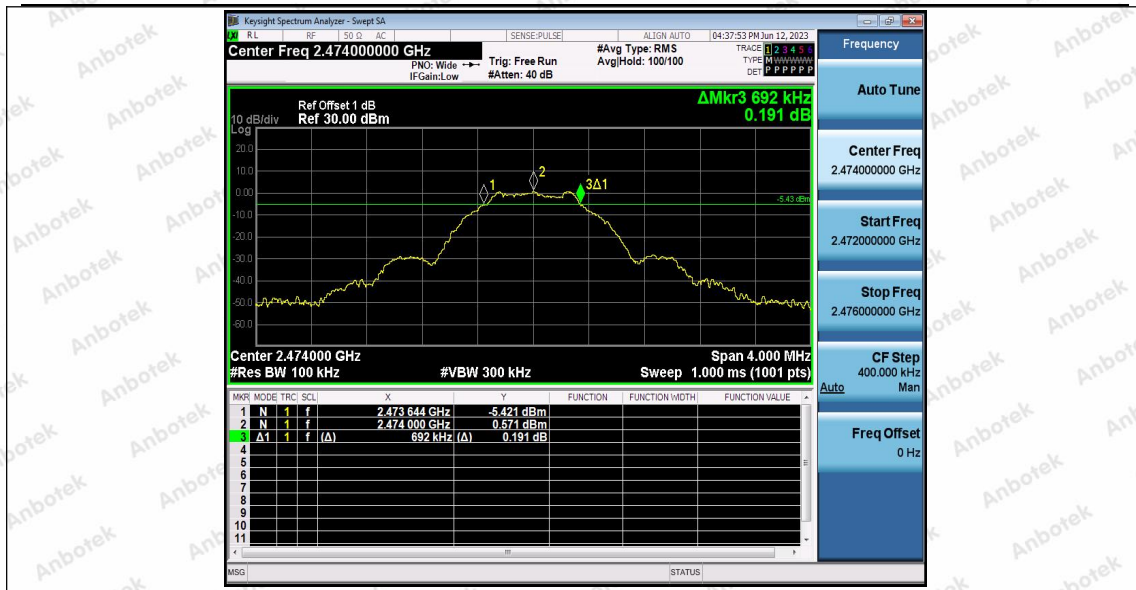

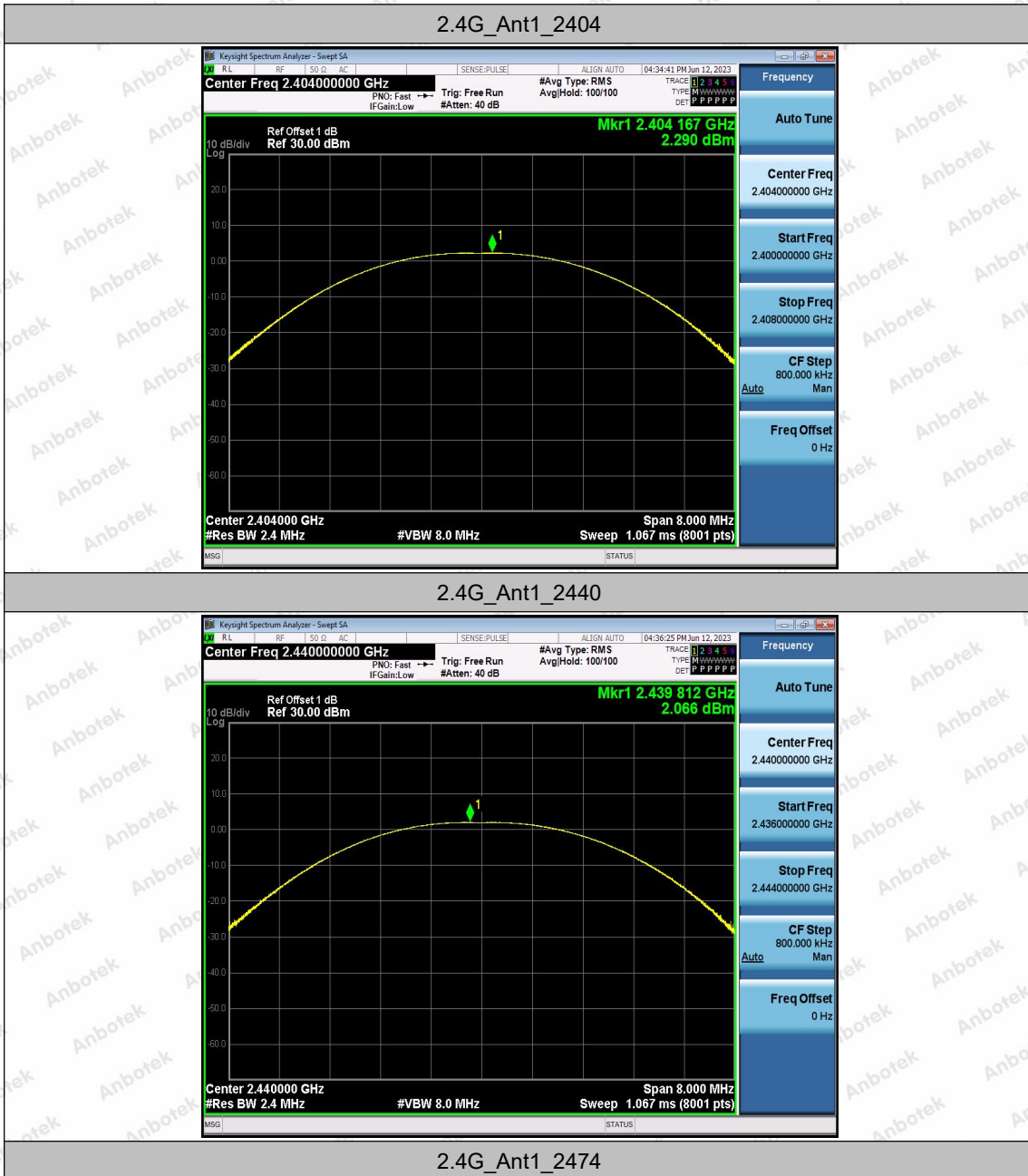

Test Graphs Peak

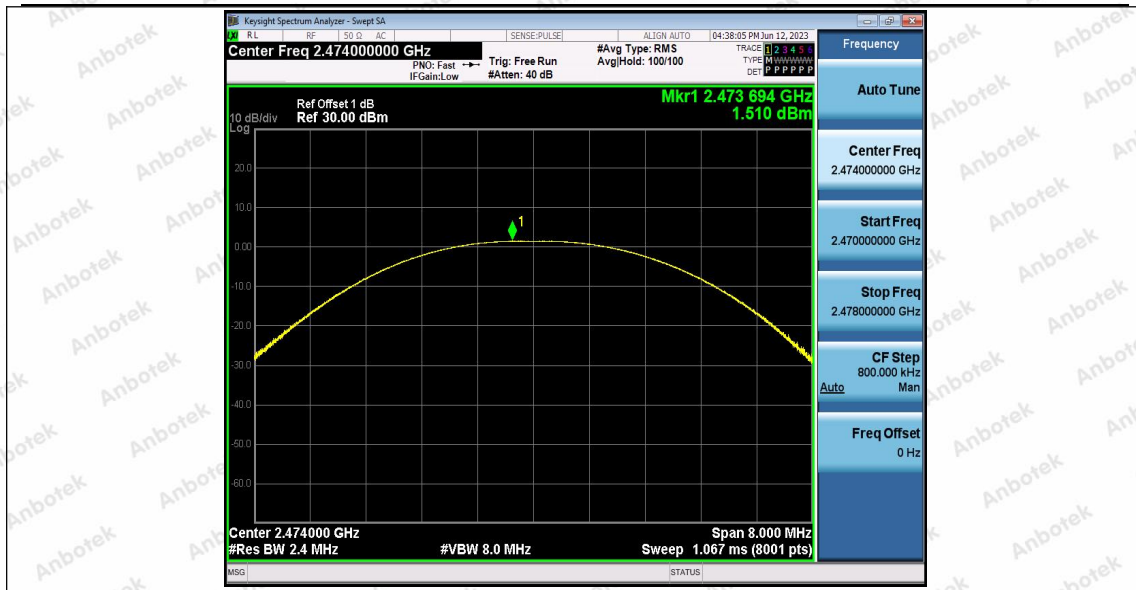

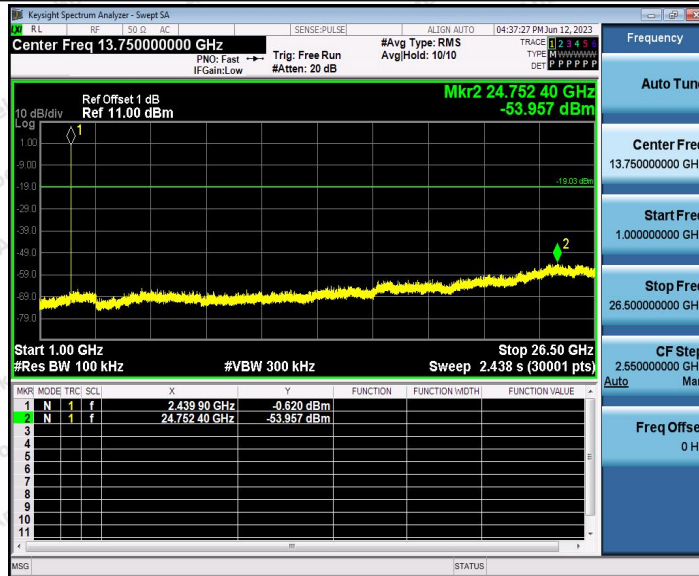
