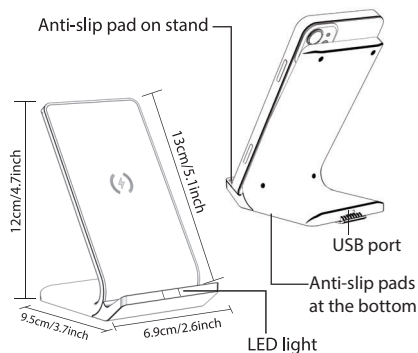

1. Holder Stand Charger

- Charge your phone vertically.
