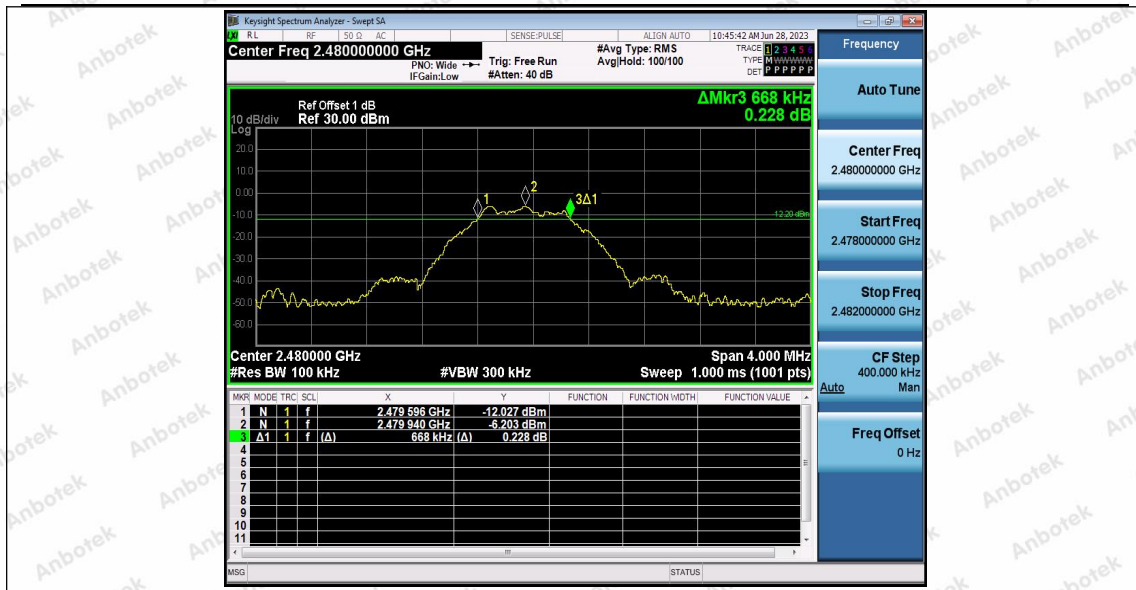

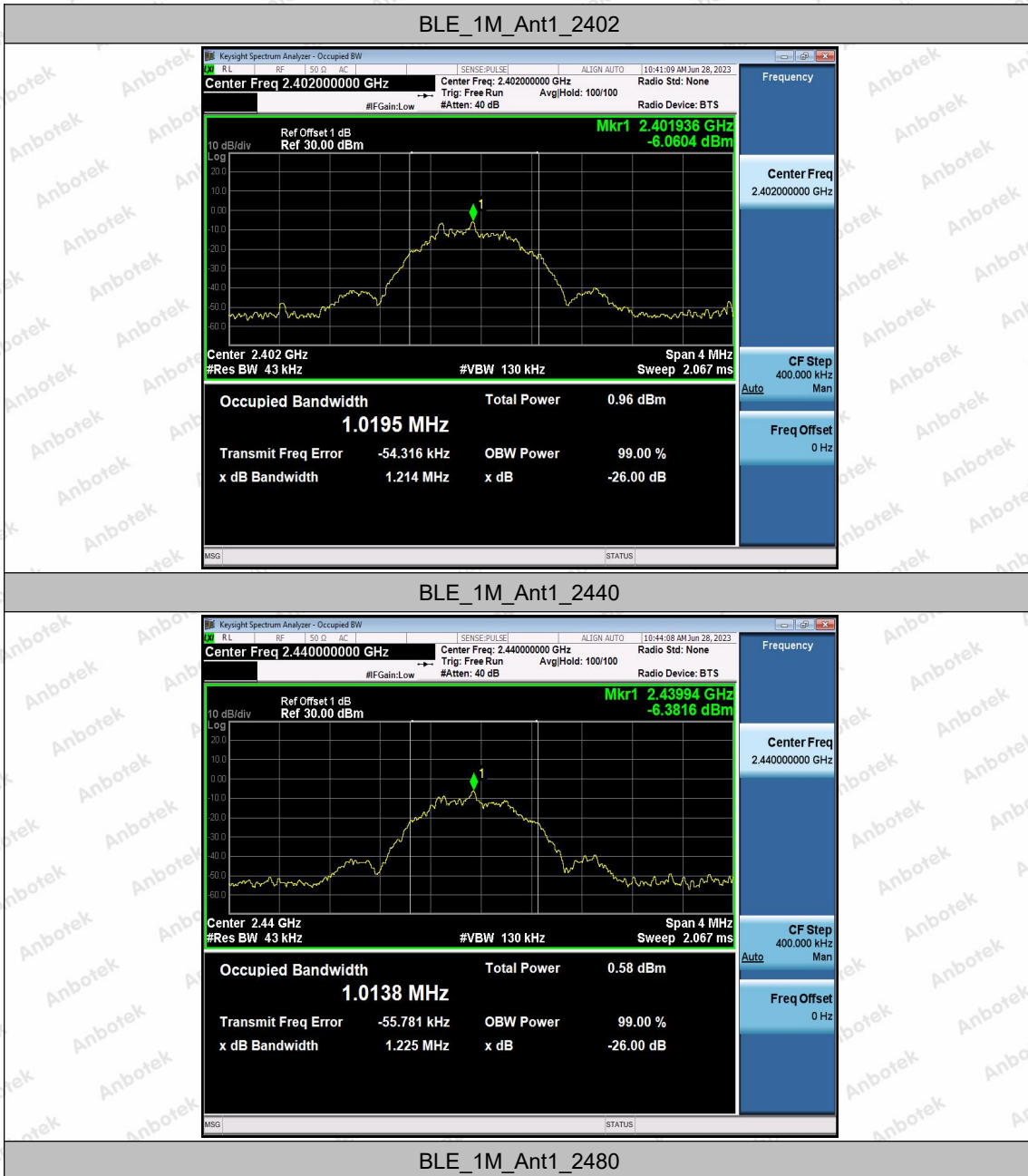

Test Graphs Peak

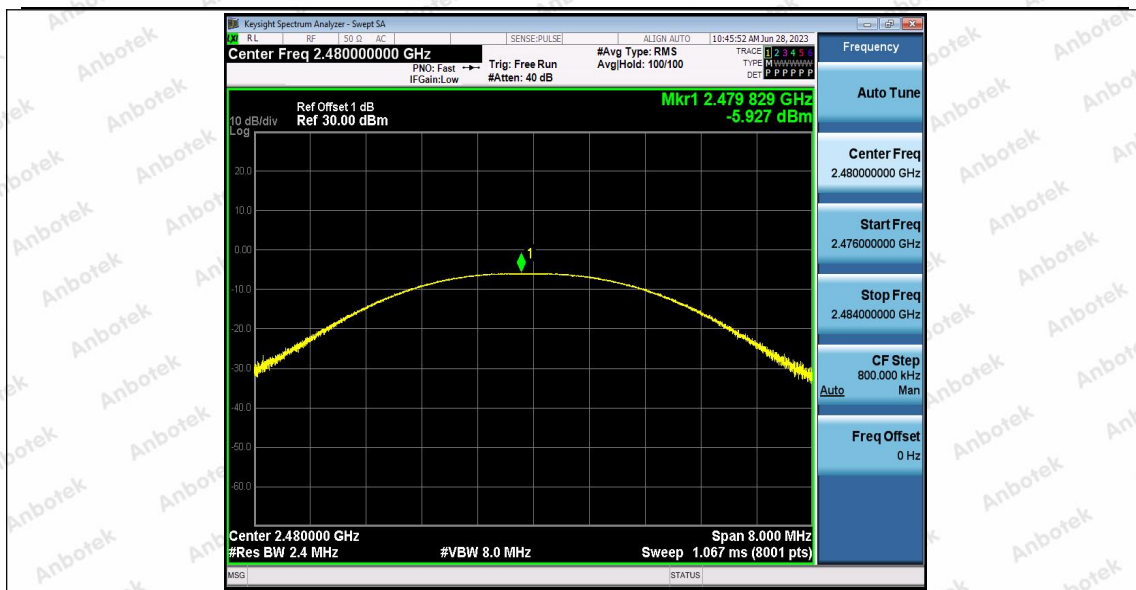
