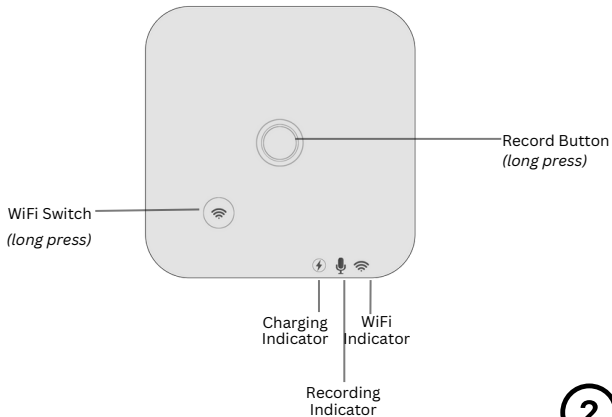

# Start Recording

Press and hold the **Record Button** for 2 seconds

Attach the device to the back of your phone and it will record both parties when you make a call (note: it can record for all apps that can make calls).

Press and hold the **Record Button** again to save the recording and the device will power off.

## Download App

- Scan the right QR code and follow the instructions to download the app.

- *iPhone users can search for “**FoCase Rec**” directly in Apple Store to download.*
- Open the app and follow the page instructions.


## Connect to device WiFi

Press and hold the WiFi Switch on the device, then turn on your phone's WiFi, find a WiFi named “**FOCASE\_xxxx**”, and connect to it.

## Set password

To access recordings, you need a password. ***The default is 888888.*** please change it in settings. If you forget, click “**Restore Factory Setting**” in settings to restore default. All recordings in device will be deleted. Files saved to phone will not be deleted.

## Store Recordings(2 methods)

**Method 1:** In the "in device" section, click  , and the files will be saved to “in phone”;



**Method 2:** On PC, connect to the device's WiFi, named FOCASE\_xxxx.

and download the [focase\\_app.exe](#) tool. You can transfer the recordings from the device to PC using this tool.

## Share Recordings

Swipe left on some recording file, you can see the share and delete icons, click "share" for sharing

***Press and hold the WiFi button again to power off.***

### Note:

1. During connection, if "Can't connect to internet... Switch networks?" appears, please select "No Thanks". (***For Android users***)
2. During downloading recording files, please ensure that your phone is always connected to "***FOCASE\_xxxx***" WiFi. If disconnected from "***FOCASE\_xxxx***" WiFi, you need to reconnect it.



# Important Tips!



If your phone does not support "Magnetic", you can attach our magnetic sheet to the back of your phone or phone case and then attach the device to it.



This ring helps attach the recording device



The device provides its own WiFi, so you don't need to rely on your home WiFi. Additionally, WiFi is only used for transmitting recording files and is not necessary during the actual recording process.



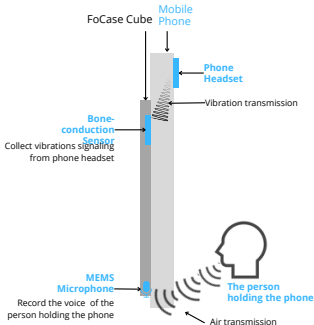
Please ***do not utilize Bluetooth headphones*** to receive calls when recording, or you will not be able to capture the voice of the other party.



When recording, please turn your earphone volume to ***more than 70%***, the higher the earphone volume, the higher the recording quality



# How Recording Works



The device utilizes a dual input method featuring **bone conduction sensor and MEMS microphones**. The MEMS microphones record the voice of the person holding the phone

Bone conduction sensor converts the vibrations from your phone's headset sound into electrical signals. The controller then picks up and stores these signals.
