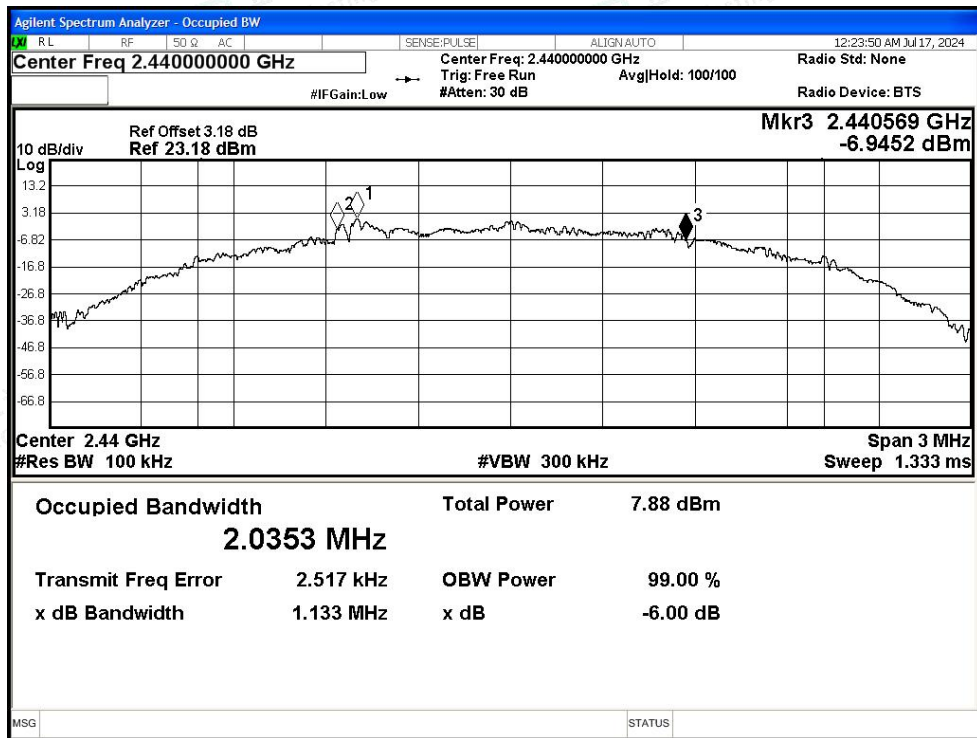

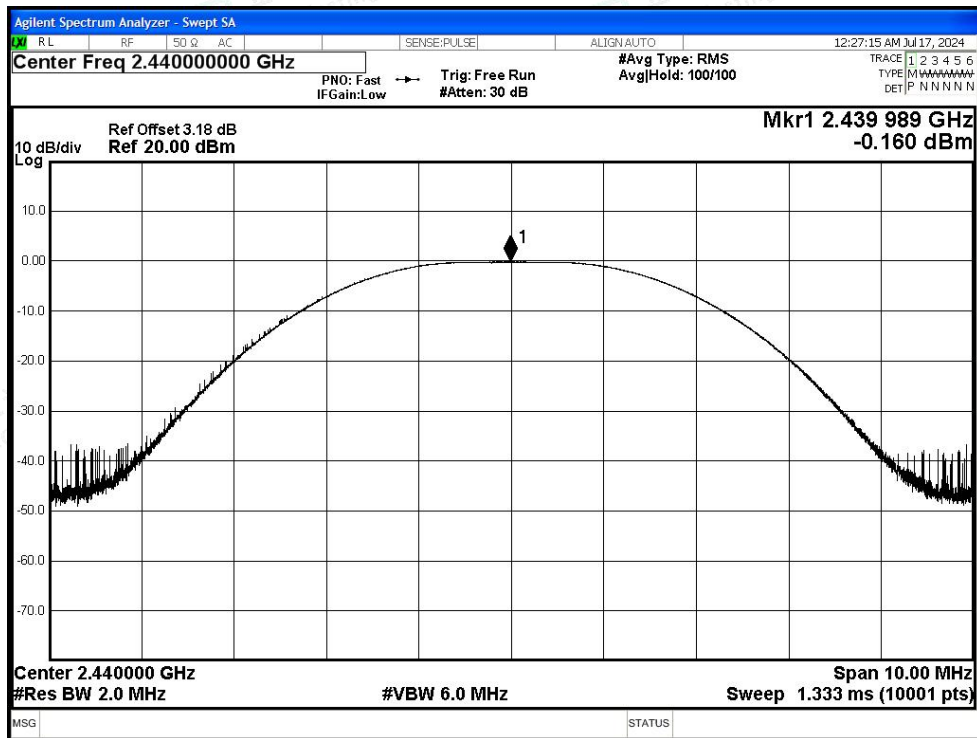

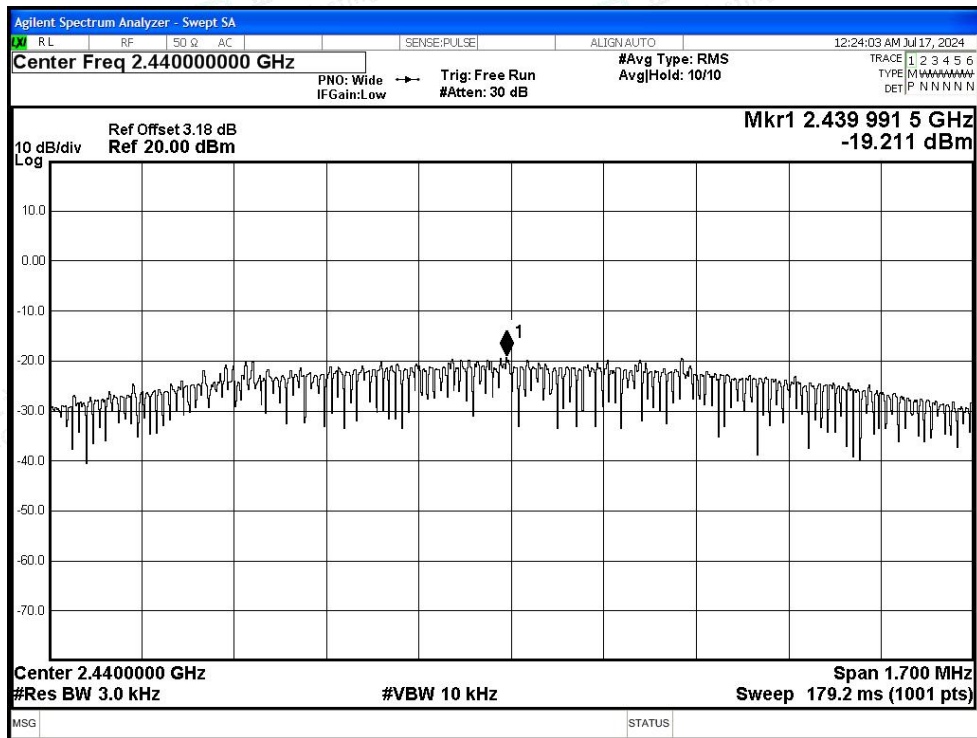

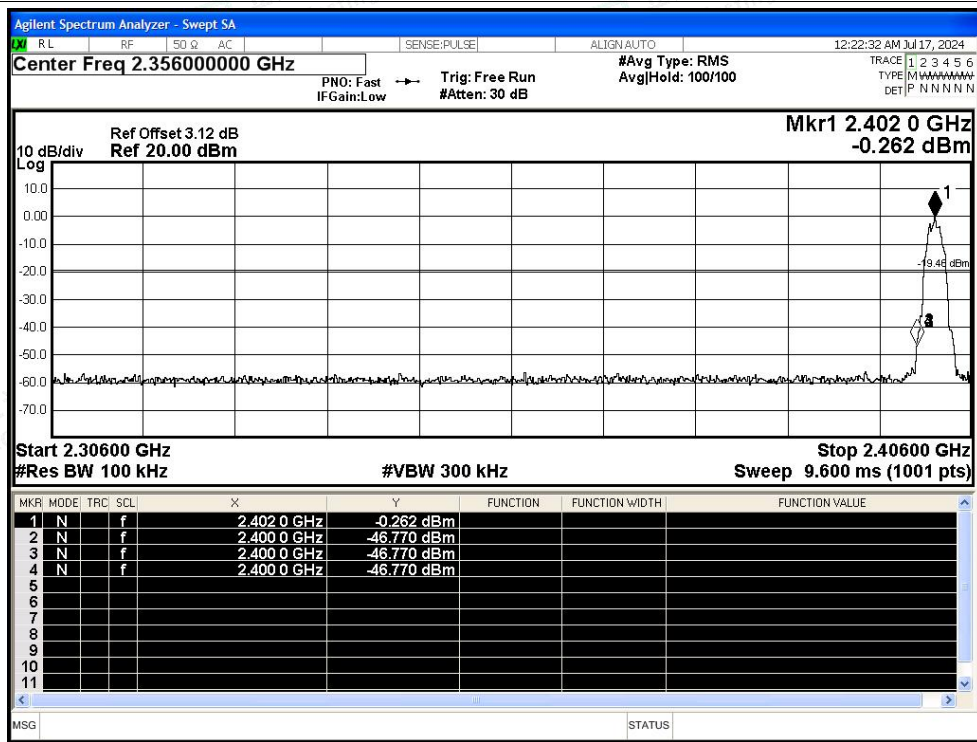

Band Edge NVNT BLE 2M 2402MHz Ant1 Ref

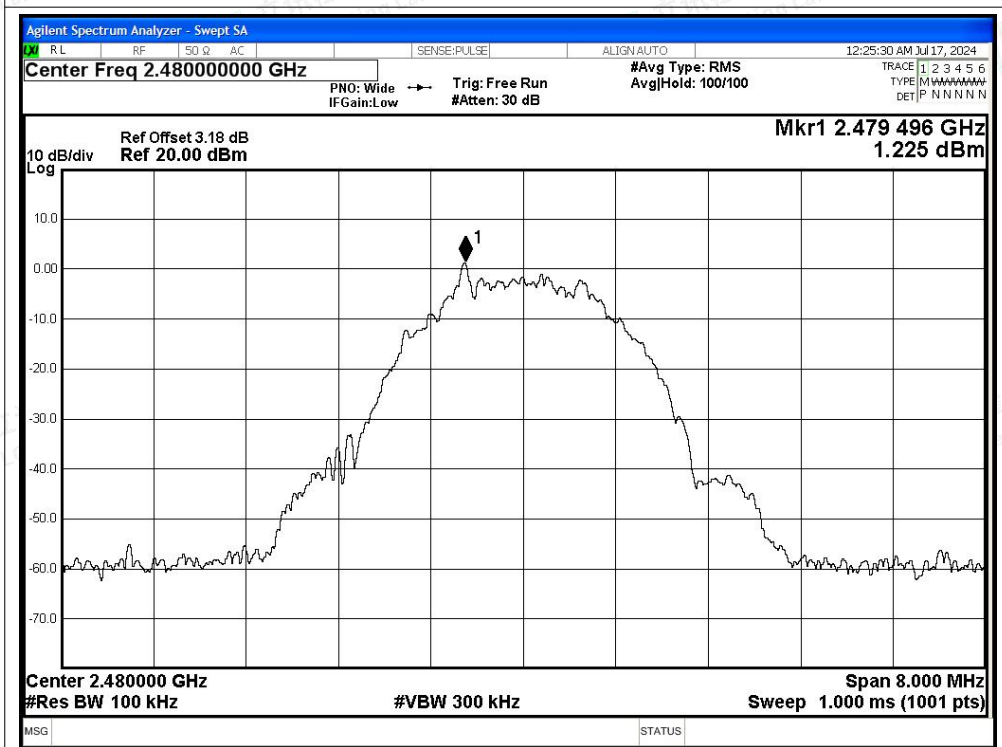


Band Edge NVNT BLE 2M 2402MHz Ant1 Emission

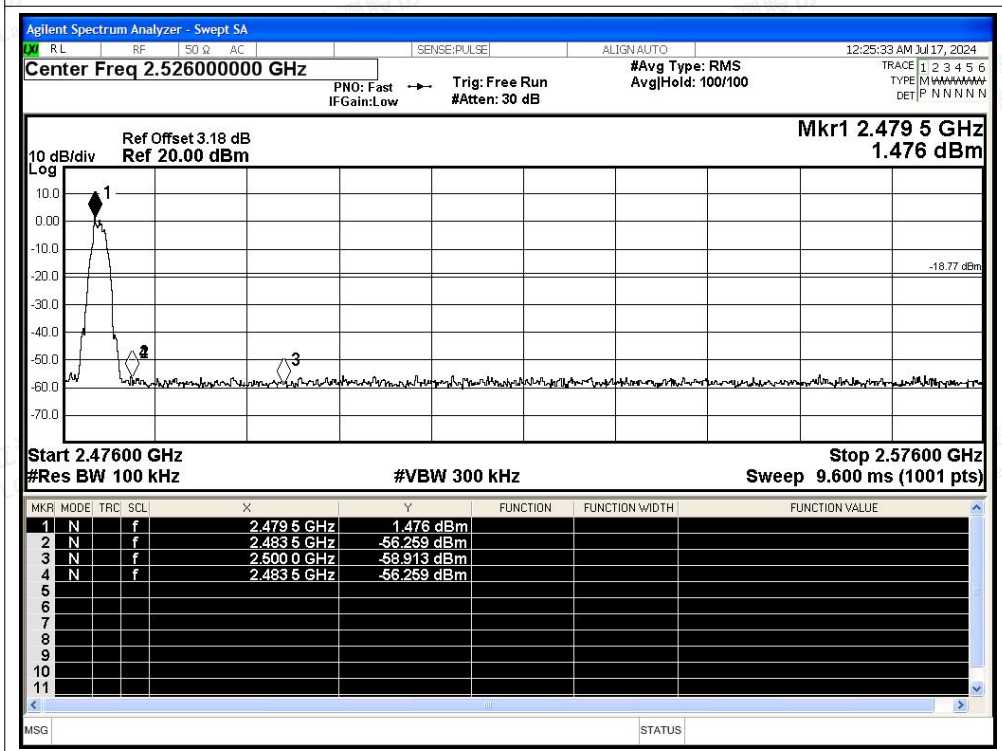




Band Edge NVNT BLE 2M 2480MHz Ant1 Ref

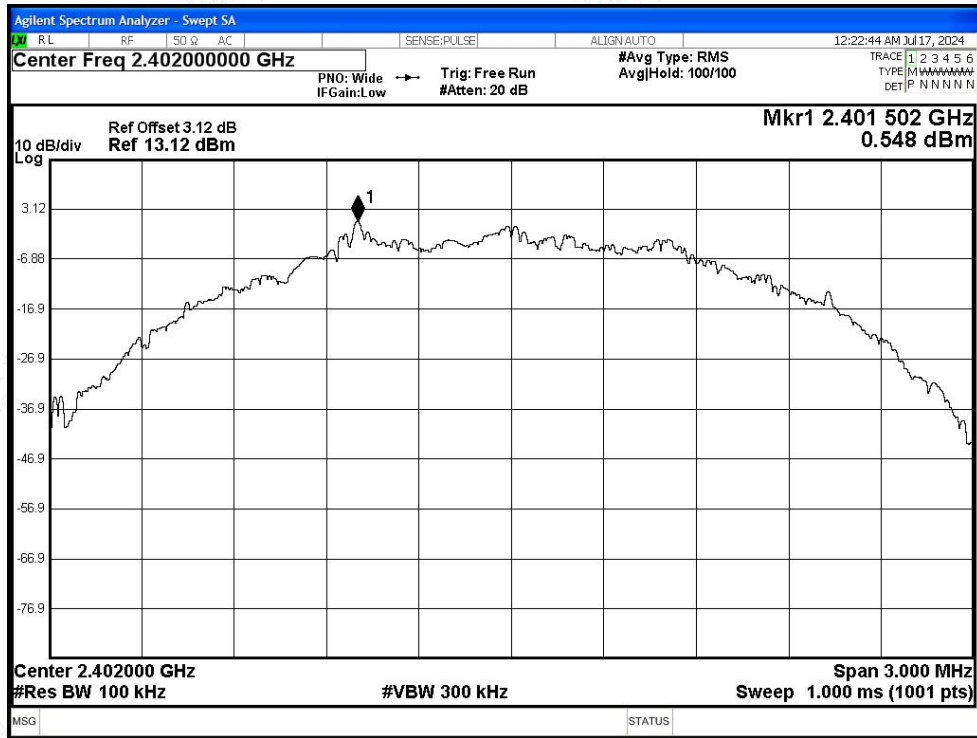

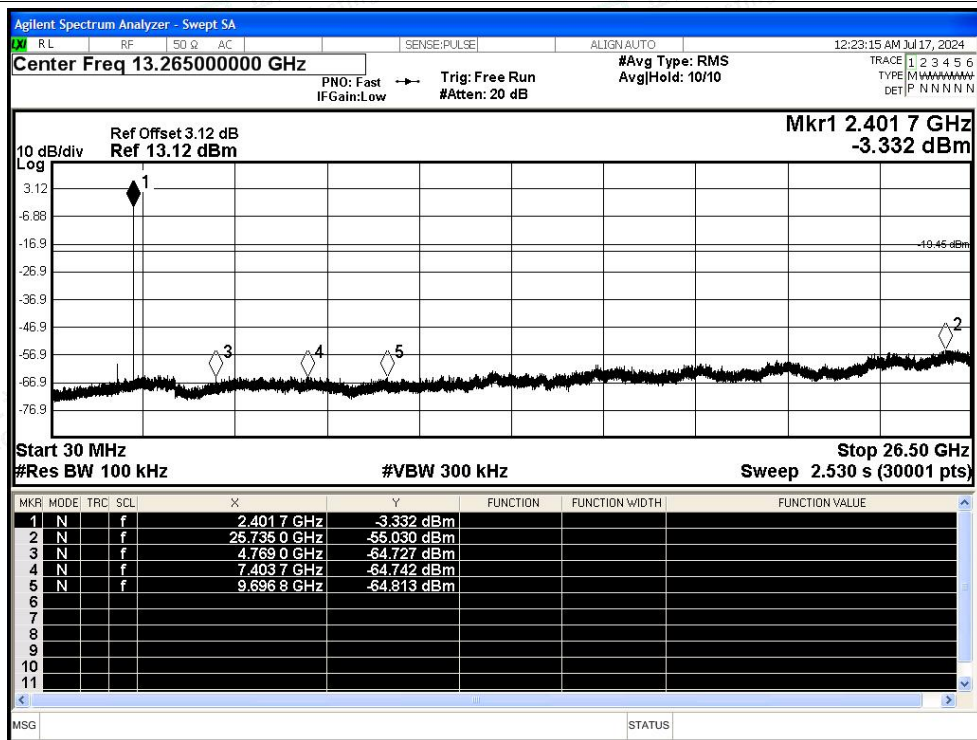

Tx. Spurious NVNT BLE 2M 2402MHz Ant1 Emission

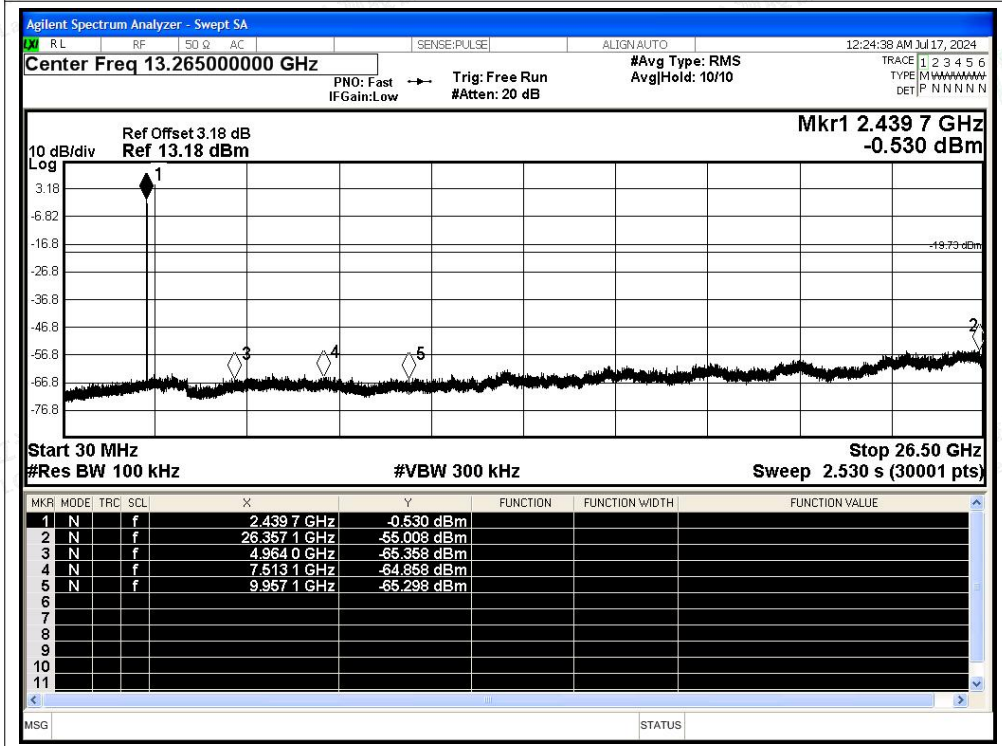




Tx. Spurious NVNT BLE 2M 2440MHz Ant1 Ref

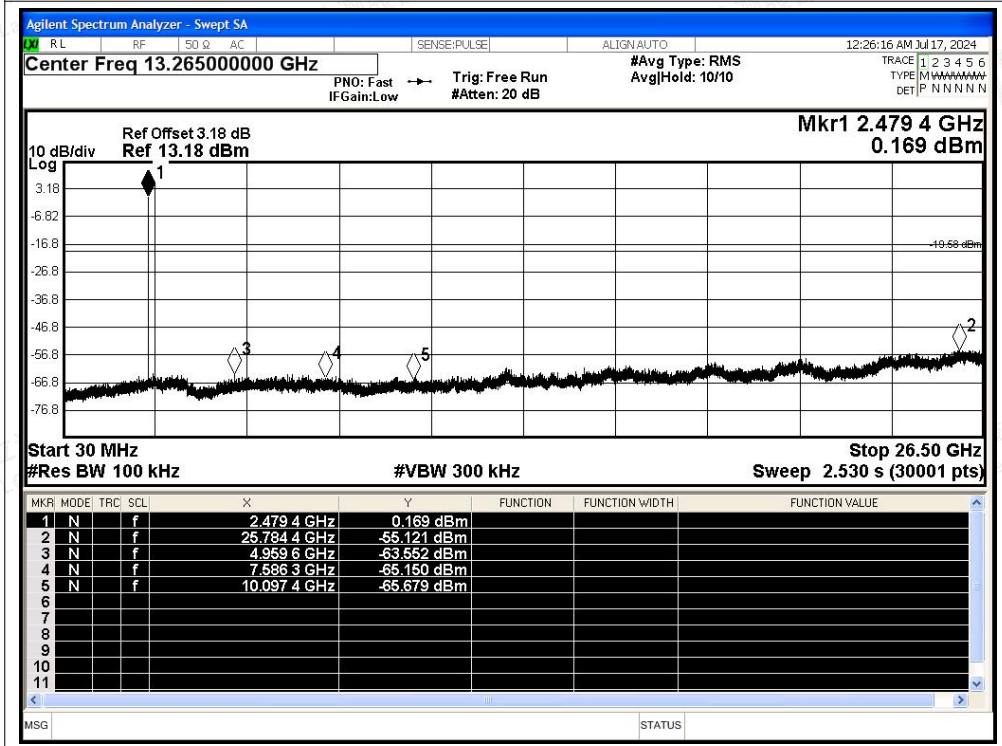




Tx. Spurious NVNT BLE 2M 2480MHz Ant1 Ref

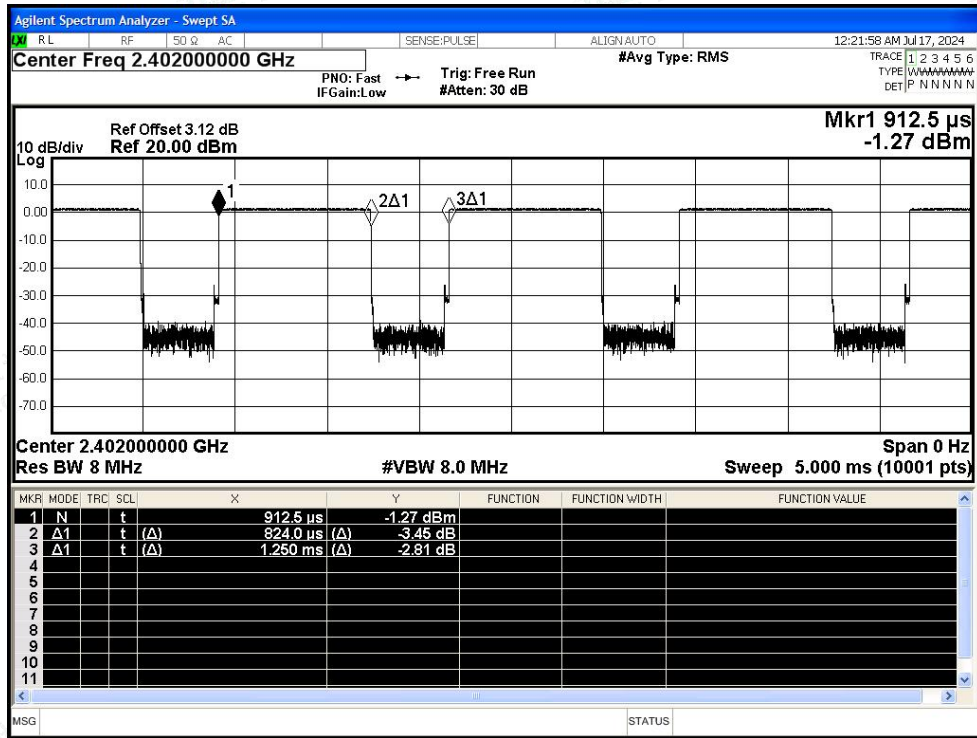

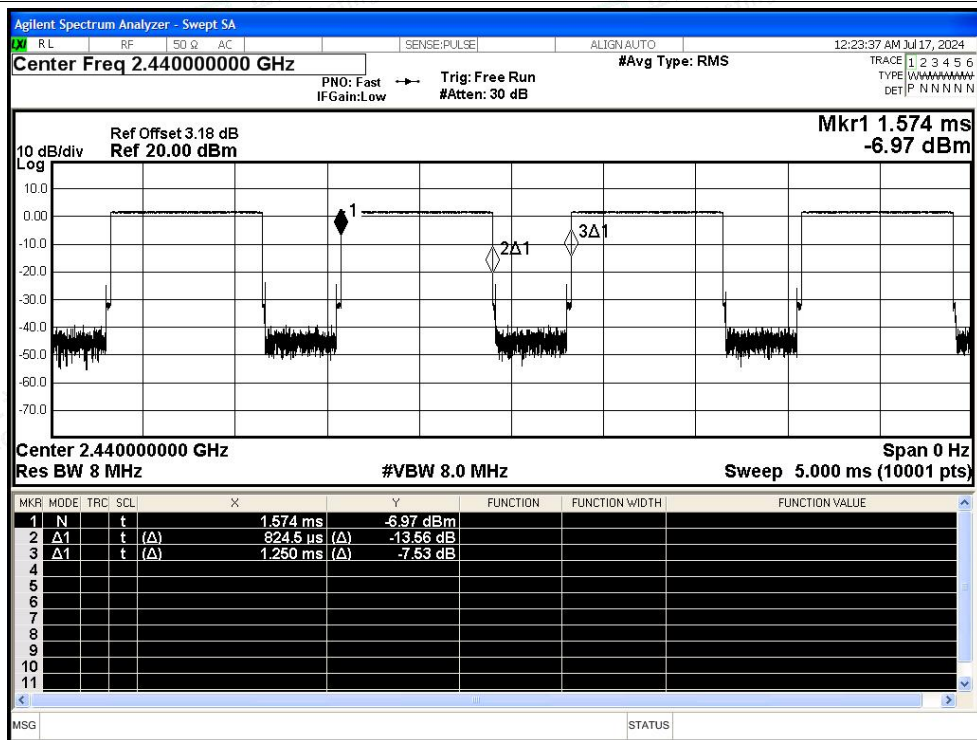

Duty Cycle NVNT BLE 2M 2402MHz Ant1

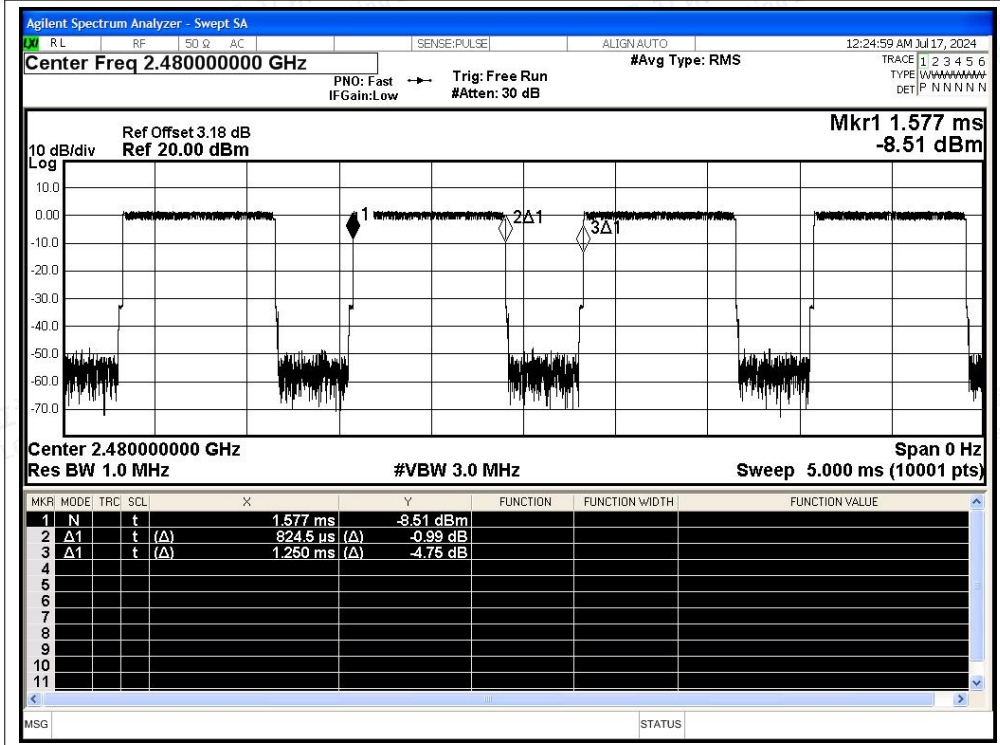


Duty Cycle NVNT BLE 2M 2440MHz Ant1

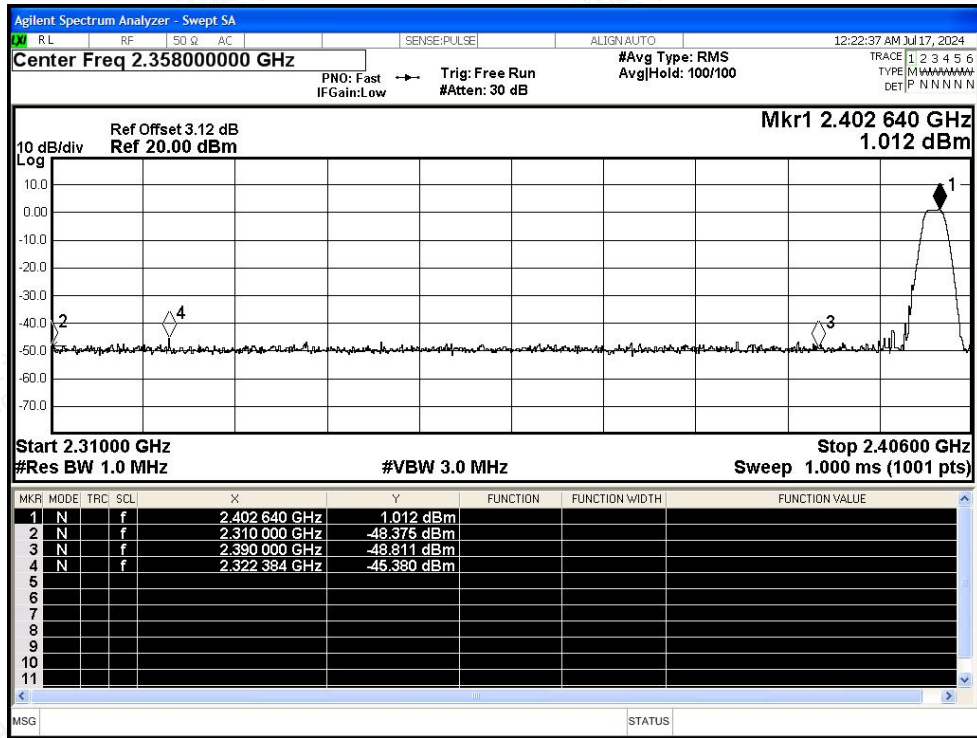

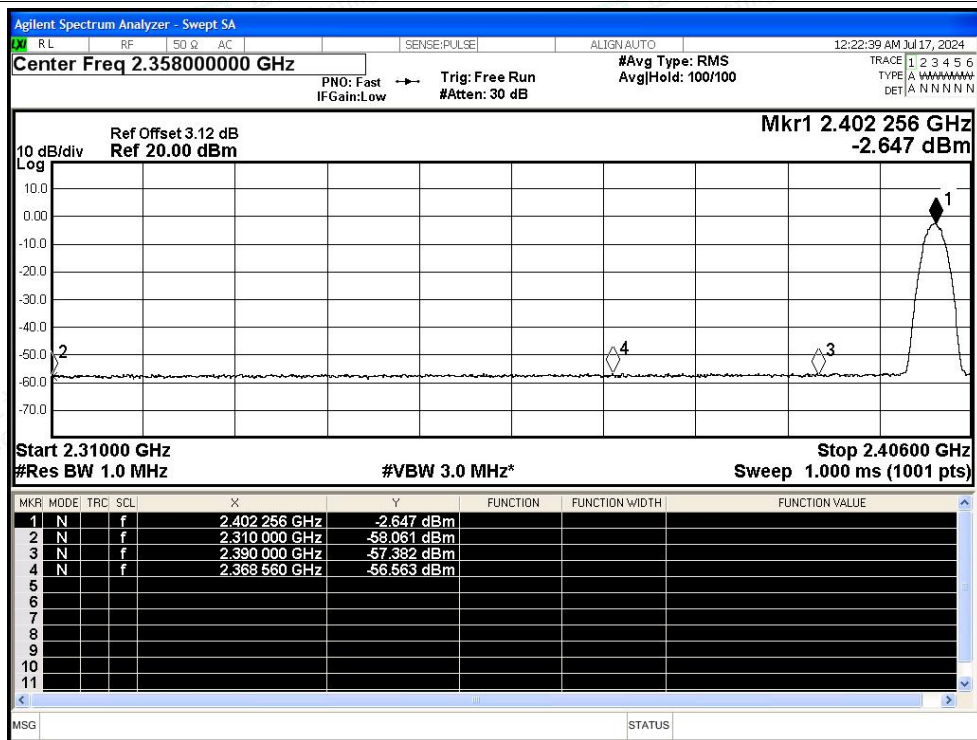

Restrict Band NVNT BLE 2M 2402MHz Ant1 Peak

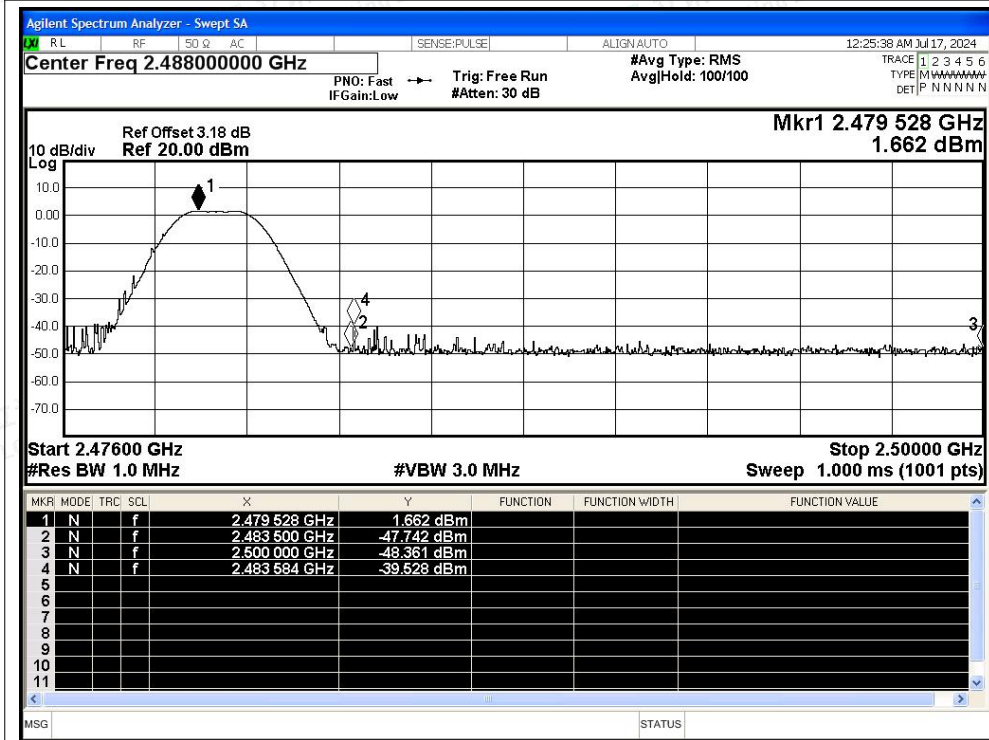


Restrict Band NVNT BLE 2M 2402MHz Ant1 Average
