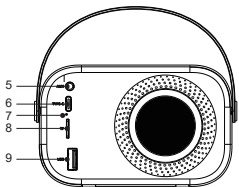
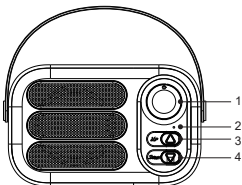

Operation Instructions

1. **Power On/Off/Vol -/Vol+:** Rotate the knob to the right to turn on the speaker and increase the volume, you will hear a tone. Rotate the knob to the left to decrease the volume and turn off the speaker.
2. **Pairing:** Once speaker is turned on, open your mobile device, search the wireless devices, and select wireless ID '25214', It will pair automatically.
3. **Next track:** Short press to next track.
4. **Previous track/ Mode/ Play/Pause:** Short press to previous track, long press to switch the mode, double press to play and pause the music.
5. **Switch Bluetooth, FM, AUX in, TF and USB disc (If ready) mode:** Long press the mode button
6. **FM mode:** Plug the Type-C cable into Type-C input port, long press the mode button to enter FM mode, long press the next track search FM button to search channel, after the search stop automatically or press the button again to end search, short press the next track and previous track to switch channel.
7. **AUX in:** Use 3.5mm plug audio cable (Not included) to connect the speaker and your phone, then you can enjoy the music.
8. **USB play:** Plug the USB disc into USB port, it will automatically play the music.

9. **TF card play:** Plug the TF card into TF slot, it will automatically play the music.
10. **Charging:** Use the Type-C cable included to connect the speaker to a computer or adaptor, the Charging LED indicator will display a solid red light.
11. When the speaker is fully charged, the red light will be turned off.
12. The speaker will be turned off automatically after disconnect and no any
