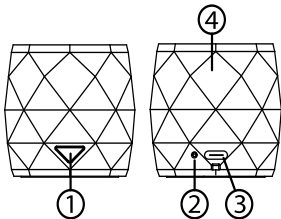


# Disco Light Up Bluetooth Speaker

## Instructions:

(Be sure to fully charge the speaker before using for the first time).

### 1. Charging the Speaker

- Connect the provided charging cable to a power source and to the Type-C port on the speaker (3).  
The LED indicator light will glow red when charging and turn off when fully charged.

### 2. Bluetooth Setup:

- Press and hold the ON/OFF Button to turn ON the device.
- Turn on the Bluetooth function on mobile device, Select "29062" pairing name.

- \* Speaker will automatically pair if the mobile device has been paired before.
- Press and hold the ON/OFF Button to turn OFF the device.

### 3. DISCO LIGHT:

- To turn OFF/ON the disco light function, double press the ON/OFF button.
