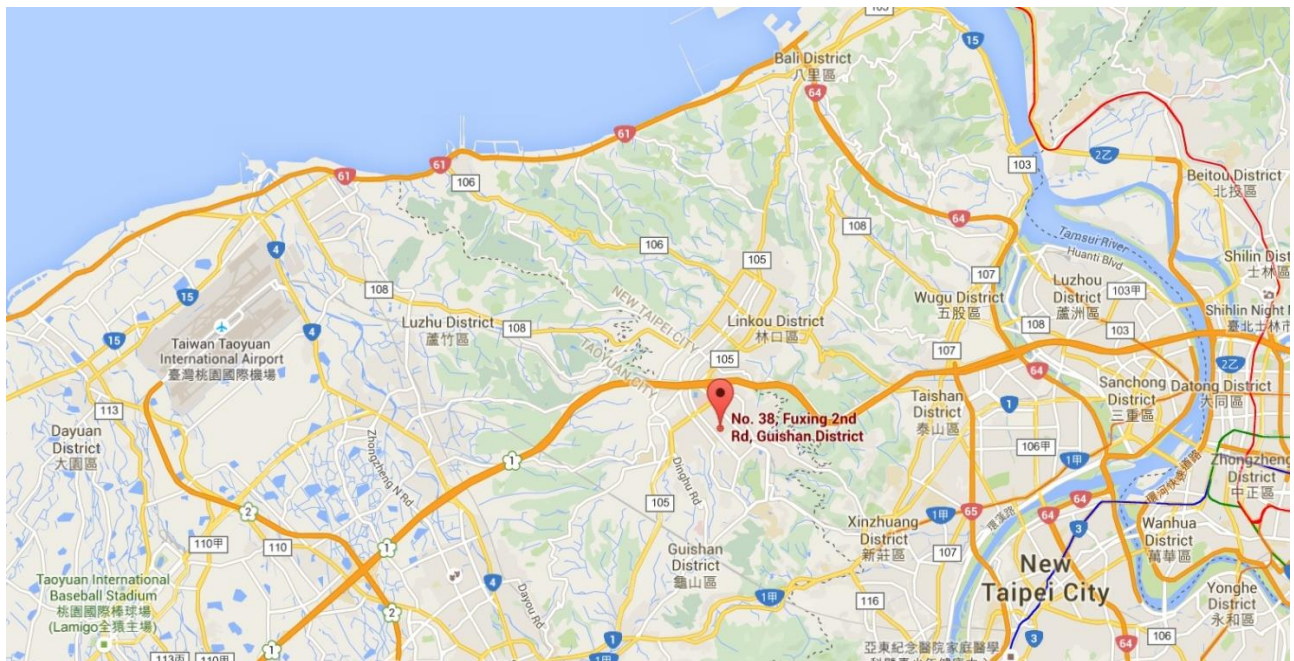
1. INTRODUCTION

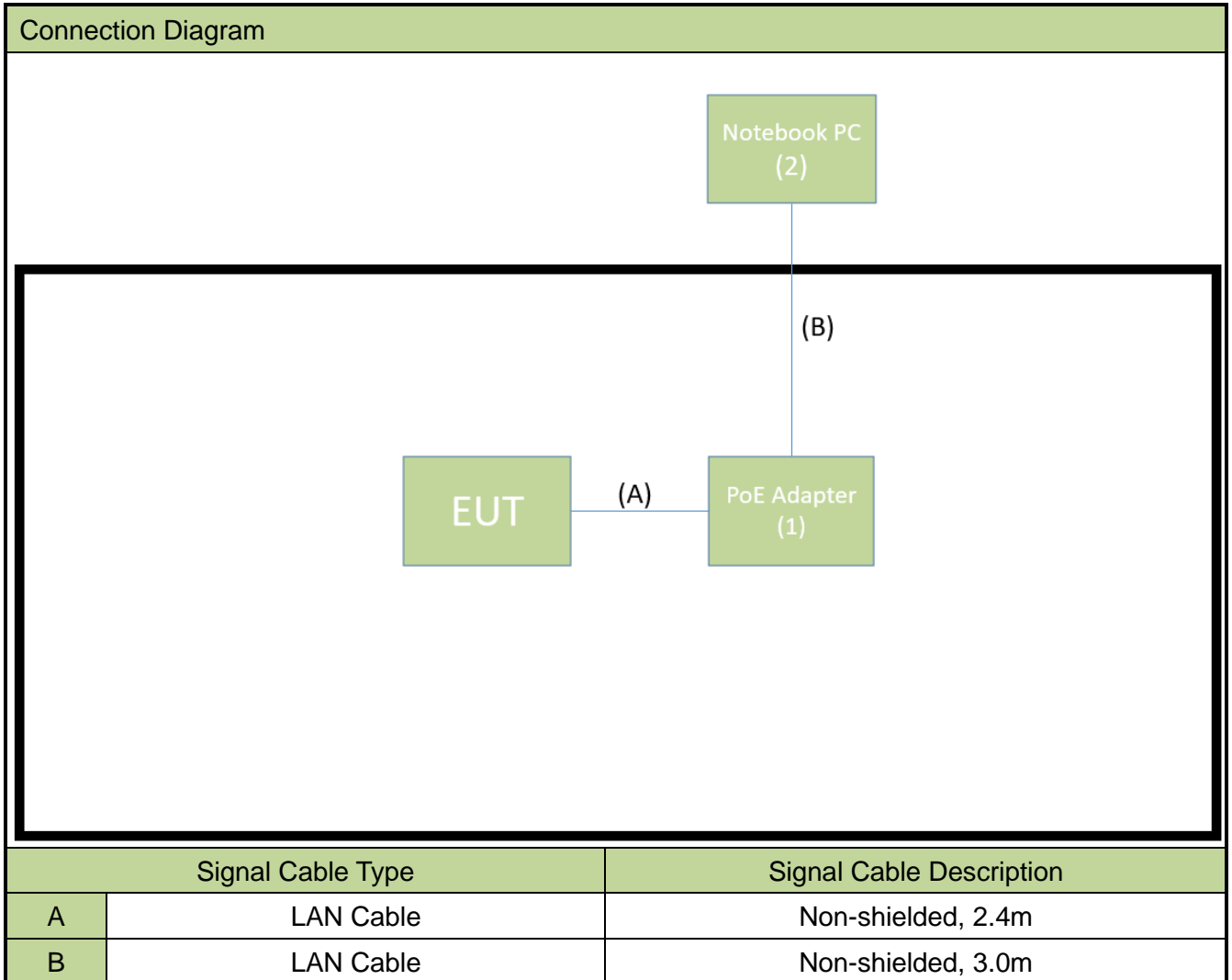

<ol style="list-style-type: none"> For Radiated emission, the modulation and the data rate picked for testing are determined by the Max. RF conducted power. This device supports 2 N_{SS} and power level of 2 N_{SS} is less than or equal to the power of 1 N_{SS}. The worst case is N_{SS}=1. Due to CDD mode was the worst mode, so all test items were evaluated in this report. The beamforming mode only evaluated the RF output power. EUT supports one configuration only in 802.11ax full RU mode.

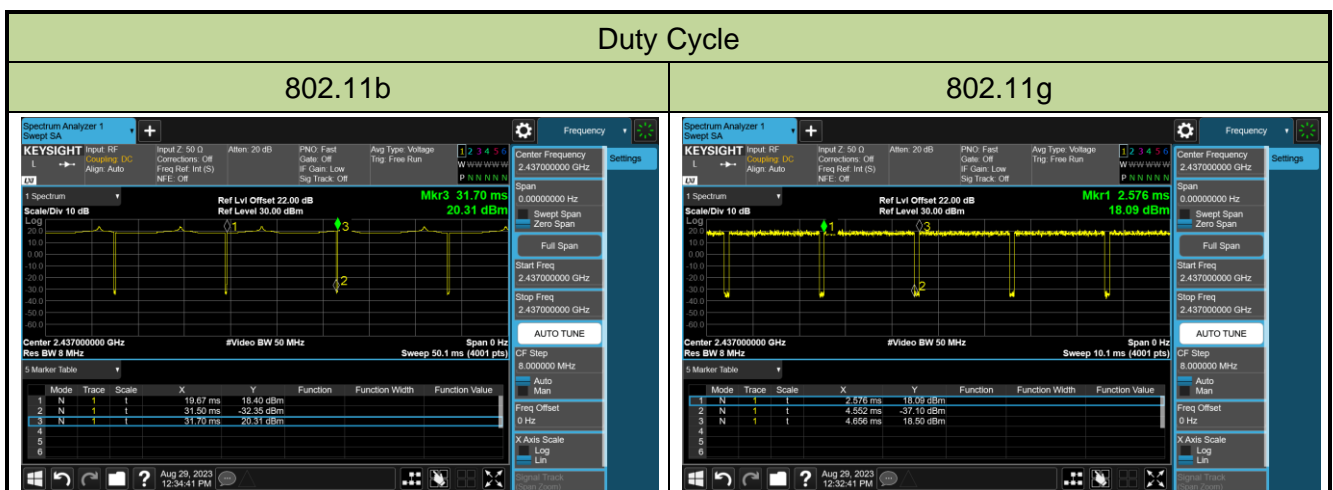

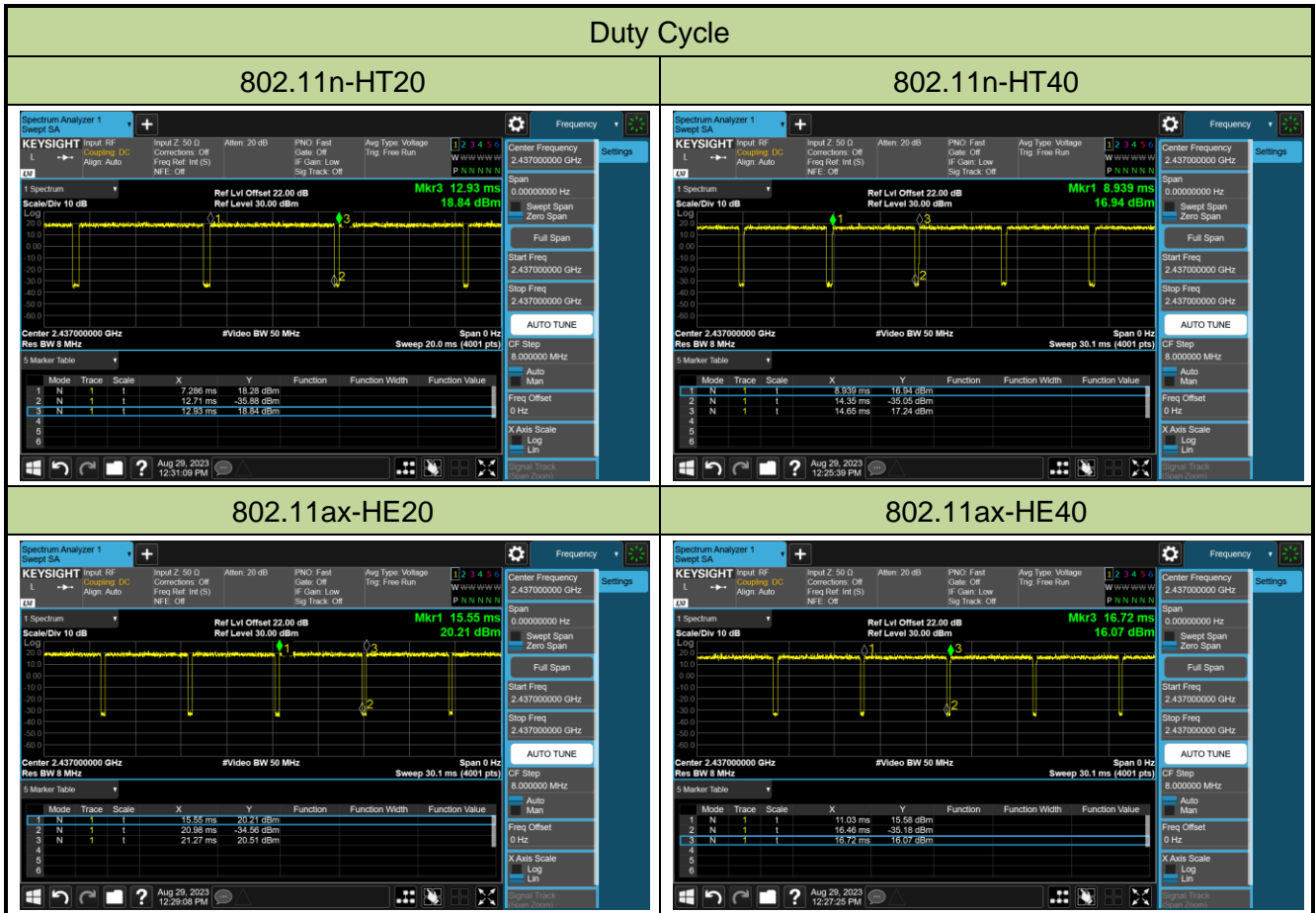

2.10. Duty Cycle

2.4GHz WLAN (DTS) operation is possible in 20MHz and 40MHz channel bandwidths. The maximum achievable duty cycles for all modes were determined based on measurements performed on a spectrum analyzer in zero-span mode with RBW = 8MHz, VBW = 50MHz. The RBW and VBW were both greater than 50/T, where T is the minimum transmission duration, and the number of sweep points across T was greater than 100. The duty cycles are as follows:

2.11. Test Configuration

The device was tested per the guidance of ANSI C63.10-2013. ANSI C63.10-2013 was used to reference the appropriate EUT setup for radiated spurious emissions testing and AC line conducted testing.

2.13. Labeling Requirements

The label shall be permanently affixed at a conspicuous location on the device; instruction manual or pamphlet supplied to the user and be readily visible to the purchaser at the time of purchase. However, when the device is so small wherein placement of the label with specified statement is not practical, only the FCC ID must be displayed on the device per Section 15.19(a)(5). 3. DESCRIPTION of TEST

3.1. Evaluation Procedure

The measurement procedures described in the American National Standard of Procedures for Compliance Testing of Unlicensed Wireless Devices (ANSI C63.10-2013), and the guidance was used in the measurement.

3.2. AC Line Conducted Emissions

The line-conducted facility is located inside an 8'x4'x4' shielded enclosure. A 1m x 2m wooden table 80cm high is placed 40cm away from the vertical wall and 80cm away from the sidewall of the shielded room. Two 10kHz-30MHz, 50Ω/50uH Line-Impedance Stabilization Networks (LISNs) are bonded to the shielded room floor. Power to the LISNs is filtered by external high-current high-insertion loss power line filters. These filters attenuate ambient signal noise from entering the measurement lines. These filters are also bonded to the shielded enclosure.

The EUT is powered from one LISN and the support equipment is powered from the second LISN. All interconnecting cables more than 1 meter were shortened to a 1 meter length by non-inductive bundling (serpentine fashion) and draped over the back edge of the test table. All cables were at least 40cm above the horizontal reference ground-plane. Power cables for support equipment were routed down to the second LISN while ensuring that that cables were not draped over the second LISN.

Sufficient time for the EUT, support equipment, and test equipment was allowed in order for them to warm up to their normal operating condition. The RF output of the LISN was connected to the receiver and exploratory measurements were made to determine the frequencies producing the maximum emission from the EUT. The receiver was scanned from 150kHz to 30MHz. The detector function was set to peak mode for exploratory measurements while the bandwidth of the analyzer was set to 9kHz. The EUT, support equipment, and interconnecting cables were arranged and manipulated to maximize each emission. Each emission was also maximized by varying power lines, the mode of operation or data exchange speed, or support equipment whichever determined the worst-case emission. Once the worst-case emissions have been identified, the one EUT cable configuration/arrangement and mode of operation that produced these emissions are used for final measurements on the same test site. The analyzer is set to CISPR quasi-peak and average detectors with a 9kHz resolution bandwidth for final measurements.

An extension cord was used to connect to a single LISN which powered by EUT. The extension cord was calibrated with LISN, the impedance and insertion loss are compliance with the requirements as stated in ANSI C63.10-2013.

3.3. Radiated Emissions

The radiated test facilities consisted of an indoor 3 meter semi-anechoic chamber used for final measurements and exploratory measurements, when necessary. The measurement area is contained within the semi-anechoic chamber which is shielded from any ambient interference. For measurements above 1GHz absorbers are arranged on the floor between the turn table and the antenna mast in such a way so as to maximize the reduction of reflections. For measurements below 1GHz, the absorbers are removed. A MF Model 210SS turntable is used for radiated measurement. It is a continuously rotatable, remote controlled, metallic turntable and 2 meters (6.56 ft.) in diameter. The turn table is flush with the raised floor of the chamber in order to maintain its function as a ground plane. An 80cm high PVC support structure is placed on top of the turntable.

For all measurements, the spectrum was scanned through all EUT azimuths and from 1 to 4 meter receive antenna height using a broadband antenna from 30MHz up to the upper frequency shown in 15.33(b)(1) depending on the highest frequency generated or used in the device or on which the device operates or tunes. For frequencies above 1GHz, linearly polarized double ridge horn antennas were used. For frequencies below 30MHz, a calibrated loop antenna was used. When exploratory measurements were necessary, they were performed at 1 meter test distance inside the semi-anechoic chamber using broadband antennas, broadband amplifiers, and spectrum analyzers to determine the frequencies and modes producing the maximum emissions. Sufficient time for the EUT, support equipment, and test equipment was allowed in order for them to warm up to their normal operating condition. The test set-up for frequencies below 1GHz was placed on top of the 0.8 meter high, 1 x 1.5 meter table; and test set-up for frequencies 1-40GHz was placed on top of the 1.5 meter high, 1 x 1.5 meter table. The EUT, support equipment, and interconnecting cables were arranged and manipulated to maximize each emission. Appropriate precaution was taken to ensure that all emissions from the EUT were maximized and investigated. The system configuration, clock speed, mode of operation or video resolution, if applicable, turntable azimuth, and receive antenna height was noted for each frequency found.

Final measurements were made in the semi-anechoic chamber using calibrated, linearly polarized broadband and horn antennas. The test setup was configured to the setup that produced the worst case emissions. The spectrum analyzer was set to investigate all frequencies required for testing to compare the highest radiated disturbances with respect to the specified limits. The turntable containing the EUT was rotated through 360 degrees and the height of the receive antenna was varied 1 to 4 meters and stopped at the azimuth and height producing the maximum emission. Each emission was maximized by changing the orientation of the EUT through three orthogonal planes and changing the polarity of the receive antenna, whichever produced the worst-case emissions. According to 3dB Beam-Width of horn antenna, the horn antenna should be always directed to the EUT when rising height.

4. ANTENNA REQUIREMENTS

Excerpt from §15.203 of the FCC Rules/Regulations:

“An intentional radiator antenna shall be designed to ensure that no antenna other than that furnished by the responsible party can be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section.”

- The antenna of the device is **an external antenna with a RP-SMA connector.**

Conclusion:

The unit complies with the requirement of §15.203.

- 2) The analyzer plots shown in this section were all taken with a correction table loaded into the analyzer. The correction table was used to account for the losses of the cables and attenuators used as part of the system to connect the EUT to the analyzer at all frequencies of interest.
- 3) For radiated emission test, every axis (X, Y, Z) was also verified. The test results shown in the following sections represent the worst-case emissions.

The minimum 6dB bandwidth shall be at least 500 kHz.

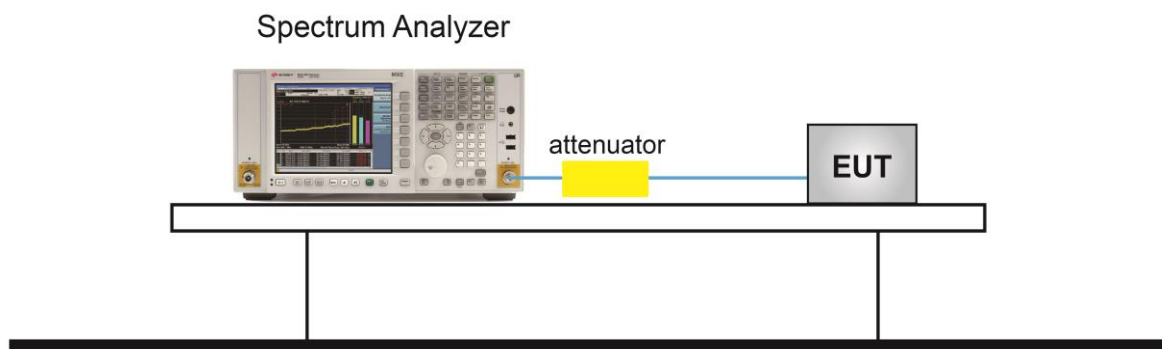
7.2.2. Test Procedure used

ANSI C63.10-2013 Section 11.8

7.2.3. Test Setting

1. The Spectrum's automatic bandwidth measurement capability was used to perform the 6dB bandwidth measurement. The "X" dB bandwidth parameter was set to $X = 6$. The bandwidth measurement was not influenced by any intermediate power nulls in the fundamental emission.
2. Set RBW = 100 kHz
3. VBW $\geq 3 \times$ RBW
4. Detector = Peak
5. Trace mode = max hold
6. Sweep = auto couple
7. Allow the trace was allowed to stabilize

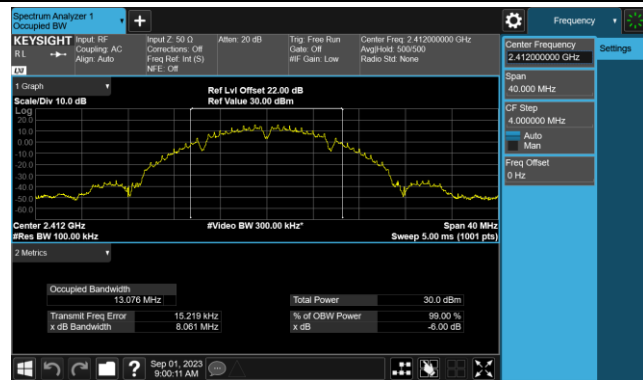

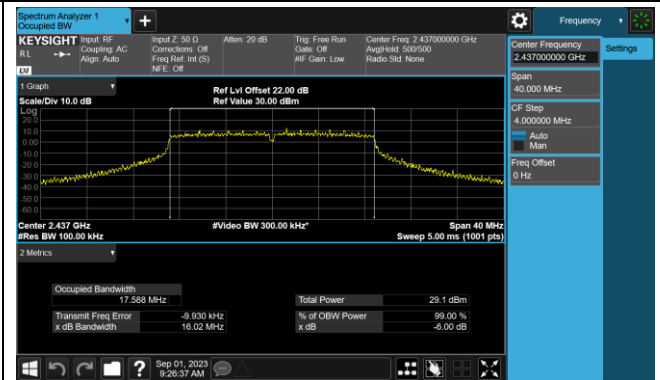


802.11n-HT20 6dB Bandwidth - Ant 1

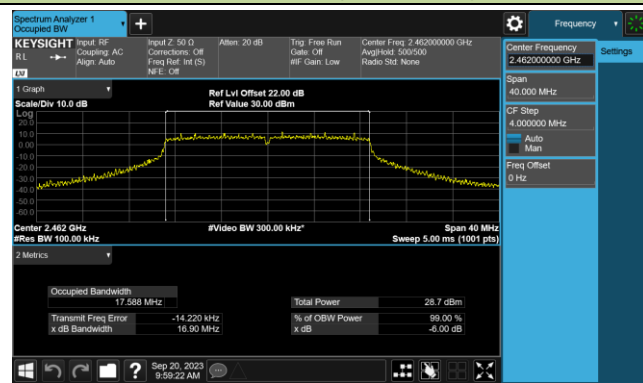

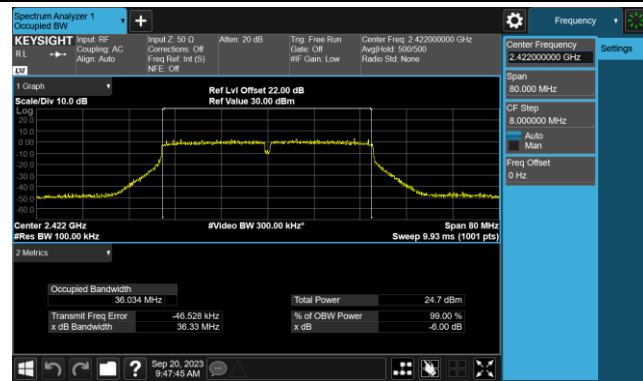

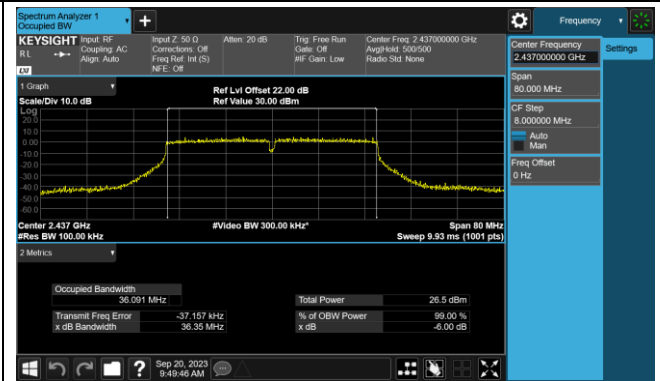


802.11n-HT40 6dB Bandwidth - Ant 1

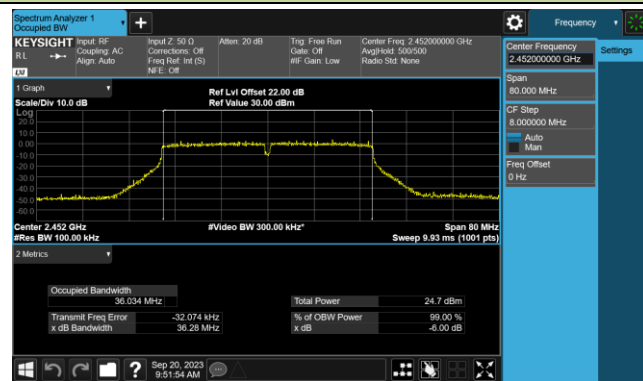

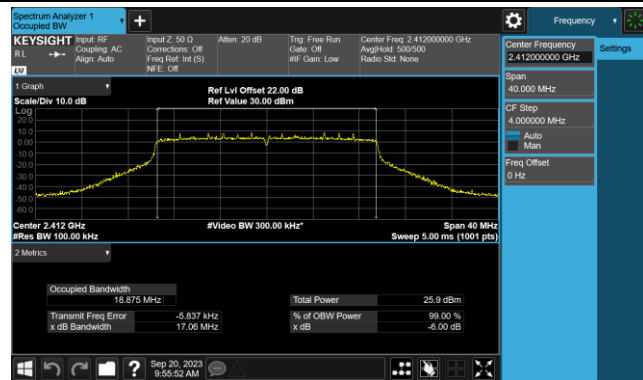

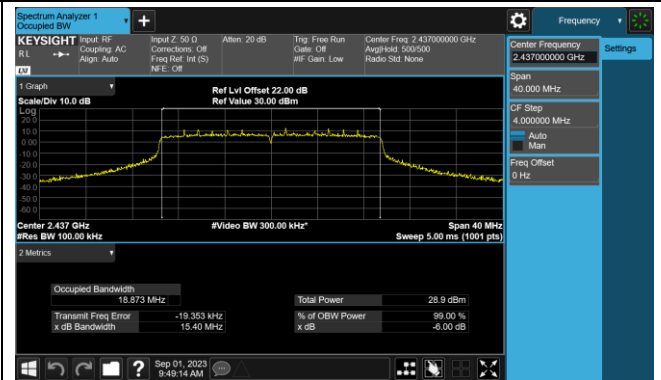


802.11ax-HE20 6dB Bandwidth - Ant 1

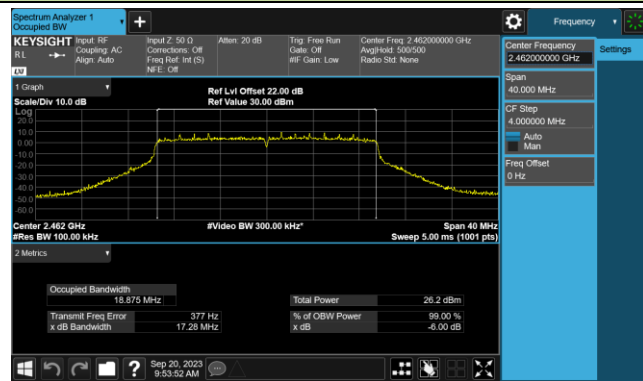

7.3. Output Power Measurement

7.3.1. Test Limit

The maximum output power shall be less 1 Watt (30dBm).

The conducted output power limit specified in paragraph FCC Part 15.247(b) of this section is based on the use of antennas with directional gains that do not exceed 6 dBi. If transmitting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraphs FCC Part 15.247(b)(3) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

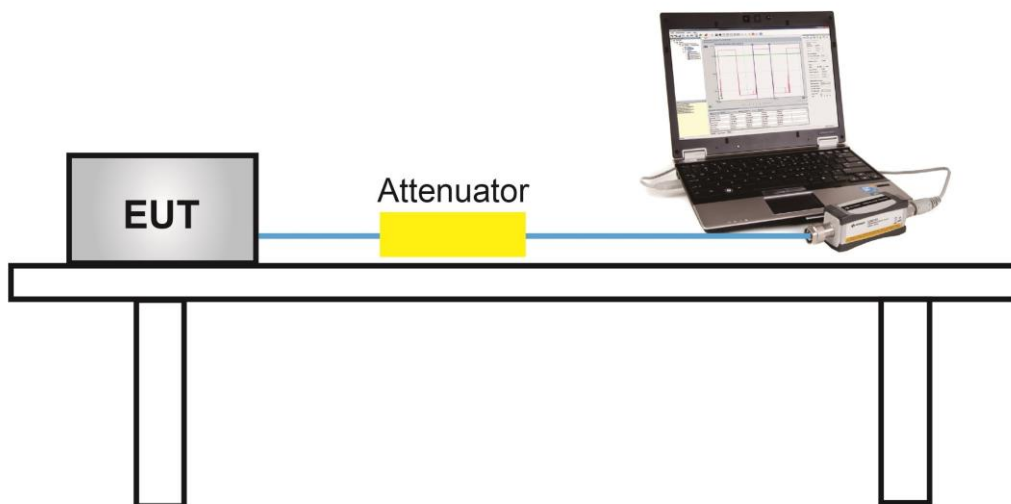

7.4. Power Spectral Density Measurement

7.4.1. Test Limit

The maximum permissible power spectral density is 8dBm in any 3 kHz band.

The same method of determining the conducted output power shall be used to determine the power spectral density.

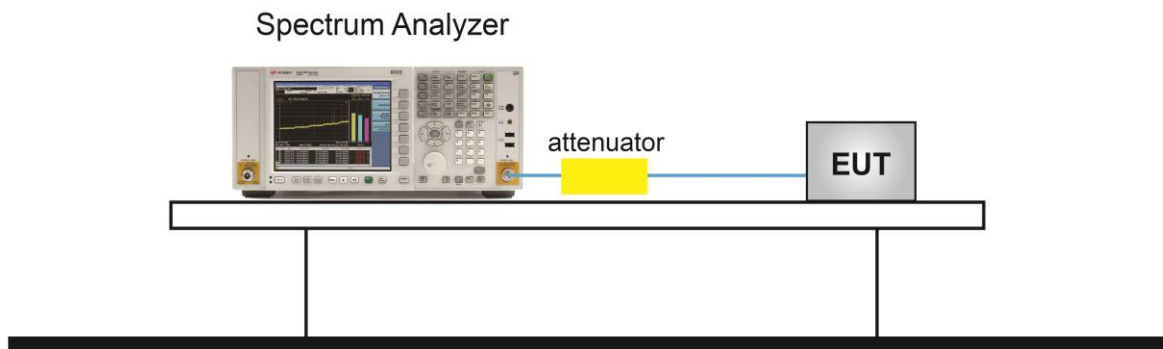

2. Set instrument center frequency to DTS channel center frequency.
3. Set span to at least 1.5 times the OBW.
4. RBW = 10 kHz.
5. VBW = 30 kHz.
6. Detector = RMS.
7. Ensure that the number of measurement points in the sweep $\geq 2 \times \text{span}/\text{RBW}$.
8. Sweep time = auto couple.
9. Don't use sweep triggering. Allow sweep to "free run".
10. Employ trace averaging (RMS) mode over a minimum of 100 traces.
11. Use the peak marker function to determine the maximum amplitude level.
12. Add $10 \log (1/x)$, where x is the duty cycle measured in step (a), to the measured PSD to compute the average PSD during the actual transmission time.

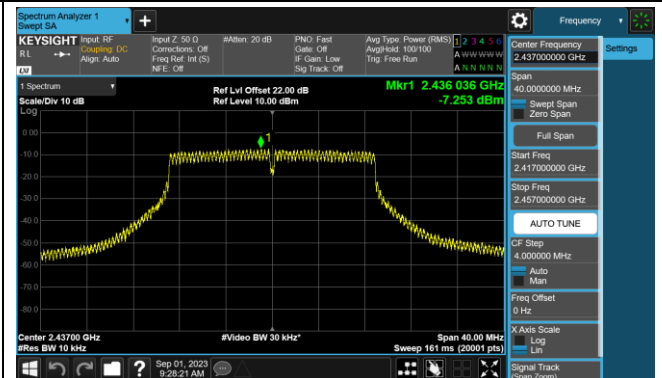


802.11n-HT20 AVGPSD - Ant 0 - CDD Mode

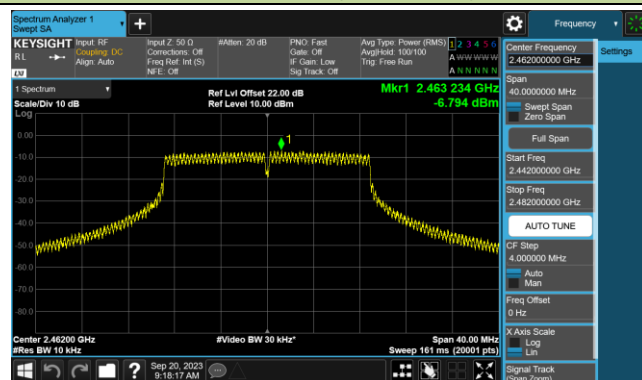

7.5. Conducted Band Edge and Out-of-Band Emissions

7.5.1. Test Limit

The limit for out-of-band spurious emissions at the band edge is 30dB below the fundamental emission level, as determined from the in-band power measurement of the DTS channel performed in a 100 kHz bandwidth per the PSD procedure.
