### 5. REQUIREMENT

#### **LIMIT AND CALCULATION METHOD**

# **CALCULATION METHOD**

 $S=PG/4\pi R^2$ 

Where:

S=power density

P=power input to antenna

G=power gain of the antenna in the direction of interest relative to an isotropic radiator

R=distance to the center of radiation of the antenna

- 2.4 GHz WiFi-H + 5 GHz WiFi-V = 0.15803+ 0.22322= 0.38125 (mW/cm<sup>2</sup>)
- $2.4 \text{ GHz WiFi-V} + 5 \text{ GHz WiFi-V} = 0.19894 + 0.22322 = 0.42216 \text{ (mW/cm}^2)$

Therefor the maximum calculations of above situations are less than the "1" limit.
