

**RF Exposure Compliance Requirement**

**Model no.: CS01, CS02**

**1. Standard requirement**

Systems operating under the provisions of this section shall be operated in a manner that ensures that the public is not exposed to radio frequency energy level in excess limit for maximum permissible exposure. In accordance with 47 CFR FCC Part 2 Subpart J, section 2.1091 this device has been defined as a mobile device whereby a distance of 0.2m normally can be maintained between the user and the device.

Note: f=frequency in MHz; \*Plane-wave equivalent power density

**2. MPE Calculation Method**

$$E (V/m) = (30 * P * G)^{0.5} / d \quad \text{Power Density: } Pd(W/m^2) = E^2 / 377$$

E=Electric Field (V/m)

P=Peak RF output Power (W)

G=EUT Antenna numeric gain (numeric)

d= Separation distance between radiator and human body (m)

The formula can be changed to

$$Pd = (30 * P * G) / (377 * d^2)$$

From the peak EUT RF output power, the minimum mobile separation distance, d=0.2m, as well as the gain of the used antenna, the RF power density can be obtained.

**3. Calculated Result and Limit**

$$0.00000000281(mW/cm^2) / 0.98(mW/cm^2) = 0.00000000287$$

Peak Output Power = 16.89dBm(max.value declared by client), antenna gain = 2.19dBi

MPE ratio:

$$0.016096 (mW/cm^2) / 1(mW/cm^2) = 0.016096$$

Peak Output Power = 2.19dBm(max.value declared by client), antenna gain = 0.5dBi

MPE ratio:

$$0.00037(\text{mW}/\text{cm}^2)/1(\text{mW}/\text{cm}^2) = 0.00037$$

Sum of the MPE ratio for all simultaneously transmitting antennas:

$$0.00000000287+0.016096+0.00037= 0.01646600287 < 1$$

According to MPE test Exclusion condition in KDB 447498 (D01) General RF Exposure Guidance D01 v06, the MPE report is not required.
