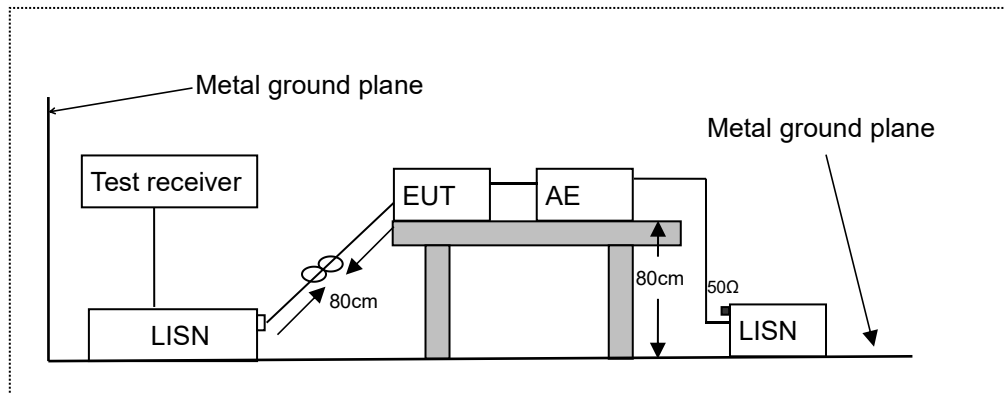

### 4.1. Block Diagram of Test Setup



LISN: Line Impedance Stabilization Network  
AE: Associated equipment  
EUT: Equipment under test

### 4.3. Test Procedure

The EUT was placed on a desk 0.8 m height from the metal ground plane and 0.4 m from the conducting wall of the shielding room and it was kept at least 0.8 m from any other grounded conducting surface. The size of the table will nominally be 1.5 m x1.0 m.

The rear of the arrangement shall be flush with the back of the supporting tabletop unless that would not be possible or typical of normal use.

All units of equipment forming the system under test (includes the EUT as well as connected peripherals and associated equipment or devices) shall be arranged such that a nominal 0.1 m separation is achieved between the neighboring units.

Connect EUT to the power mains through a line impedance stabilization network (LISN). Where the mains cable supplied by the manufacturer is longer than 1 m, the excess should be folded at the centre into a bundle no longer than 0.4 m, so that its length is shortened to 1 m.

All the support units are connecting to the other LISN.

The LISN provides 50 ohm coupling impedance for the measuring instrument.

Both sides of AC line were checked for maximum conducted interference.

The frequency range from 150 kHz to 30 MHz was sweep.

Set the test-receiver system to quasi peak detect function and average detect function, and to measure the conducted emissions values.

Test results were obtained from the following equation:

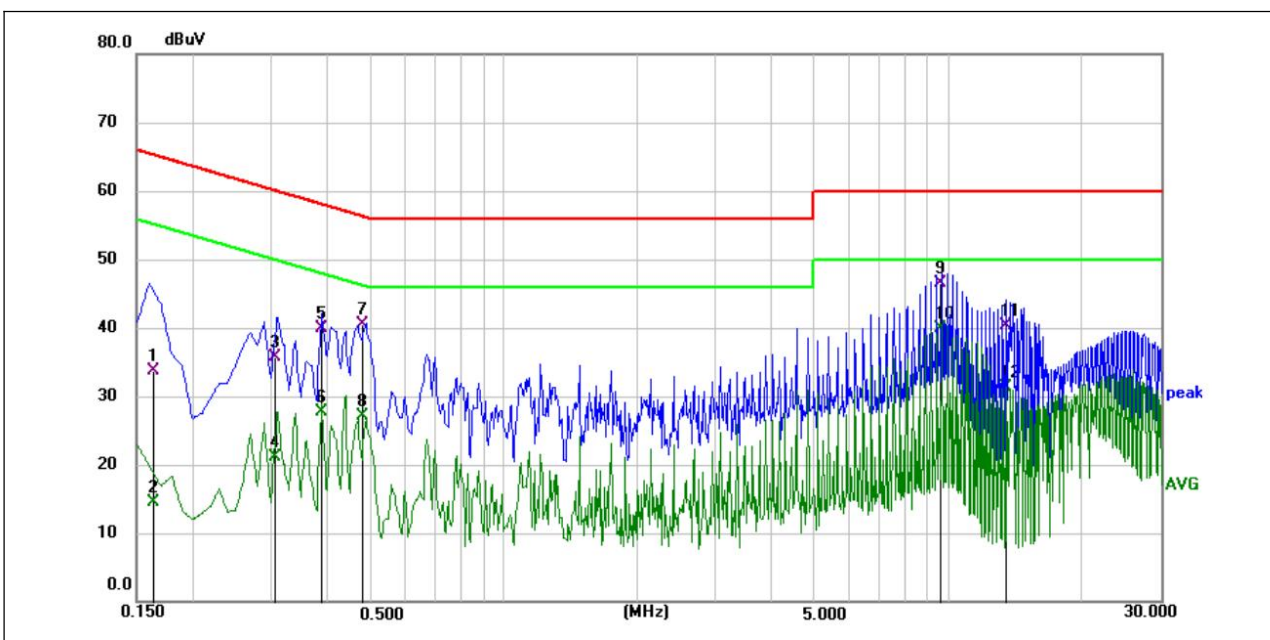
Emission Level (dB $\mu$ V) = LISN Factor (dB) + Cable Loss (dB) + Reading (dB $\mu$ V)

Margin (dB) = Emission Level (dB $\mu$ V) - Limit (dB $\mu$ V)

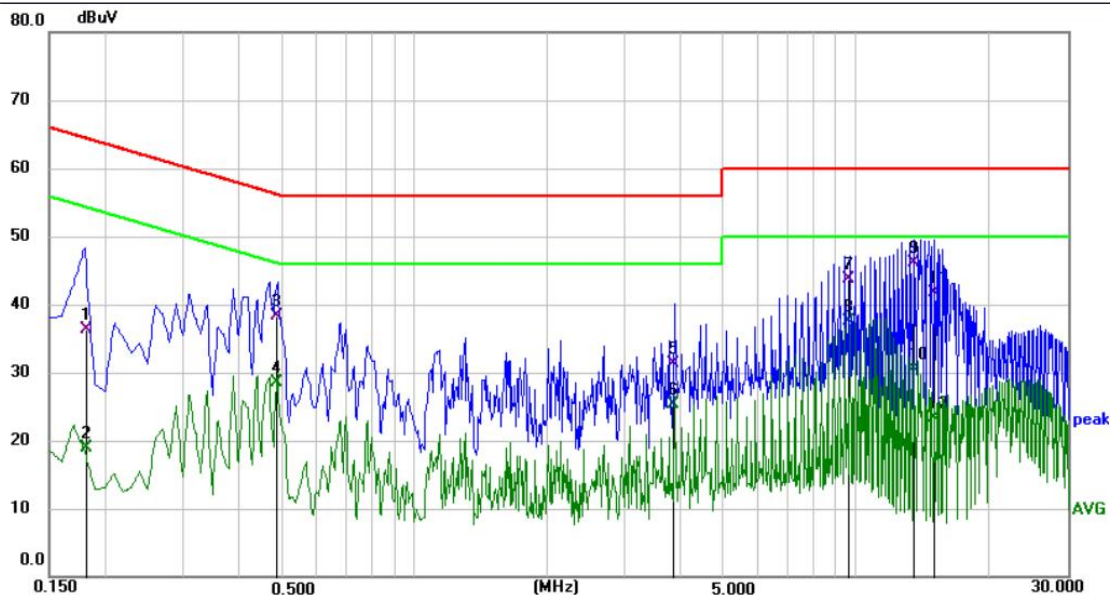

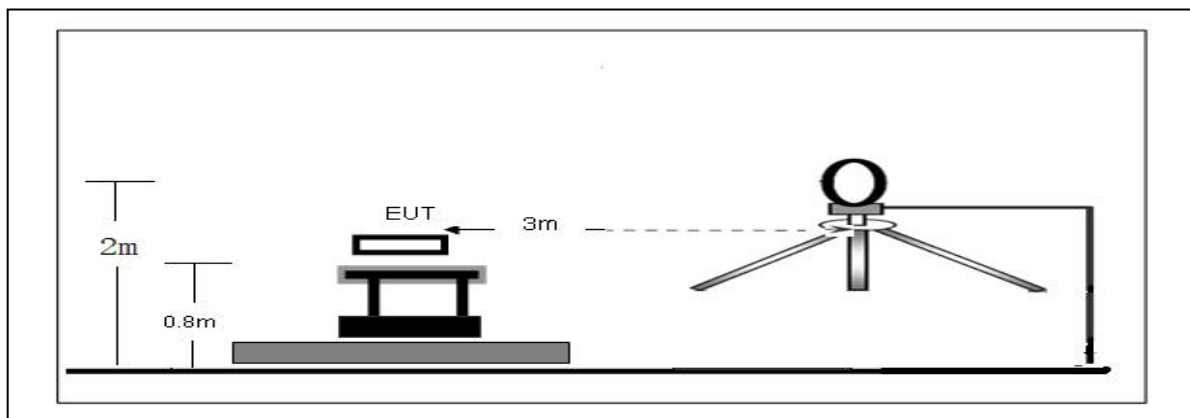
## 5. RADIATED EMISSION TEST

### 5.1.Measurement Procedure

1. The EUT was placed on a turn table which is 0.8m above ground plane.
2. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
3. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
4. Repeat above procedures until all frequency measured were complete.
5. Use the following receiver/spectrum analyzer settings:  
Span = wide enough to fully capture the emission being measured  
RBW=200Hz for 9KHz to 150KHz,  
RBW=9kHz for 150KHz to 30MHz,  
RBW=120KHz for 30MHz to 1GHz  
VBW  $\geq 3 \times$  RBW  
Sweep = auto  
Detector function = QP  
Trace = max hold

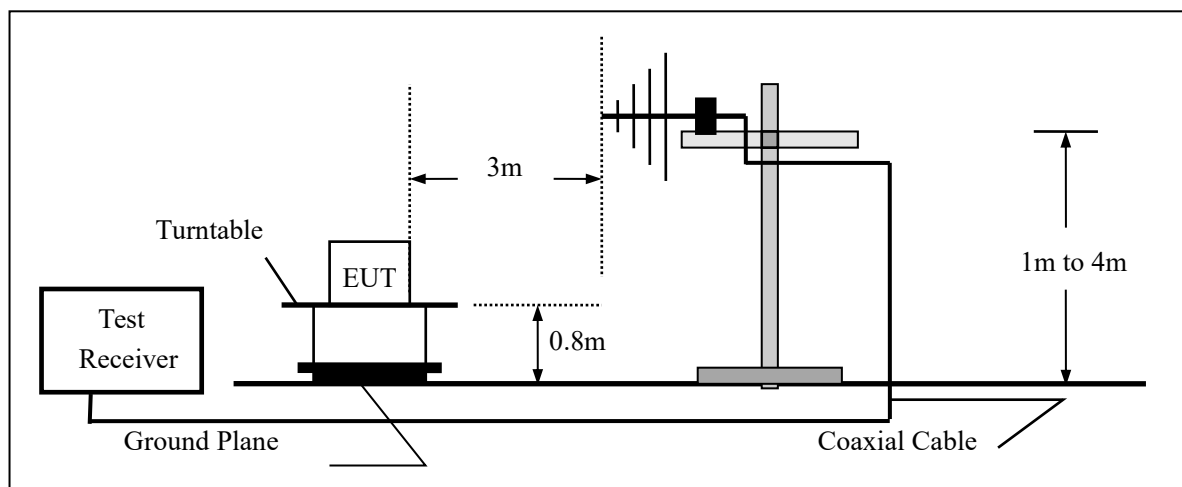

## 5.3. Radiated Emission Limit

Limits for frequency below 30MHz

Except as provided elsewhere in this Subpart 18.305 (b), the field strength levels of emissions which lie outside the bands specified in § 18.301, unless otherwise indicated, shall not exceed the following table:

### 5.4. 4.4 EUT Configuration on Test

The FCC PART 18 regulations test method must be used to find the maximum emission during radiated emission test. The configuration of EUT is the same as used in conducted emission test. Please refer to Section 2.2.

### 5.5. 4.5 Operating Condition of EUT

Same as conducted emission test, which is listed in Section 2.2 except the test set up replaced as Section 4.1.

#### 5.6. 4.6 Test Procedure

##### 1) Sequence of testing 9 kHz to 30 MHz

###### Setup:

--- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.

--- If the EUT is a tabletop system, a rotatable table with 0.8 m height is used.

--- If the EUT is a floor standing device, it is placed on the ground.

--- Auxiliary equipment and cables were positioned to simulate normal operation conditions.

--- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.

--- The measurement distance is 3 meter.

--- The EUT was set into operation.

###### Premeasurement:

--- The turntable rotates from 0° to 315° using 45° steps.

--- The antenna height is 2.0 meter.

--- At each turntable position the analyzer sweeps with peak detection to find the maximum of all emissions Final measurement:

--- Identified emissions during the premeasurement the software maximizes by rotating the turntable position (0° to 360°) and by rotating the elevation axes (0° to 360°).

--- The final measurement will be done in the position (turntable and elevation) causing the highest emissions with QPK detector.

--- The final levels, frequency, measuring time, bandwidth, turntable position, correction factor, margin to the limit and limit will be recorded. Also a plot with the graph of the premeasurement and the limit will be stored.

##### Sequence of testing 30 MHz to 1 GHz Setup:

--- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.

--- If the EUT is a tabletop system, a table with 0.8 m height is used, which is placed on the ground plane.

--- If the EUT is a floor standing device, it is placed on the ground plane with insulation between both.

--- Auxiliary equipment and cables were positioned to simulate normal operation conditions

--- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.

--- The measurement distance is 3 meter.

--- The EUT was set into operation.

###### Premeasurement:

--- The turntable rotates from 0° to 315° using 45° steps.

--- The antenna is polarized vertical and horizontal.

--- The antenna height changes from 1 to 4 meter.

--- At each turntable position, antenna polarization and height the analyzer sweeps three times in peak to find the maximum of all emissions.

###### Final measurement:

--- The final measurement will be performed with minimum the six highest peaks.

--- According to the maximum antenna and turntable positions of premeasurement the software maximize the peaks by changing turntable position ( $\pm 45^\circ$ ) and antenna movement between 1 and 4 meter.

--- The final measurement will be done with QP detector with an EMI receiver.

--- The final levels, frequency, measuring time, bandwidth, antenna height, antenna polarization, turntable angle, correction factor, margin to the limit and limit will be recorded. Also a plot with the graph of the premeasurement with marked maximum final measurements and the limit will be stored

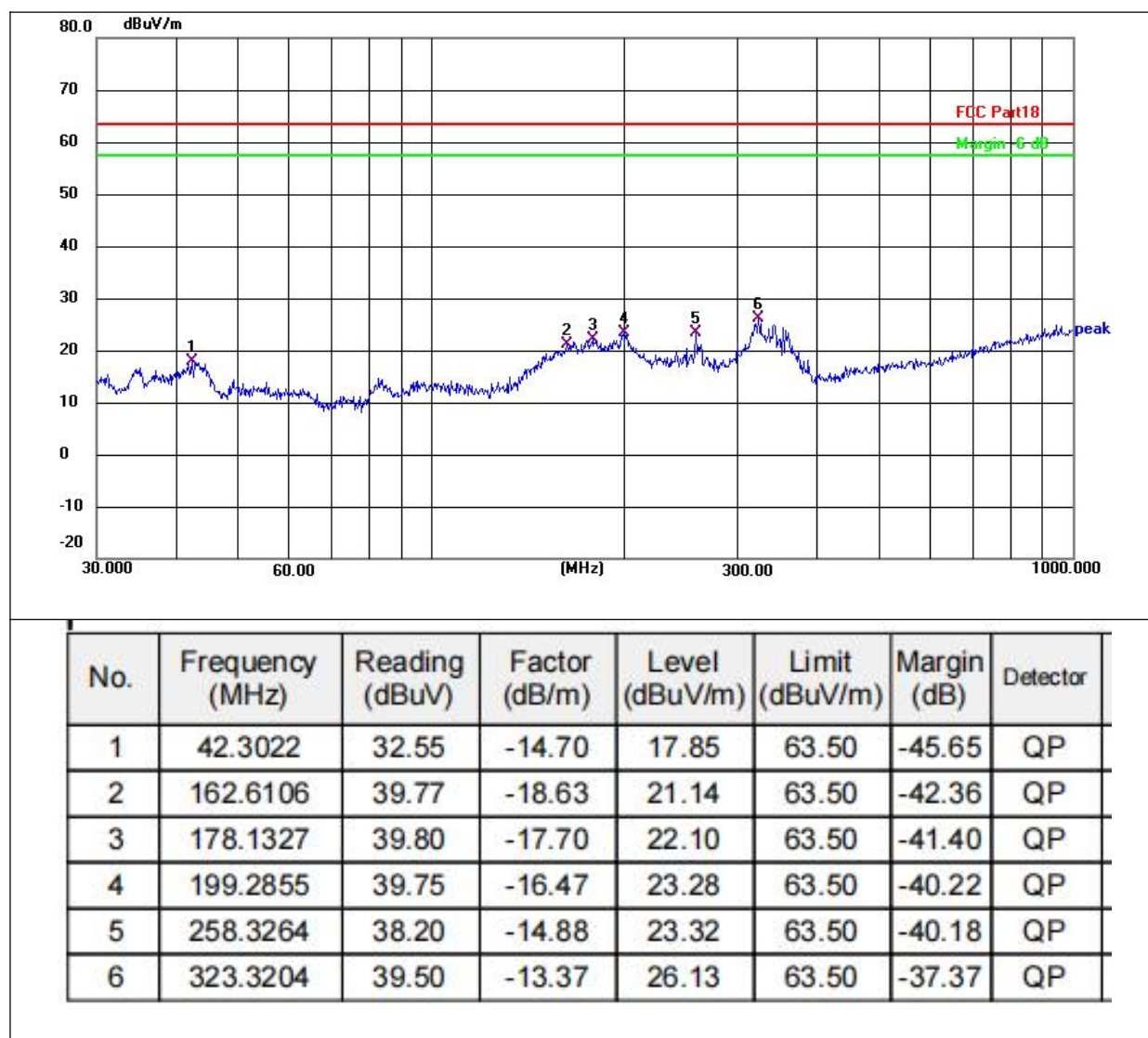

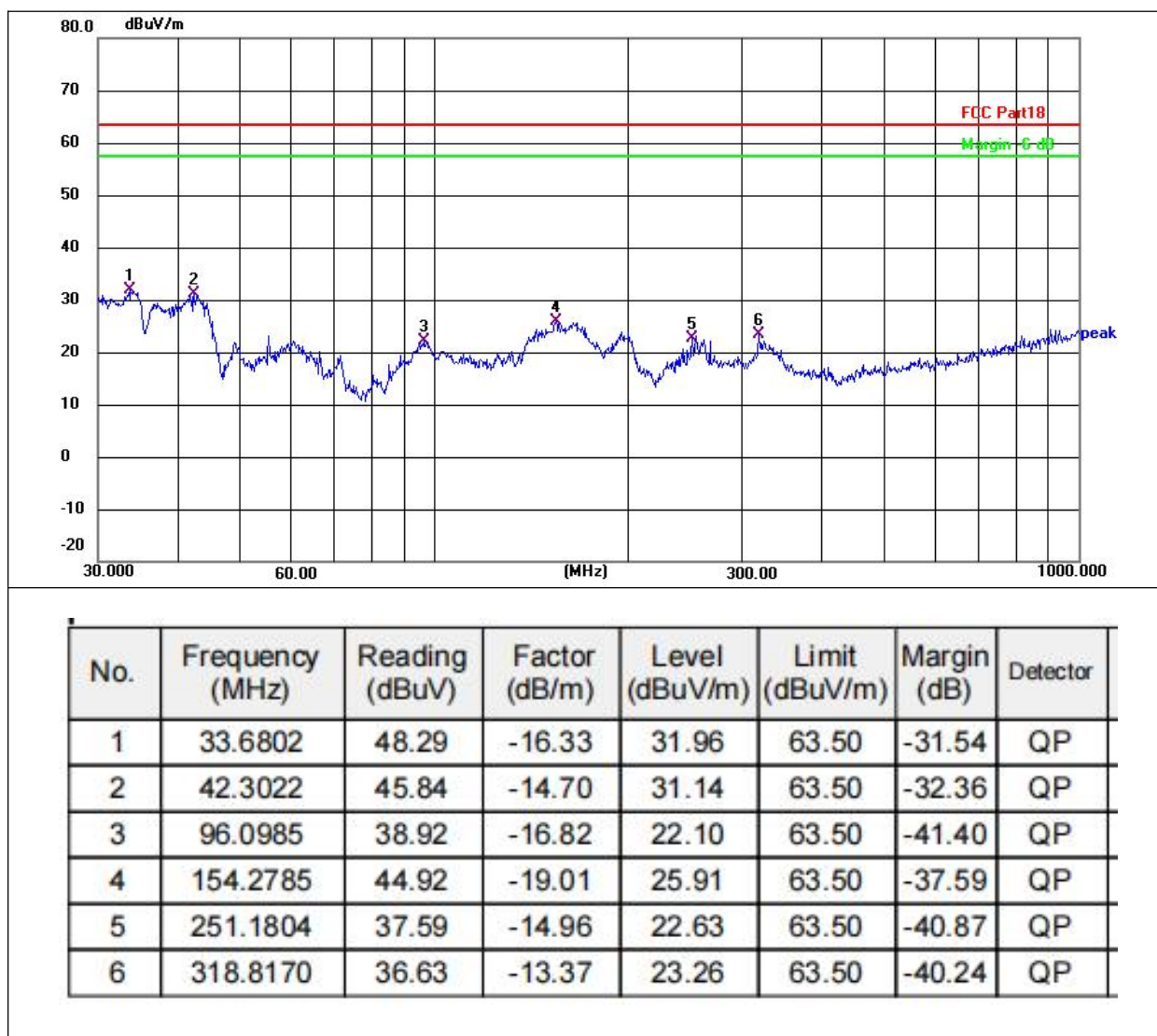
