本产品是基于蓝牙5.0/5.2，通过蓝牙自拍器按键远程控制手机相机拍照功能，从而实现远程控制手机拍照。本产品同时兼任安卓，苹果系统。无需切换，连上蓝牙即可实现拍照及录视频功能。

使用操作：

- 1：长按按键开机，蓝灯闪烁。
- 2：打开手机“设置”，找到“蓝牙”，搜索到蓝牙设备名：AB Shutter3。
- 3：手机打开“相机”，单击自拍器按键，即可实现拍照。

User Manual of Self timer

This product is based on Bluetooth 5.0/5.2. It can remotely control the camera photographing function of the mobile phone through the button of the Bluetooth self timer, thus realizing remote control of the mobile phone photographing. This product also serves as Android and Apple systems. You can take photos and record videos by connecting Bluetooth without switching.

Operation:

- 1: Press and hold the key to start the machine, and the blue light flashes.
- 2: Open the mobile phone "Settings", find "Bluetooth", and search for the Bluetooth device name: AB Shutter3.
- 3: Turn on "Camera" and click the self timer button to take pictures.
