




4.2 ACCOUNT REGISTRATION AND LOGIN

 4. Welcome to your home (you can set your own name for your home) (Figure 3).




4.3 STARTING UP THE DEVICE

- 3. After the PTZ self-test is successful, if you hear the voice prompt "waiting for network configuration" then the device has been successfully started up.


4.4 CONNECTING THE APP WITH THE DEVICE

 2. Enter the device connection interface, click "Connect", as shown in (Figure 6).




