

**Note:** Music playback is paused during call functions and resumes when the calls ended.



# How to use:

### A. Charge:

- Connect the Type-C charging cable to the headphone and a USB source;
- 2. The LED lights blue when fully charged.

#### **B. 2.4GHZ CONNECTION:**

- 1. When the headsets is turned on, the default connection is on 2.4GHz mode.
- 2. Insert 2.4GHz dongle to your device. The headsets will be automitically detected.

#### C. BLUETOOTH CONNECTION

- 1. Press and hold the MODE button to switch to Bluetooth mode.
- 2.On your device, turn on the Bluetooth function, and set it to search for Bluetooth devices.
- 3. Select (WD-GT08) from the list of found devices.
- 4. When paired, the LED light blue.

### Note:

During pairing, if the headets are not connected to a device within
5 minutes, they automatically turn off.
