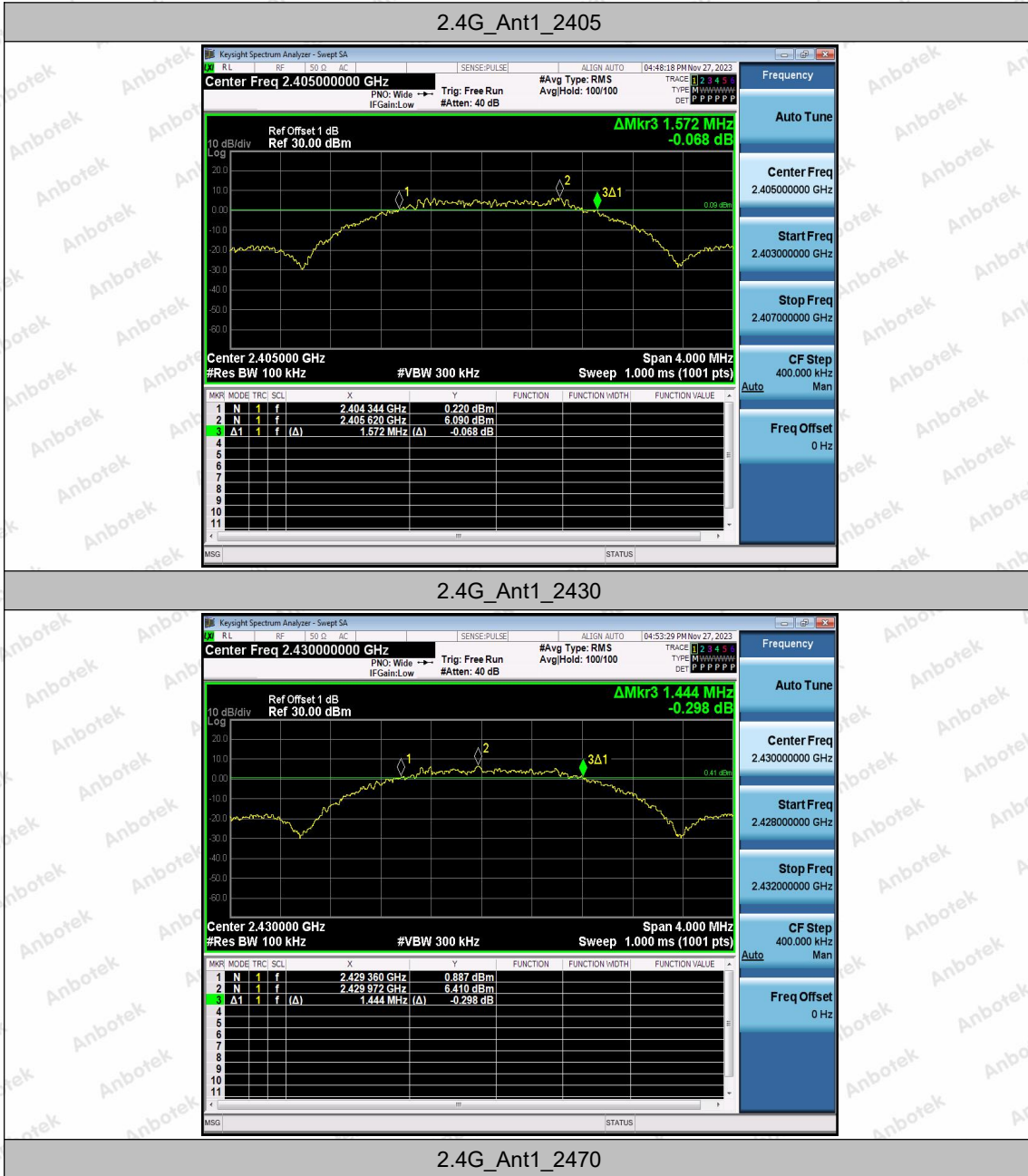

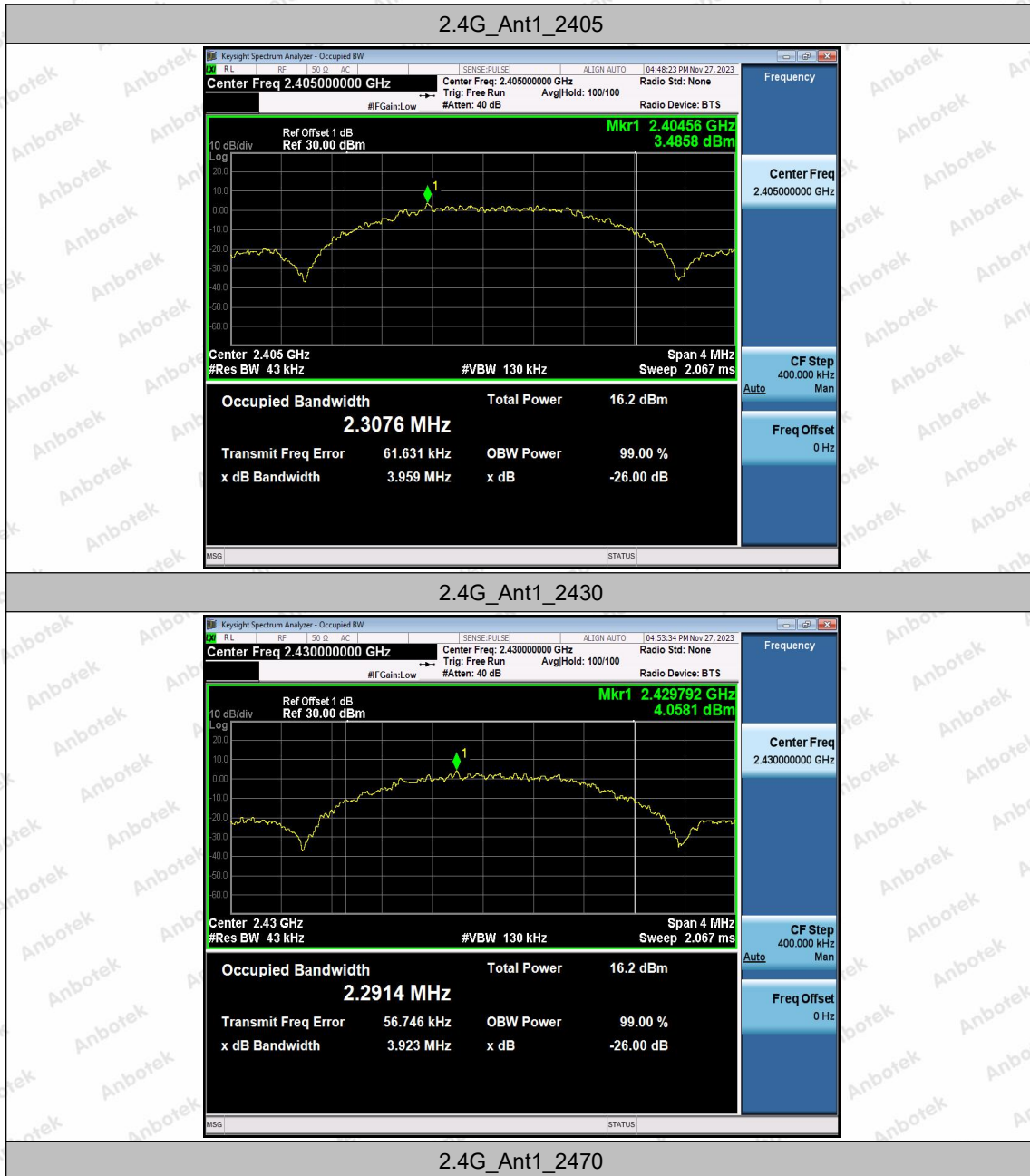

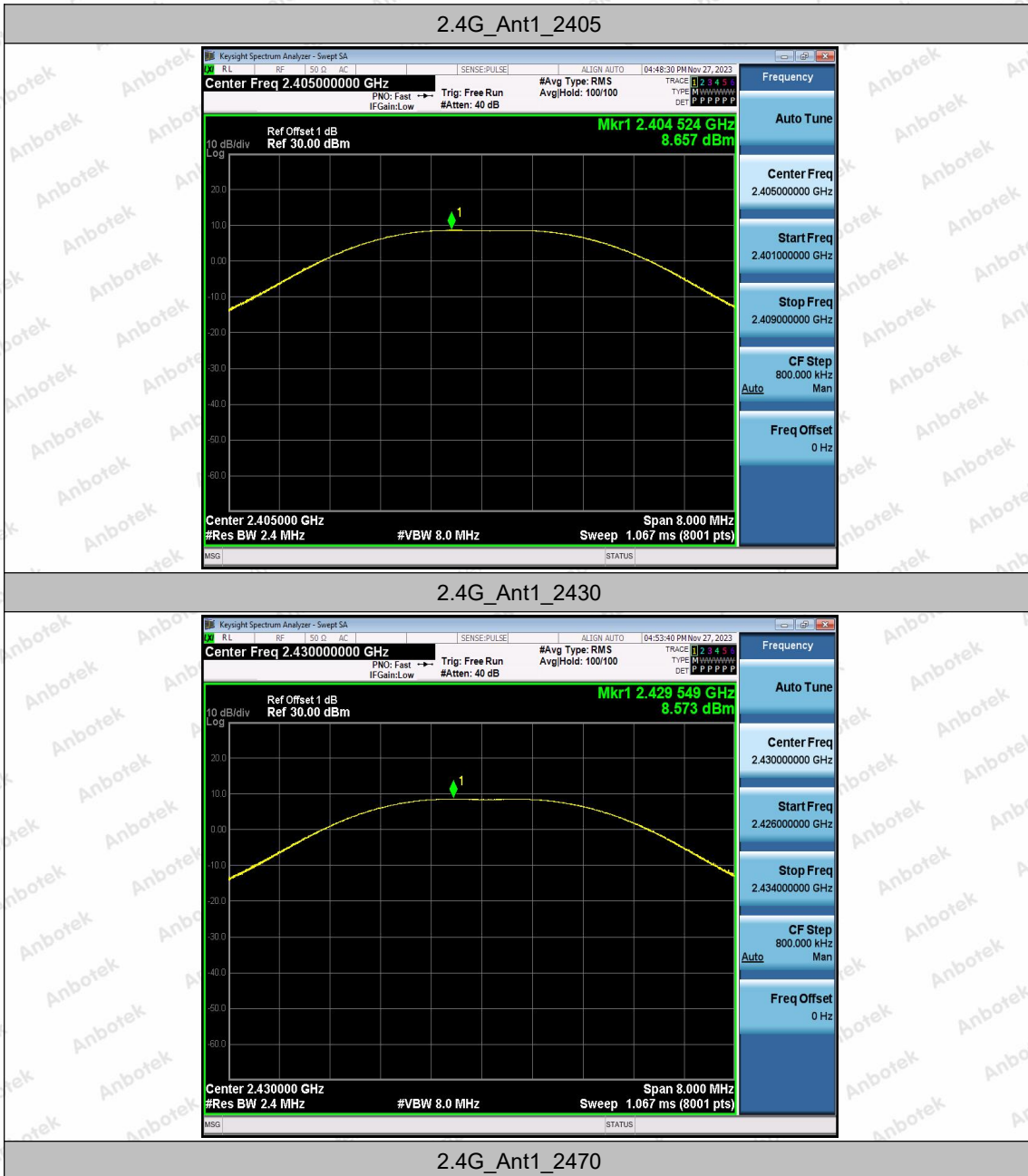

Test Graphs Peak

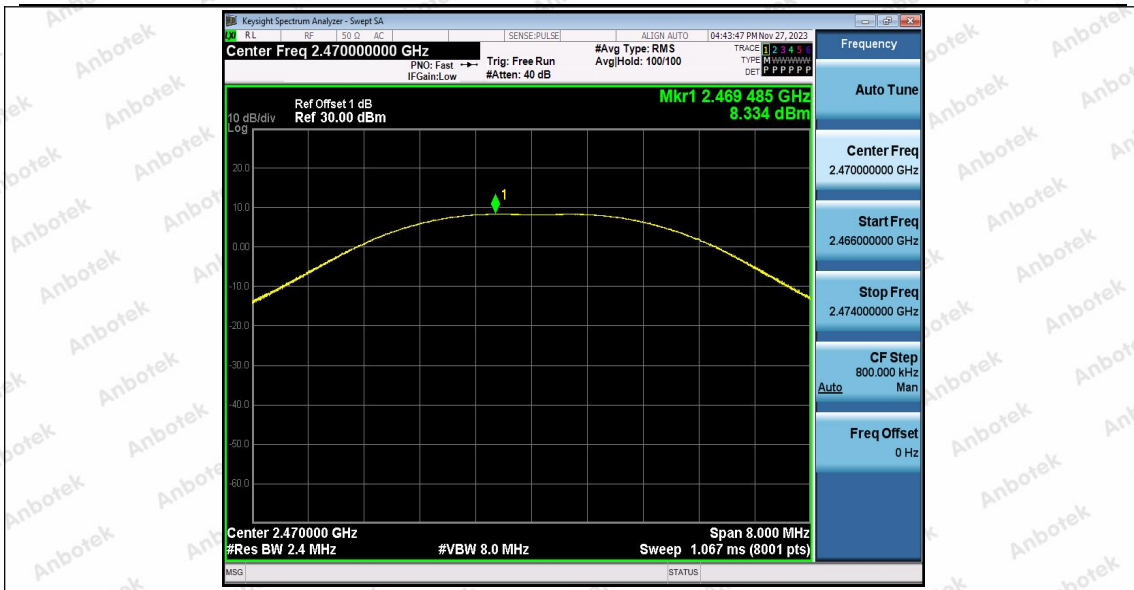
