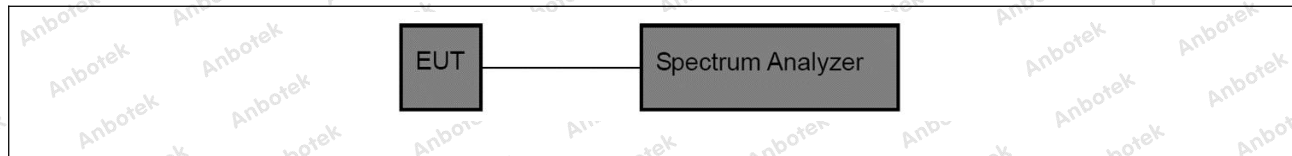
5. Maximum Conducted Output Power
