## 2. Antenna requirement

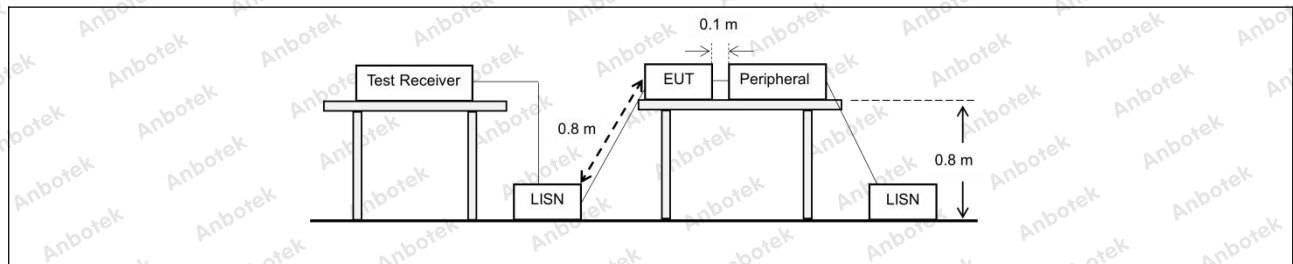

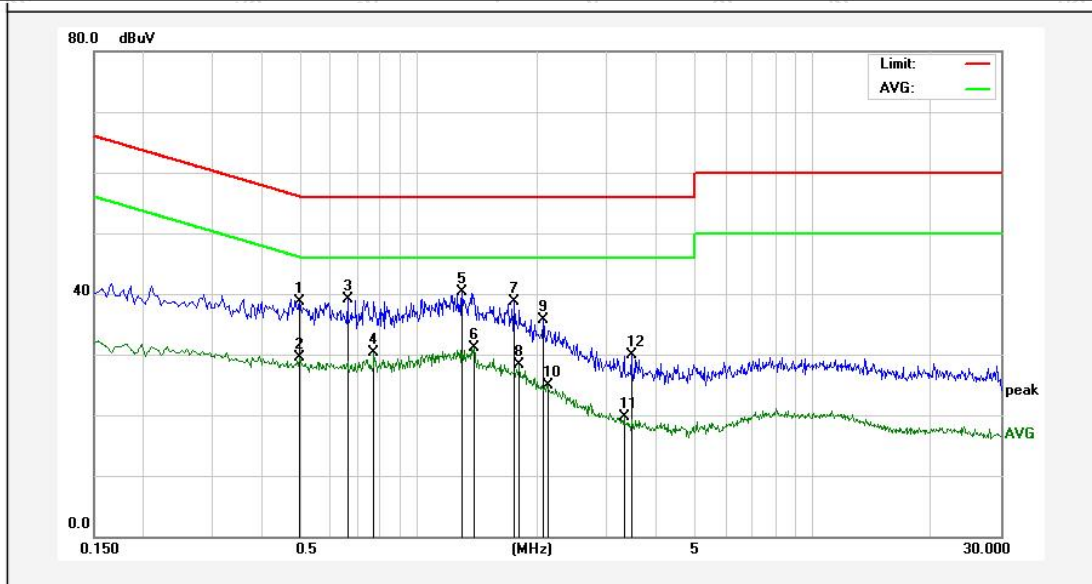

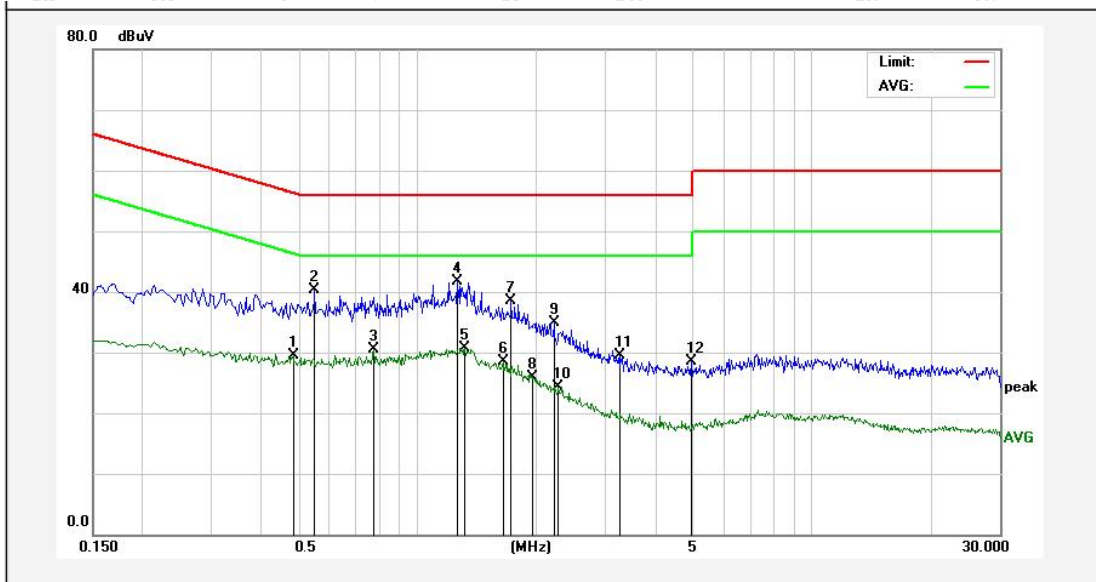

## 4. Occupied Bandwidth

Test Requirement:	47 CFR 15.215(c)

If the device has a multiple transmissions per hop then the dwell time is measured from the start of the first transmission to the end of the last transmission.</p> <p>The time of occupancy is the total time that the device dwells on a channel over an observation period specified in the regulatory requirement. To determine the time of occupancy the spectrum analyzer will be configured to measure both the dwell time per hop and the number of times the device transmits on a specific channel in a given period.</p> <p>The EUT shall have its hopping function enabled. Compliance with the requirements shall be made with the minimum and with the maximum number of channels enabled. If the dwell time per channel does not vary with the number of channels then compliance with the requirements may be based on the minimum number of channels. The trigger level might need adjustment to reduce the chance of triggering when the system hops on an adjacent channel.</li> <li>e) Detector function: Peak.</li> <li>f) Trace: Clear-write, single sweep.</li> <li>g) Place markers at the start of the first transmission on the channel and at the end of the last transmission. 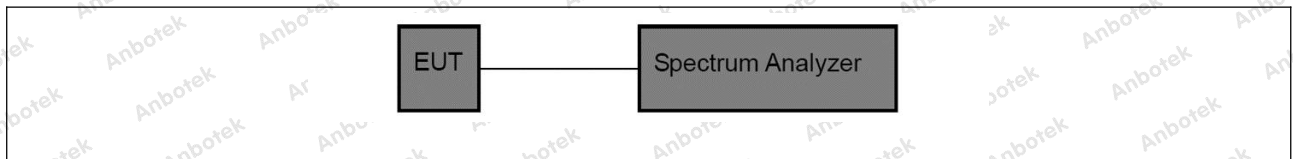


	<p>these two markers.</p> <p>To determine the number of hops on a channel in the regulatory observation period repeat the measurement using a longer sweep time. When the device uses a single hopping sequence the period of measurement should be sufficient to capture at least 2 hops.
