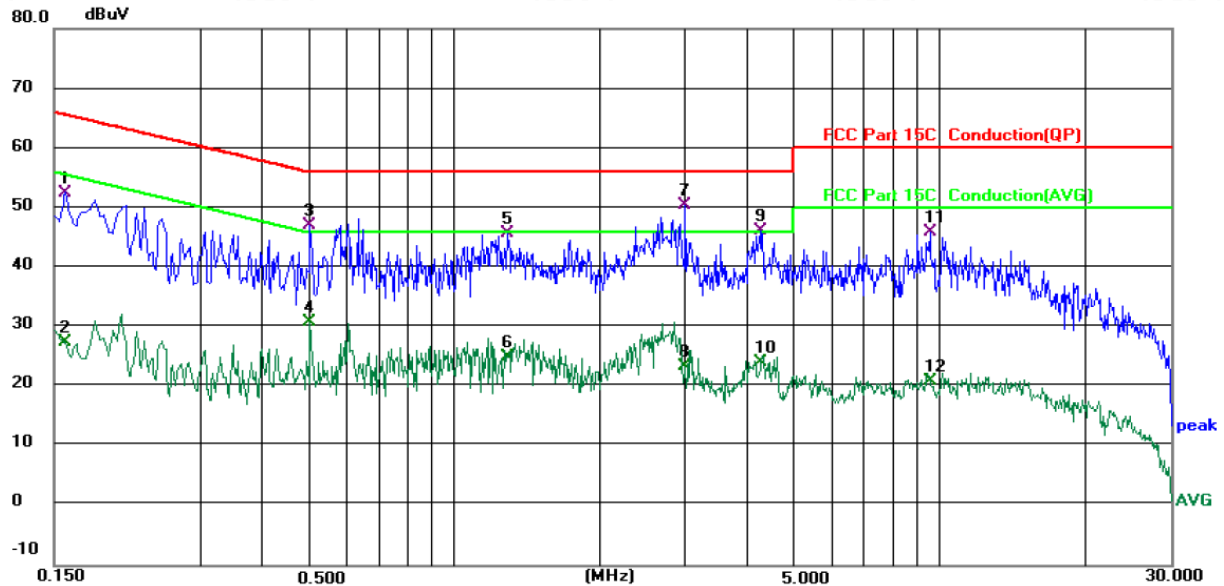

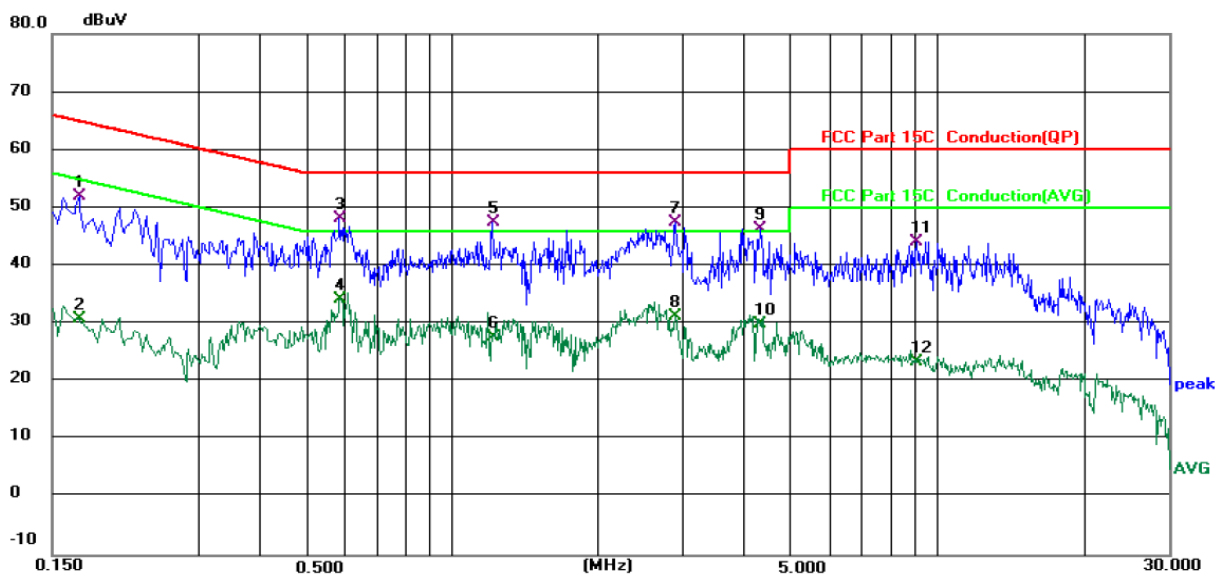

### Test Procedure:

1. For the radiated emission test below 1GHz:  
The EUT was placed on a turntable with 0.8 meter above ground. The EUT was set 3 meters from the interference receiving antenna, which was mounted on the top of a variable height antenna tower. The EUT was arranged to its worst case and then tune the antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading. For the radiated emission test above 1GHz:

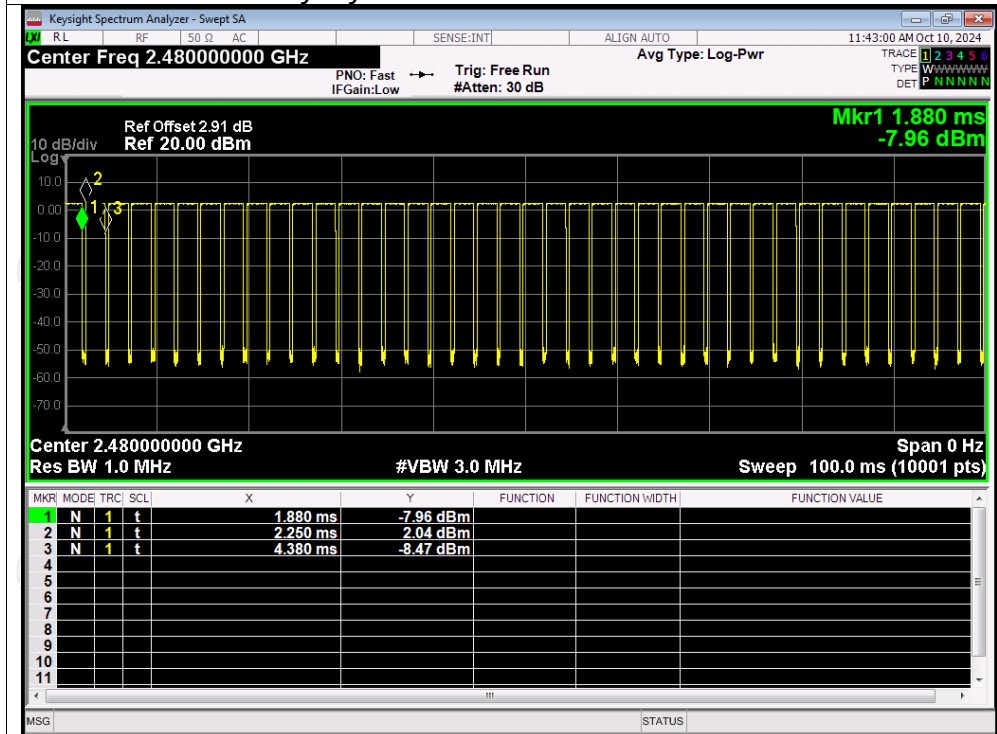
### Test Graphs Duty Cycle NVNT BLE 1M 2402MHz



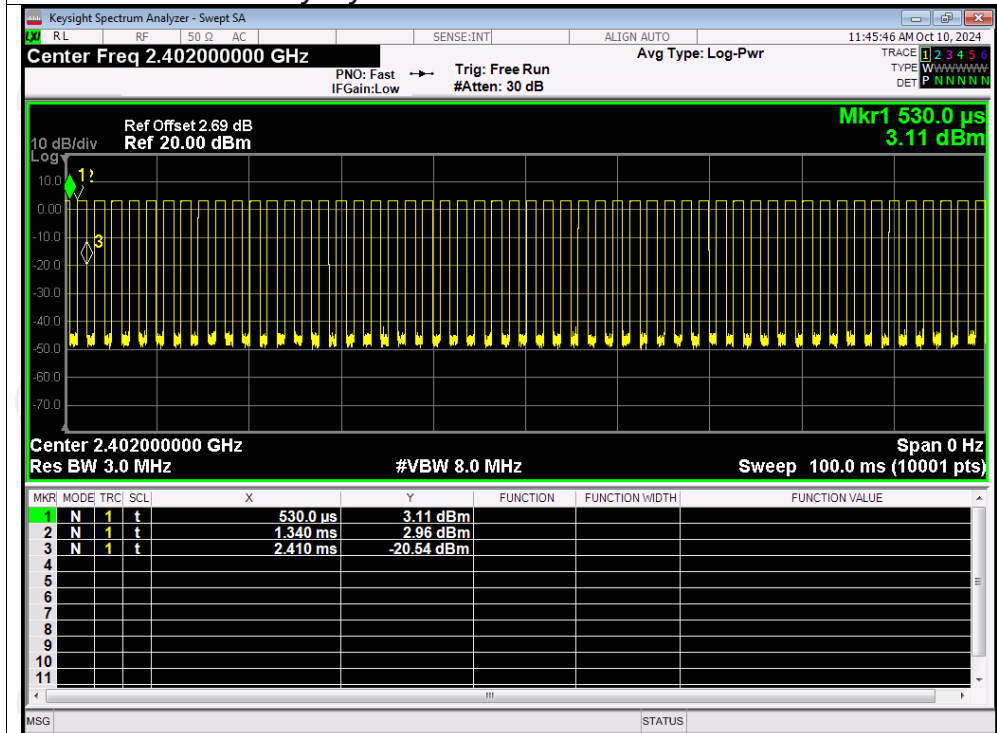
### Duty Cycle NVNT BLE 1M 2440MHz



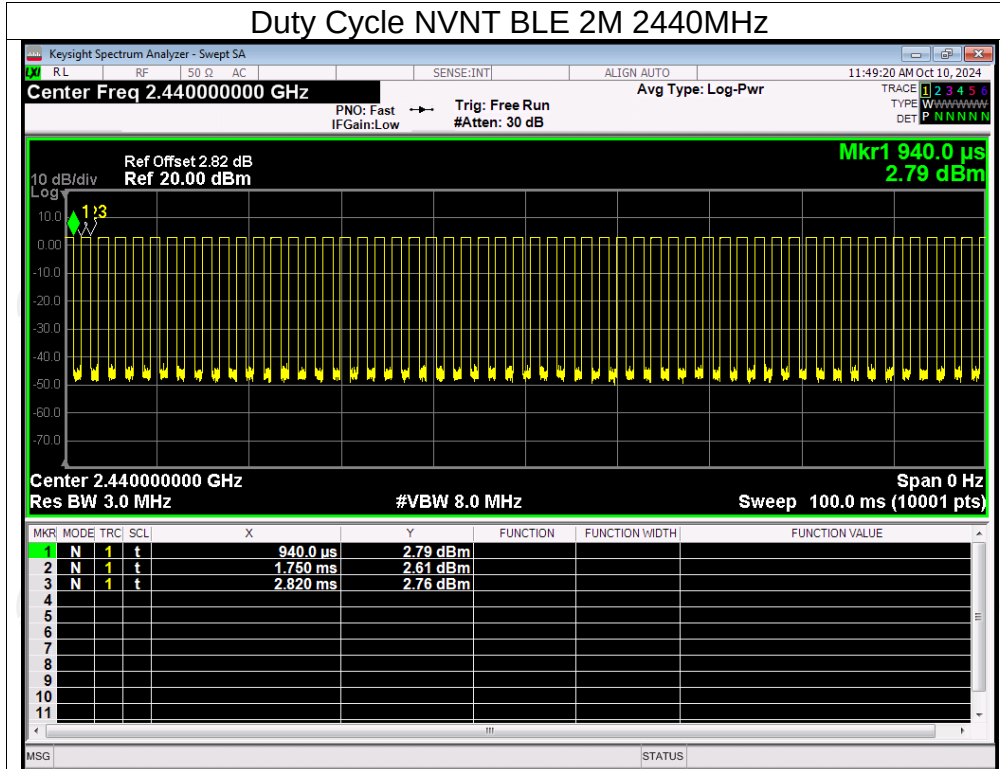

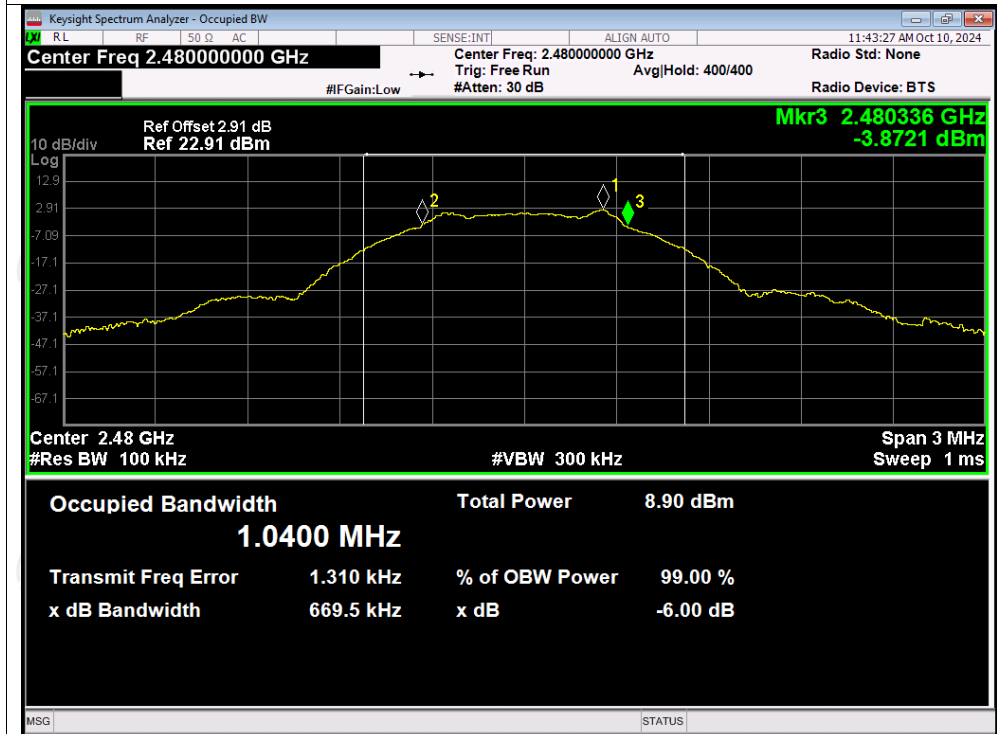
#### -6dB Bandwidth NVNT BLE 1M 2402MHz



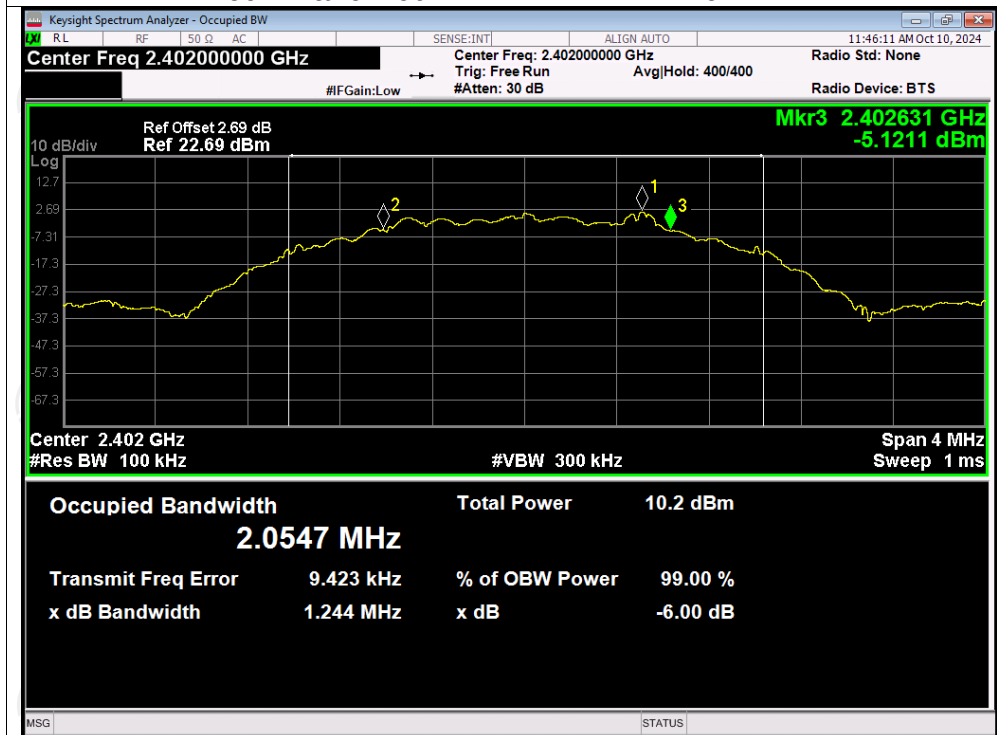

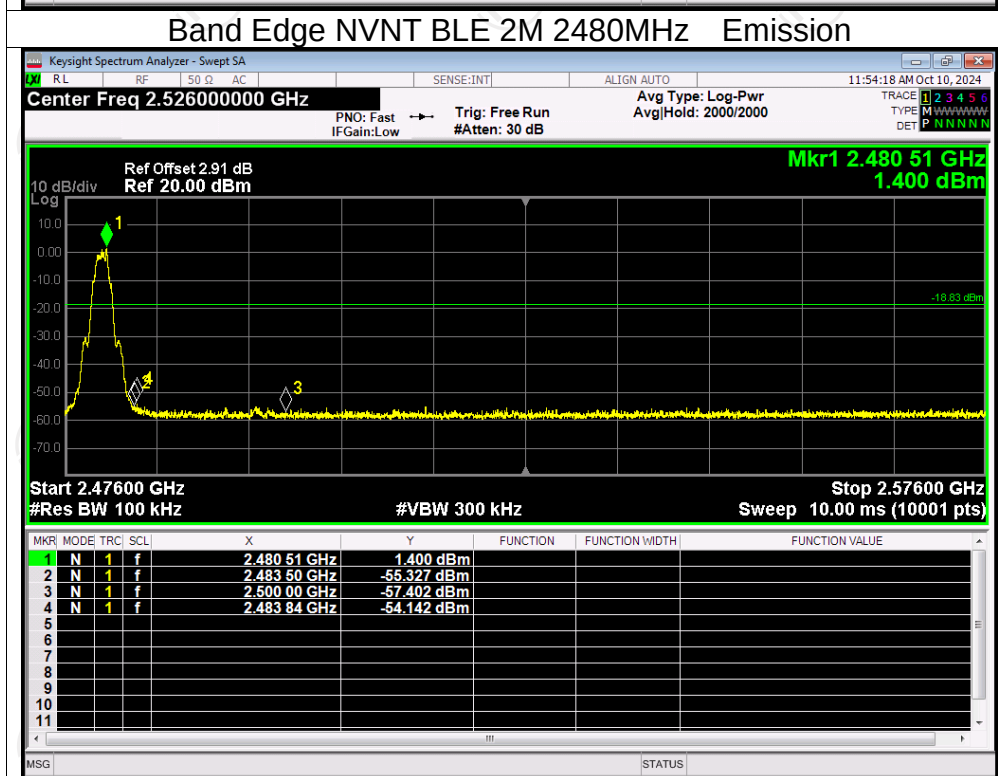
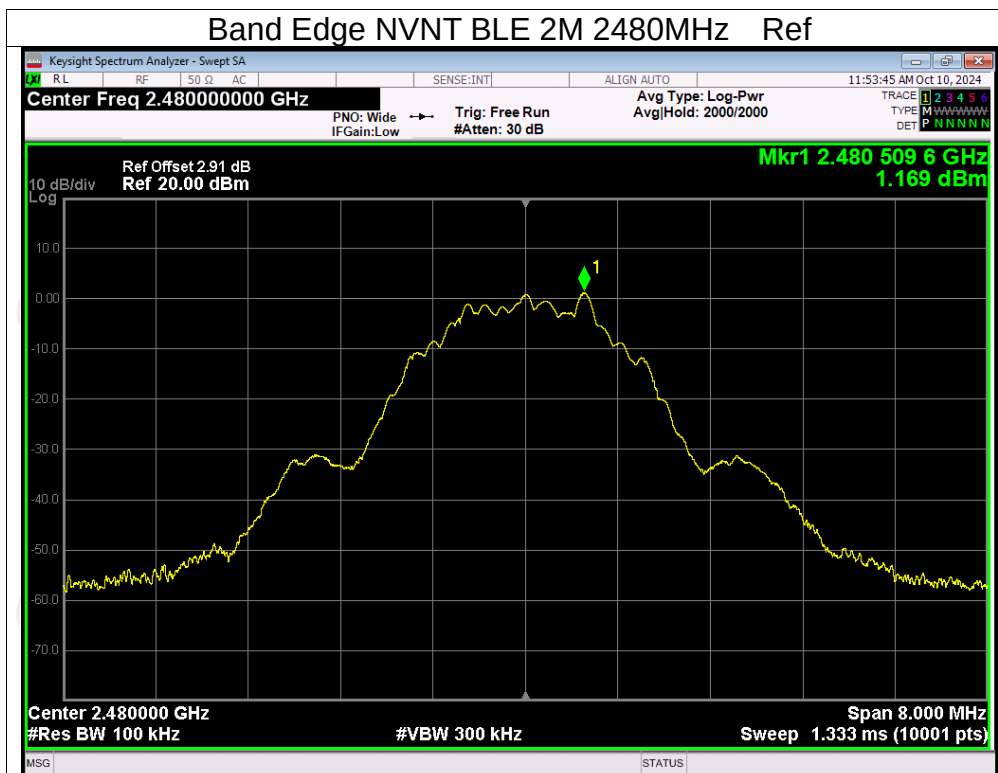


### Band Edge NVNT BLE 1M 2402MHz Emission







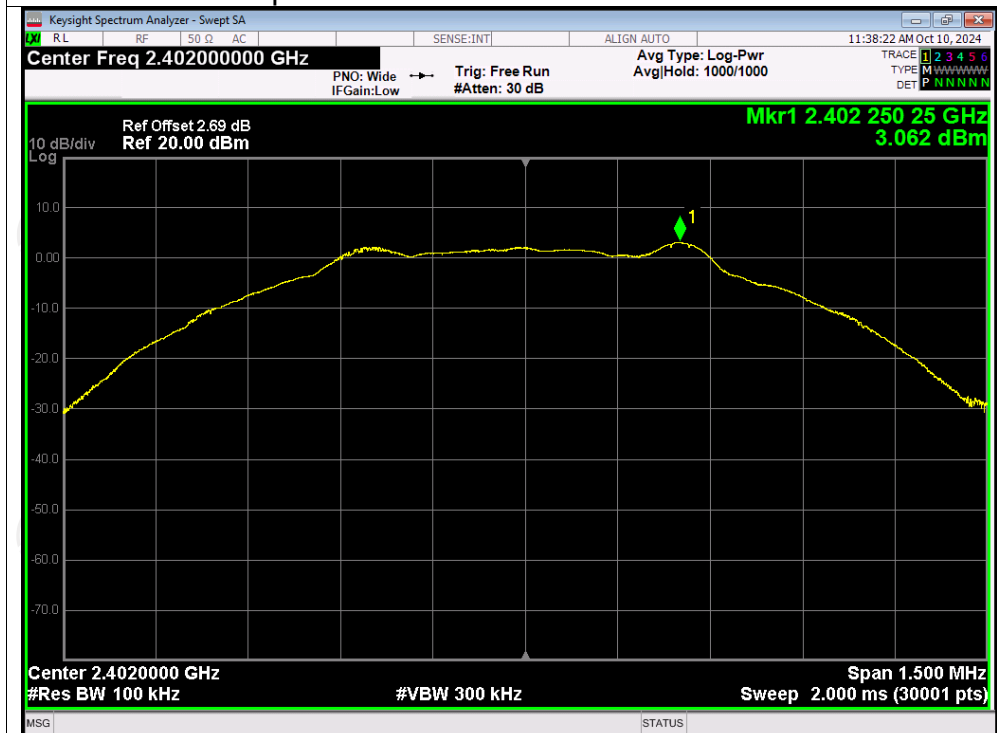

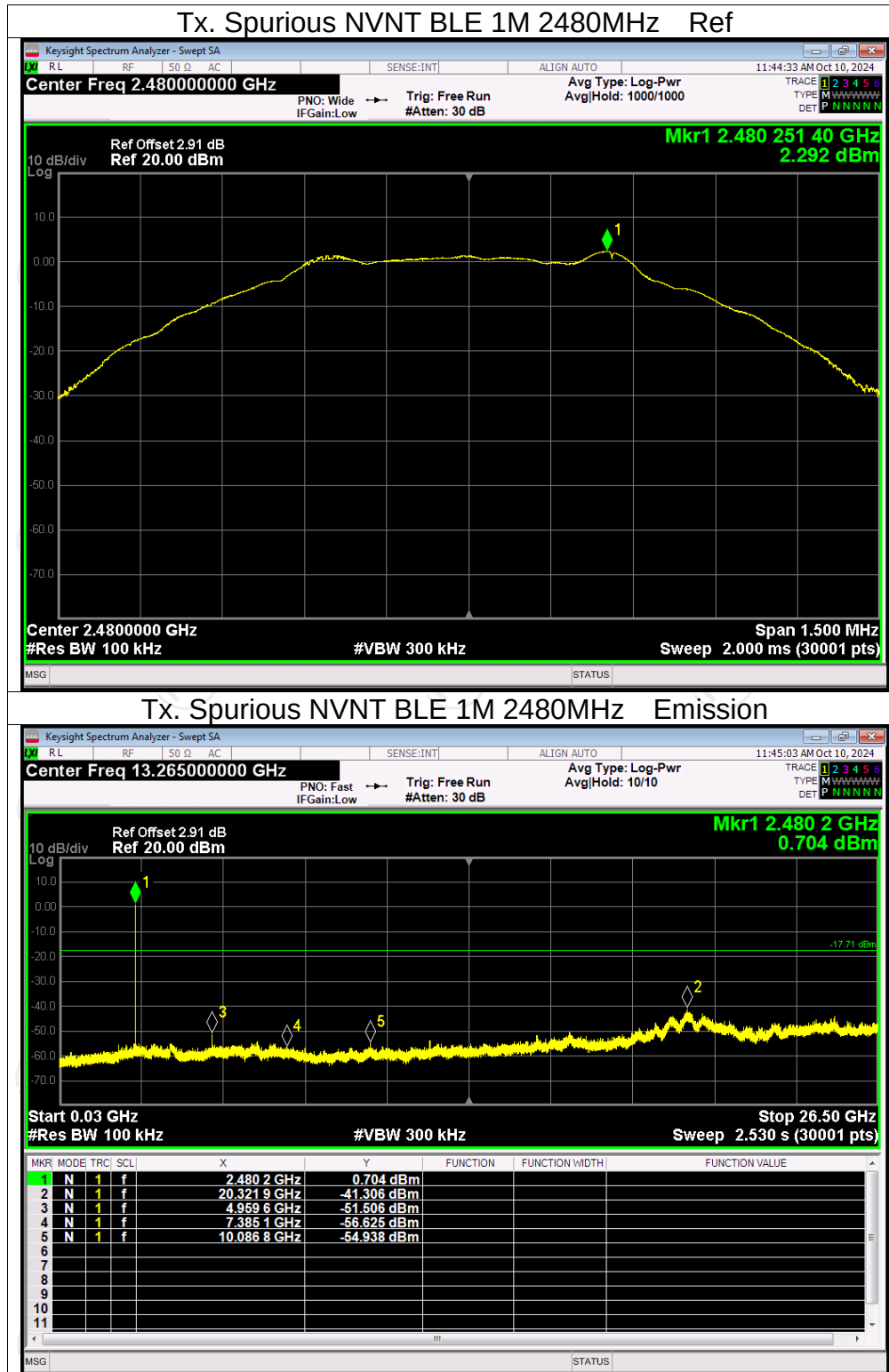
#### Tx. Spurious NVNT BLE 1M 2402MHz Ref



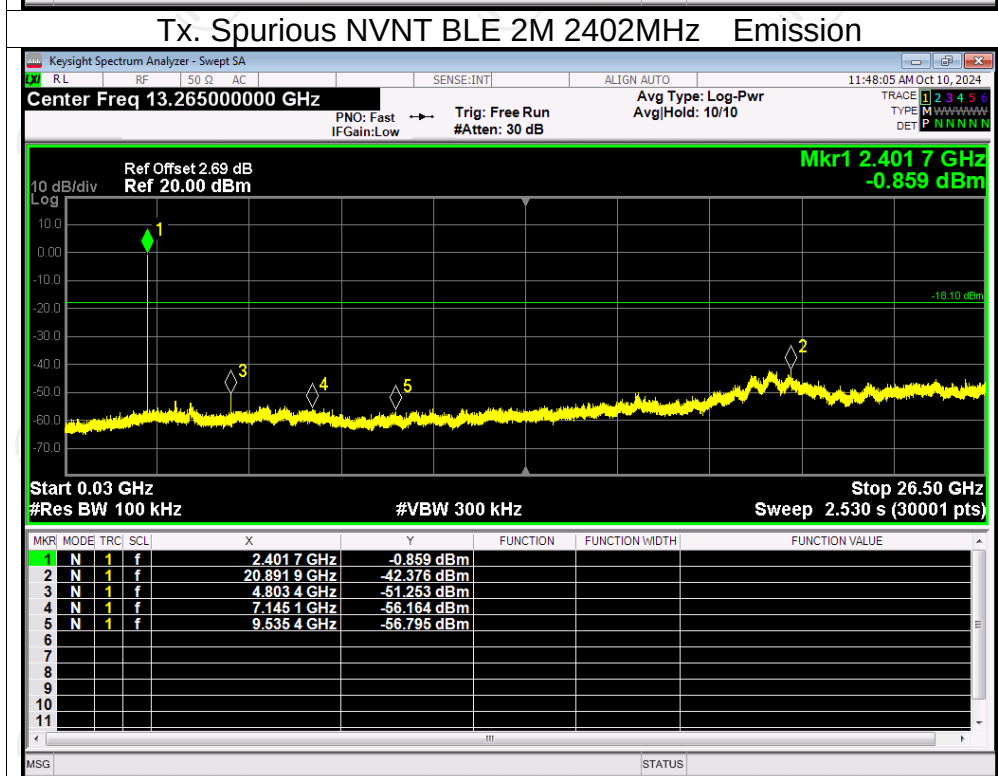
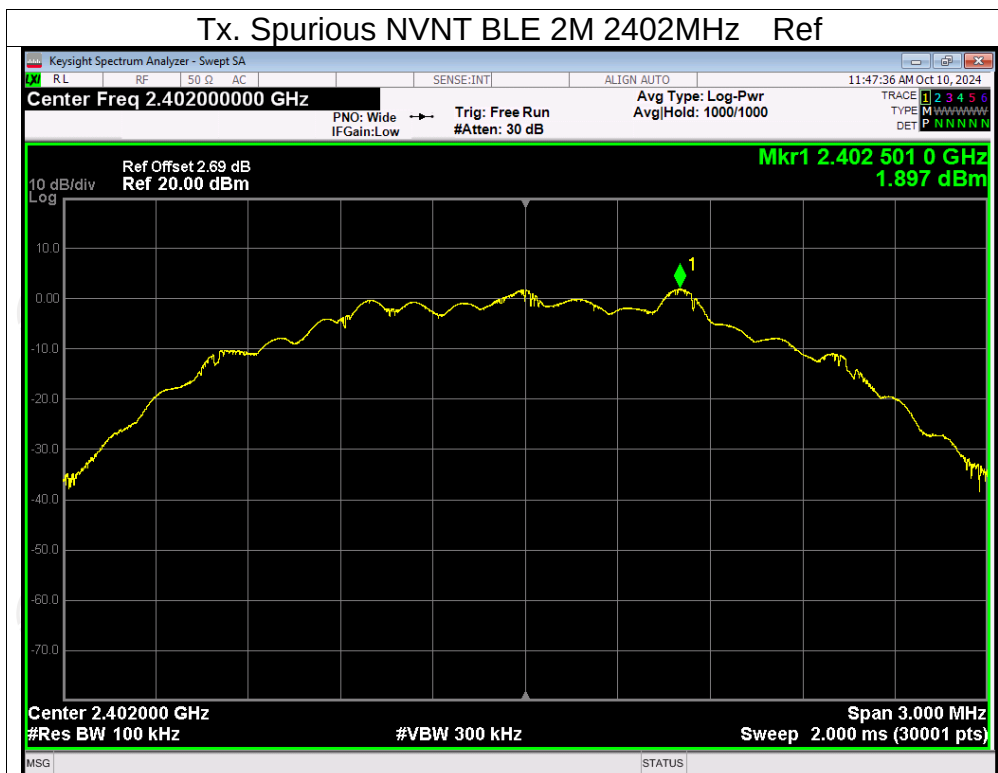
