





Overview



Power on/off

Auto power on: Take out the earphones, and the earphones will power on automatically and enter pairing mode, waiting to connect to the phone.

Manual power on: If the earphones are not in the charging case and are off, press and hold both earphones for 3s to power them on.

Auto power off:


1. Put the left and right earphones into the charging case, and close the charging case, it will automatically power off and charge.

2. The earphones will automatically power off when it is not connected to the device for 5mins.

Manual power off: If the earphones are on and connected to each other, press and hold either earphones for 5s to power them off.

Pairing mode

① Take the earphones out of the charging case, when successfully connected, the main headset will flash white and the secondary headset light will go out.



② The earphones in the pairing mode, select Netac OS01 for pairing in the mobile BT menu.

③ After successful connection, there is a reminder.

Music

▶ Play/Pause: Click the touch zone while playing.
 ▶ Previous song: Double-click the left earphones touch zone.
 ▶ Next song: Double-click the right earphones touch zone.

Volume

◀+ Volume up: Triple click the left earphones touch zone.
 ▶- Volume down: Triple click the right earphones touch zone.

Call

Answer: Double-click the touch zone when an incoming call comes in.
 Reject: Long press the touch zone for 2s during an incoming call.
 Hang up: Double-click the touch zone during a call.

Active the voice assistance

Press and hold the left ear touch zone for 2s to wake up/exit the voice assistant.

Charge

① Charge the charging case through the charging cable, the charging case indicator light is always on when charging is complete.


② The earphones are put into the charging case and charged automatically, the earphones indicator light is off when charging is complete.






开机 / 关机

自动开机: 取出耳机, 此时耳机自动开机匹配, 等待连接手机。
手动开机: 耳机不在充电仓里并且耳机是关机的状态, 长按左右耳机3秒开机。
自动关机: 1. 将左右耳机放入充电仓, 关上充电仓上盖, 会自动关机并充电。
 2.5分钟未连接设备状态下, 耳机会自动关机。

手动关机: 如果耳机处于开机并且相互连接状态, 长按任意一只耳机5秒关机。

蓝牙配对

① 打开充电仓, 取出耳机自动开机。



② 开机后将左右耳机贴近, 组队成功后指示灯: 主耳机为白灯闪烁, 副耳机灯熄灭。

③ 打开手机蓝牙界面, 搜索“Netac OS01”, 点击配对, 连接成功并伴有提示音。
