1. Applicable Standards

1.2. MPE Calculation Method

E (V/m) =
$$\frac{\sqrt{30 \times P \times G}}{d}$$
 Power Density: Pd (W/m²) =

E = Electric Field (V/m)

P = Peak RF output Power (W)

G = EUT Antenna numeric gain (numeric)

d = Separation distance between radiator and human body (m)

The formula can be changed to

$$\mathsf{Pd} = \frac{30 \times \mathsf{P} \times \mathsf{G}}{377 \times \mathsf{d}^2}$$

From the peak EUT RF output power, the minimum mobile separation distance, d=0.2m, as well as the gain of the used antenna, the RF power density can be obtained
