Smart Prado Dual Mode DM915 Baby Monitor

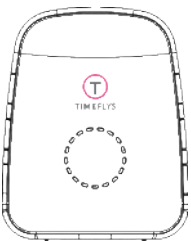
QUICK SET UP :

1. Plug parent & baby units with type C power cords, make sure your baby units and parent unit are more than 6 feet (2 meters) apart to avoid screeching noise.
(Parent Unit: Pre-installed with lithium rechargeable battery, please fully charge before use)
(Baby Unit: Please connected with AC power when in use!)
2. Power on both units and tune to same channel
(Channel A or B).
3. Place the baby unit more than 3 feet (1 meter) away from your baby. Do not place this product on an unstable table, shelf, stand or other unstable surfaces. When power on, you could hear baby's sound via parent unit.
4. Download our APP (Please read the guideline at the back) and get connected with baby unit in video mode, you could monitor baby with APP on your phone anywhere.

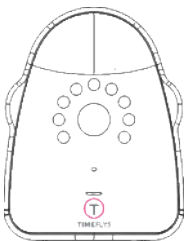

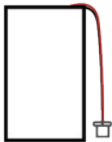

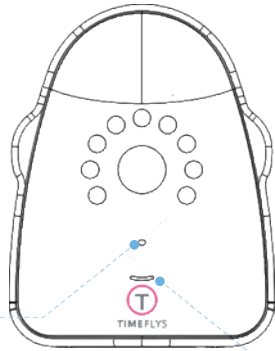
Safety Instructions

Quick Set Up

1. Plug parent & baby unit with type C power cords or install 1.5V AAA alkaline battery[^] or 1.2V AAA NiMH rechargeable battery*, make sure your baby unit and parent unit are more than 6 feet (2 meters) apart to avoid screeching noise.

2. Power on both units. Both units turn to same channel (channel A or B).



3. Place the baby unit more than 3 feet (1 meter) away from your baby. Do not place this product on an unstable table, shelf, stand or other unstable surfaces. When power on, you could hear baby's sound via parent unit.

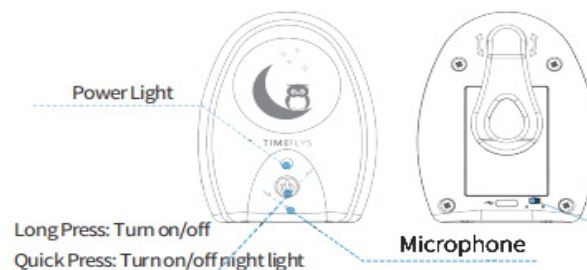
4. If no sound/have interference, please turn off both units, and repeat set up procedure 1 – 3 above.

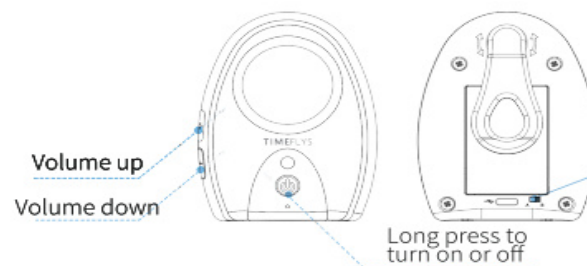

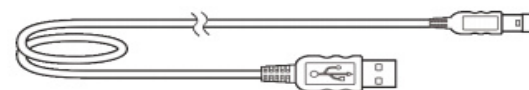
