



That the default working time of startup is 15 minutes, and it will be automatically power off when the time finishes. If you need to continue to use it, press the on / off mode button again.

Do not wash this product with alcohol or corrosive liquid. When the product breaks down, please ask professional technicians to repair it. Do not disassemble the product by yourself.


Collection

After using, please put the product in a safe place, put it into a bag, and put it in the packing box.

Please do not place heavy objects on the product to avoid moisture and contamination.



- (Rotate the product to the angle shown in the figure below to expose the type-C charging interface, and then insert the charging plug into the charging hole of the product.
- Plug the charger plug into a 100-240V ~, 50 / 60Hz power outlet.
- Ø After the charger is powered on, the red light of the battery indicator is on.
- It takes about 3-5 hours to fully charge the battery, and the green light on the battery indicator light will illuminate after it is fully charged.

Power button

- POWER DUITON 1. Press and hold for 2 seconds to start / standby; 2. There are four modes, which can be switched by short pressing; 1) Beautiful eye mode: air pressure (moderate), vibration, hot compress on, air pressure, hot compress, vibration, battery function display light on, cyan light; 2) Eye protection mode: air pressure (moderate), hot compress on, air pressure, hot compress, battery
