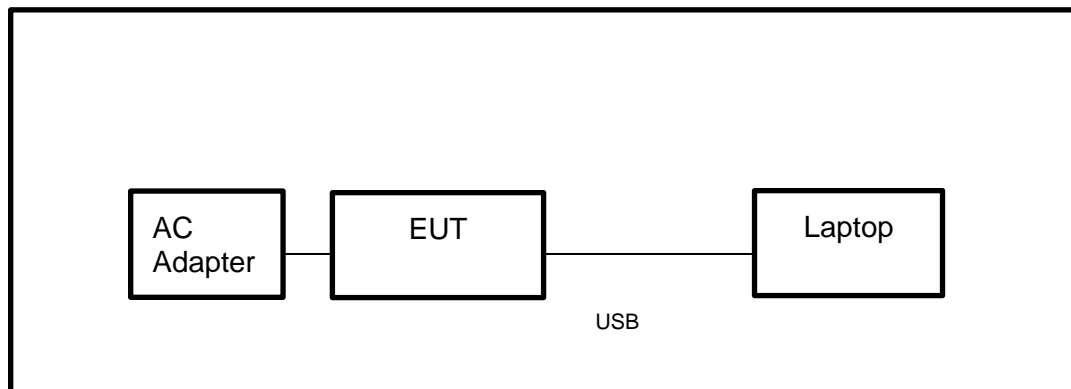

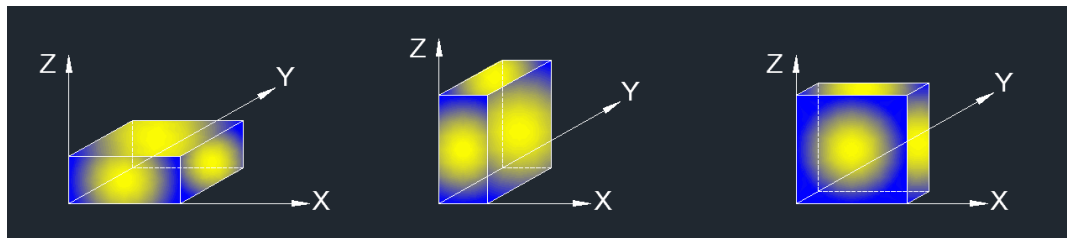

TEST PROCEDURE
