















7. Maximum Conducted Output Power

7.1 Standard and Limit

According to 15.247(b)(3). For systems using digital modulation in the 902–928 MHz, 2400–2483.5 MHz, and 5725–5850 MHz bands: 1 Watt. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted output power. Maximum Conducted Output Power is defined as the total transmit power delivered to all antennas and antenna elements averaged across all symbols in the signaling alphabet when the transmitter is operating at its maximum power control level. Power must be summed across all antennas and antenna elements. The average must not include any time intervals during which the transmitter is off or is transmitting at a reduced power level. If multiple modes of operation are possible (e.g., alternative modulation methods), the *maximum conducted output power* is the highest total transmit power occurring in any mode.

7.2 Test Procedure

A spectrum analyzer or similar device shall be used to observe a sample of the modulated transmitter's radio frequency power output.

- 1) A measurement instrument with an integrated channel bandwidth function may be used to automate the test process.
- 2) Set center of frequency = operating frequency.
- 3) Connect the EUT to the RF input of the spectrum analyzer via a low loss RF cable
- 4) Set the RBW = 1MHz, VBW = 3MHz, Detector = RMS, Sweep = Auto.
- 5) Set the SPAN to 40MHz/80MHz for 20MHz/40MHz emission bandwidth mode.
- 6) Measure the highest amplitude appearing on spectral display and mark the value.
- 7) Repeat the above procedures until all frequency measured was complete.




According to 15.247(a)(2), Systems using digital modulation techniques may operate in the 902–928 MHz, 2400–2483.5 MHz, and 5725–5850 MHz bands. The minimum 6 dB bandwidth shall be at least 500 kHz.

- 4) Set a reference level on the measuring instrument equal to the highest peak value.
- 5) Measure the frequency difference of two frequencies that were attenuated 6dB from the reference level. Record the frequency difference as the emission bandwidth.
- 6) Repeat the above procedures until all frequencies measured were complete.




Test Setup Block Diagram




9.1 Standard and Limit

According to FCC 15.247(e), For digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8dBm in any 3 kHz band during any time interval of continuous transmission. This power spectral density shall be determined in accordance with the provisions of paragraph (b) of this section. The same method of determining the conducted output power shall be used to determine the power spectral density.




Test Setup Block Diagram



10. Band-edge Emission(Conducted)

10.1 Standard and Limit

According to §15.247(d), In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. In addition, radiated emissions which fall in the restricted bands, as defined in § 15.205(a), must also comply with the radiated emission limits specified in § 15.209(a) (see § 15.205(c)).







11. Conducted RF Spurious Emissions

11.1 Standard and Limit

According to §15.247(d), In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. Attenuation below the general limits specified in § 15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in § 15.205(a), must also comply with the radiated emission limits specified in § 15.209(a) (see § 15.205(c)).
