



TEST PROCEDURE

1 The equipment was set up as per the test configuration to simulate typical actual usage per the user's manual. The EUT is a tabletop system, a wooden table with a height of 0.8 meters is used and is placed on the ground plane as per ANSI C63.10-2013.

2 Support equipment, if needed, was placed as per ANSI C63.10-2013

3 All I/O cables were positioned to simulate typical actual usage as per ANSI C63.10-2013

4 The EUT received DC5V power from adapter, the adapter received AC120V/60Hzand AC 240V/60Hz power through a Line Impedance Stabilization Network (LISN) which supplied power source and was grounded to the ground plane.

5 All support equipments received AC power from a second LISN, if any.

6 The EUT test program was started. Emissions were measured on each current carrying line of the EUT using a spectrum Analyzer / Receiver connected to the LISN powering the EUT. The LISN has two monitoring points: Line 1 (Hot Side) and Line 2 (Neutral Side). Two scans were taken: one with Line 1 connected to Analyzer / Receiver and Line 2 connected to a 50 ohm load; the second scan had Line 1 connected to a 50 ohm load and Line 2 connected to the Analyzer / Receiver.

7 Analyzer / Receiver scanned from 150 KHz to 30MHz for emissions in each of the test modes. 8 During the above scans, the emissions were maximized by cable manipulation.



Test Procedure

- 1. EUT was placed on a 1.5 meter high non-conductive stand at a 3 meter test distance from the receive antenna. A receiving antenna was placed on the antenna mast 3 meters from the EUT for emission measurements. The height of receiving antenna is 1.5m. Detected emissions were maximized at each frequency by rotating the EUT through 360° and adjusting the receiving antenna polarization. The radiated emission measurements of all test transmit frequencies were measured with peak detector.
- 2. A log-periodic antenna or double-ridged waveguide horn antenna shall be substituted in place of the EUT. The log-periodic antenna will be driven by a signal generator and the level will be adjusted till the same power value on the spectrum analyzer or receiver. The level of the spurious emissions can be calculated through the level of the signal generator, cable loss, the gain of the substitution antenna and the reading of the spectrum analyzer or receiver.
- The EUT is then put into continuously transmitting mode at its maximum power level during the test. Set 3. Test Receiver or Spectrum RBW=1MHz, VBW=3MHz, And the maximum value of the receiver should be recorded as (Pr).
- The EUT shall be replaced by a substitution antenna. In the chamber, an substitution antenna for the 4. frequency band of interest is placed at the reference point of the chamber. An RF Signal source for the frequency band of interest is connected to the substitution antenna with a cable that has been constructed to not interfere with the radiation pattern of the antenna. A power (P_{Mea}) is applied to the input of the substitution antenna, and adjust the level of the signal generator output until the value of the receiver reach the previously recorded (Pr). The power of signal source (PMea) is recorded. The test should be performed by rotating the test item and adjusting the receiving antenna polarization.
- 5. An amplifier may be connected to the Signal Source output port. And the cable should be connect between the Amplifier and the Substitution Antenna. The cable loss (Pcl) ,the Substitution Antenna Gain (G_a) and the Amplifier Gain (P_{Ag}) should be recorded after test. The measurement results are obtained as described below:

Power(EIRP)=P_{Mea+}P_{Ag} - P_{cl} + G_a

- 6. This value is EIRP since the measurement is calibrated using an antenna of known gain (2.15 dBi) and known input power.
- 7. ERP can be calculated from EIRP by subtracting the gain of the dipole, ERP = EIRP-2.15dBi. ..., E







- 1. With the Low Frequency (LF) audio signal generator set to 500 Hz, the audio input level to the EUT shall be Adjusted to 8 dB below the limiting threshold (-8dB limit) as declared by the manufacturer.
- 2. The corresponding audio output level from the demodulator shall be measured and recorded.





The frequency tolerance of the carrier signal shall be maintained within ±0.005% of the operating frequency over a temperature variation of -20 degrees to +50 degrees C at normal supply voltage, and for a variation in the primary supply voltage from 85% to 115% of the rated supply voltage at a temperature of 20 degrees C. Battery operated equipment shall be tested using a new battery.

Test Procedure

Frequency stability versus environmental temperature a)


- Setup asTest Configuration for frequencies measured at ambient temperature if it is within 15 °C to 25 °C. 1. Otherwise, an environmental chamber set for a temperature of 20°C shall be used.
- Turn on EUT and set SA center frequency to the right frequency needs to be measured. Then set SA 2. RBW to 3 kHz, VBW to 10kHz and frequency span to 500 kHz. Record this frequency to be a reference.
- Set the temperature of chamber to 50°C. Allow sufficient time (approximately 30 min) for the temperature 3. of the chamber to stabilize. While maintaining a constant temperature inside the chamber, turn the EUT on and measure the EUT operating frequency.
- Repeat step 2 with a 10°C decreased per stage until the lowest temperature -20°C is measured, record all 4. measurement frequencies.

Frequency stability versus input voltage b)

- 1. Setup asTest Configuration for frequencies measured at ambient temperature if it is within 15 °C to 25 °C. Otherwise, an environmental chamber set for a temperature of 20 °C shall be used. Install new batteries in the EUT.
- 2. Set SA center frequency to the right frequency needs to be measured. Then set SA RBW to 3kHz, VBW to 10kHz and frequency span to 500 kHz. Record this frequency to be a reference.
- 3. For non hand carried, battery operated device, supply the EUT primary voltage with 85 and 115 percent of the nominal value and record the frequency.
