The antenna is a **PCB antenna** which permanently attached, and the best case gain of the antenna is **2.54 dBi**. It complies with the standard requirement.



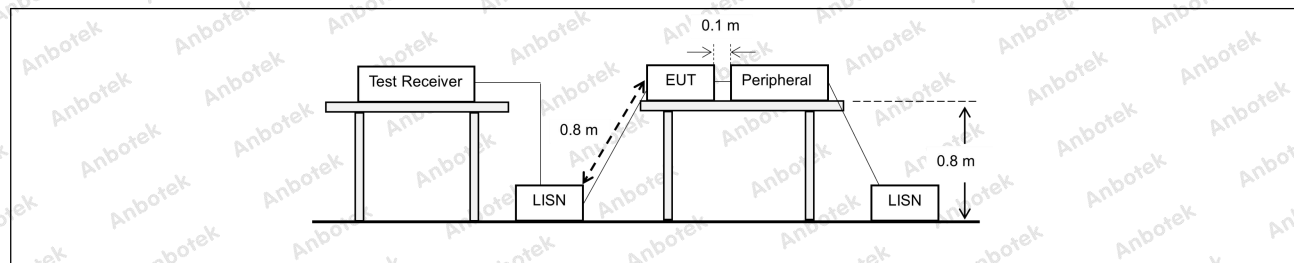
