

2.5 Receiver Input Bandwidth

The input bandwidth of the receiver is 1.3MHz, in every connection one Bluetooth device is the master and the other one is slave. The master determines the hopping sequence. The slave follows this sequence. Both devices shift between RX and TX time slot according to the clock of the master. Additionally, the type of connection (e.g. single of multi slot packet) is set up at the beginning of the connection. The master adapts its hopping frequency and its TX/RX timing according to the packet type of the connection. Also, the slave of the connection will use these settings. Repeating of a packet has no influence on the hopping sequence. The hopping sequence generated by the master of the connection will be followed in any case. That means, a repeated packet will not be send on the same frequency, it is send on the next frequency of the hopping sequence.

2.6 Equally Average Use of Frequencies and Behaviour.

The generation of the hopping sequence in connection mode depends essentially on two input values:

1. LAP/UAP of the master of the connection.
2. Internal master clock.

The LAP (lower address part) are the 24 LSB's of the 48 BD_ADDRESS. The BD_ADDRESS is an unambiguous number of every Bluetooth unit. The UAP (upper address part) are the 24MSB's of the 48BD_ADDRESS

The internal clock of a Bluetooth unit is derived from a free running clock which is never adjusted and is never turned off. For behavior action with other units only offset is used. It has no relation to the time of the day. Its resolution is at least half the RX/TX slot length of 312.5us. The clock has a cycle of about one day(23h30).

In most case it is implemented as 28 bits counter. For the deriving of the hopping sequence the entire. LAP (24 bits),4LSB's(4bits) (Input 1) and the 27MSB's of the clock (Input 2) are used. With this input values different mathematical procedures (permutations, additions, XOR-operations) are performed to generate the Sequence. This will be done at the beginning of every new transmission.

Regarding short transmissions the Bluetooth system has the following behavior:

The first connection between the two devices is established, a hopping sequence was generated. For Transmitting the wanted data the complete hopping sequence was not used. The connection ended.

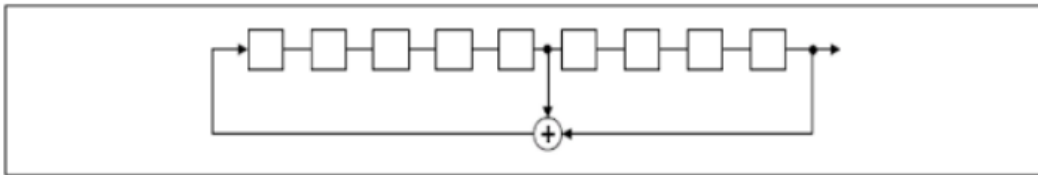
The second connection will be established. A new hopping sequence is generated. Due to the fact the Bluetooth clock has a different value, because the period between the two transmission is longer (and it Cannot be shorter) than the minimum resolution of the clock(312.5us). The hopping sequence will always differ from the first one.

2.7 Pseudorandom Frequency Hopping Sequence

The pseudorandom sequence may be generated in a nine-stage shift register whose 5th and 9th stage outputs are added in a modulo-two addition stage. And the result is fed back to the input of the first stage. The sequence begins with the first ONE of 9 consecutive ONES; i.e. the shift register is initialized with nine ones.

- Number of shift register stages: 9
- Length of pseudo-random sequence: $2^9 - 1 = 511$ bits
- Longest sequence of zeros: 8 (non-inverted signal)



Linear Feedback Shift Register for Generation of The PRBS Sequence

An example of Pseudorandom Frequency Hopping Sequence as follow:



Each frequency used equally on the average by each transmitter.

The system receivers have input bandwidths that match the hopping channel bandwidths of their Corresponding transmitters and shift frequencies in synchronization with the transmitted signals.

Test Graphs of Conducted Output Power

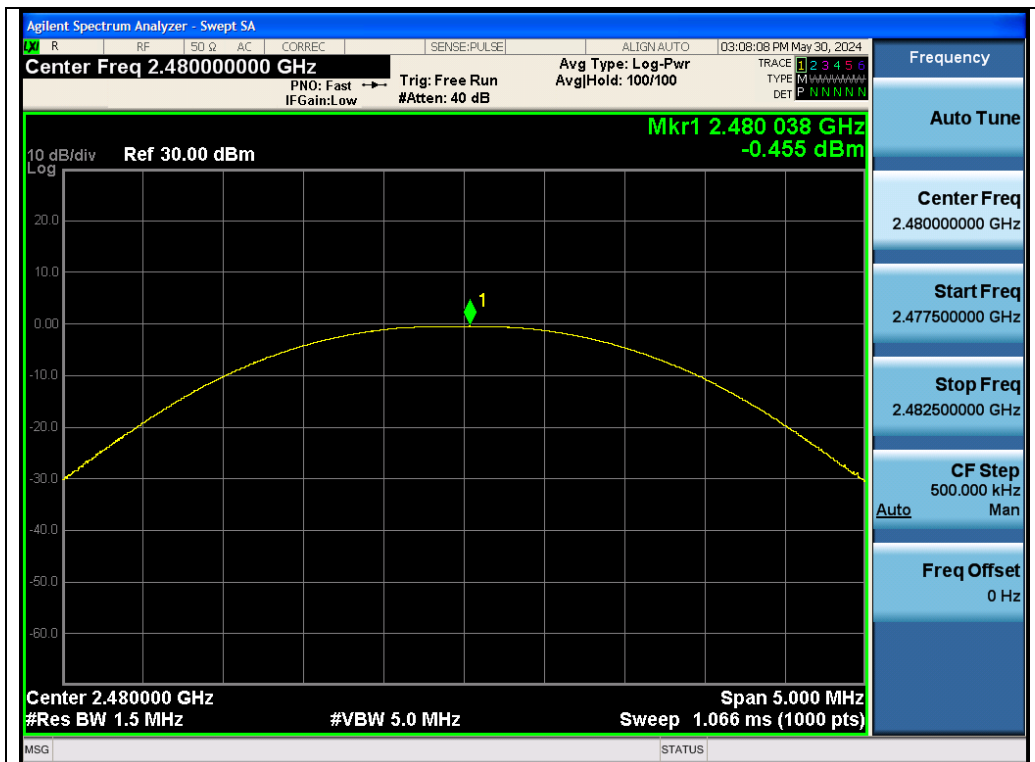


Test_Graph_BR_ANT1_2402_1Mbps_Peak Power

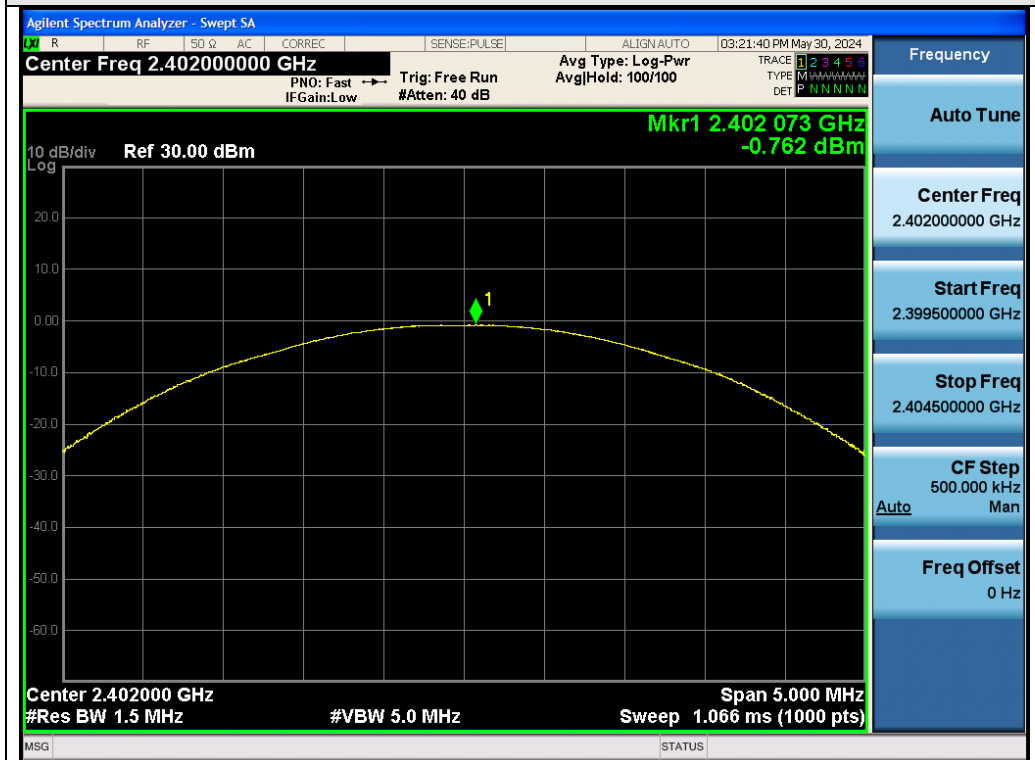


Test_Graph_BR_ANT1_2441_1Mbps_Peak Power

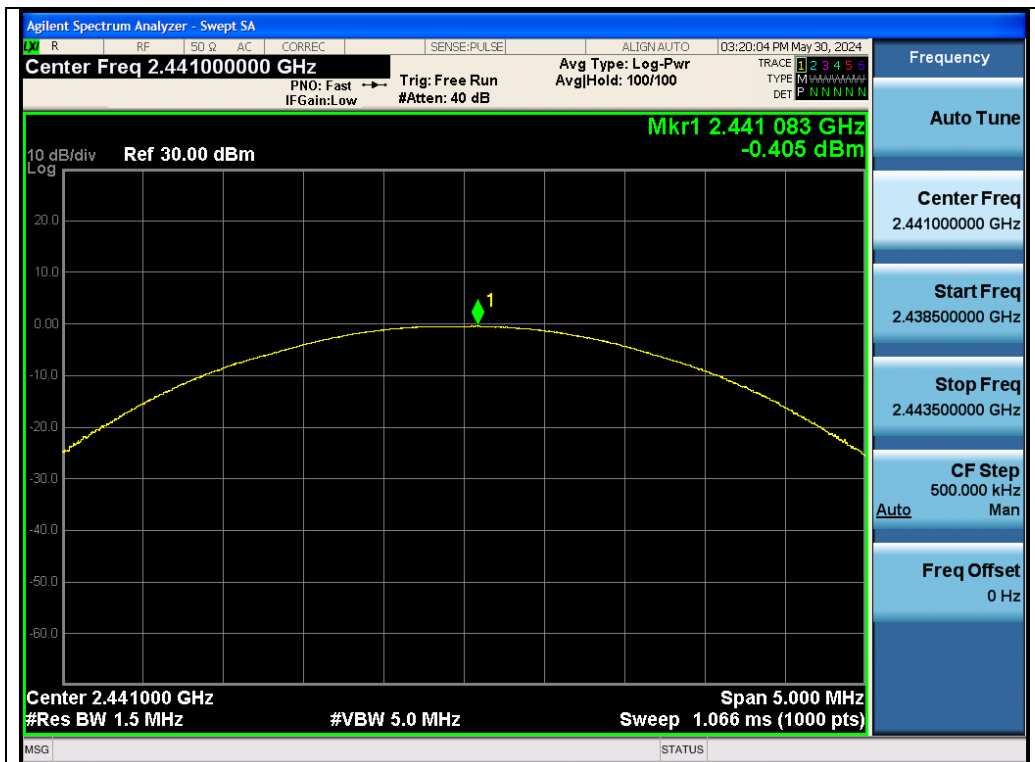


Test_Graph_BR_ANT1_2480_1Mbps_Peak Power

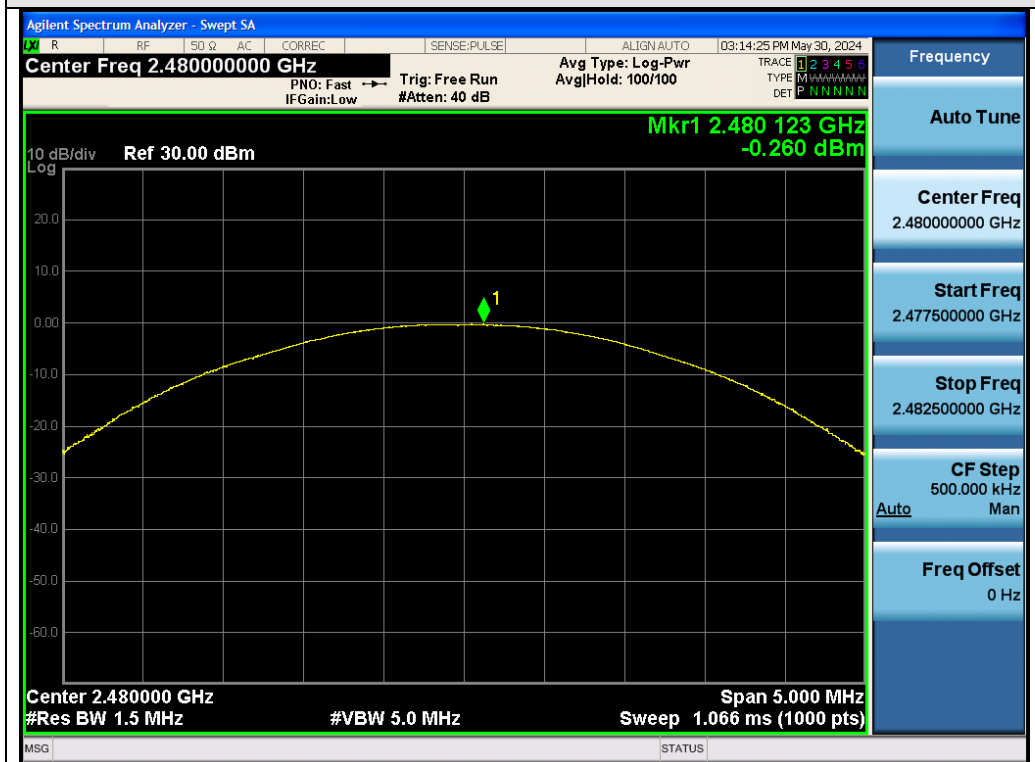

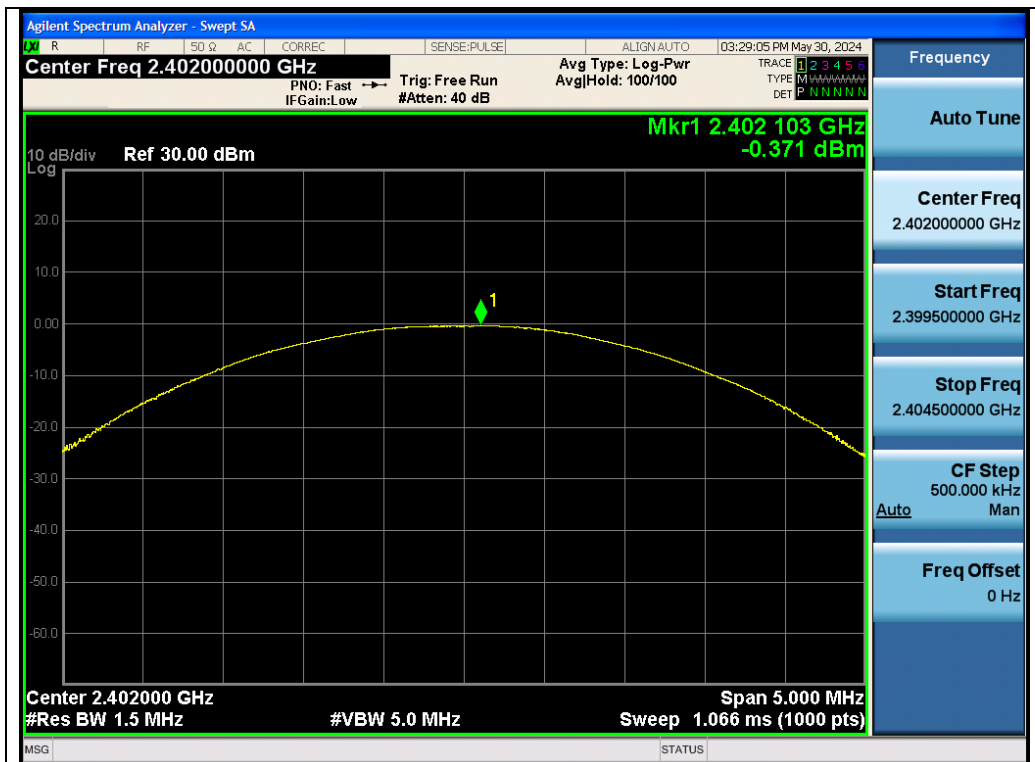


Test_Graph_EDR_ANT1_2441_2Mbps_Peak Power

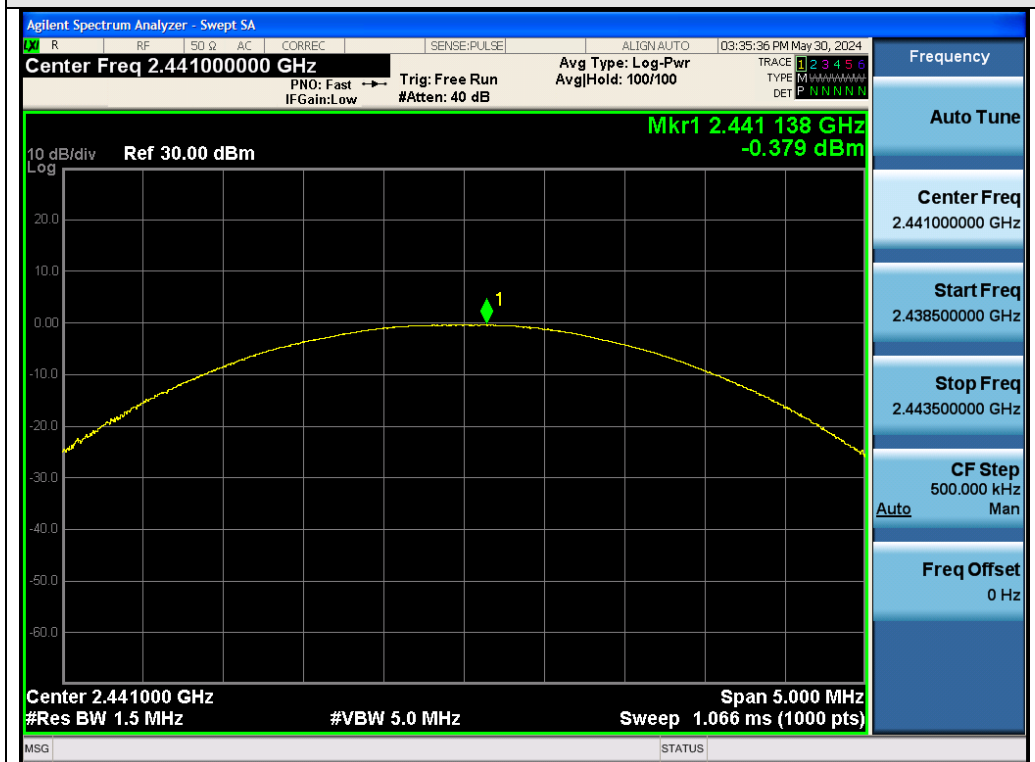

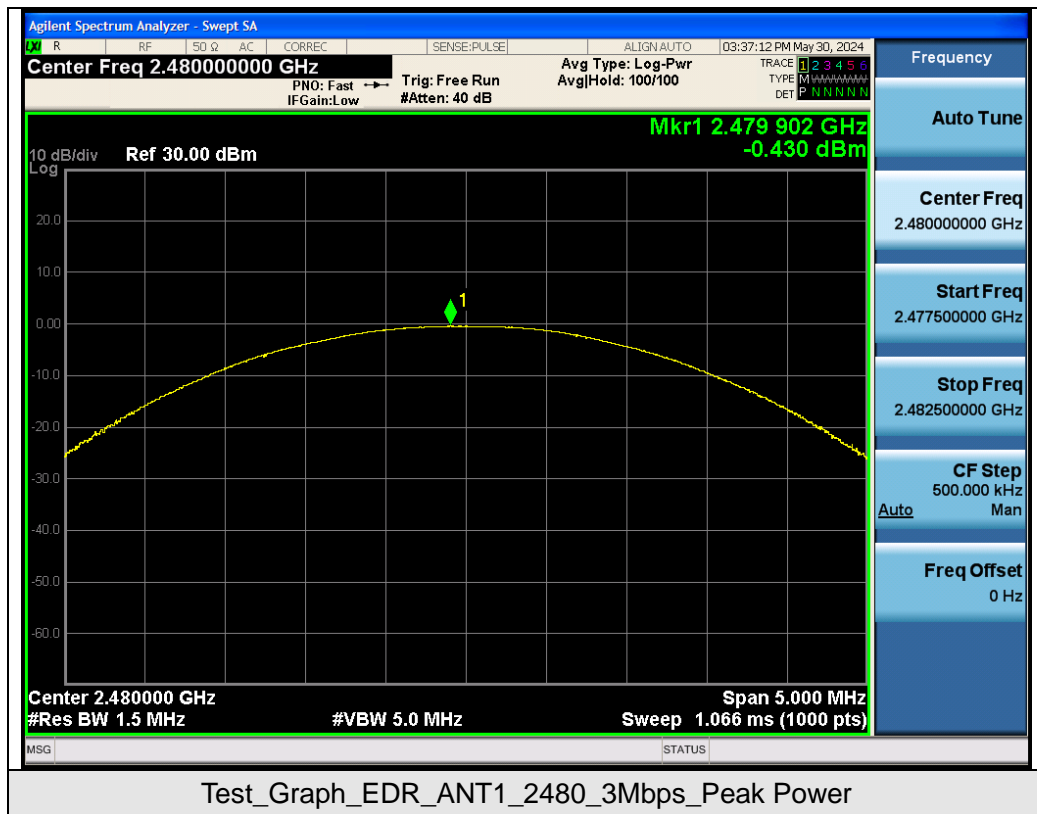


Test_Graph_EDR_ANT1_2402_3Mbps_Peak Power

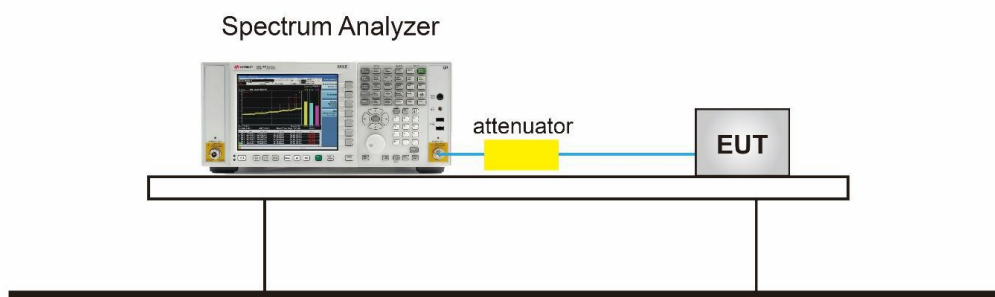

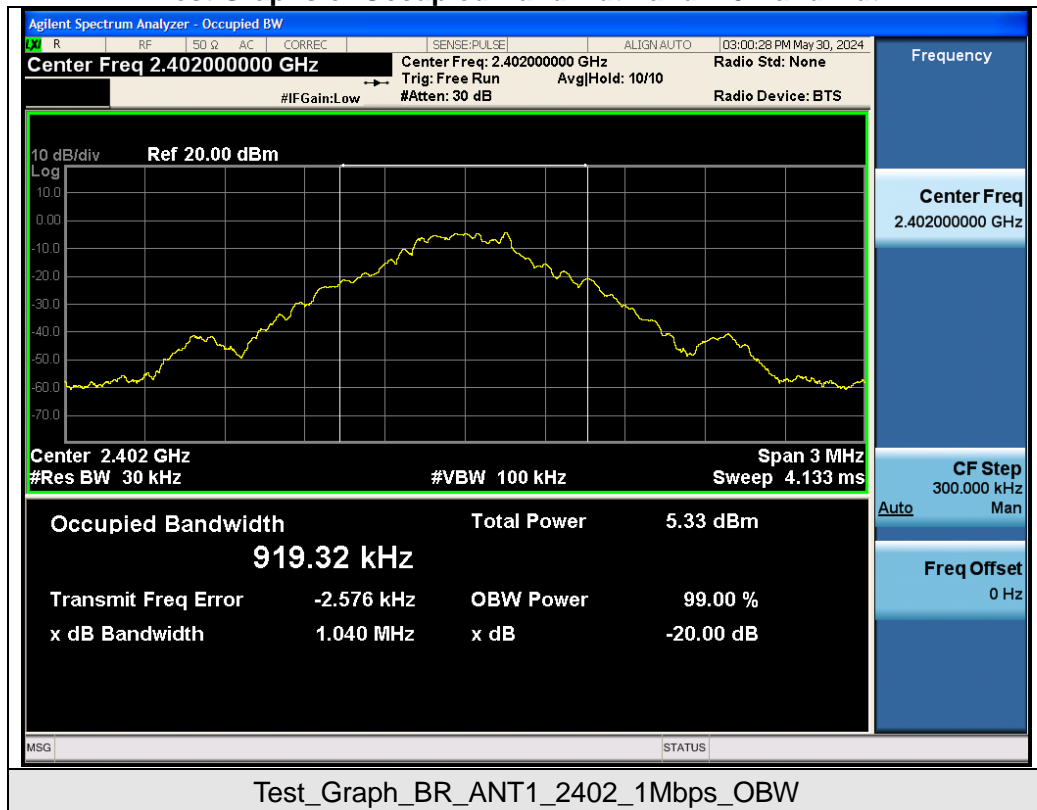

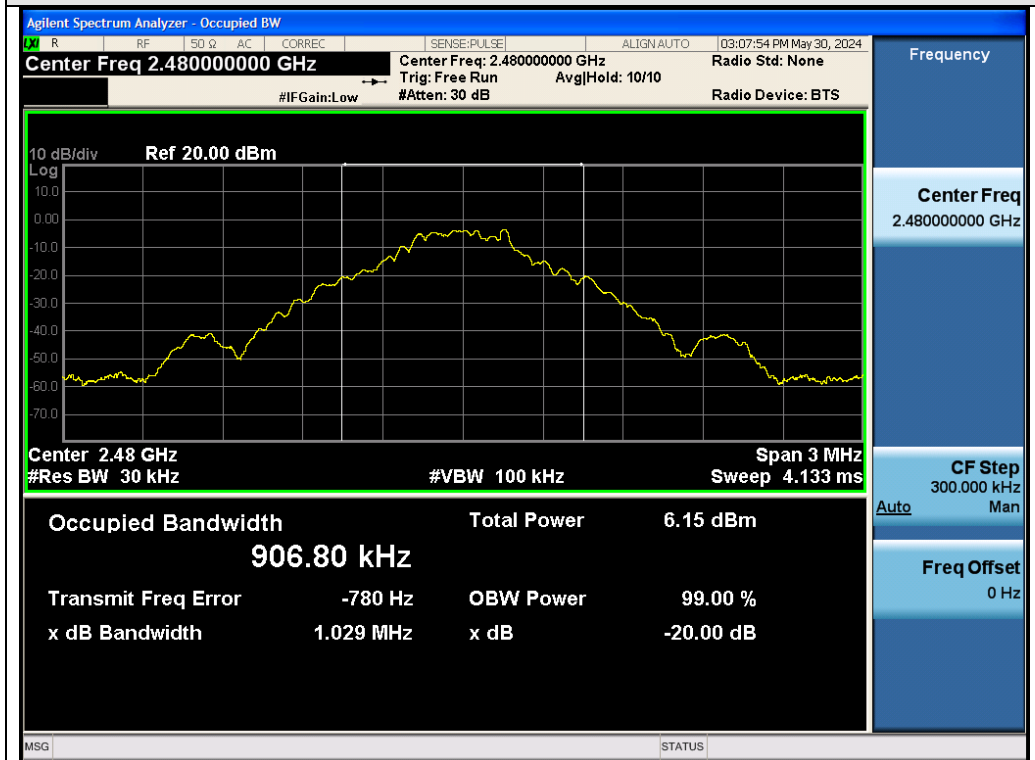
Test Graphs of Occupied Bandwidth and -20 Bandwidth

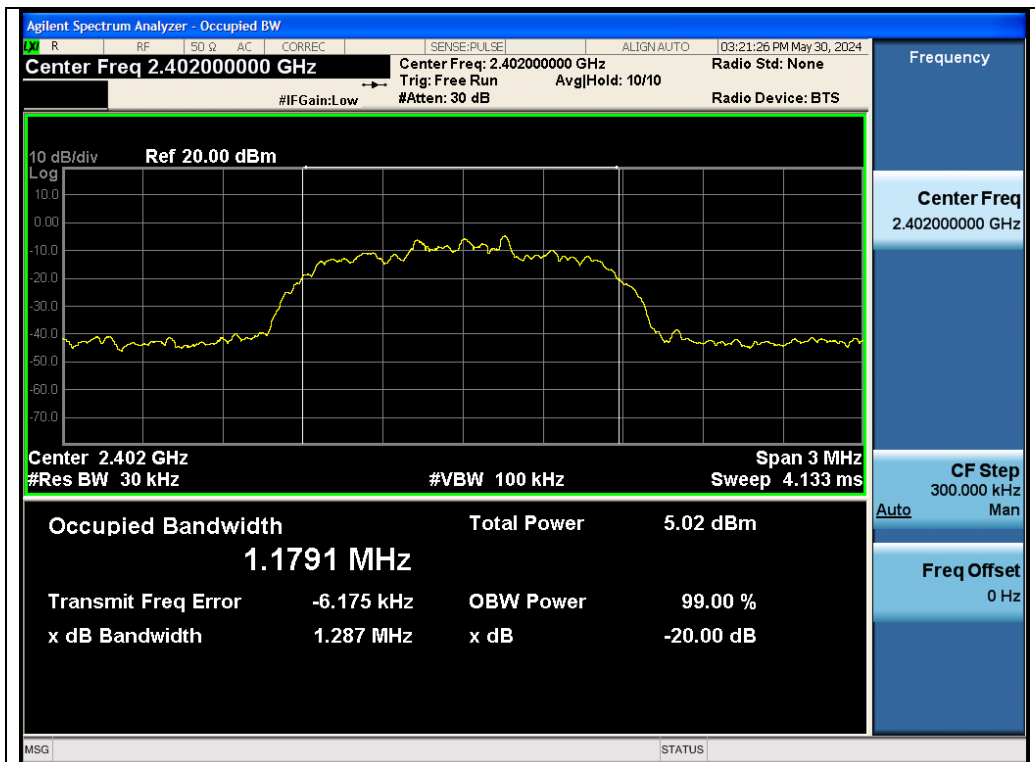


Test_Graph_BR_ANT1_2441_1Mbps_OBW

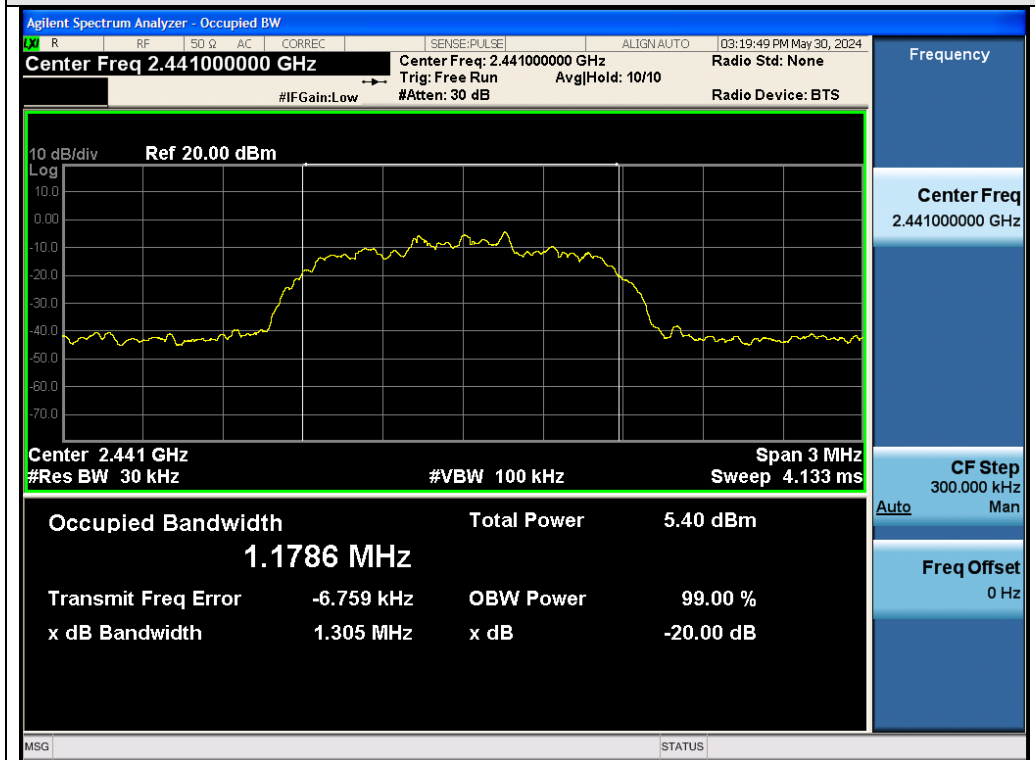

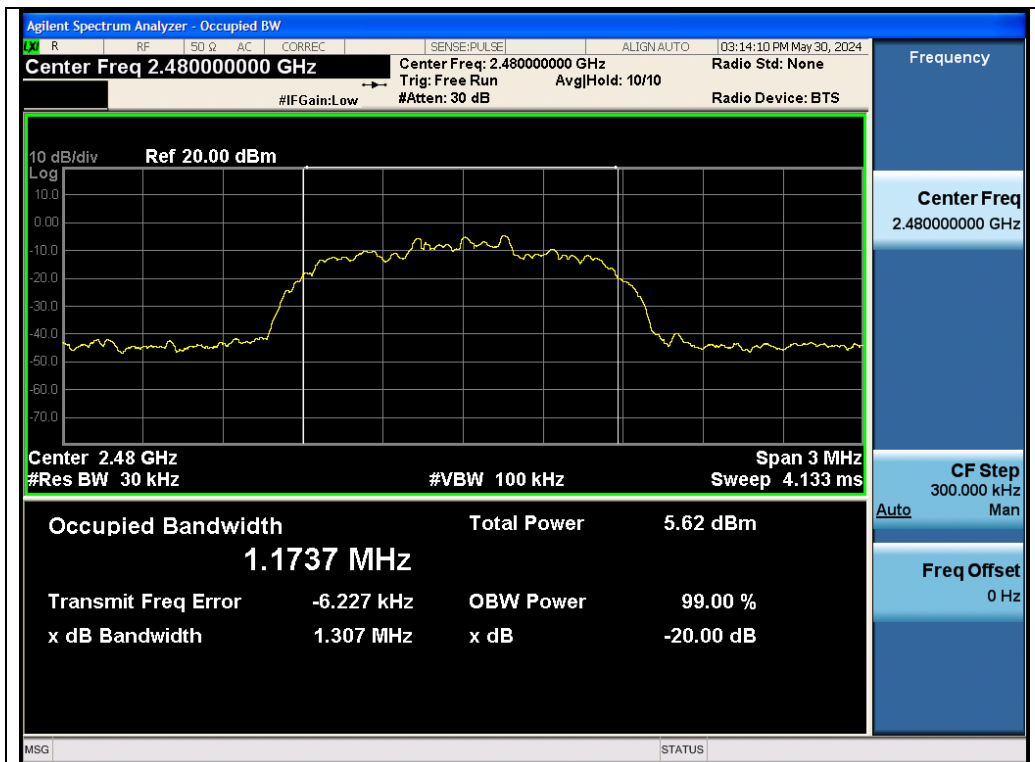


Test_Graph_EDR_ANT1_2402_2Mbps_OBW

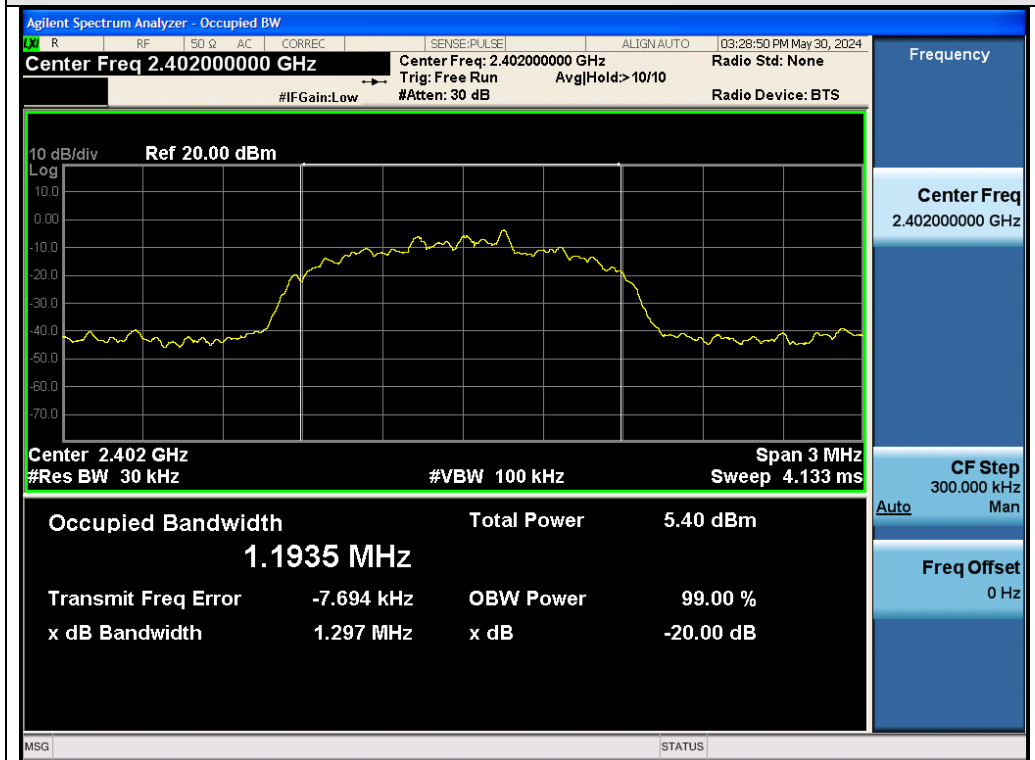

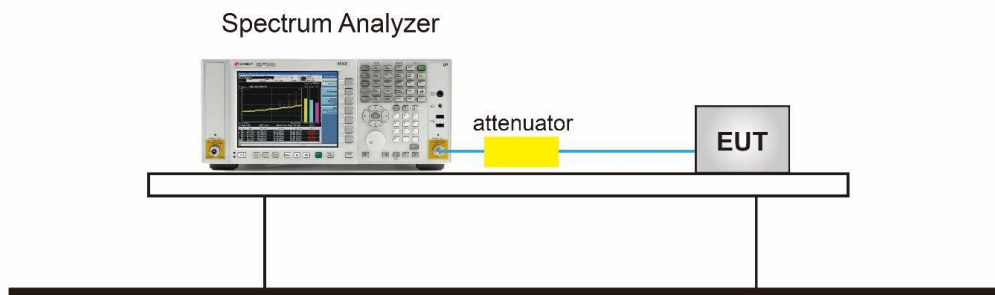
In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, the attenuation required under this paragraph shall be 30 dB instead of 20 dB.

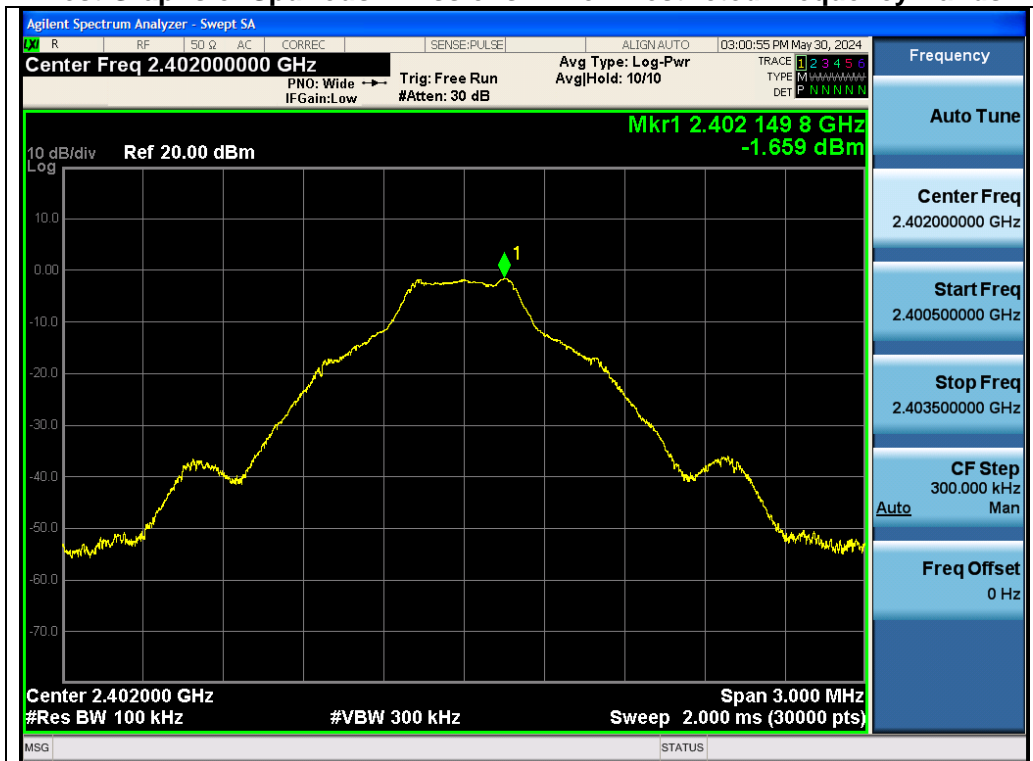

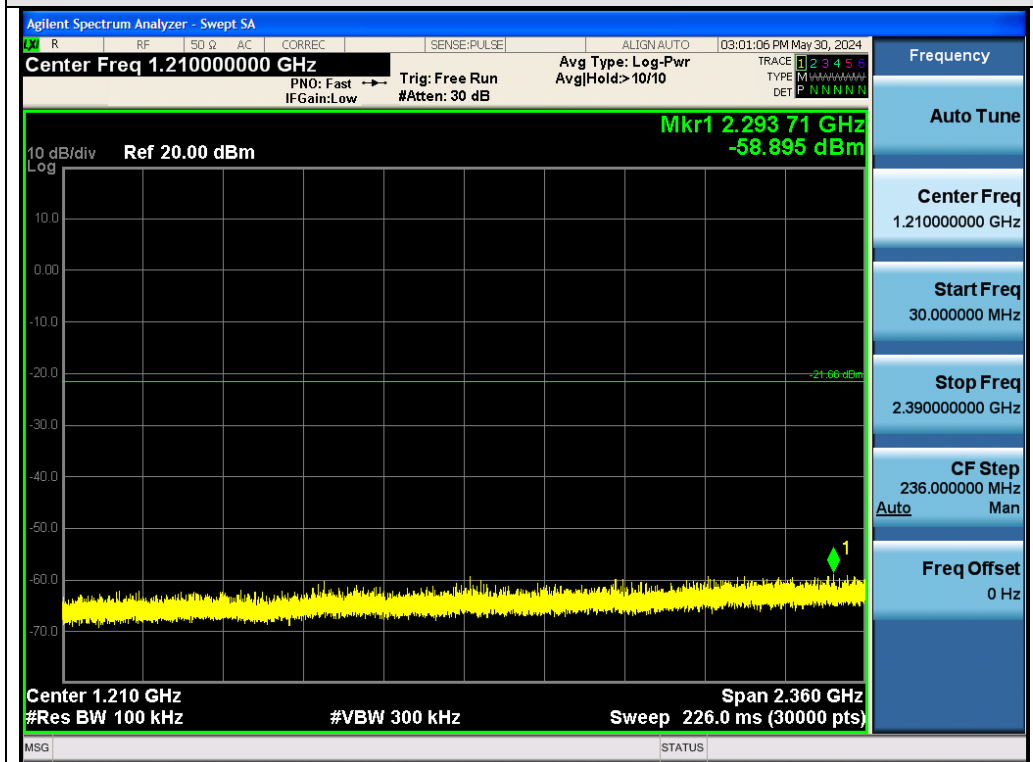

Test Graphs of Spurious Emissions in Non-Restricted Frequency Bands

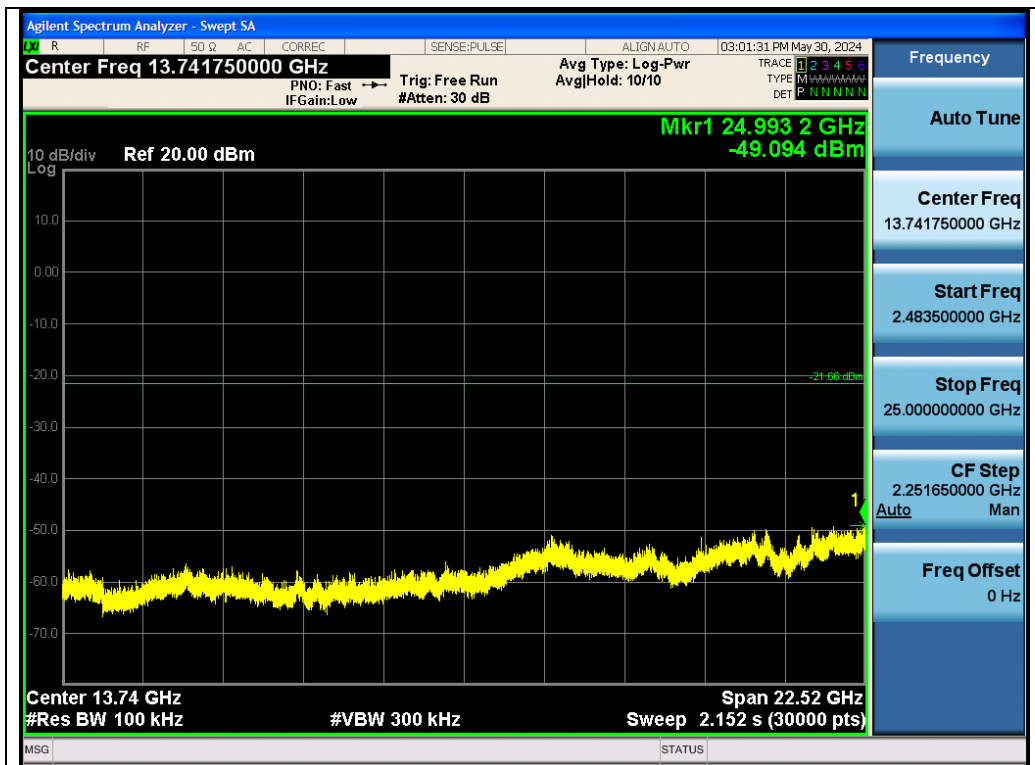

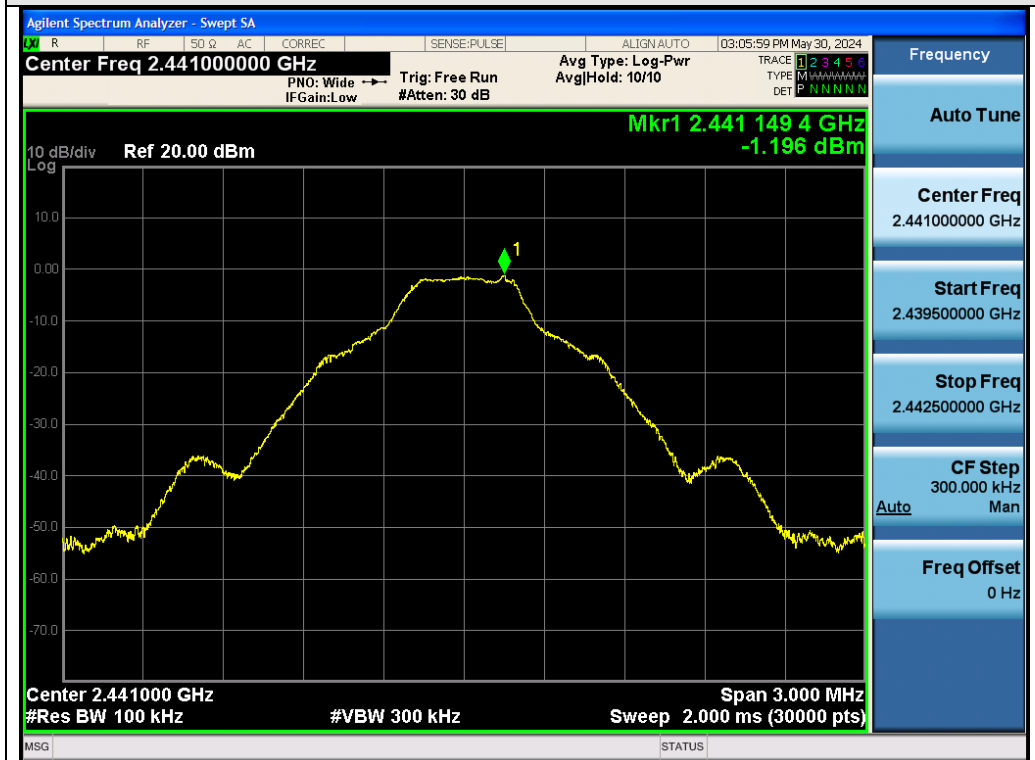

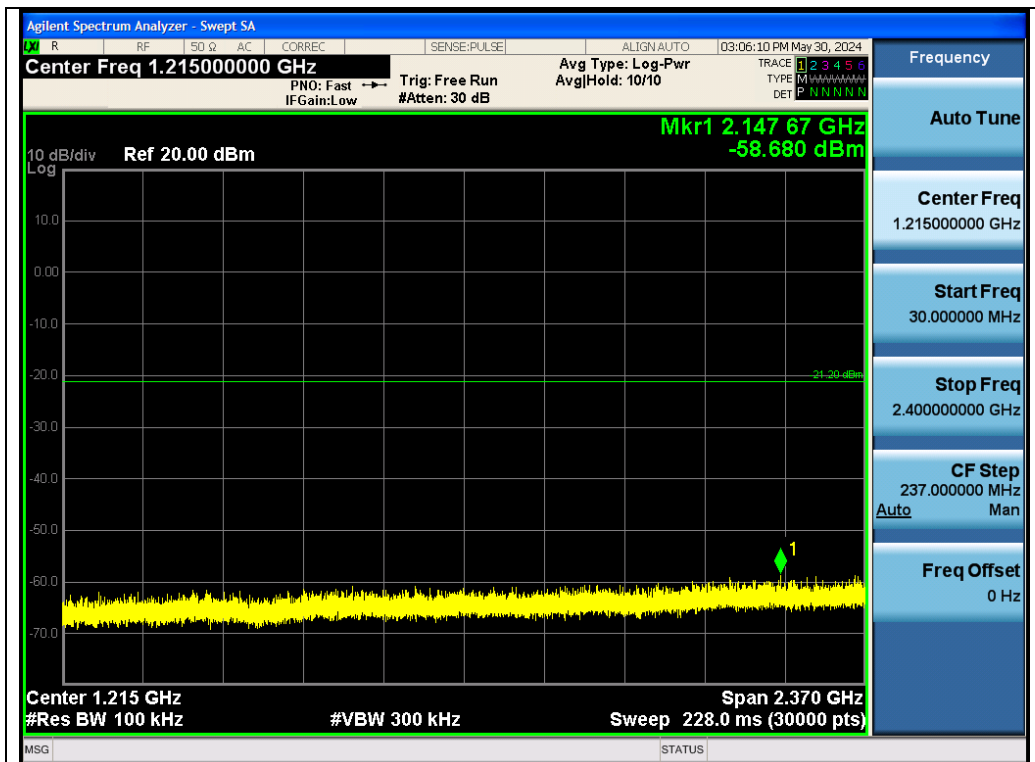


Test_Graph_BR_ANT1_2402_1Mbps_Higher Band Emissions

Test_Graph_BR_ANT1_2441_1Mbps_Lower Band Emissions

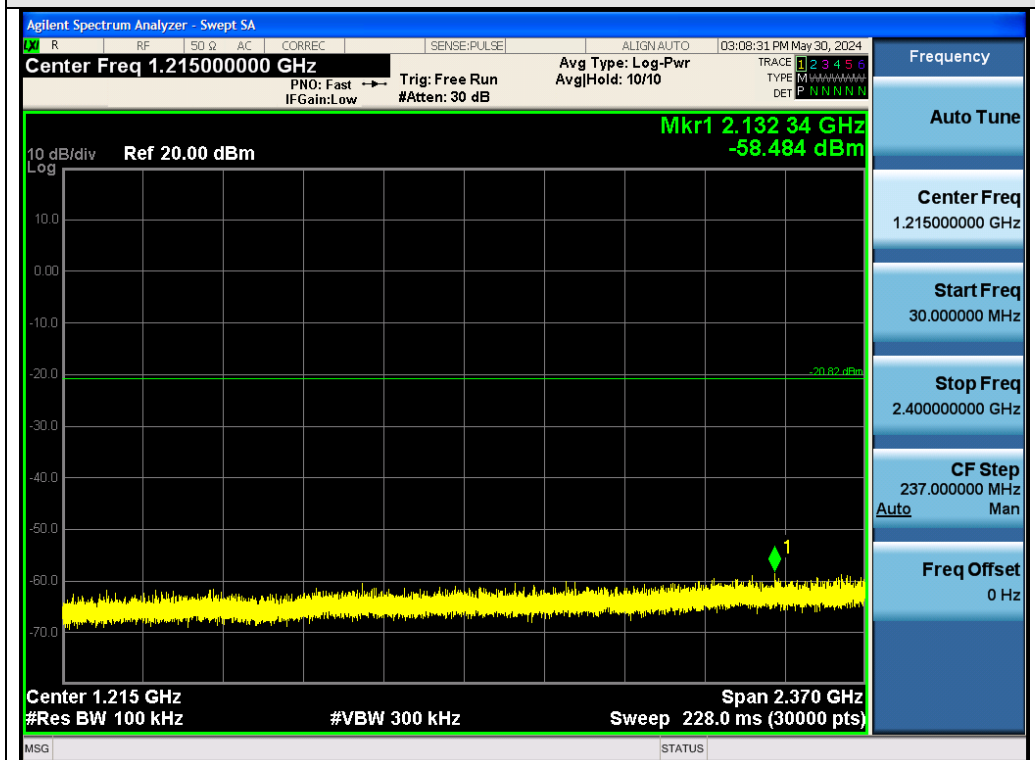

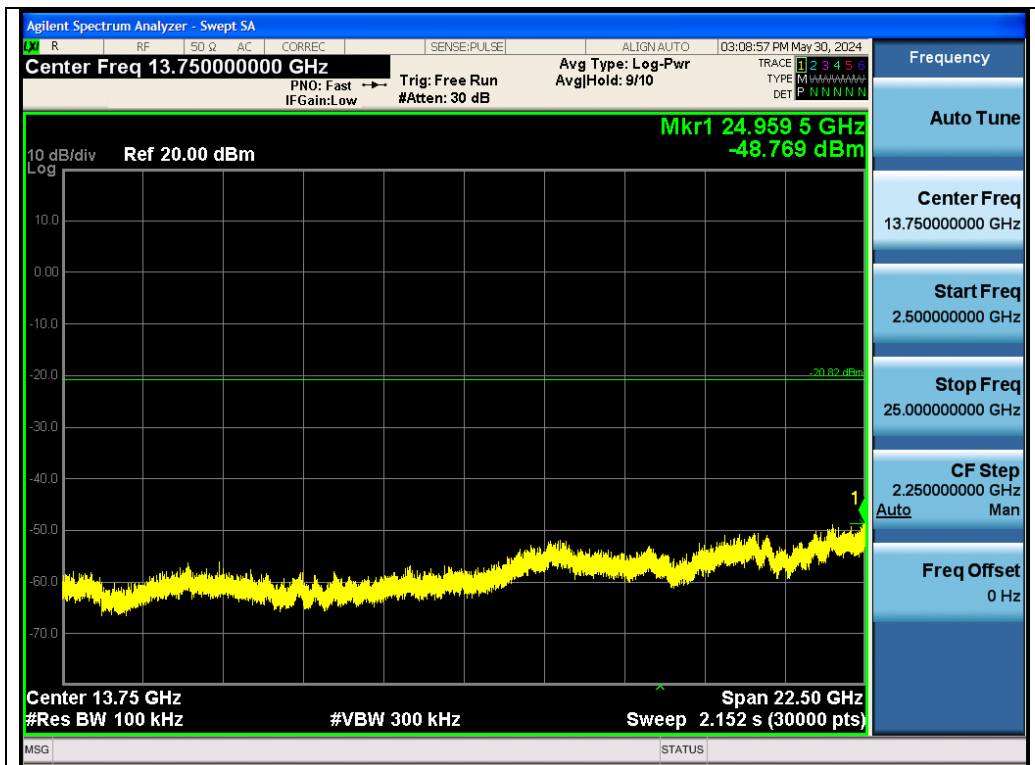


Test_Graph_BR_ANT1_2480_1Mbps_Reference Level

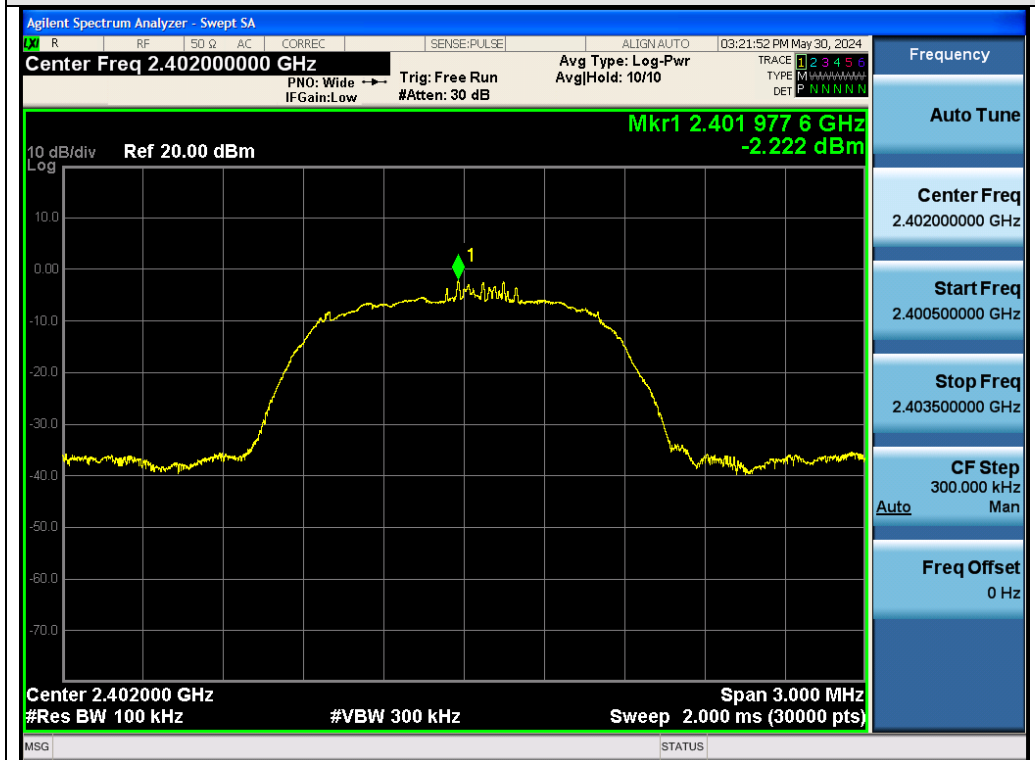

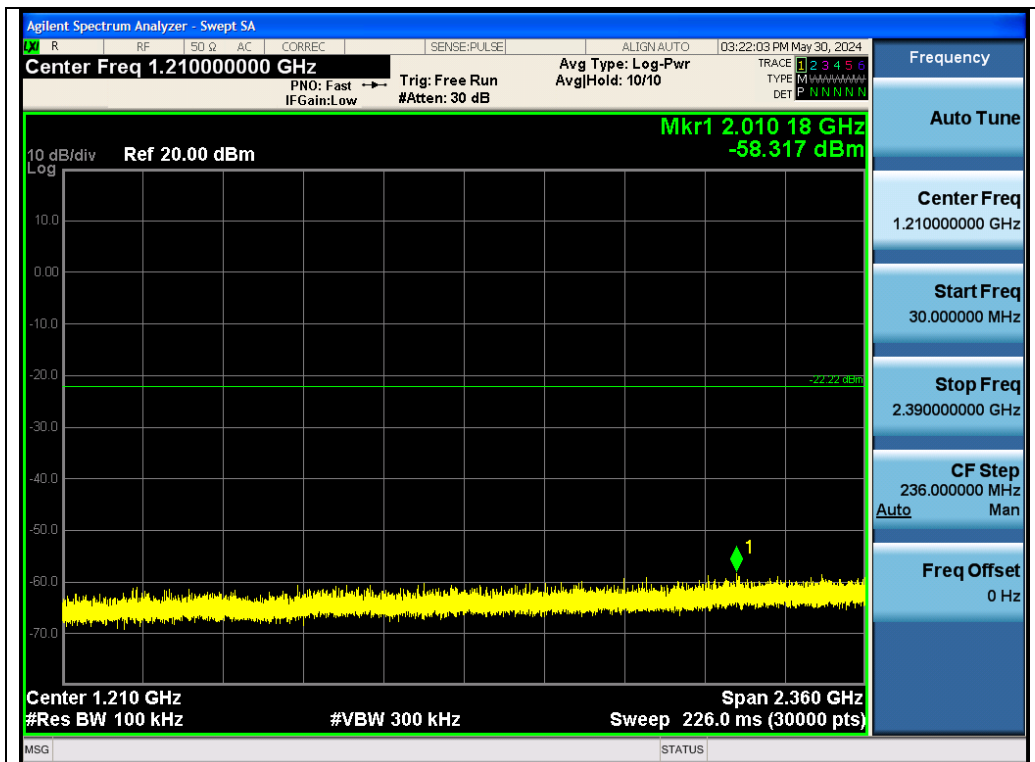
Test_Graph_BR_ANT1_2480_1Mbps_Higher Band Emissions



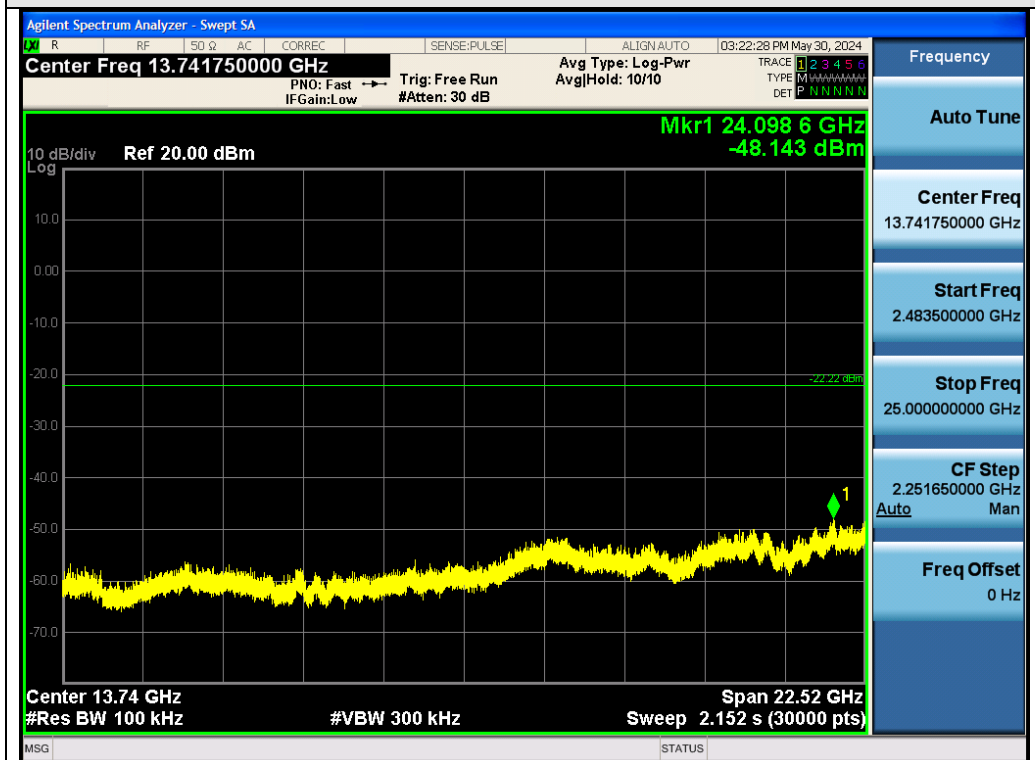

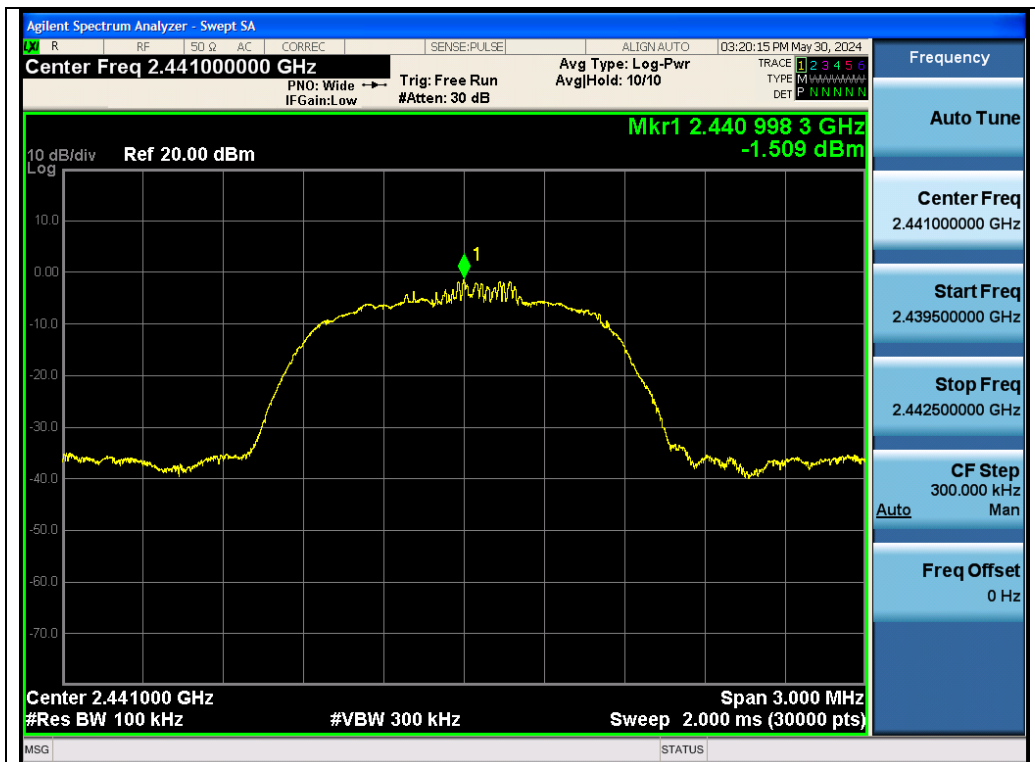


Test_Graph_EDR_ANT1_2402_2Mbps_Lower Band Emissions

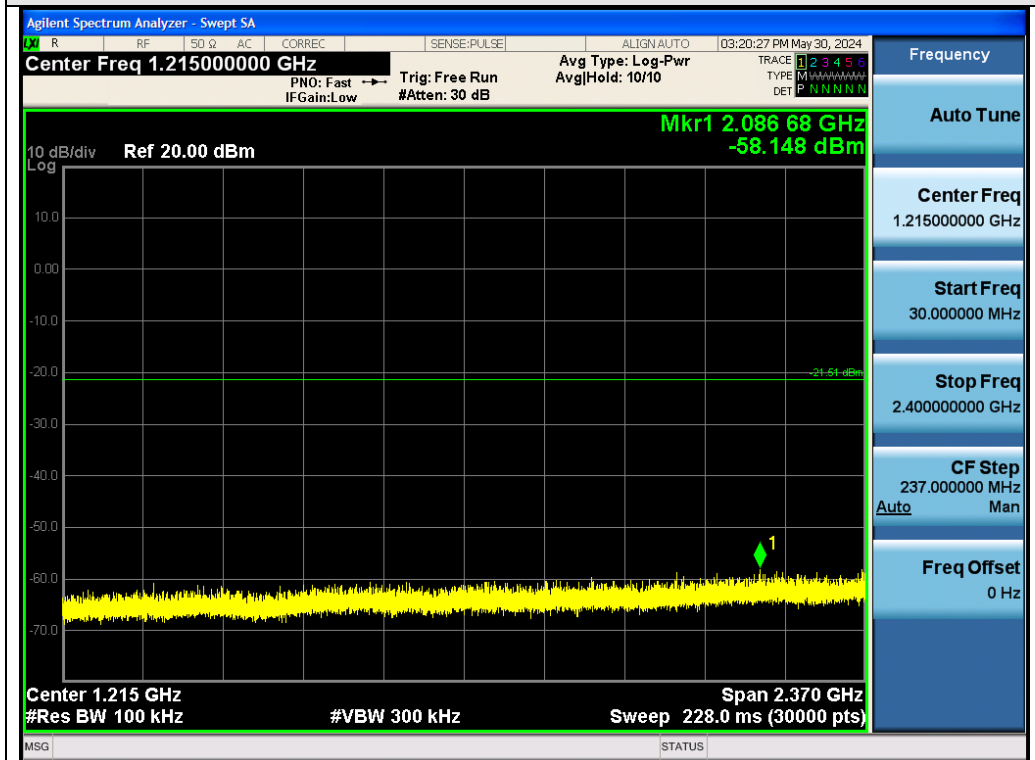

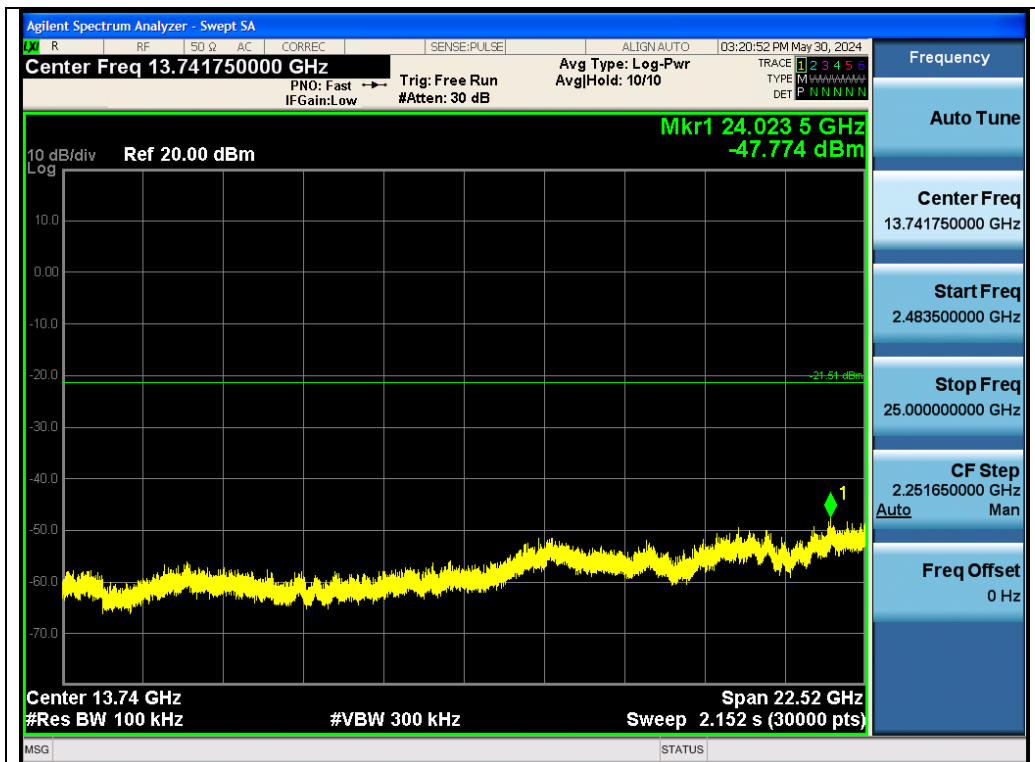


Test_Graph_EDR_ANT1_2441_2Mbps_Reference Level

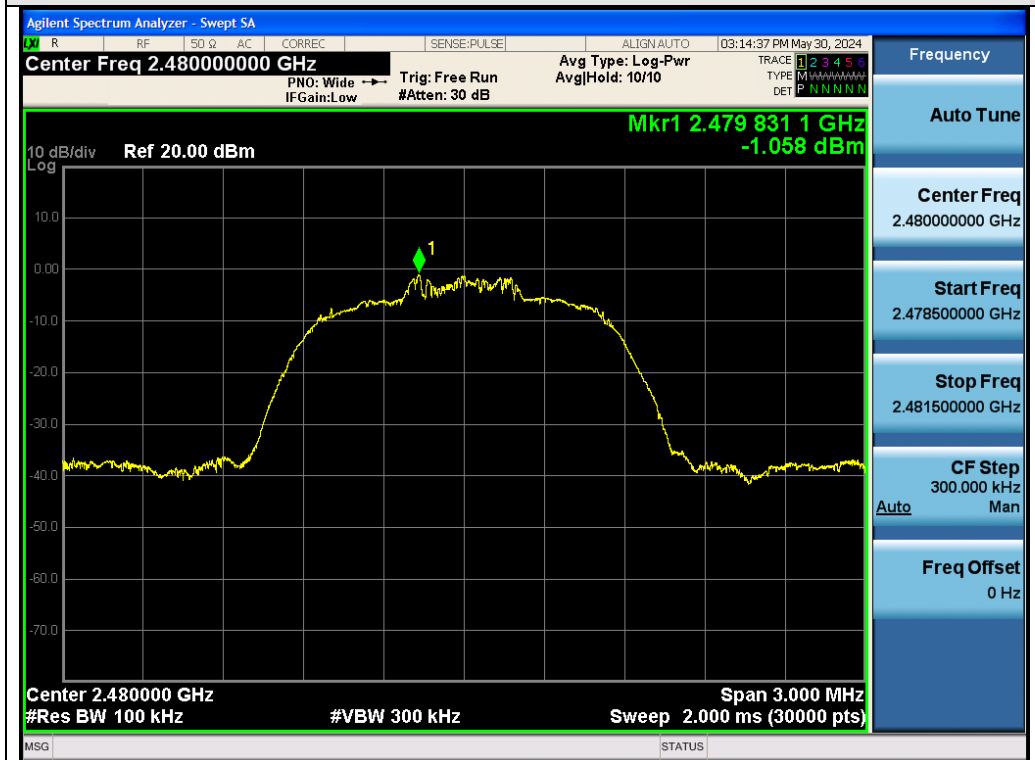

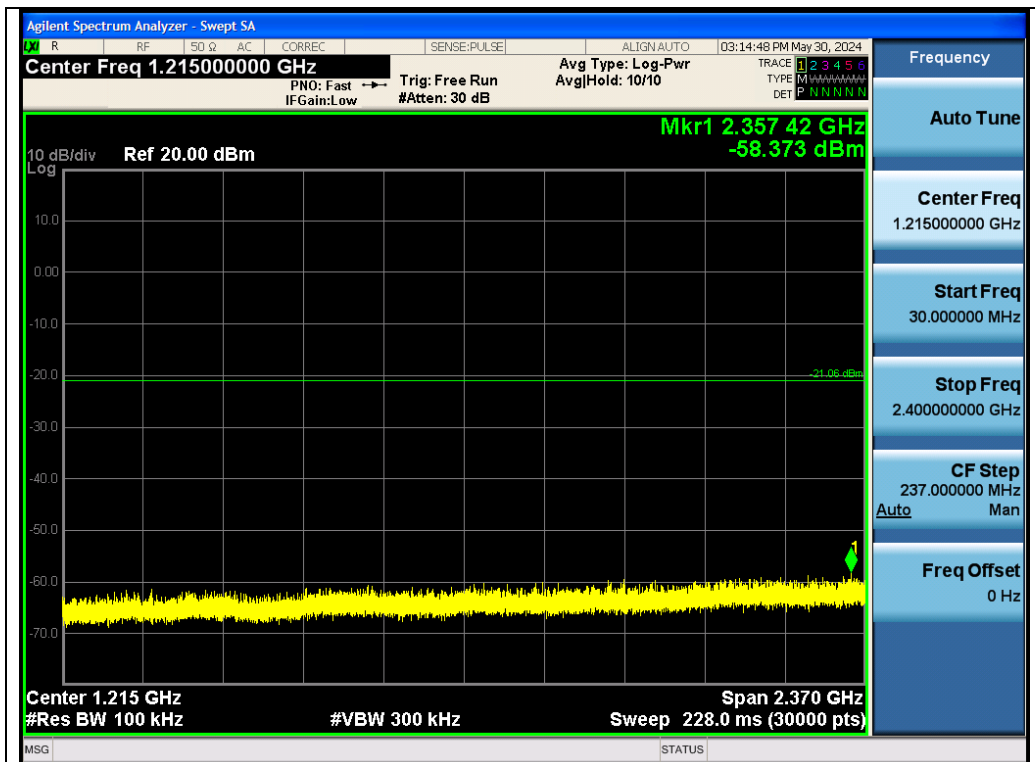


Test_Graph_EDR_ANT1_2441_2Mbps_Higher Band Emissions

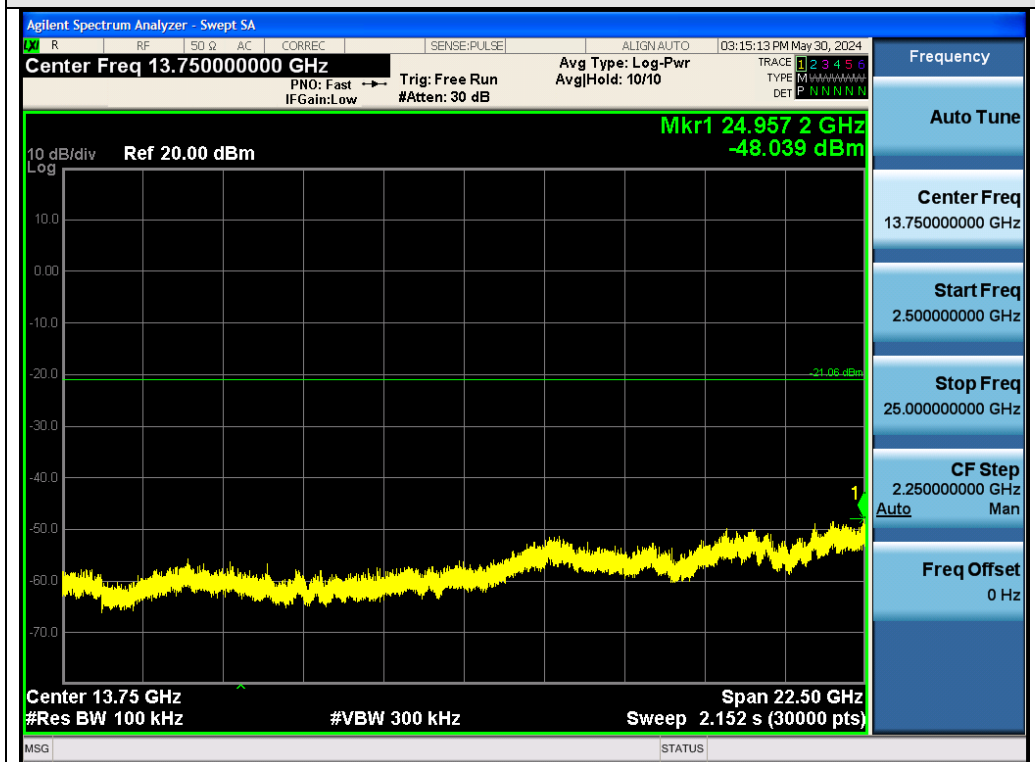

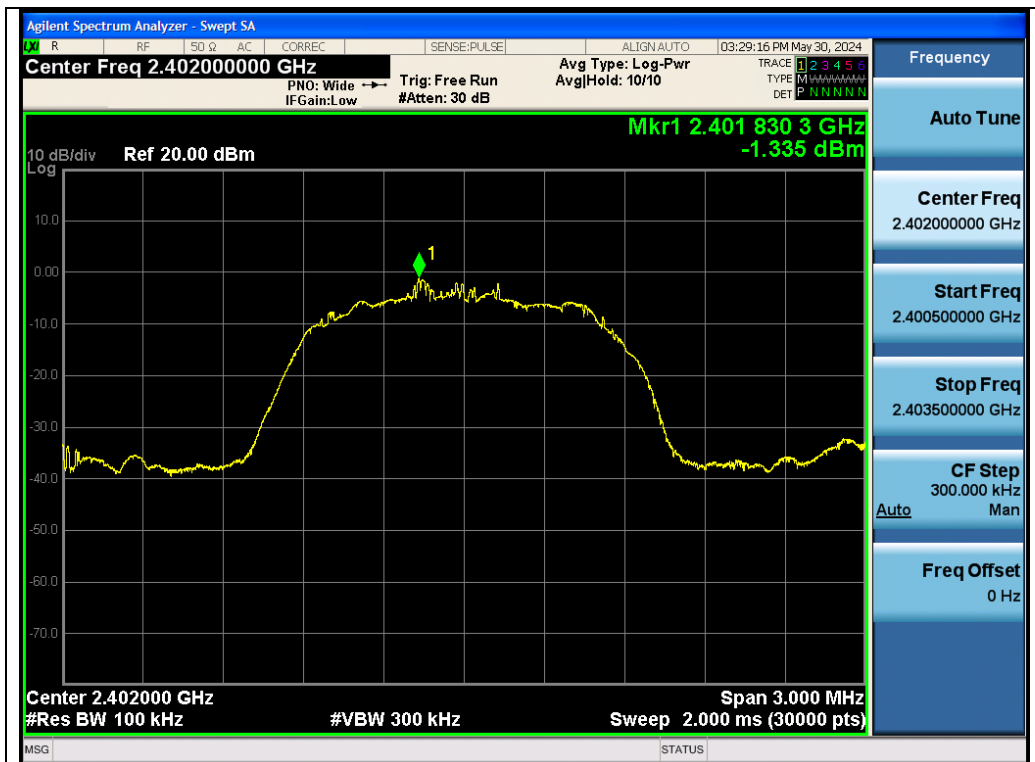


Test_Graph_EDR_ANT1_2480_2Mbps_Lower Band Emissions

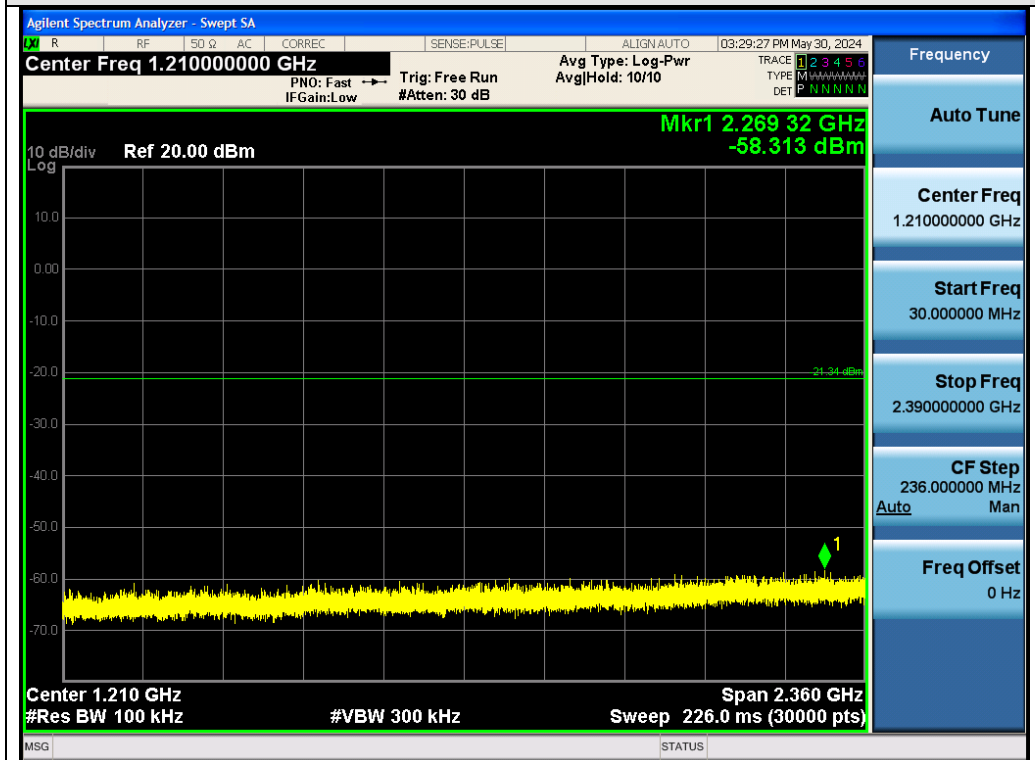


Test_Graph_EDR_ANT1_2480_2Mbps_Higher Band Emissions

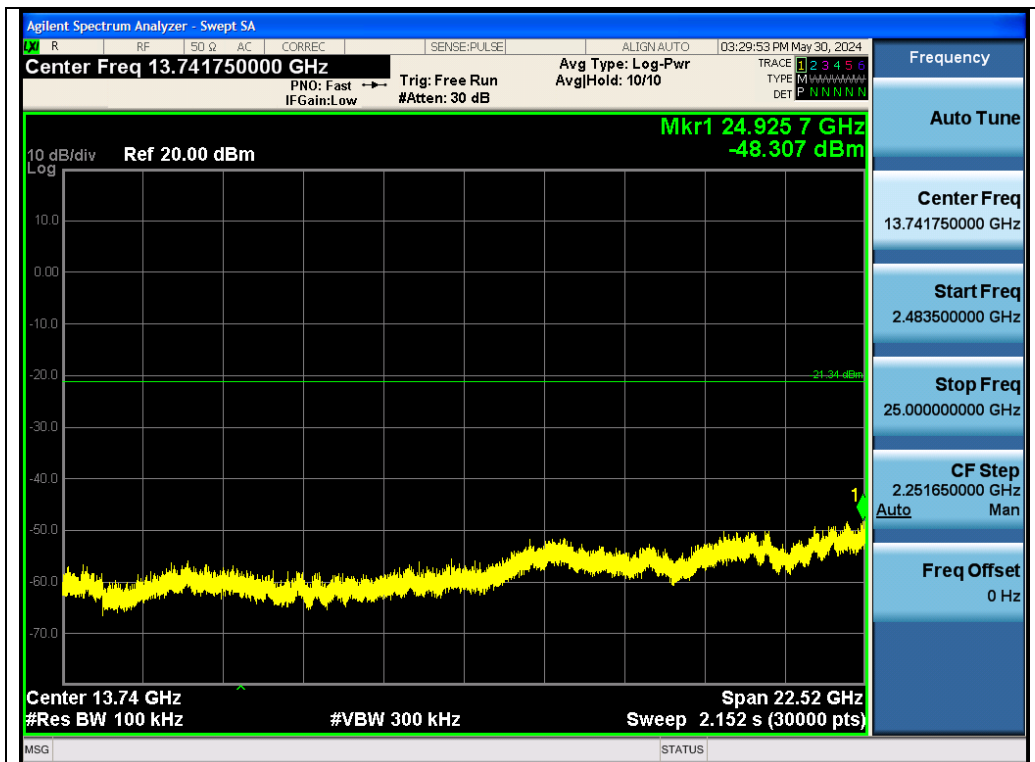

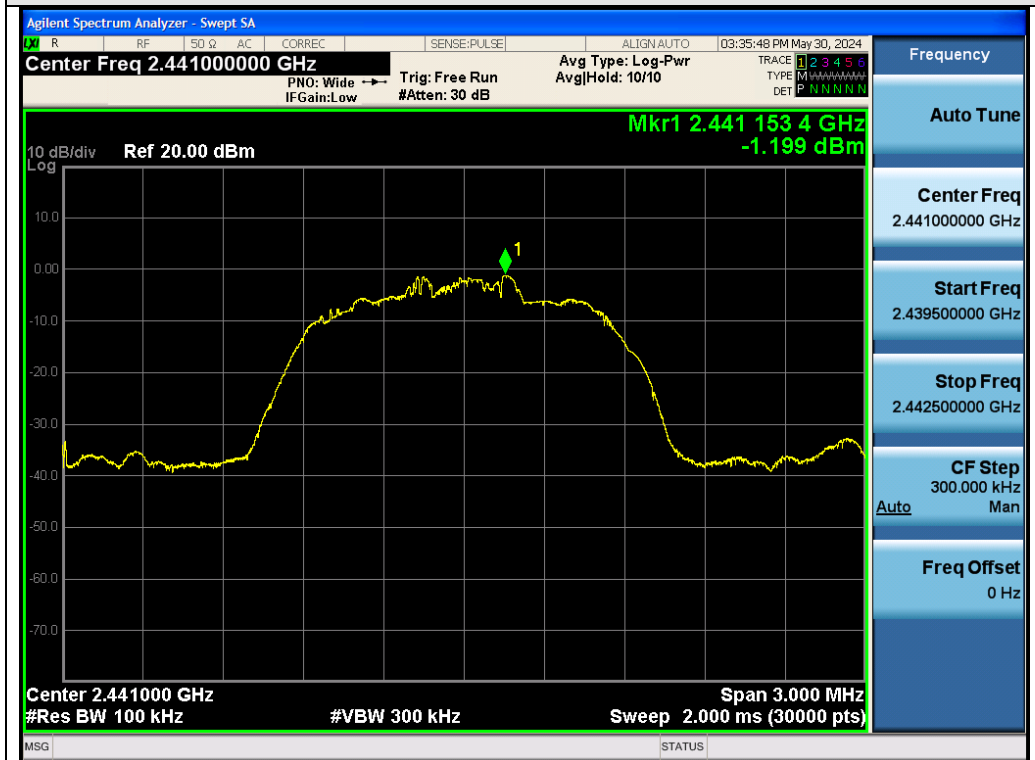

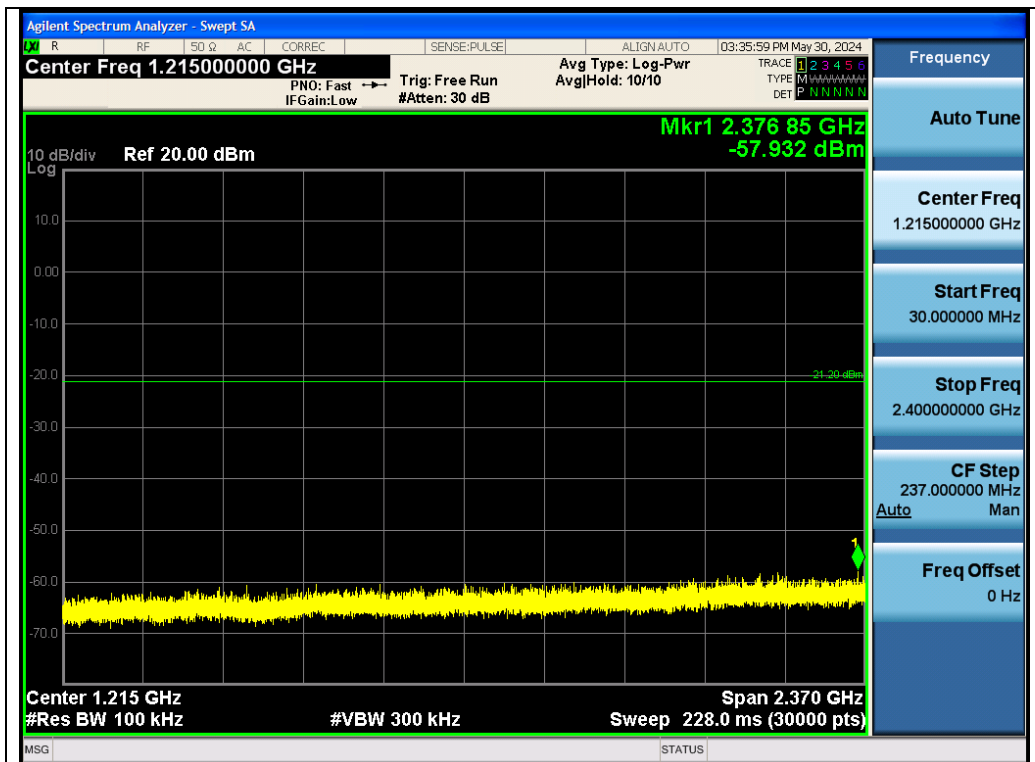
Test_Graph_EDR_ANT1_2402_3Mbps_Higher Band Emissions



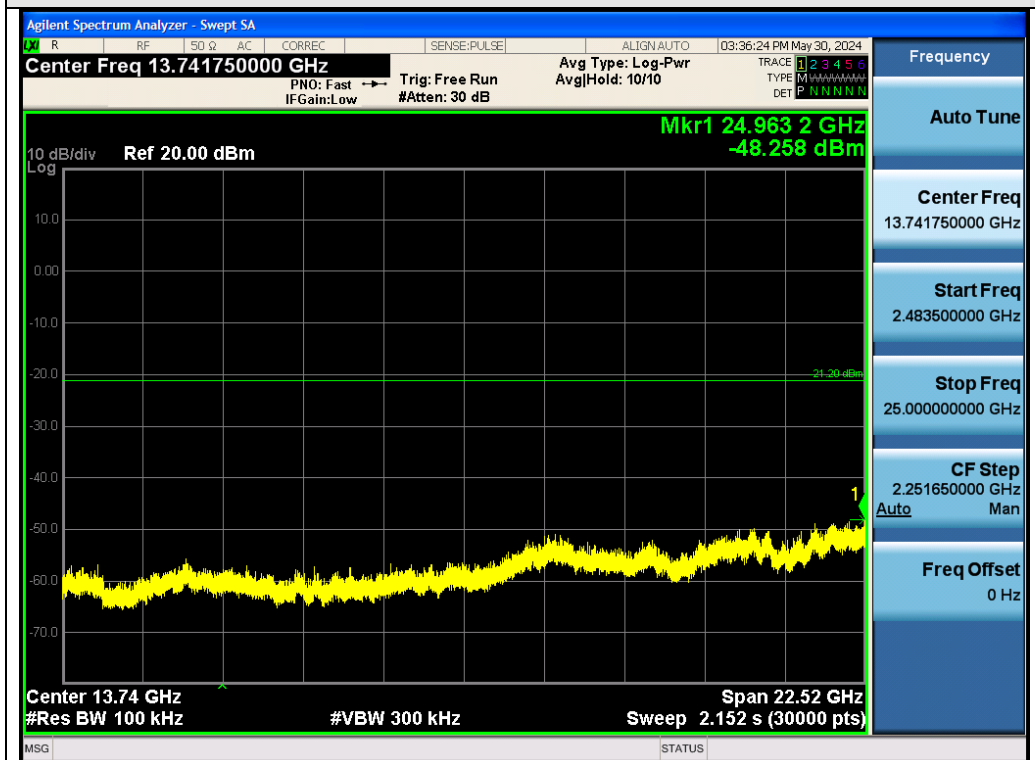

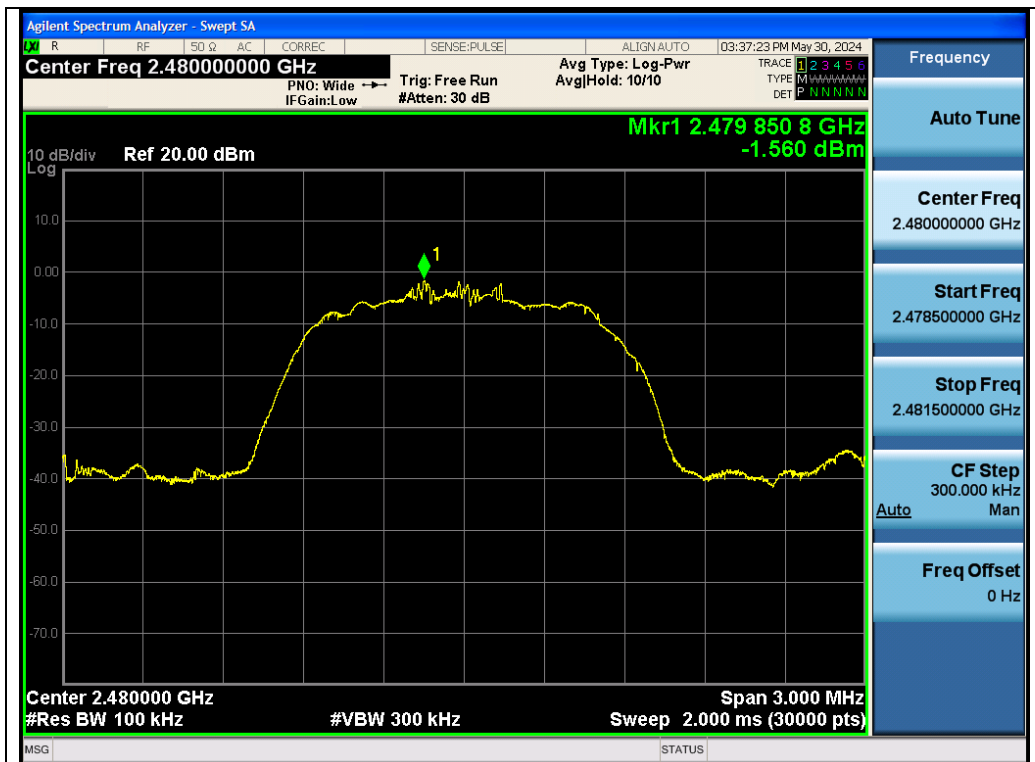


Test_Graph_EDR_ANT1_2441_3Mbps_Lower Band Emissions

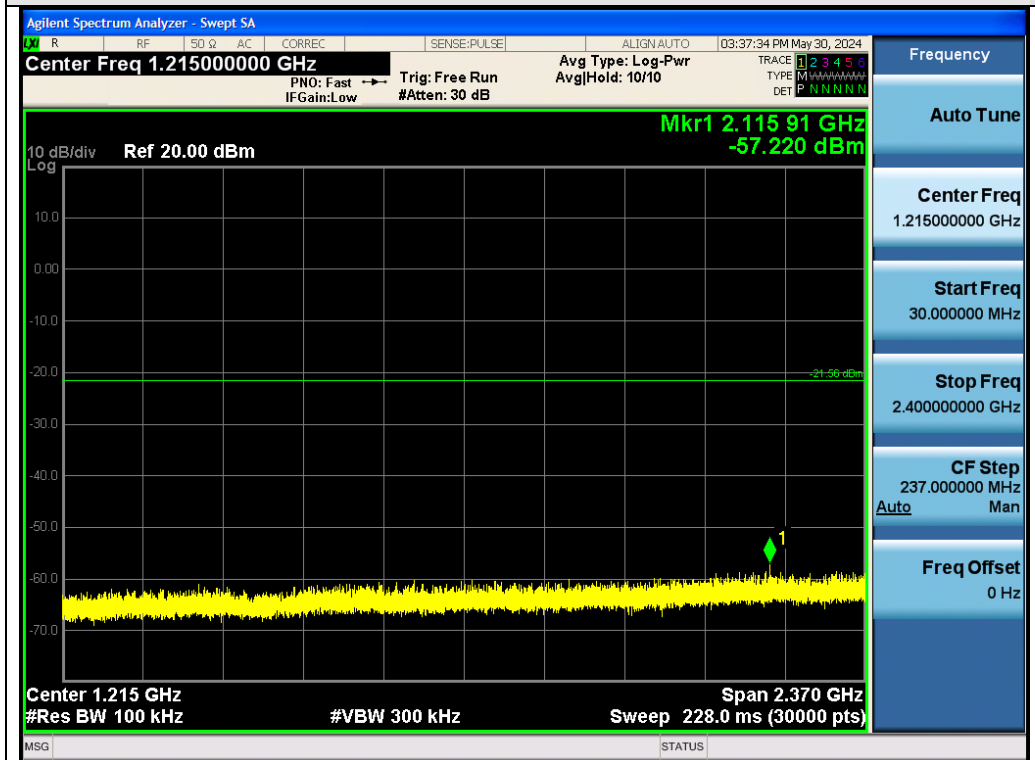


Test_Graph_EDR_ANT1_2441_3Mbps_Higher Band Emissions

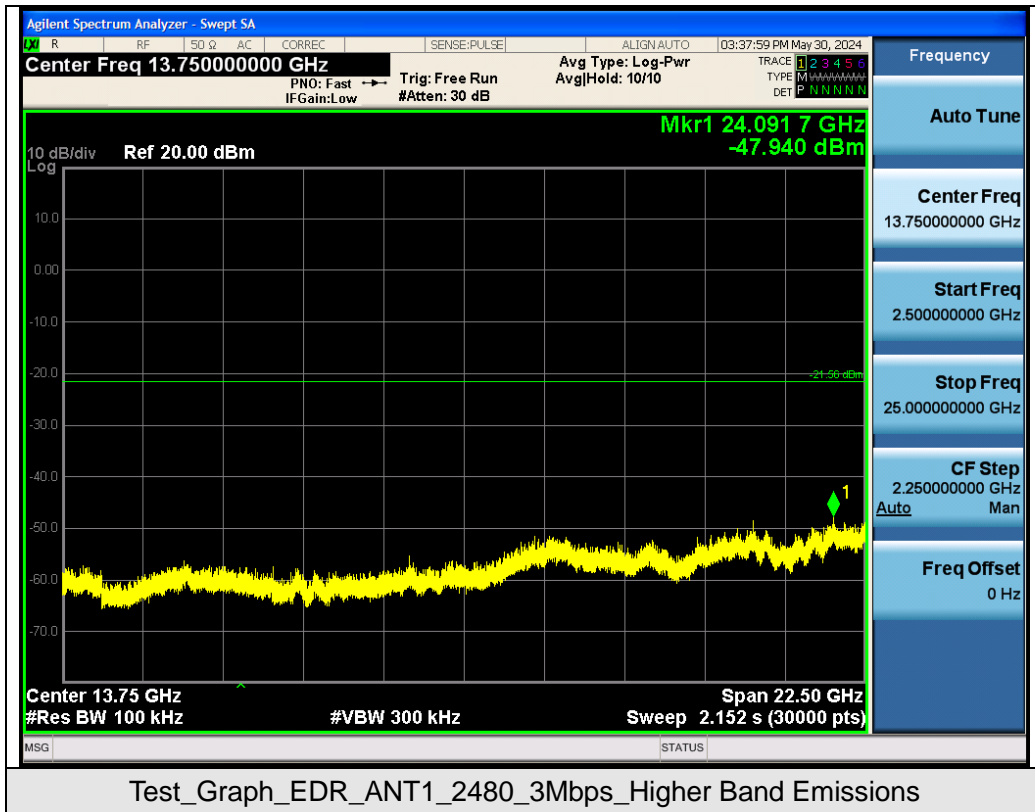


Test_Graph_EDR_ANT1_2480_3Mbps_Reference Level



Test_Graph_EDR_ANT1_2480_3Mbps_Lower Band Emissions

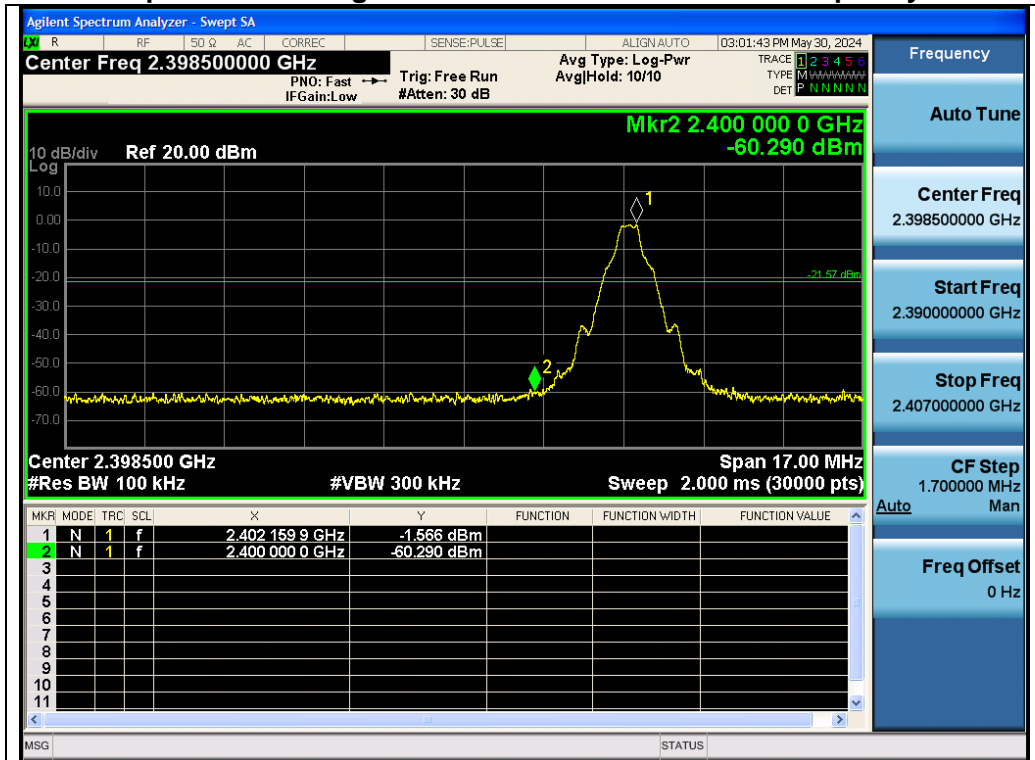

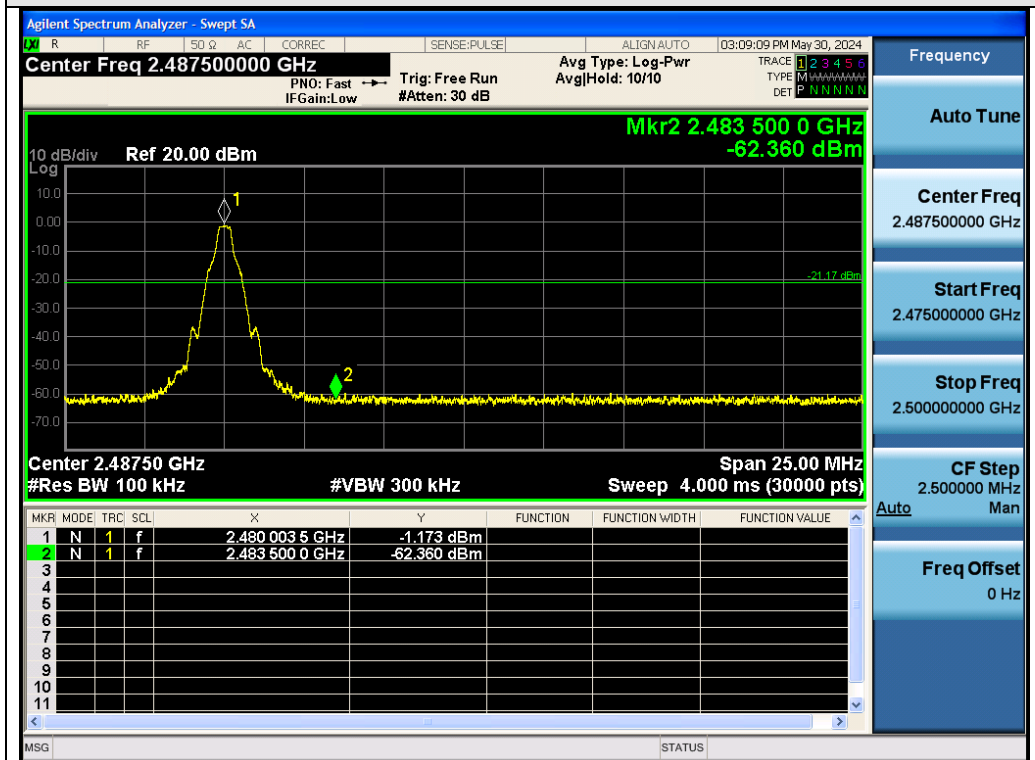

Test Graphs of Band Edge Emissions in Non-Restricted Frequency Bands

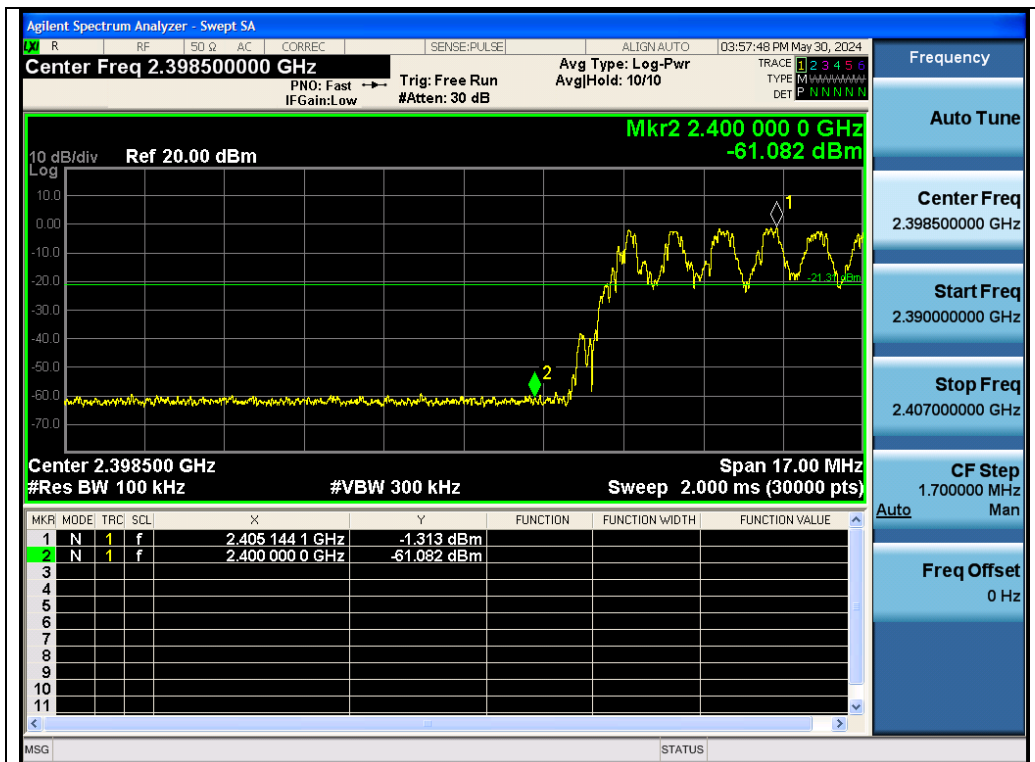


Test_Graph_BR_ANT1_2402_1Mbps_Lower Band Edge Emissions

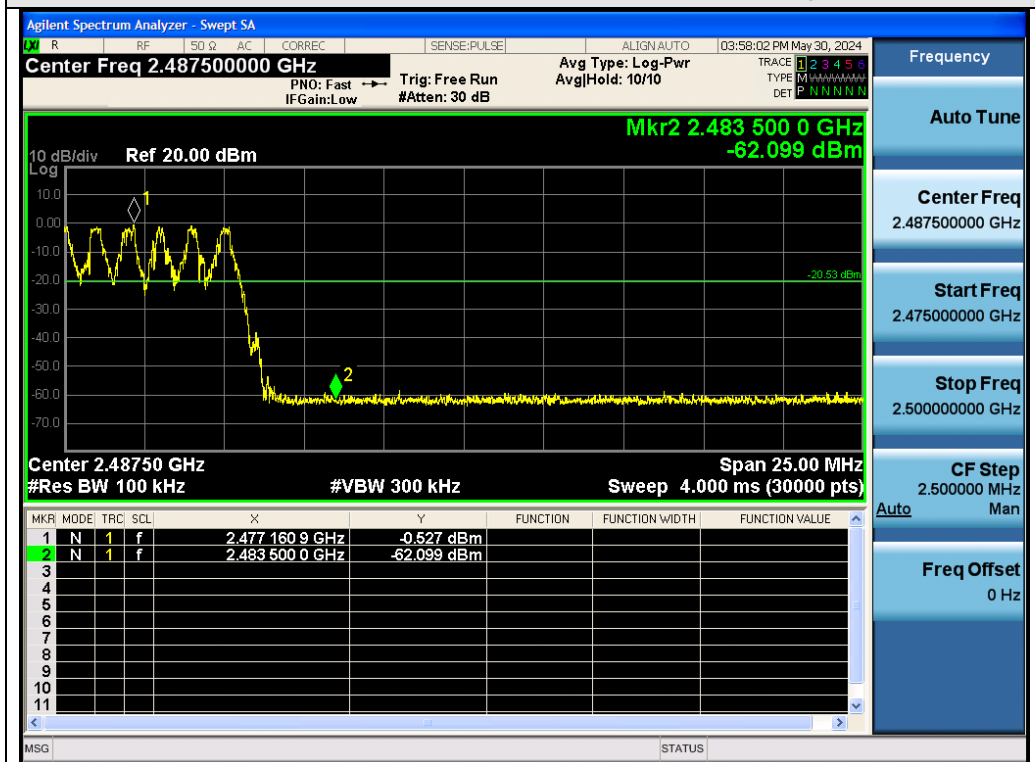


Test_Graph_BR_ANT1_2480_1Mbps_Higher Band Edge Emissions

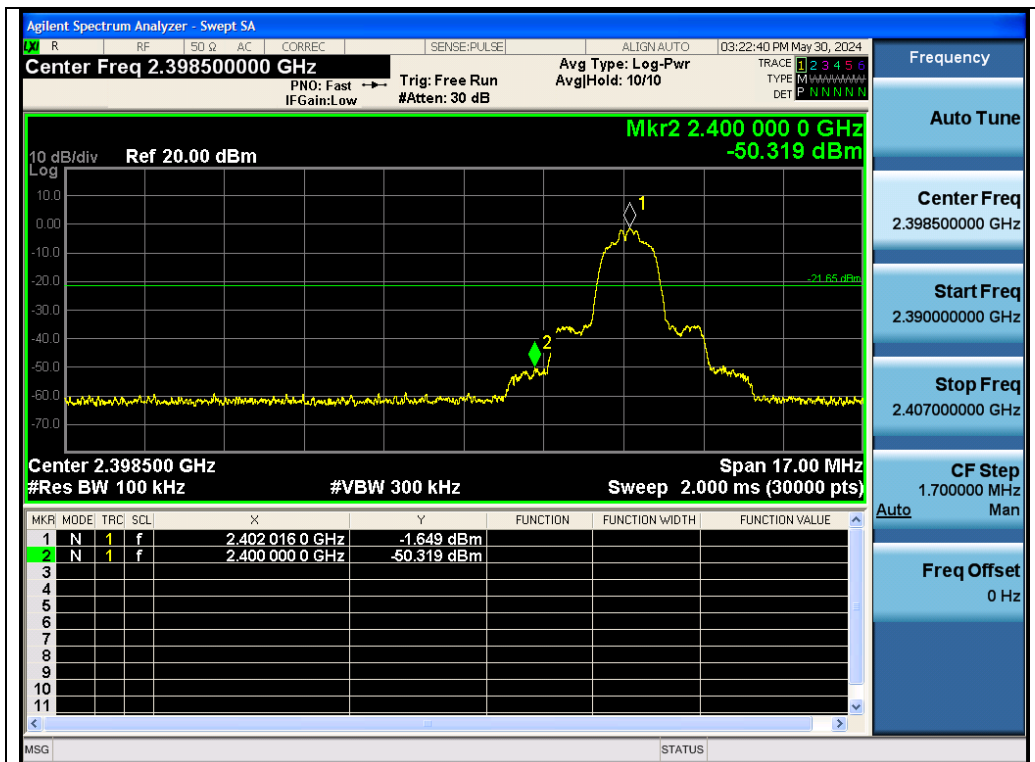


Test_Graph_BR_HOP_ANT1_NA_1Mbps_Lower Band Edge Emissions

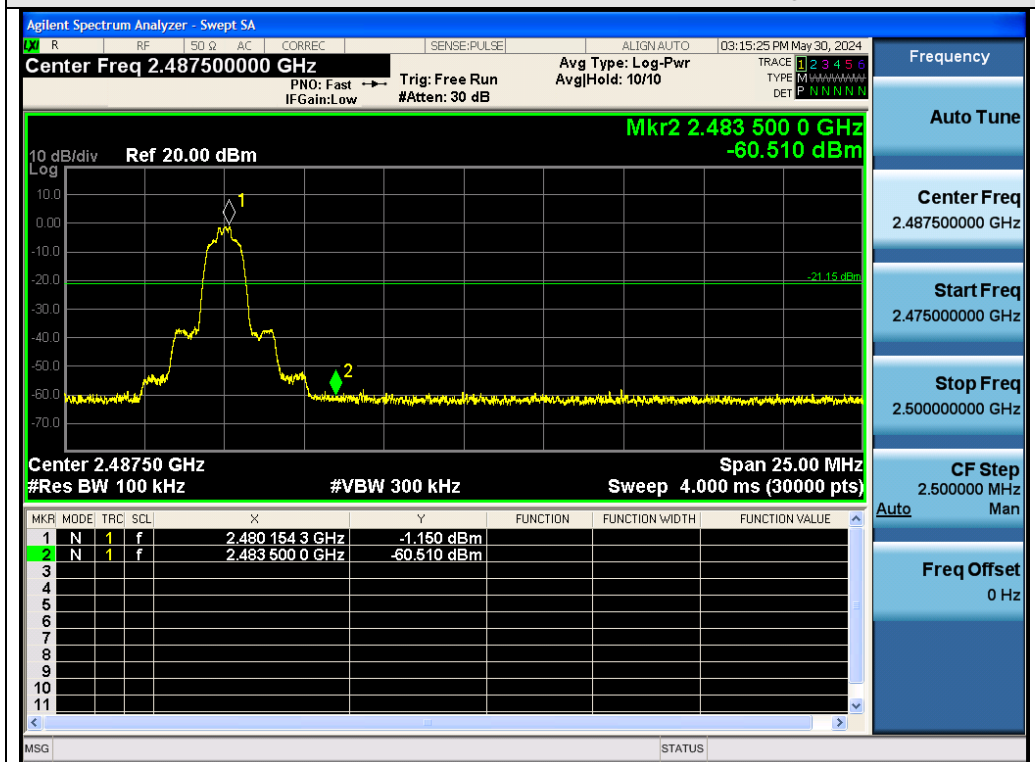


Test_Graph_BR_HOP_ANT1_NA_1Mbps_Higher Band Edge Emissions

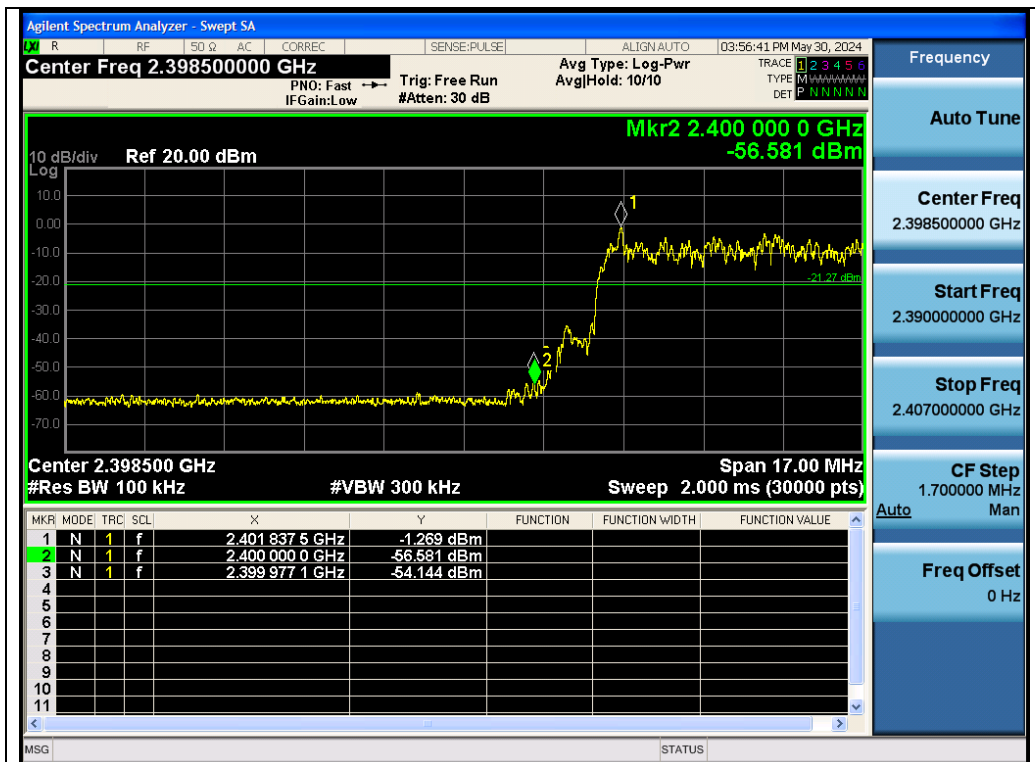


Test_Graph_EDR_ANT1_2402_2Mbps_Lower Band Edge Emissions

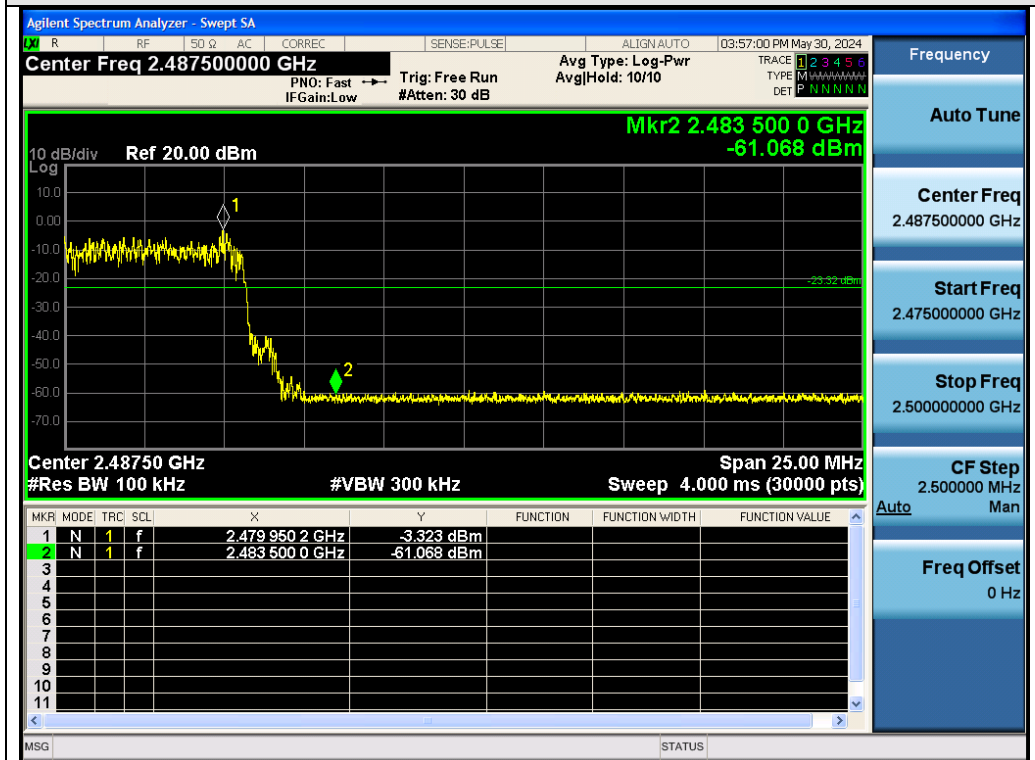


Test_Graph_EDR_ANT1_2480_2Mbps_Higher Band Edge Emissions

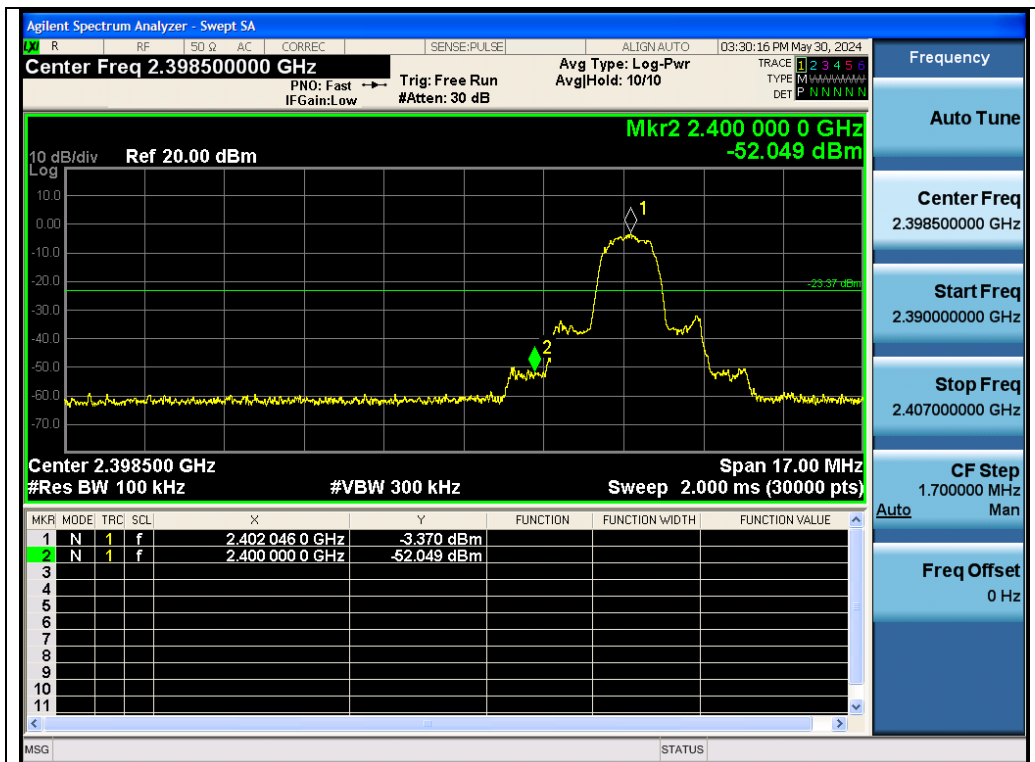


Test_Graph_EDR_HOP_ANT1_NA_2Mbps_Lower Band Edge Emissions

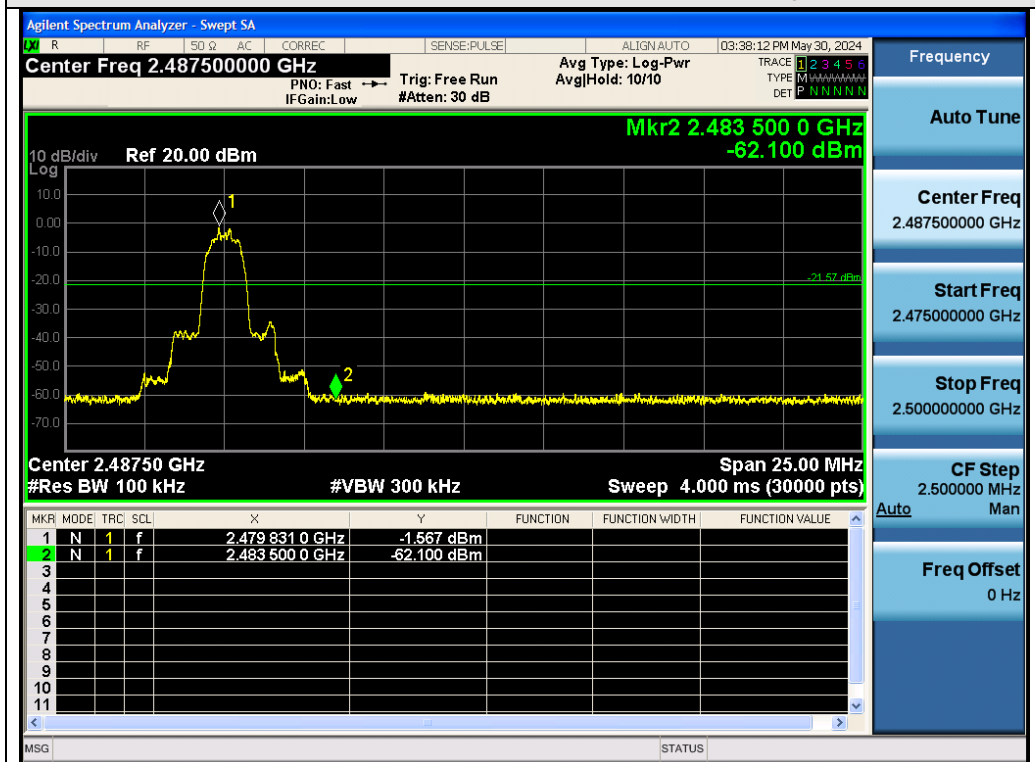


Test_Graph_EDR_HOP_ANT1_NA_2Mbps_Higher Band Edge Emissions

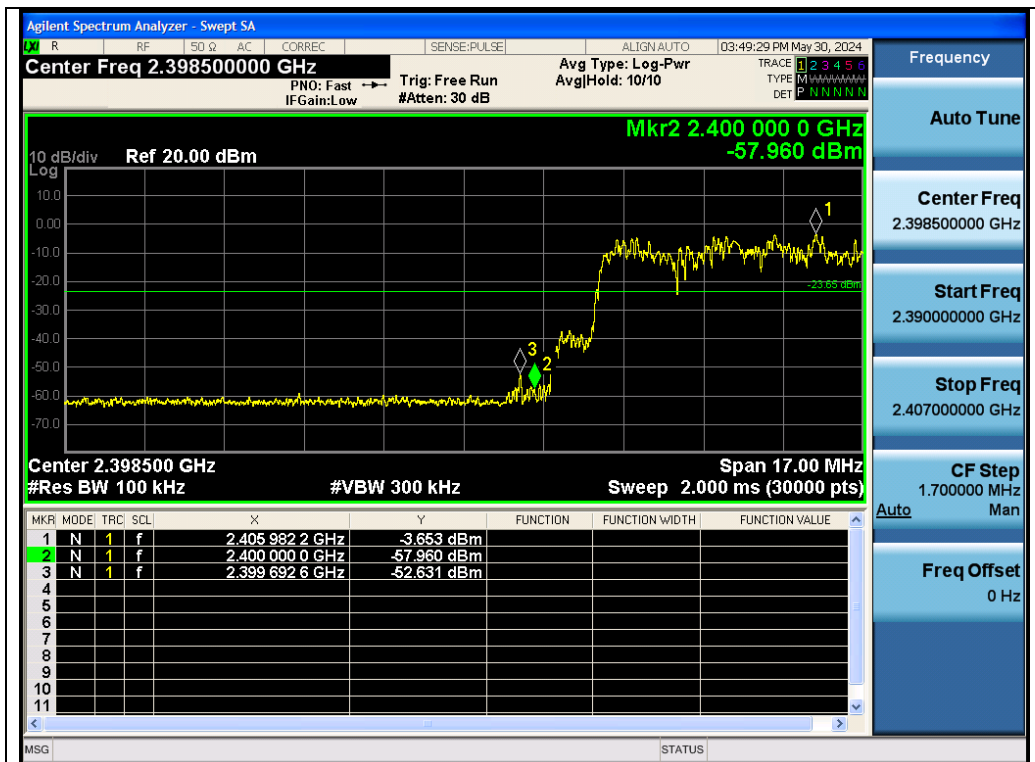


Test_Graph_EDR_ANT1_2402_3Mbps_Lower Band Edge Emissions

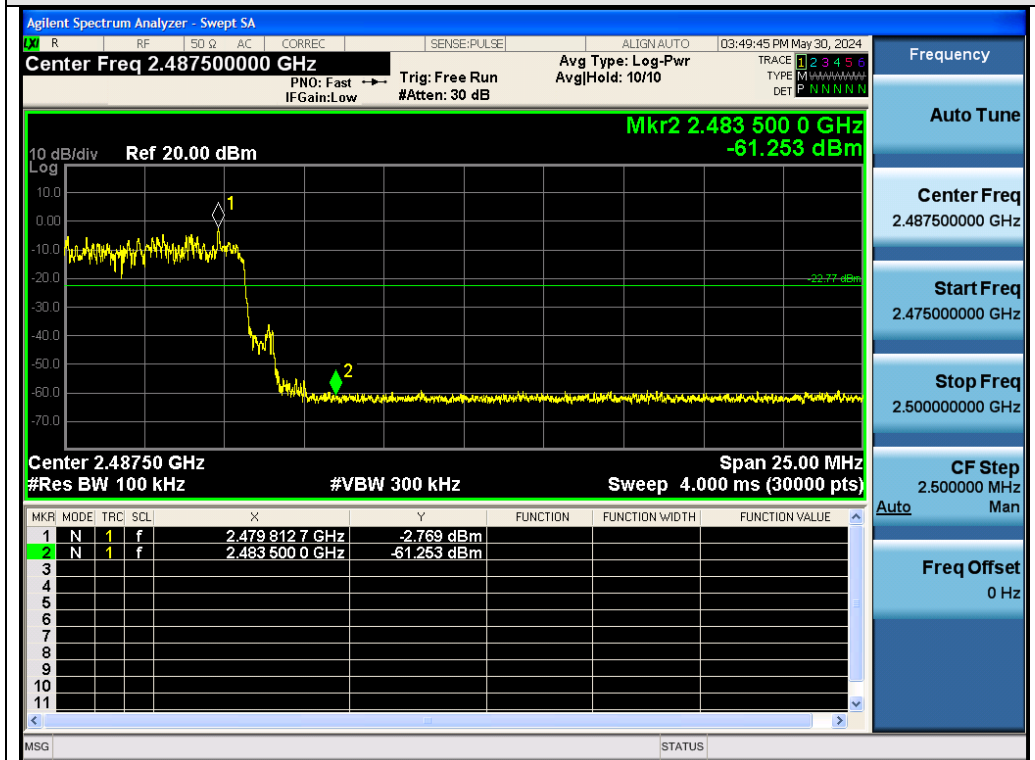


Test_Graph_EDR_ANT1_2480_3Mbps_Higher Band Edge Emissions

9.2 Measurement Procedure

1. The EUT was placed on the top of the turntable 0.8 or 1.5 meter above ground. The phase center of the receiving antenna mounted on the top of a height-variable antenna tower was placed 3 meters far away from the turntable.
2. Power on the EUT and all the supporting units. The turntable was rotated by 360 degrees to determine the position of the highest radiation.
3. The height of the broadband receiving antenna was varied between one meter and four meters above ground to find the maximum emissions field strength of both horizontal and vertical polarization.
4. For each suspected emission, the antenna tower was scan (from 1 M to 4 M) and then the turntable was rotated (from 0 degree to 360 degrees) to find the maximum reading.
5. Set the test-receiver system to Peak or CISPR quasi-peak Detect Function with specified bandwidth under Maximum Hold Mode.
6. For emissions above 1GHz, use 1MHz RBW and 3MHz VBW for peak reading. Place the measurement antenna away from each area of the EUT determined to be a source of emissions at the specified measurement distance, while keeping the measurement antenna aimed at the source of emissions at each frequency of significant emissions, with polarization oriented for maximum response. The measurement antenna may have to be higher or lower than the EUT, depending on the radiation pattern of the emission and staying aimed at the emission source for receiving the maximum signal. The final measurement antenna elevation shall be that which maximizes the emissions. The measurement antenna elevation for maximum emissions shall be restricted to a range of heights of from 1 m to 4 m above the ground or reference ground plane.
7. When the radiated emissions limits are expressed in terms of the average value of the emissions, and pulsed operation is employed, the measurement field strength shall be determined by averaging over one complete pulse train, including blanking intervals, as long as the pulse train does not exceed 0.1 seconds. As an alternative (provided the transmitter operates for longer than 0.1 seconds) or in cases where the pulse train exceeds 0.1 seconds, the measured field strength shall be determined from the average

8. If the emissions level of the EUT in peak mode was 3 dB lower than the average limit specified, then testing will be stopped and peak values of EUT will be reported, otherwise, the emissions which do not have 3 dB margin will be repeated one by one using the quasi-peak method for below 1GHz.
9. For testing above 1GHz, the emissions level of the EUT in peak mode was lower than average limit (that means the emissions level in peak mode also complies with the limit in average mode), then testing will be stopped and peak values of EUT will be reported, otherwise, the emissions will be measured in average mode again and reported.
10. In case the emission is lower than 30MHz, loop antenna has to be used for measurement and the recorded data should be QP measured by receiver. High - Low scan is not required in this case.

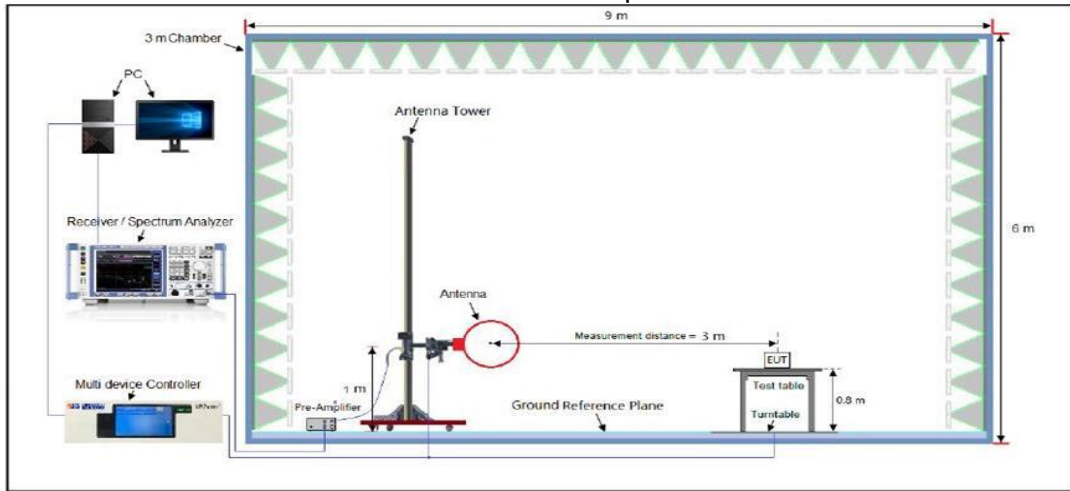

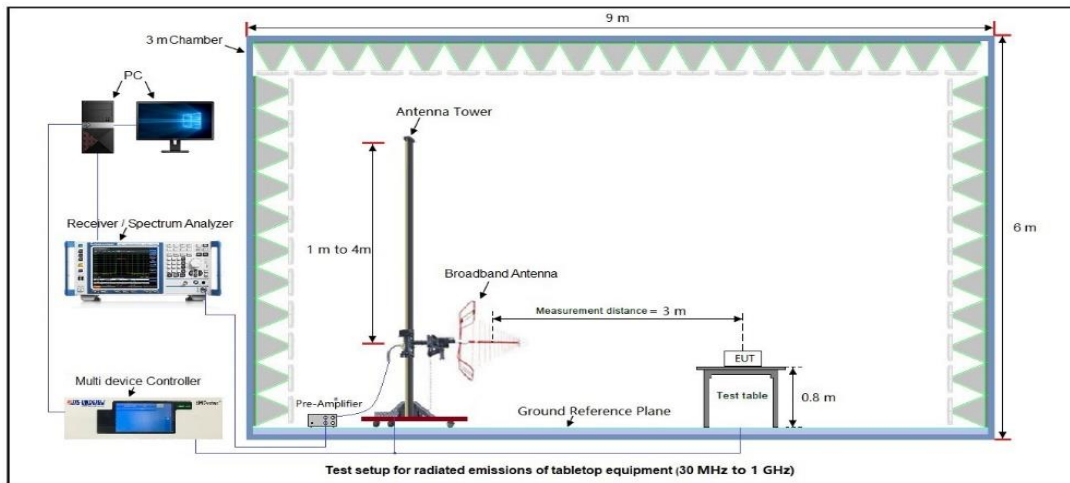

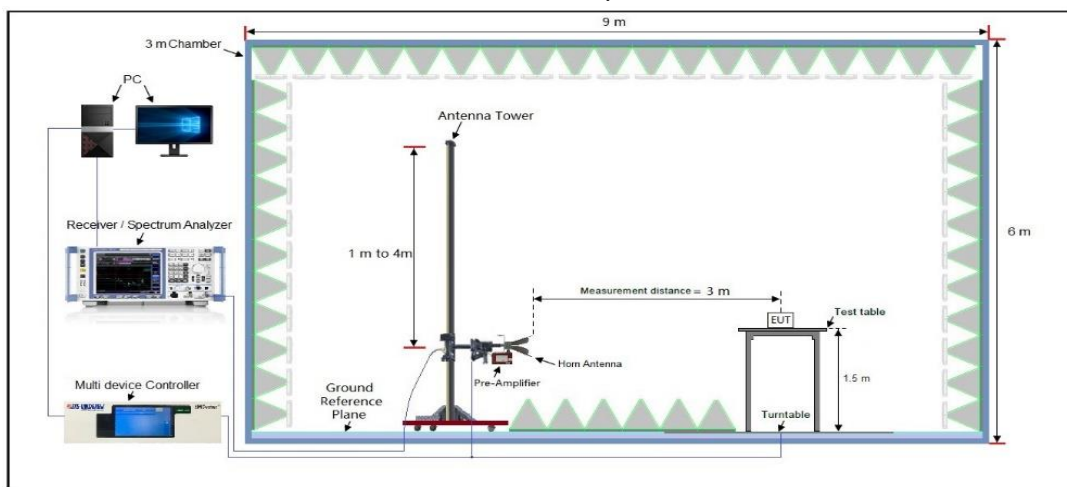
Radiated Emission Test Setup 9KHz-30MHz

Radiated Emission Test Setup Above 1000MHz



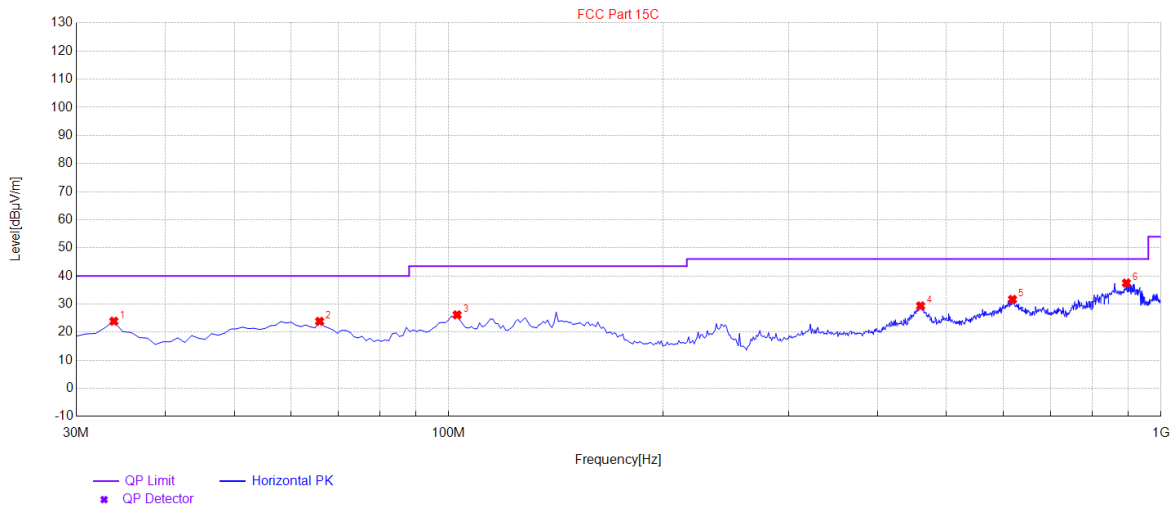

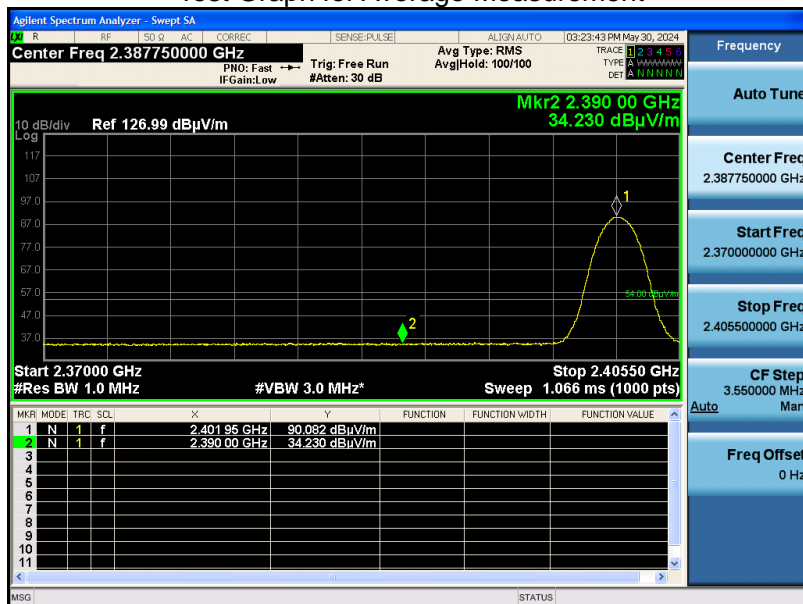

Test Graph for Average Measurement



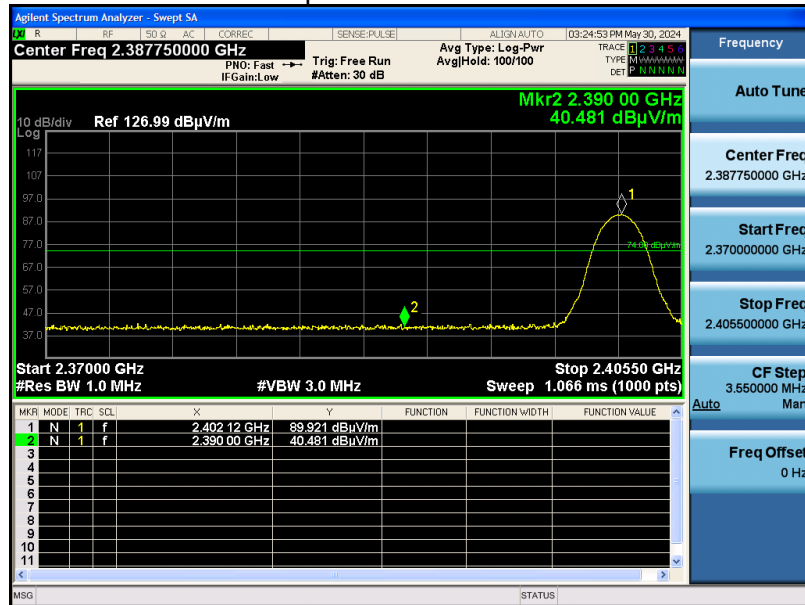

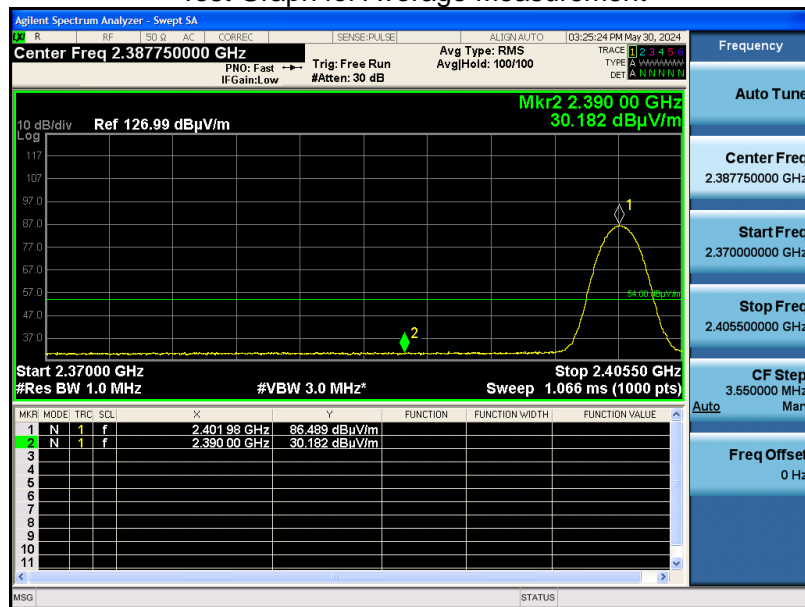

Test Graph for Average Measurement



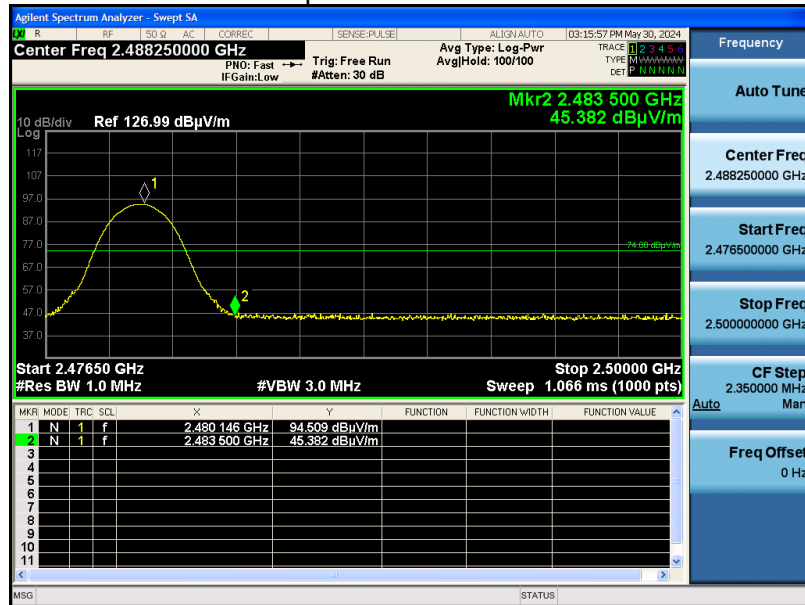

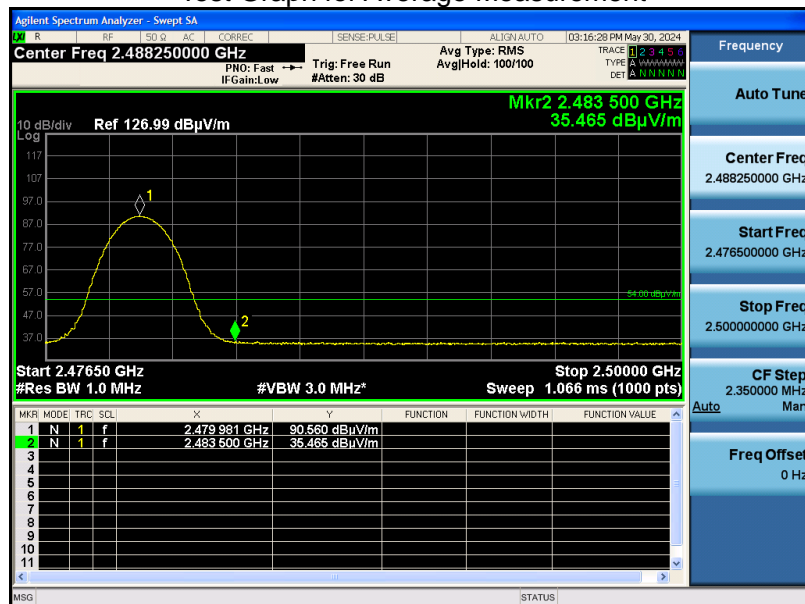

Test Graph for Average Measurement



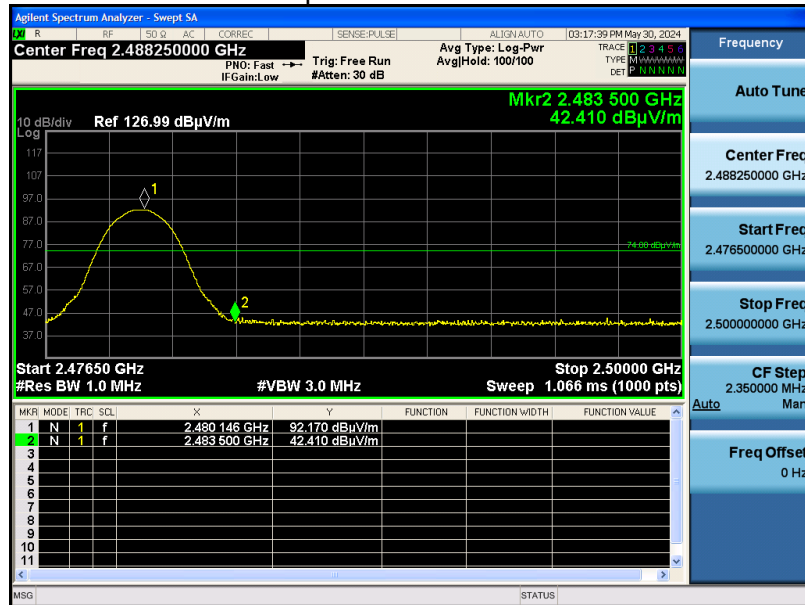

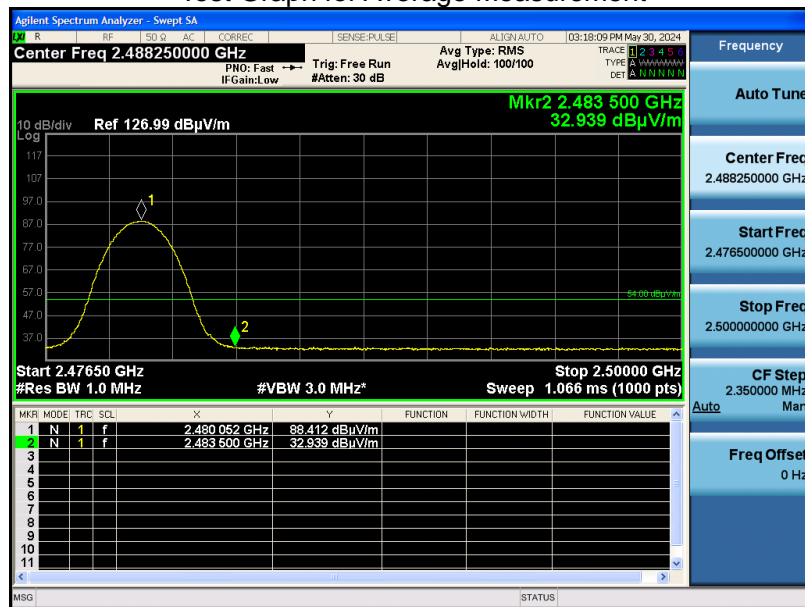

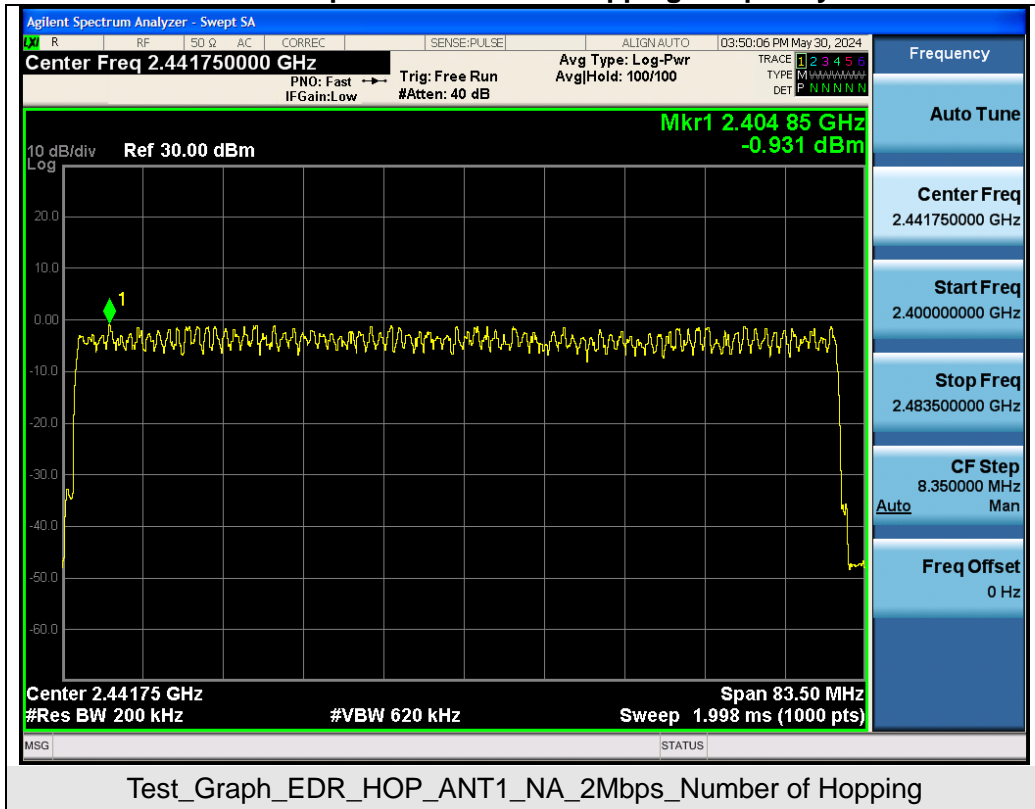

Test Graphs of Dwell Time

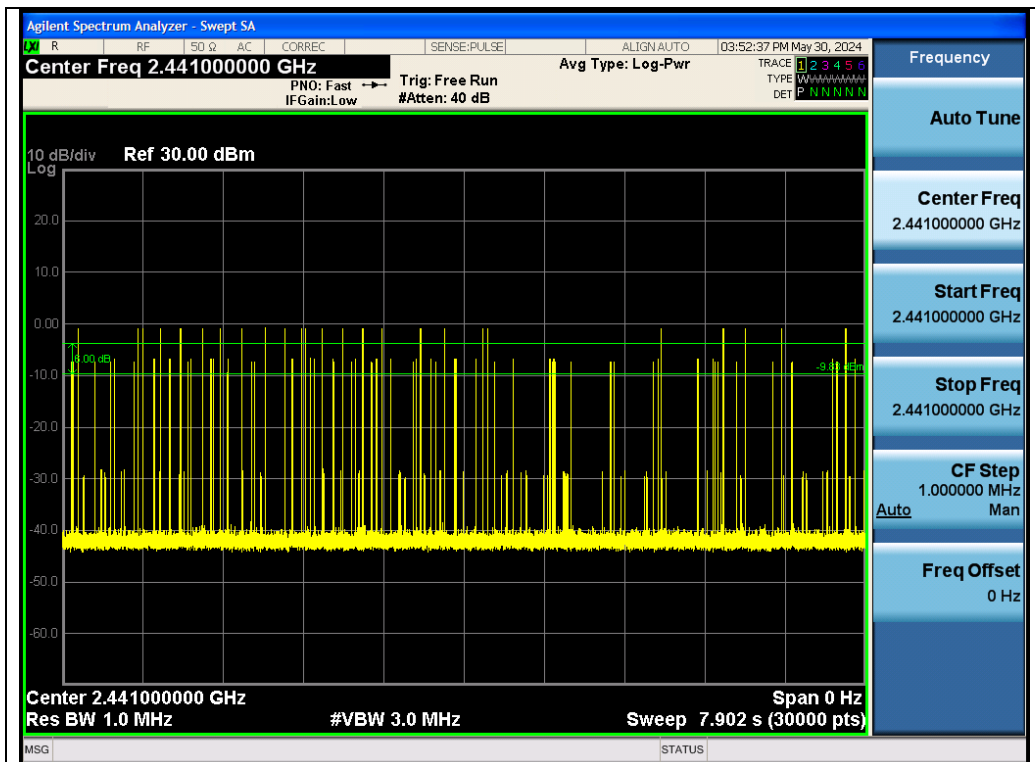


Test_Graph_EDR_HOP_ANT1_NA_2Mbps_2402_Number of Burst

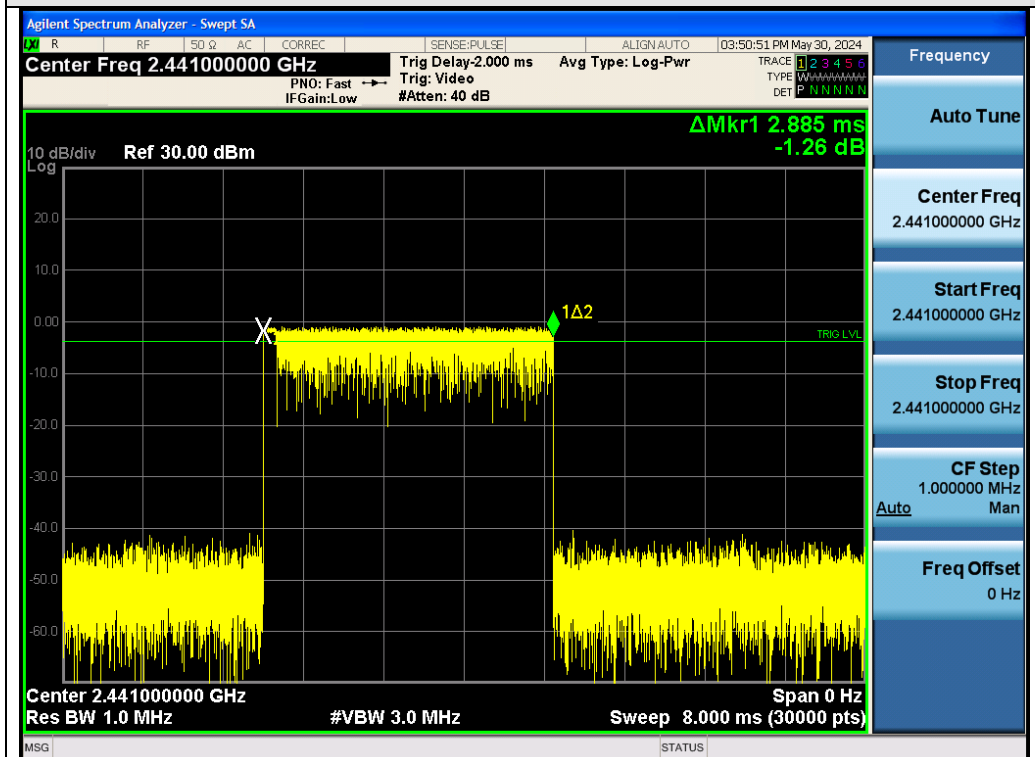


Test_Graph_EDR_HOP_ANT1_NA_2Mbps_2402_Time per Burst

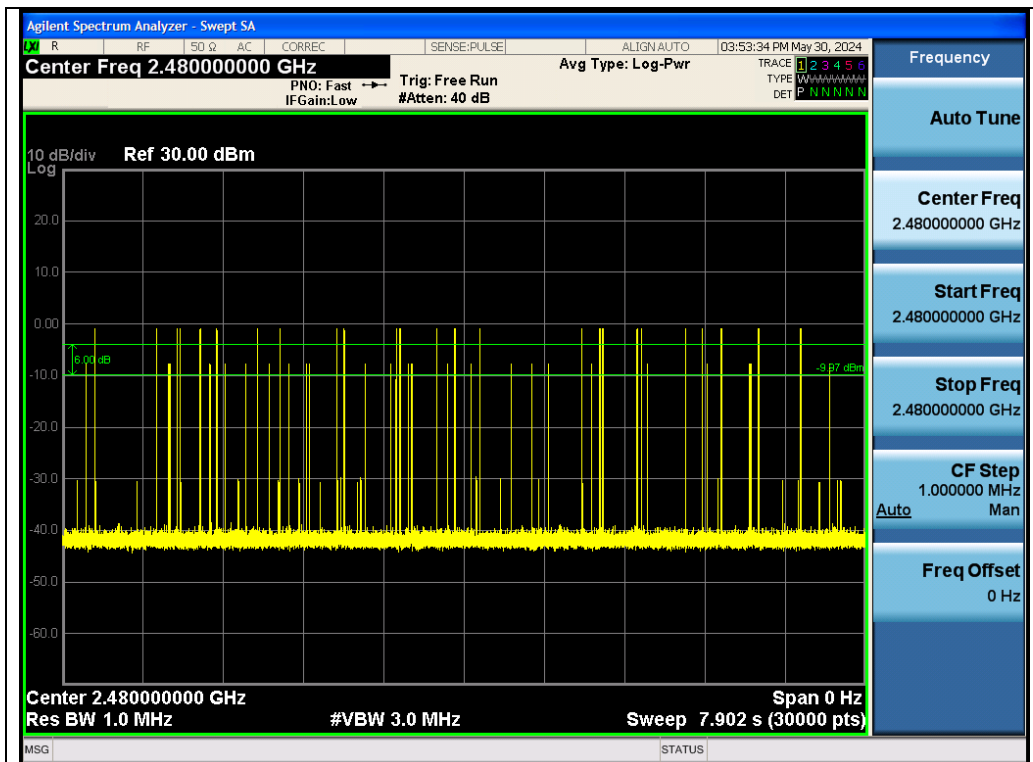


Test_Graph_EDR_HOP_ANT1_NA_2Mbps_2441_Number of Burst

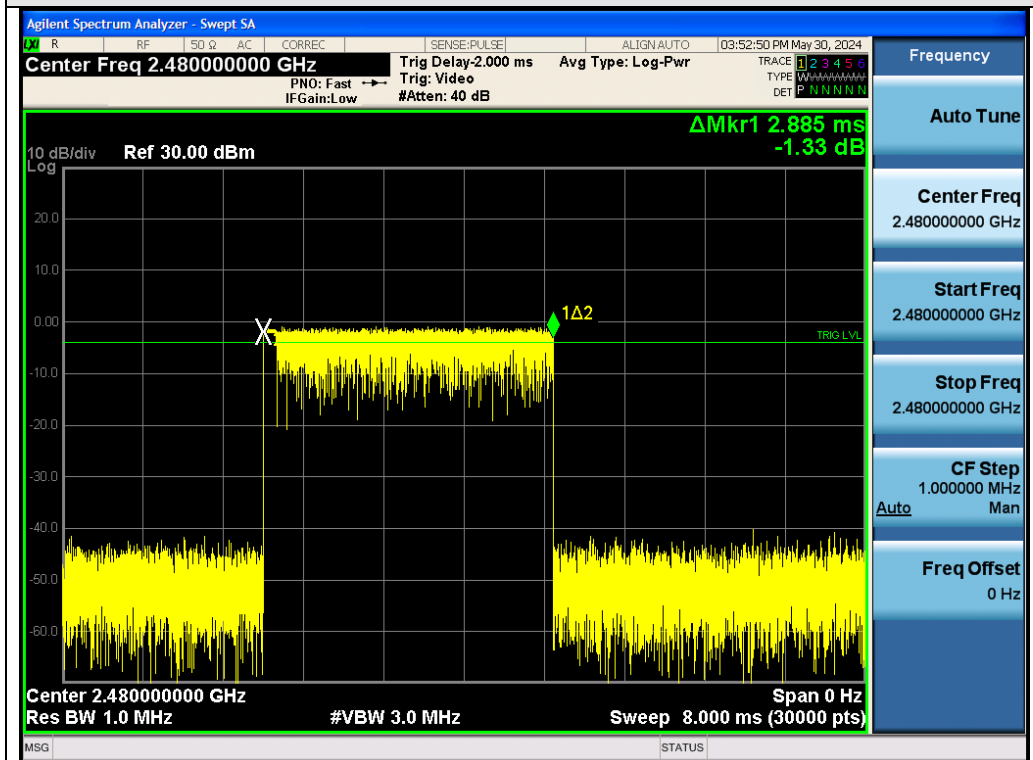


Test_Graph_EDR_HOP_ANT1_NA_2Mbps_2441_Time per Burst

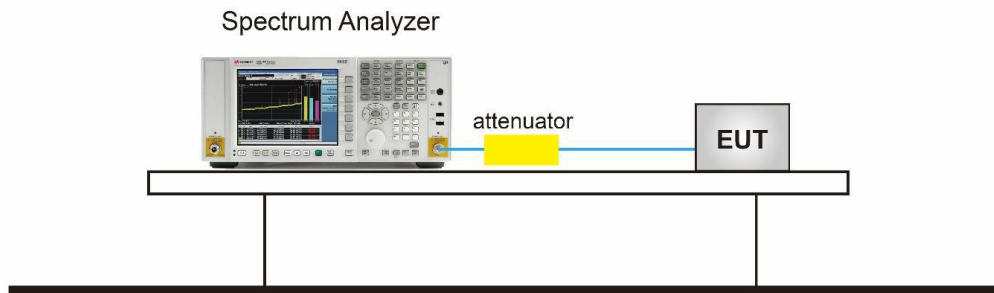

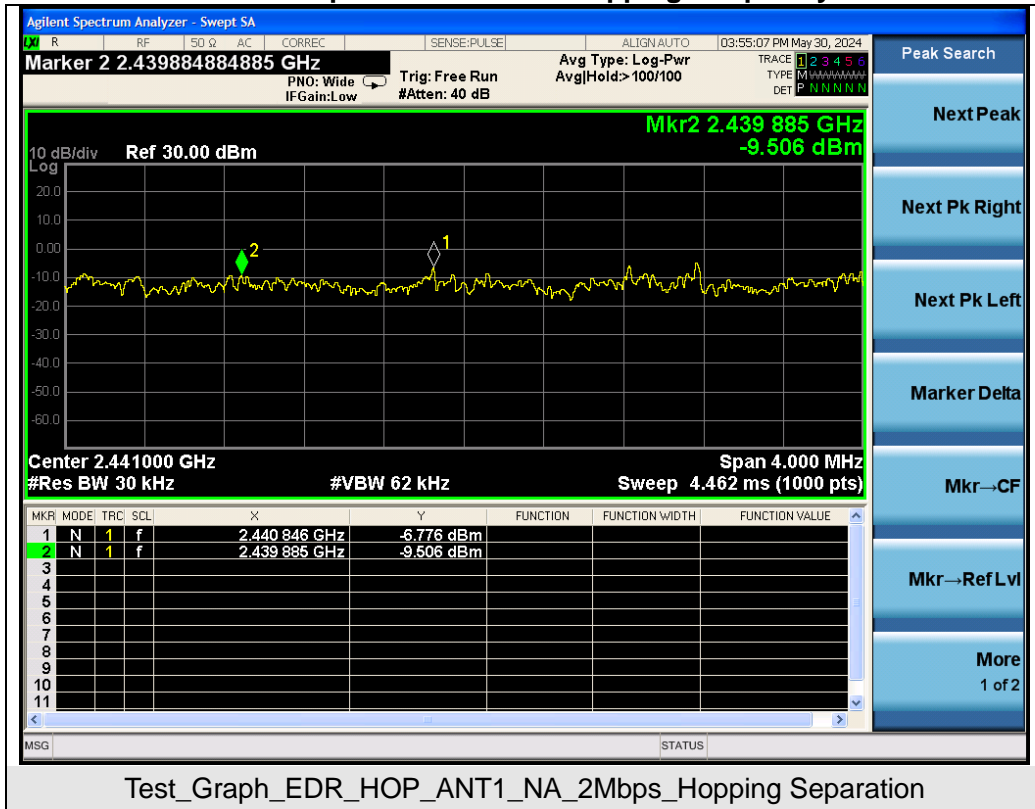

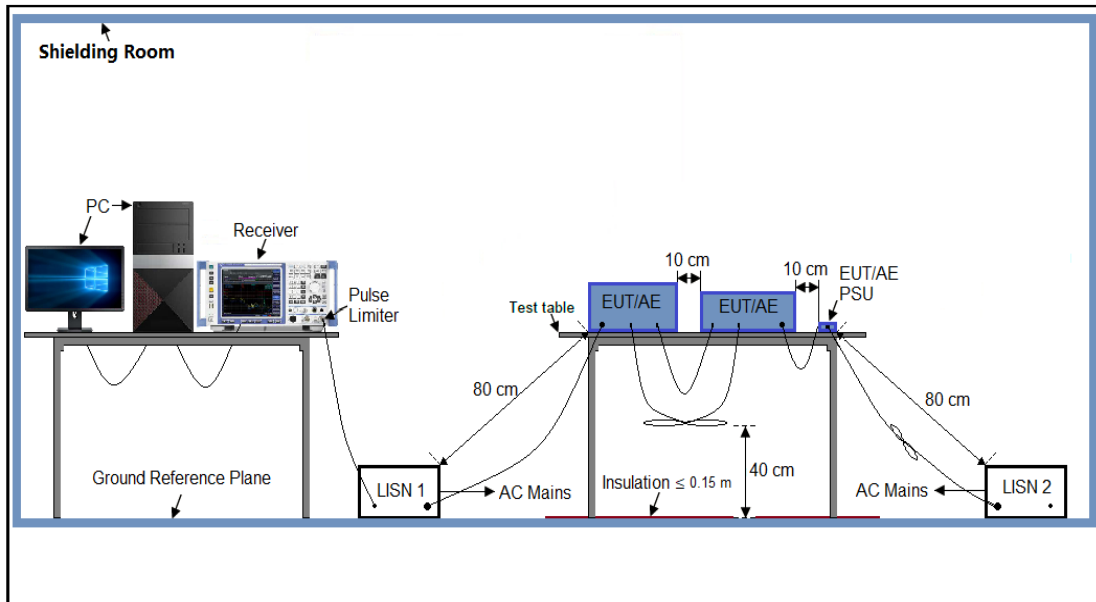

13.3 Preliminary Procedure of Line Conducted Emission Test

1. The equipment was set up as per the test configuration to simulate typical actual usage per the user's manual. When the EUT is a tabletop system, a wooden table with a height of 0.8 meters is used and is placed on the ground plane as per ANSI C63.10 (see Test Facility for the dimensions of the ground plane used). When the EUT is a floor-standing equipment, it is placed on the ground plane which has a 3-12 mm non-conductive covering to insulate the EUT from the ground plane.
2. Support equipment, if needed, was placed as per ANSI C63.10.
3. All I/O cables were positioned to simulate typical actual usage as per ANSI C63.10.
4. All support equipment received AC120V/60Hz power from a LISN, if any.
5. The EUT received DC 5V power from adapter which received AC120V/60Hz power from a LISN.
6. The test program was started. Emissions were measured on each current carrying line of the EUT using a spectrum Analyzer / Receiver connected to the LISN powering the EUT. The LISN has two monitoring points: Line 1 (Hot Side) and Line 2 (Neutral Side). Two scans were taken: one with Line 1 connected to Analyzer / Receiver and Line 2 connected to a 50 ohm load; the second scan had Line 1 connected to a 50 ohm load and Line 2 connected to the Analyzer / Receiver.
7. Analyzer / Receiver scanned from 150 kHz to 30MHz for emissions in each of the test modes.
8. During the above scans, the emissions were maximized by cable manipulation.
9. The test mode(s) were scanned during the preliminary test.

Then, the EUT configuration and cable configuration of the above highest emission level were recorded for reference of final testing.

13.4 Final Procedure of Line Conducted Emission Test

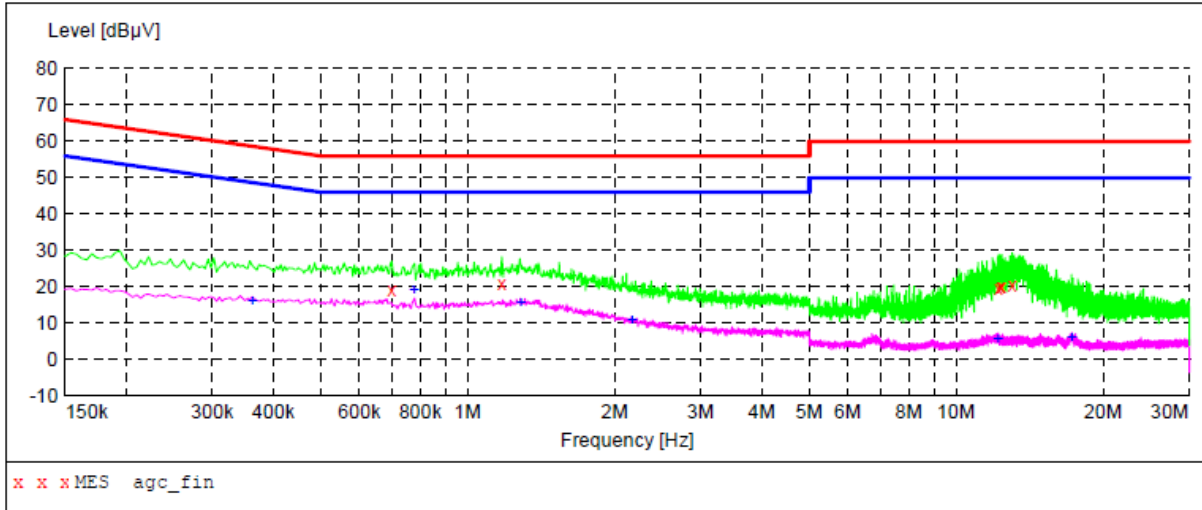
1. EUT and support equipment was set up on the test bench as per step 2 of the preliminary test.
2. A scan was taken on both power lines, Line 1 and Line 2, recording at least the six highest emissions. Emission frequency and amplitude were recorded into a computer in which correction factors were used to calculate the emission level and compare reading to the applicable limit. 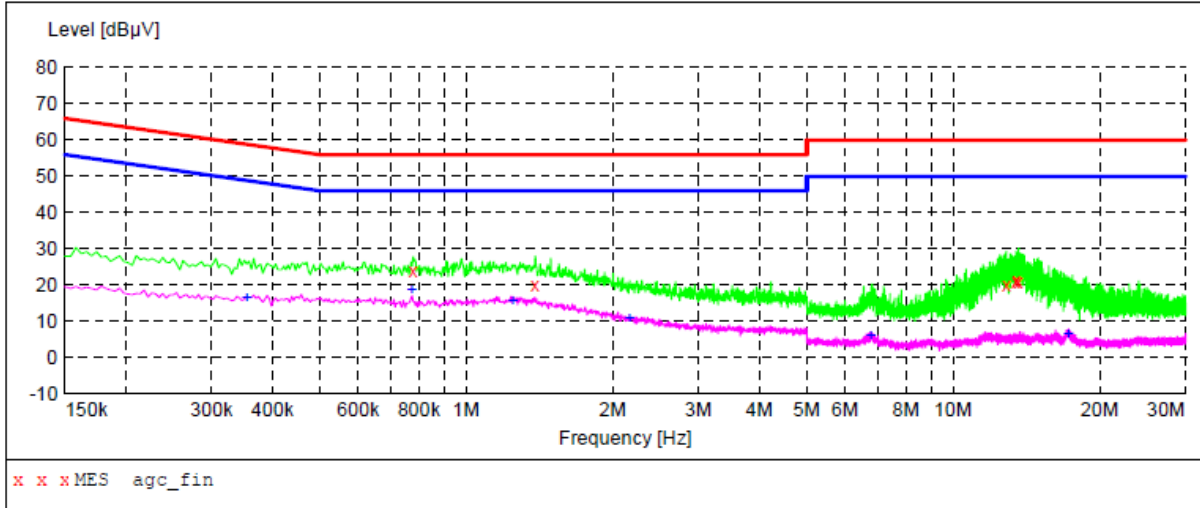
