

Overview:

Basic Safety & Maintenance

- Electrical Safety: Only use the power cable provided in the box to power your device and connect it only to compatible power sources. Check electrical specifications to ensure device compatibility.
- Ventilation: Ensure the device's vents are not blocked to prevent overheating.
- Liquid Exposure: Keep the device away from liquids to avoid damage.
- Cleaning: Clean the device with a soft, dry cloth regularly to prevent the accumulation of dust outside and inside the device.
- Caution: Do not use chemical cleaners, as these might damage the finishing on the surface of the device.

Setup Instructions:

- I. Unbox and Inspect:
- 1.2. Open the box and ensure that all the items listed in Section 3 [What's in the Box] are present and in brand-new condition*
- 1.3. Locate the serial number on the back of the device and note it down for later steps
- 2. Connect to Power:
- 2.1. Plug the appropriate end of the power cable to your Blockchain Computer Device
- 2.2. Connect the other end to a power outlet
- Network Connection:
- 3.1. Take the Ethernet cable from the box
- 3.2. Plug the blue color-coded end of the cable into the WAN port of your device
- 3.3. Plug the yellow color-coded end of the cable into a free port on your WiFi router
- 3.4. Wait approximately 15-30 minutes for the device to activate
- 3.5. A green indicator in front of your device will light up to let you know that you have connected to the network successfully

- 4.1. Continue your user setup by scanning the QR code below:






Product Visualization:
