The RF output power selection is for the setting of RF output power expected by the customer and is going to be fixed on the firmware of the final end product.

- 3. The EUT used fully charge battery when tested.
- 4. The test voltage was tuned from 85% to 115% of the Nominal rate supply votage, and found that the worst case was the nominal rated supply condition, So the report just shows that condition's data




MID-2440MHZ

5. BAND EDGE AND SPURIOUS(CONDUCTED)

5.1 LIMIT

In any 100kHz bandwidth outside the frequency bands in which the spread spectrum intentional radiator in operating, the radio frequency power that is produced by the intentional radiator shall be at least 30dB below that in the 100kHz bandwidth within the band that contains the highest level of the desired power.

5.2 TEST PROCEDURE



Low 2402MHz 0.3GHz-25GHz




Middle 2440MHz 0.3GHz-25GHz

6. POWER SPECTRAL DENSITY

6.1 LIMIT

For digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8dBm in any 3 kHz band during any time interval of continuous transmission.




7.2 TEST PROCEDURE

- a. The measuring distance of at 3 m shall be used for measurements at frequency 0.009MHz up to 1GHz, and above 1GHz.
- b. The EUT was placed on the top of a rotating table 0.8 meters (above 1GHz is 1.5 m) above the ground at a 3 meter anechoic chamber test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- c. The height of the equipment shall be 0.8 m(above 1GHz is 1.5 m); the height of the test antenna shall vary between 1 m to 4 m. horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. The initial step in collecting conducted emission data is a spectrum analyzer peak detector mode pre-scanning the measurement frequency range. Significant peaks are then marked and then QuasiPeak detector mode re-measured.
- e. If the Peak Mode measured value compliance with and lower than Quasi Peak Mode Limit, the EUT shall be deemed to meet QP Limits and then no additional QP Mode measurement performed.
- f. For the actual test configuration, please refer to the related Item –EUT Test Photos.
 - Both horizontal and vertical antenna polarities were tested and performed pretest to three orthogonal axis. The worst case emissions were reported




(A) Radiated Emission Test-Up Frequency Below 30MHz
