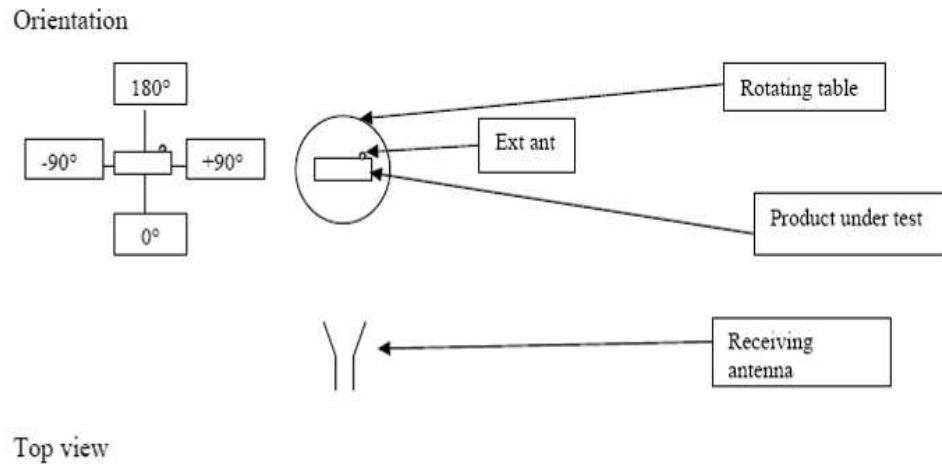

1. MEASUREMENTS SETUP



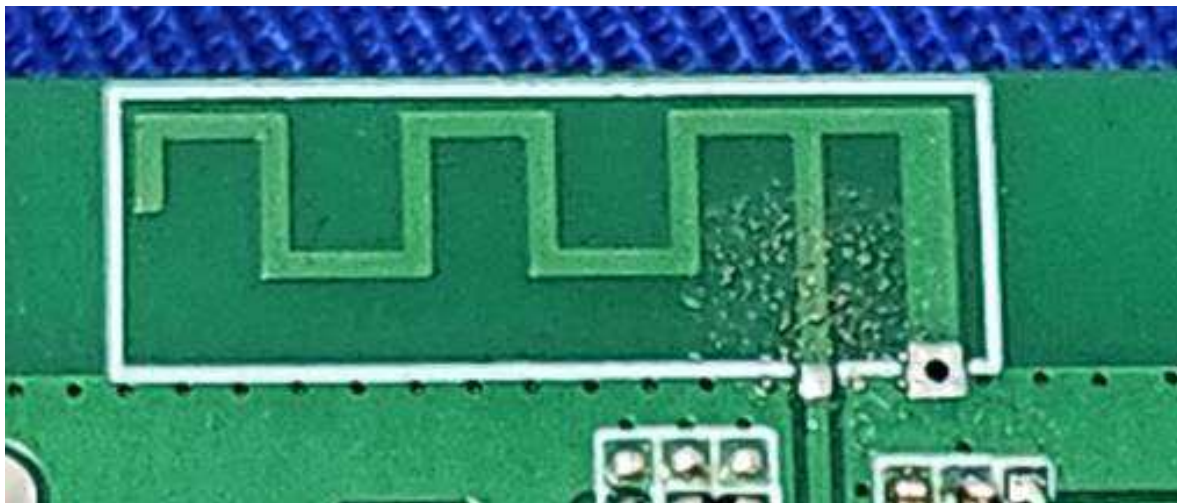
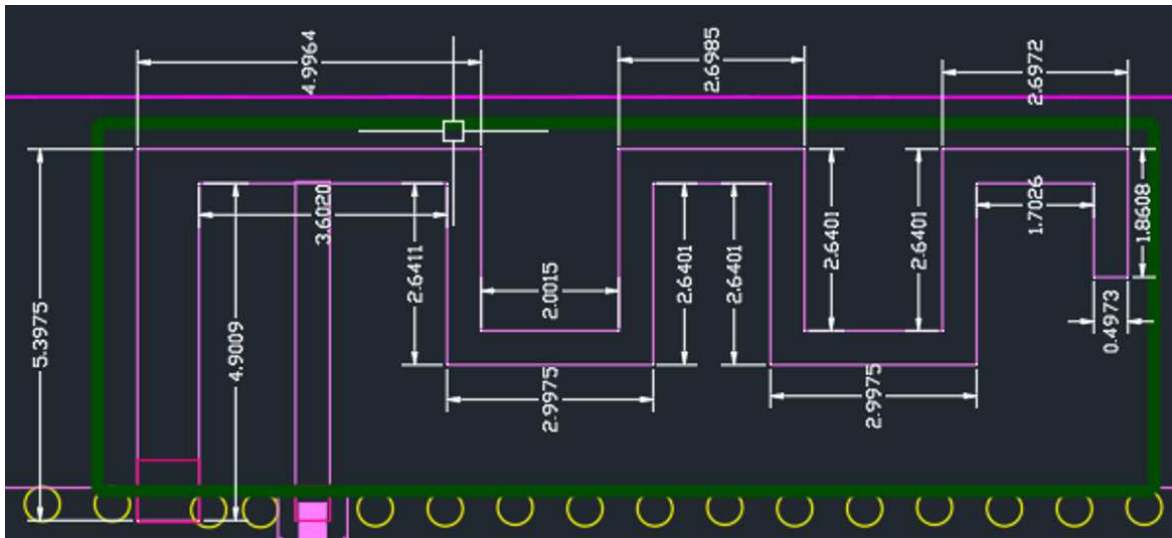
1.1 TEST PROCEDURE

- The EUT was placed on the rotating table 1.5 meters above the ground at a Fully Anechoic Room, the table was rotated 360 degrees.
- The EUT was set 3 meters away from the receiving antenna, which was mounted on the top of a antenna tower.
- The antenna is 1.5 meters above the ground. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- During the test, each emission was maximized by: having the EUT continuously working, investigated all operating modes, rotated about all 3 axis (X, Y & Z) and considered typical configuration to obtain worst position.

2. MEASUREMENT UNCERTAINTY

Expanded Uncertainty for Measurement (k=2 or 95% confidence level) at Passive antenna test over frequency range 1000MHz-6000MHz is +/- 1.86dB.

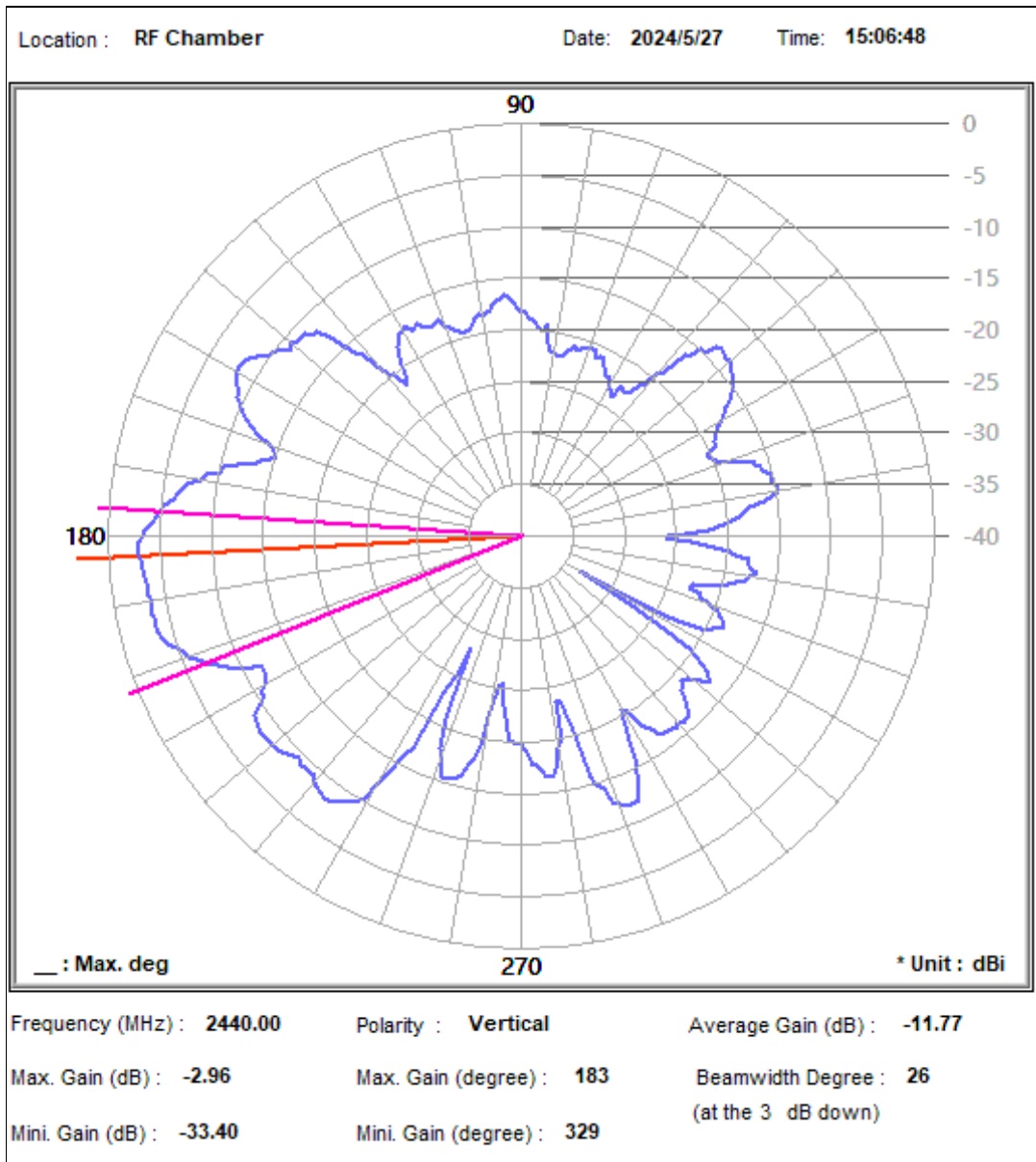
Frequency: 2440 MHz (Horizontal)

Frequency: 2440 MHz (Vertical)

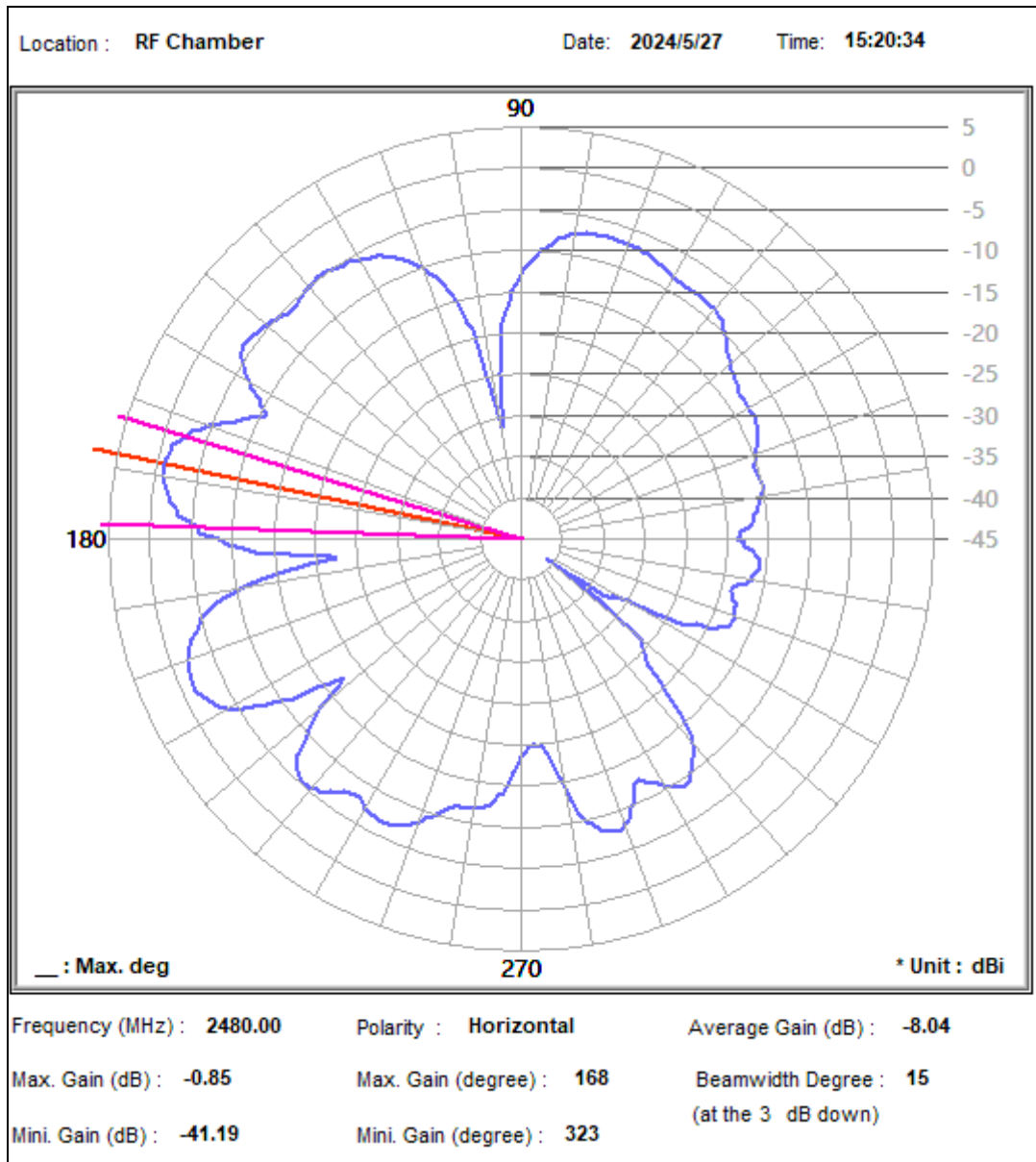

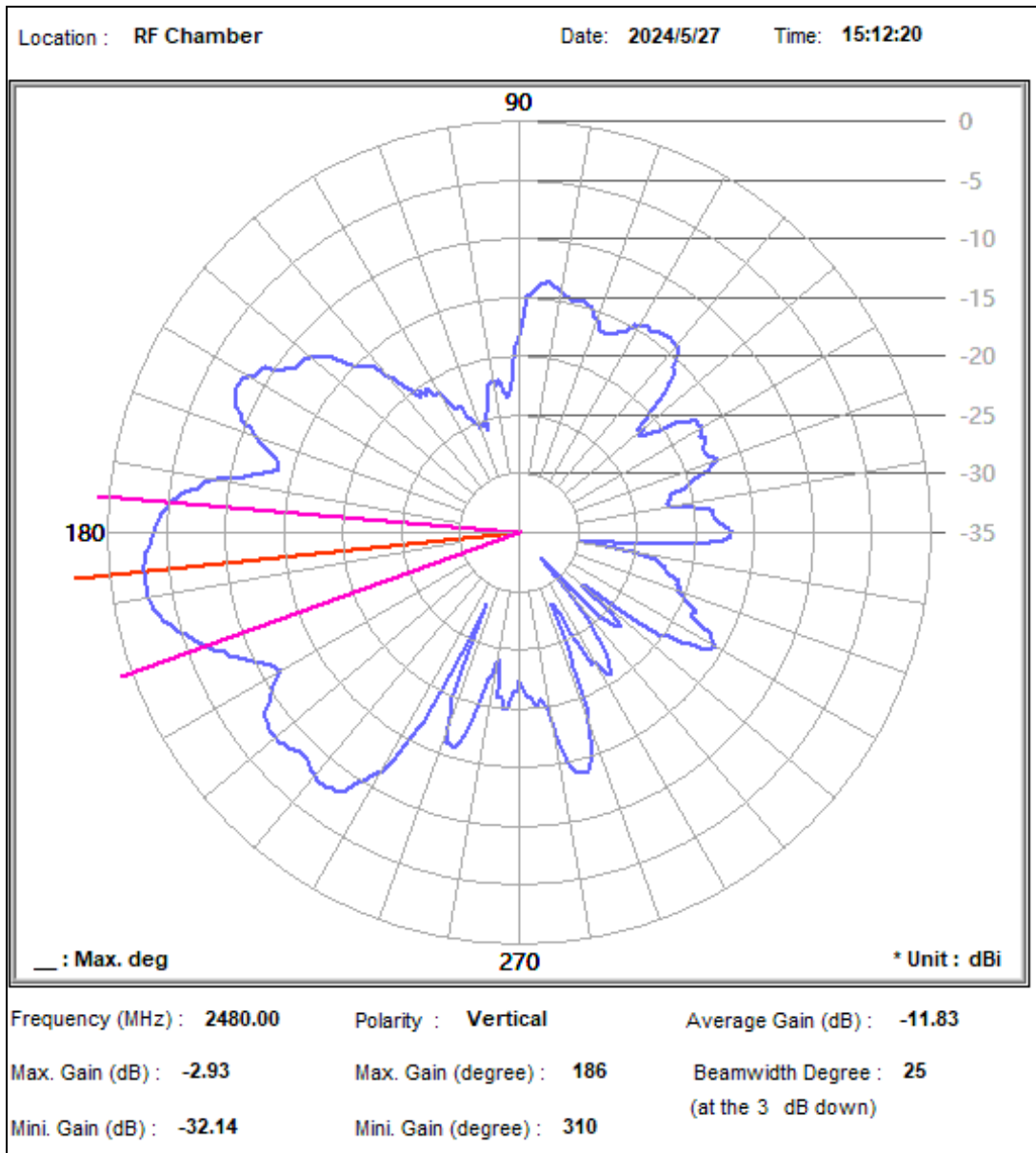
