The antenna is a PCB Antenna which permanently attached, and the best case gain of the antenna is 0.338dBi. It complies with the standard requirement.



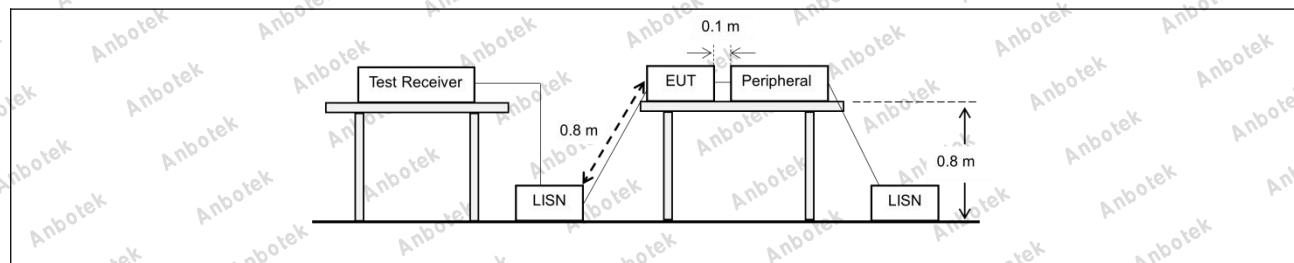

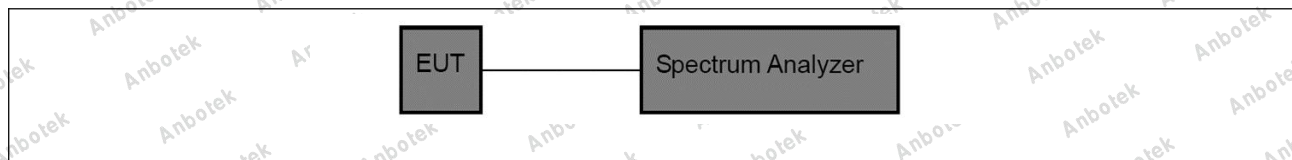
## 5. Maximum Conducted Output Power
