1.连接方法

2.4GHz无线连接

1. 拔下鼠标背面底部的 USB 接收器并将其插入计算机。
2. 打开鼠标背面开关并将其推至 2.4GHz 无线模式。
3. 鼠标和USB接收器可以正常使用5秒。

USB连接

1. 只需将鼠标的 USB 数据线连接到所需的设备。

2.系统要求

系统兼容性: Windows 7/8/8.1/10/Mac/Android
硬件兼容性: PC有可用的USB端口

3.如何清洁您的设备

可以使用 70% 异丙醇和 30% 水的溶液作为常用的清洁溶液。其他酒精可能会造成损害不建议使用漂白剂。

1.Connection Method

2.4GHz wireless connection

1. Unplug the USB receiver at the bottom of the back of the mouse and plug it into your computer.
2. Turn on the mouse reverse switch and push it up to 2.4GHz wireless mode.
3. The mouse and USB receiver can be used normally for 5 seconds.

USB connection

1. Just connect the mouse's USB data cable to the desired device.

2.System Requirements

System compatibility: Windows 7/8/8.1/10/Mac/Android
Hardware compatibility: The PC has an available USB port

3.How to Clean Your Device

A solution of 70% isopropyl alcohol and 30% water can be used as a common cleaning solution. Other alcohols can cause damage and bleach is not recommended.
