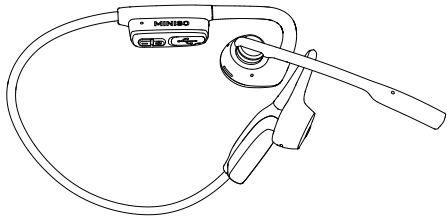
Indicator Light Description

Power On: Press & hold the button + for 3 sec, White and green leds flash. Prompt: Power on pairing.

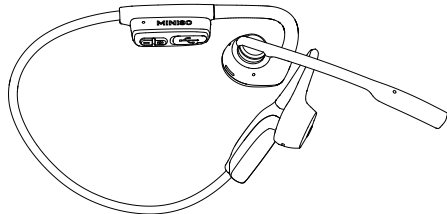
Power Off
